Mayor Brian Arrigo announced his candidacy for re-election at a breakfast Saturday morning at Casa Lucia.

The breakfast was part of a series of events kicking off his campaign. Many campaign volunteers had participated in a sign-holding on Broadway prior to the break-

"I want to thank you all for coming out on a cold, rainy May day [to hold signs]," Arrigo said at the outset of his speech.

There was also door-knocking event and an open house at the mayor's campaign headquarters at 26 Revere St.

Following a delicious breakfast catered by De-Maino's Restaurant, Arrigo took the podium, receiving a warm ovation from the guests, many of whom were orange-and-blue "Arrigo" T-shirts.

Rep. Vincent leads effort for new park for seniors at

To the residents who expressed concern about the lack of recreational areas and green space along Revere Beach during the Metropolitan Beaches Commission meeting last Wednesday, Rep. RoseLee Vincent has already taken the initiative.

Vincent, working in coordination with Speaker of the House Robert A. DeLeo, has proposed a new park for seniors, including bocce, shuffleboard, and pickleboard courts, at Sullivan Field, where youth baseball was once played regularly, but has sat dormant for several years.

DeLeo, at the request of Vincent, put a \$200,000 appropriation in the state budget for major renovations to Sullivan Field, which is located next to the former site of Bianchi's Pizza.

It has been a goal of Vincent to bring a park geared for seniors to Revere for several years. Chelsea has a bocce court at Voke Park where Revere seniors travel to compete in the popular activity.



Since the drive began in 1993, total donations have surpassed 1.6 billion pounds of food. The food drive has become the nation's largest one-day campaign to collect food for distribution to needy families.

Making a donation is easy. Customers should leave their non-perishable food donations in a bag near their mailbox on Saturday, May 11, before their letter carrier arrives. In the days leading up to the food drive, letter carriers will be delivering special bags along with your mail that may be used to make donations. While all non-perishable donations are welcome, foods that are high in protein such as canned tuna, salmon, beans and peanut butter are most needed. SPRING CLEANING BRINGS HEALTH BENEFITS

Spring is here! This time of year offers a perfect moment to stop and enjoy the outdoors and the beautiful flowers budding, like tulips and daffodils. "When we have a chance to put dollars back into the pockets of those who served our country, built our community over generations and drive our economy - we do it," Mayor Brian Arrigo said. "Thank you to the City Council for their vote of support for these smart tax saving policies."

The new policies will al-

- A real estate tax exemption for Gold Star families.
- A Veteran Work-Off program, proposed by Councillor Steven Morabito, to give veterans, the spouse of a disabled veteran, or the surviving spouse of a deceased veteran, an option to volunteer with the city in exchange for a reduction in real property tax obligations, up to \$1,000 in a given tax year.
- A personal property tax exemption for the more than 500 Revere businesses with personal property valued at less than \$10,000.

The project will improve fire safety and water pressure. The line is being extended to also connect with North Shore Road. Bypass water will be provided and residents should see no interruption in service.

City Council approves plan to hold 75th Anniversary observance of D-Day on June 6

The City Council unanimously approved a motion by Councillor-at-Large Dan Rizzo to hold a City of Revere commemoration ceremony of D-Day on June 6, 2019.

The event will mark the Allied Invasion across the English Channel and on to the beaches of Normandy, France that occurred on June 6, 1944 during World War II.

"This will be the 75th anniversary of Operation Overlord, otherwise known as the Battle of Normandy, and otherwise known as D-Day," said Rizzo in presenting his motion. "Obviously it was a major milestone, not only for this country, but for the world."

Rizzo, said World War II veterans and other war veterans would be invited to the ceremony and be recognized for their service to the country.

Marc Silvestri, director of veterans services, commended Rizzo for the motion, stating to the Council, "I support it 100 percent."

Silvestri said the city is planning a June 6 breakfast honoring the 75th anniversary of D-Day.

"D-Day was an important day in history as well as it was in Revere's history," said Silvestri. "We have one or two [World War II) veterans in Revere, but several Revere residents have been highly decorated from that invasion and the following [operations] on Omaha Beach and during the rest of World War II."

Rizzo, who served six years of active duty in the U.S. Navy, said he was pleased that the city will be holding a local observance of D-Day with a breakfast and ceremony.

"I am happy that the city is going to act on my motion and I think it's very fitting that we celebrate the 75th anniversary of Operation Overlord otherwise known as the Battle of Normandy," said Rizzio. "It's a very significant date in our country's history and we in Revere should do our part in recognizing any living veterans that participated in that operation as well as honoring all veterans who have defended our country and made it is

We wrote about every aspect of the tobacco industry, from the insidious means by which the tobacco companies were pushing their products with advertising geared toward young people, to taking to task local authorities who were not doing as much as they could have (by means of ordinances limiting smoking in public places) in order to prevent young people from becoming the future tobacco addicts of America.

This exact week in 1999, we editorialized in favor of a state law to ban smoking in restaurants.

So it was with a great deal of personal satisfaction that we took some degree of pride in what seemed to be the vanquishing of a foe -- the tobacco lobby -- that for generations in this country had reigned with impunity and that had seemed invincible until there finally were laws enacted throughout the country limiting the sale and use of tobacco beginning in the mid-2000s.

Shortly after these laws went into effect, teenage cigarette smoking rates began to decline precipitously and smoking in public became an anathema.

Big Tobacco had been defeated.

Or so it seemed.

But like one of those horror-film swamp creatures that becomes resurrected in even more ominous form when exposed to seemingly deadly radiation, Big Tobacco is back -- and in a big way -- thanks to the new, so-called e-cigarettes.

A recent article in the New York Times put it this way, "Although teen cigarette smoking rates have fallen below five percent, America is now contending with an epidemic of young people using e-cigs, vapes, and other 'nicotine delivery devices,' as the tobacco industry christened them years ago in secret memos, searching for an official alternative to describing their products as cigarettes."

Nicotine is considered by some to be the most addictive substance, legal or otherwise, known to man. In previous generations, teen smokers, encouraged by images of James Dean with a cigarette hanging from his lips, became lifetime smokers, assuring Big Tobacco of a steady stream of income ad infinitum.

Teens once again have become the target consumer group for Big Tobacco, a dangerous trend on many levels. According to one study, the effects of teens using these new products are dramatic and significant: "For a teen, becoming nicotine-addicted greatly increases the likelihood that they will graduate to traditional, combustible cigarettes. Importantly, nicotine addiction during adolescence increases the vulnerability to subsequent addictions, like opioids or cocaine. For most users of illicit drugs, their initial addiction was to nicotine."

More ominously, the use of these new products, known ubiquitously as juuling, delivers as much nictone in one pod as 200 cigarettes, all but assuring users of a fast-track to addiction.

The bottom line is that Big Tobacco (which owns or controls all of the largest of these e-cigarette companies) has found a 21st century means by which to hook a new generation of future tobacco addicts.

Parents have to take a watchful eye to make sure their children are not using these products and society needs new laws to ensure that these products cannot be sold to those under the

Big Tobacco is back -- and we need to take action immediately.

Anti-Islamic remarks raises Superintendent's ire

At a public Revere GOP meeting Gina Castiello felt she needed to get something off her chest about Revere schools.

When given the opportunity to speak, Castiello, who was being filmed by a friend who goes by the name of, Stiletto Dee, launched into an anti-Islamic, anti-Muslim tirade that seemed to puzzle Councillor Tony Zambuto and others that were looking on.

"I love this city, but I'm very concerned about Islam in our school system," said Castiello. "We can not allow this horrific ideology in our public schools. It's not a religion. We need to get educated and we need people to back us."

What seemed to bug Castiello the most was the school allowing Muslim students to pray at school. Devout Muslims pray five times during the day, once at dawn, once in early afternoon, a late afternoon prayer, a sunset prayer and a prayer at night.

"They have prayer rugs

in our schools," Castiello lamented.

Her comments were edited from the online version of the meeting but later resurfaced on Dee's Facebook feed and went viral.

Days later Castiello bemoaned the fact they cut her arguably offensive speech out from the online broadcast.

"I viewed my concern about Islam in our Public Schools," she later said. "It appears the GOP public meeting, which was filmed, cut this portion of the meeting out! This is even more concerning to me!"

Her rant received an immediate backlash from Revere School Superintendent Dianne Kelly.

"We are proud of our diversity in Revere and we do our best to honor each student's culture and individuality," said Kelly in a statement. "Our curriculum in no way suggests students adhere to any religious beliefs. Our students study various religions as part of the history curriculum (as required by the Massachusetts Department of Elementary and Secondary

Education) and to help with their understanding of global history."

Kelly went on to say that Revere will always support students and employees who choose to exercise their religious freedoms on their breaks and during non-academic times.

"This is something we do for all – not any one particular group," she said. "Priorities for us are welcoming and including everyone and anyone who chooses to learn in our schools, as well as ensuring physically and emotionally safe spaces for all members of our school community."

Dee, who helped make the video of Castiello's speech go viral, recently got into some hot water in neighboring East Boston.

At the end of last month Dee walked into the Excel Academy Charter High School in East Boston and allegedly began recording an Anti-Arab video that was later posted to her Facebook account.

The school, which was celebrating Arab Heritage Month, buzzed Dee into the

school's lobby. Inside the lobby a display made by students reflecting the contributions Arabs and Muslims have made to civilization since the dawn of time was clearly visible.

In the video, allegedly Dee can be heard saying, "We're in America man. I don't like this (expletive). I'm just getting sick to my stomach being here."

The video was picked up by several social media discussion groups where many condemned the woman's rant.

The incident forced Excel to change its security protocols.

"This incident led us to reexamine and make changes to our security protocols for allowing visitors into the building," said Excel's Executive Director Owen Stearns. "We are investing in locks for our secondary interior front doors, so that all visitors will need permission to enter the building and will only be allowed to pass through the second set of doors once they have been cleared by our front office staff."





As an elite college athlete, DA Rollins got a taste of the law and never turned back

New Suffolk County DA Rachael Rollins has quickly come to be known as an agent of change, a passionate advocate for equity in the law and a solid leader ready to stand up for a cause – but few know that before all that she was an elite Division 1 college athlete, and it was on the playing field where she first gained her

love and respect for the law. Rollins grew up in a large family in Cambridge, and sports were part of her family from the beginning, long before she ever thought of the legal system.

Rollins said she was a team captain of every sport she played going back to youth soccer, and an All-Scholastic in basketball at Buckingham, Brown & Nichols School (BB&N), but it was on the lacrosse field where she was the most outstanding. The sport – which was somewhat newer

to New England in the 1980s when she was in high school was fast moving and, having been recruited to play after a basketball practice, Rollins had a great skill set to be a high achiever.

"I was the oldest of five siblings and my parents worked very hard to make sure we got a great education," she said. "I got into BB&N after the third grade, but at one point my parents sat me down and told me I was a good athlete and a good student and needed to get a scholarship if I wanted to go to college."

Her skills led her to a full Division 1 Scholarship to UMass-Amherst for lacrosse, this coming after winning a national championship on the high school level in 1989. After an outstanding freshman year, Rollins and her teammates were shocked to learn that their sport was being eliminated by the university due to budget cuts.

Though she was able to keep her scholarship, she said she eventually missed the athletic fields, and that's when she and some other women athletes turned to the law which she found to be a powerful leveler for those without much of a voice.

"At first, I was kind of relieved because I didn't have to wake up at 5 a.m. for conditioning anymore, but later I began to miss sports," she

said. "I'd played sports my entire life and missed the camaraderie you feel when you have the team behind you and you score a goal.

"We only had three or four scholarship players and we were good," she continued. "The men's football team hadn't won a game in years and they had 75 full-time scholarships with everything provided for them, including food and lodging. I didn't know a lawyer or a judge, but it seemed so unfair. Myself and a few other athletes from the women's teams, asked to meet with the Athletic Direc-

That meeting didn't go so well, and there was no change, but DA Rollins said everything changed when they got a lawyer.

"Our lawyer threatened a Title 9 lawsuit," she said. "The AD completely changed his tune. We got all or our teams re-instituted after a while."

Rollins - who attended Northeastern University Law School after UMass - said it was her first taste at how the law can be used to empower and bring about justice.

And it was a powerful ex-

"I saw that lawyers matter and words matter," she said. "As a young person, I thought, 'Oh my God, lawyers are awesome.' They make everyone fall into line and things change.'

It was the defining moment she points to after a long legal career with MassPort, the MBTA, and now as the Suffolk District Attorney, where the law became her passion.

However, when it came to leadership - another characteristic she said has been critical as the newly-elected DA in an office that has had the same leader for almost two decades - it was what happened after the teams were re-instated that taught her the most.

She said when the team was finally brought back, she was the only player left with any real experience. Most of the players and coaches had been plucked from other sports like track and volleyball. The elite athlete soon found herself the

selves.

Yet, she said it was the most important time of her life, leading a team that likely wasn't going to win, but could still accomplish some goals in the meantime.

"It was one of the best learning experiences I ever had," she said. "You show up with a smile on your face and give 100 percent even when things aren't going well. It taught me character...Anyone can be present when things are going great, but where are you when things get hard? Do you still show up? I like to say it costs very little to pay someone a compliment or be respectful. Yet so few do it."

That kind of optimism for a competitive person in the midst of a losing season was life changing.

'What's beautiful is to learn not to be discouraged and to be optimistic," she said. "Those are actually the years I broke records because the numbers of goals I scored. There are still records out there 26 or 27 years later that I set and I'm proud to say I still

Certainly, the end of her athletic career did not mean an end to those valuable lessons. In fact, she said, it has been sports that taught her about justice and leadership.

"We are breaking down barriers," she said. "When you see a woman in leadership roles, it happens quite often that in the past that woman had some athletic ability or played some sport. It teaches us about inclusion or teamwork or perseverance. Sports doesn't care about how much money you have or where you live, it's about how well you perform on the field. It's a great leveler. It's been invaluable for me."

And in the office, she is adjusting to being that new person who is also the leader of the office. That, she said, takes the kind of skills she honed on the athletic fields some years ago.

"I'm the new person to the team here in the DA's office and I'm also their leader," she said. "Change is difficult. What I try to do is show up, captain of a team that couldn't know the great work they do

purposeful as I can."

Nowadays, Rollins doesn't spend much time on the playing field, but still enjoys watching her daughter run track, where she has won national championships in the 100m and 200m races. Such things are encouraging, she said, to see girls and young women have so many opportunities that were hard-fought by the generation ahead of them – a generation such as the women athletes like Rollins who used the legal system to challenge decision makers.

"It's really exciting to see young women are getting the same opportunities men have had a long time," she said. "Being excited for my young girls playing sports doesn't take away from my excitement for young men playing sports. We want everyone to have the opportunity for success, on and off the field."

DA Rollins indicates her office will be more present at crime scenes

Suffolk County District Attorney Rachael Rollins said one change she has made immediately to the office is making sure at major crime scenes, she and members of her office are on scene.

That includes homicides and other such crimes.

Whether in Boston, Chelsea, Revere or Winthrop, she said it is important to be present at the scene, even if it's the middle of the night.

She said she has instructed everyone to call her no matter what time, and not to wait for the morning to brief her on major crimes.

"For me, it's important to kind of be proximate and present when things happen so people know we not only handle the case, but also we had boots on the ground from the beginning. A lot of the work we do is behind the scenes and people don't see it...So, it's important they see us and we experience what they are dealing with because it really makes us have insight into the work we do every single day."

She said that, particularly at homicides, she and her office would make every effort to be on scene throughout the county.

Getting Out

Caroline, or Change

Thirteen years ago, in early May, SpeakEasy Stage Company, helmed by incomparable Artistic Director-Director Paul Daigneault, presented the New England premiere of Tony Kushner's hit musical, "Caroline, or Change," in association with North Shore Music Theatre,

At the time, I heralded Kushner's two-act, 2-1/2 hour musical as "a bag full of great things. It's rife with symbolism, play on words, personification, Tony Kushner's clever lyrics, Jeanine Tesori's memorable music ... a clever, four-level set design, and talented cast.'

Fast forward to now, at the same location, Stanford Calderwood Pavilion at the Boston Center for the Arts. 527 Tremont St., Boston. This time, Kushner's loosely autobiographical play is presented by Moonbox Productions, boasting an ardent, talented cast of Boston headliners, per-

forming on Janie E. Howland's striking, layered set.

Moonbox Director Allison Olivia Choat and Company provide their own uplifting, lilting nuances, punctuating and separating people embracing modernity vs. those resistant to broadening new horizons. Set in 1963, Kushner's tale highlights JFK's assassination, Martin Luther King's peace marches, civil rights changes, and bylaws that segregated white and black bus riders.

Seated on an upper left-hand level, hidden from theatergoers, pianist conductor Dan Rodriguez and his eight musicians provide fine accompaniment to Tesori's lexicon of rhythm and blues, gospel, Judaic traditional, Motown, Zydeco, and more.

Portraying lead character Caroline Thibodeaux, Yewande Odetoyinbo is dramatically dynamic as conflicted 39-year-old housemaid-divorced, formerly abused mother of four, who does laundry in the basement o the Gellman family, while listening to the radio. At times, the washing machine personifies into a bubbles-bedecked and/or lunar, glittery figure (Pier Lamia Porter), whose operatic voice soars in her personified portrayals of the washing machine and the

The dryer, personified by versatile star Davron S, Monroe, unleashes his voice too, resembling religious chanting at times. He's a hovering, "smooth-singing devil " in disguise, garbed in pure white garb. Early in Act I, Monroe, encased in a metal frame with bright headlights, doubles as a public bus.

Enlivening the 1960s, harmonic trio Maria Hendricks, Aliyah Harris and Lovely Hoffman portray Radio Voices 1,2,and 3.

Odetoyinbo dramatically and musically captures Caroline's weariness, discontent and bitterness in her hometown of Lake Charles, La., where she feels stuck. "Nothing ever happens [here]," she intones.

But she's wrong. Change pervades the country - the worldeven Lake Charles in 1963, as black power gains clout, with promises of a better future. However, America's idyllic Camelot is shattered when President John F. Kennedy is assassinated.

For 21 years, Caroline, who's uneducated, worked as a housemaid. She's employed by the Gellmans, a Jewish family, composed of 8-year-old Noah, his clarinetist father, and his well-meaning, New York-raised stepmother, Rose Stopnick Gellman (Sarah Kornfeld), whose acts of kindness Noah (amazing Ben Choi-Harris) rebuffs. Noah grieves for his mother, a heavy smoker who succumbed to lung cancer. Noah longs to be part of Caroline's family, despite their poverty. They're happy, he sings.

Surprisingly, Caroline sneaks cigarettes in the basement and allows Noah to light them -but

Ben Choi-Harris appears delicate, but his professionalism, especially interacting with this phenomenal cast, and ability to blend in tri-part harmony, belies his youth.

Embittered Caroline, a devout churchgoer, resents Noah's dad, who doesn't believe in God, claiming he scientific. She resents her best friend, Dotty Moffett (Lyndsey Allyn Cox), too, who avoids attending church, but eagerly embraces new trends

Caroline's eldest child, Em-

mie, does, too, frequently clashing with Caroline. Kira Troiio delights theatergoers with her vouthful demeanor, playing with her two adorable younger siblings, Jackie (Mark Johnson) and Jo (Razan Mohamed). She's also a banner-waver for change.

Troilo's lovely voice and dramatic fervor beautifully outline Emmie's dreams of someday owning her own home, car, and elevating her lifestyle.

In an uplifting second act scene, the Gellmans- Noah, Rose, Noah's clarinetist dad Stuart (Robert Orzalli), Stuart's parents (Ellen Peterson and Kevin C. Groppe), and Rose's dad, Mr. Stopnick (Phil Thompson) joyously celebrate Chanukah, while, on a split stage, Caroline and family's kitchen and serving chores draw a sharp contrast.

An incident between Noah and Caroline drives her to her breaking point. She storms out of the house, refusing to return.

As their door closes, another opens for Rose and Noah- and us appreciative theatergoers.

Becoming Dr. Ruth

At New Repertory Theater, Jeffrey Petersen's cluttered set of Dr. Ruth Westheimer's apartment has stacks of carton boxes she's filling, preparing to move elsewhere the following day. The indomitable nonagenarian is an adroit multi-tasker, too, answering one phone call after another, Born Karola Ruth Siegel of Frankfort, Germany, the renowned psychologist of human sexuality pioneer and globally-revered sex therapist busily wraps and stacks books and framed photos, while answering her frequently-ringing telephone. She suddenly becomes aware of her visiting guests - us.

Prolific award-winning writer St. Germain met Dr. Ruth in 2013 and convinced her to let him write this play. He said reliving her experience as an orphan of the Holocaust, having lost her family, "deals a blow to anyone who denies the Holocaust ever happened." Basing it partially on her 1988 autobiography, "All in a Lifetime," St. Germain adopted the contemporary, popular structure of the one-person, one-act play, in which the character welcomes us visitors while performing mundane tasks and taking phone calls. O' Sullivan occasionally makes direct eyeor conversational contact with

individuals, too.

She switches back and forth through the years, her colorful biographical narrative enhanced by Jonathan Carr's enlarged images of historic, familial, and milestone color and black-andwhite snapshots and videos as she encases picture frames in bubble wrap, then stacks them in cartons. Her lilting, sometimes raspy, voice elevates with excitement, her joie de vivre is infectious.

Besides acknowledging us, she directly addresses individual theatergoers.

"All of my life, I've gone to the theater; now the theater has come to me," she jokes.

Directed by award-winning, New York-based Stephen Nachamie, Anne O'Sullivan portrays the four-foot-seven inch, effervescent, energetic, and spritely 90-year-old, brilliantly, capturing Dr. Ruth Westheimer's spontaneity, rapier wit, and abundant love of life. Despite

O'Sullivan's dynamic portrayal, the play drags at times.

Her boundless energy and running narrative astounds us as she traces her life - how she escaped the Holocaust when her parents moved her to a Swiss school, but her entire family perished. She immigrated to Israel, joined the underground Haganah, and trained as a sniper. She was married a few times, lived in France, rejoiced in the birth of her son and daughter, came here and earned advance degrees and recognition in America.

Regardless of her circumstances, Dr. Ruth tackled controversy, broke barriers, faced life-threatening danger, trained as a sniper in Israel, and faced other head-on obstacles.

She became a call-in radio host, TV personality, writer, and expert, handling deeply personal, intimate questions about sexuality, that was formerly taboo, and more.





The 4 x 800 relay quartet who earned third-place ribbons consisted of Brian Perez, Lucas Hurtado, Carlos Quintanilla, and Eiad Karageh.

"Usually this meet is a fun meet for our young kids to only compete against their peers and I take a relaxed approach to it," said Ros. "This year, I knew going into the meet that our chances of finishing in the top three as a team was a real possibility and that Peabody would be the biggest threat to how well we might do.

"We started the meet well with a second-place finish in the javelin with Ryan Doucette," Ros said. "Based on season PRs, Ryan was the top seed in that event. Finishing second isn't a disappointment at all. If anything by his performance, it showed that he is getting more consistent. As the meet progressed, the boys were doing well. We didn't think winning was possible until we had a stretch of six events in which we won every doubles, Oufessa and sophosingle one. It started with the more Xiomara Romani Rojas 4x100 relay, then the 100mh, 400m, 800m, 200m, and 4x400 relay.

"They made an annoucement for the scoring update right before the 4x800 started that didn't factor the 4x400 relay," Ros said. "At that point we were up by eight points which put us in the driver's seat for the win. We knew that Peabody needed to win the 4x800 to give them a shot to beat us. With that knowledge, we let our 4x800 team know that we didn't need anything special out of them. All they had to do was finish close to Peabody. They did even better. For 65 percent of the race, it was back and forth with us and Peabody in the second/ third place behind the eventual winner, Gloucester.

"Danvers passed us at one point, but we were concentrating on Peabody," Ros continued. "Our third leg, Carlos Quintanilla, fell behind Peabody by about 20 yards on his first lap, but Carlos regained control in the second lap. From then on, we never looked back. Eiad Karageh took the baton with us ahead of Peabody and we eventually beat them by almost 30 seconds to secure the win.

"This is very exciting for us and the conference," Ros added. "Peabody has had a stranglehold on this meet ever since they've came into the NEC over 10 years ago. For us or any other team to beat them is an achievement. I have tremendous respect for the Peabody coaching staff and their team, but getting the win meant a lot. This is the first big championship win by any Revere track team in too long to remember. As long as I have been a member of our coaching staff, I don't remember us winning this big at all. We have hard-working boys

and coaches on this team and this result is a testament to that work."







NEWS FROM AROUND THE REGION

SUPERINTENDENT FINALISTS AT COMMUNITY FORUMS

CHELSEA - The three finalists for the position of superintendent of schools have been on whirlwind tours of the district last week, concluding the day with a community forum at the Williams School.

On Monday, Weston High Principal Anthony Parker visited Chelsea and spoke with teachers/staff, business leaders and at a community forum in the evening. On Tuesday, Ligia Noriega-Murphy, currently the assistant superintendent of secondary schools in Boston Public Schools, went through the same agenda. Finally, today (May 2), Almudena Abeyta, currently the assistant superintendent of Curriculum, Instruction and Assessment for the Somerville Public Schools, will visit the city and have a forum at 4:30 p.m.

School Committeewoman Jeannette Velez said the School Committee would start with separate rounds of public interviews with the candidates. They would follow the same order as this week.

All interviews are open to the public. Interviews will be held at City Hall Council Chambers in the evening.

The goal of the Committee is to have a vote on May 9 – after the final interview – to decide who to pick and negotiate a contract with. If all goes well, that person would likely begin on July 1.

At Monday's community forum, Parker said he was very interested in Chelsea because it was a challenge and a place to learn. Though he has spent most of his career in suburban schools like Newton and Weston, he said he feels like he could be very successful in Chelsea.

"I like what I read about Chelsea and I like the emphasis on building bridges and the pathways," he said. "I like the diversity of it...It was different enough for me to be interesting. I think any district is a challenge. It's the opportunity to build on what is here. What you have is Chelsea is you have a great district that wants to be excellent in many ways. I believe I can help you do that."

He also said he hasn't applied to any other districts, only Chelsea.

"This is where I want to be," he said.

The forum was sparsely attended, and likely because it wasn't well publicized ahead of the beginning of the forums by the Collins Center – which is running the superintendent search process.

However, numerous students from the Chelsea Collaborative and organizers from the Collaborative did show up with many questions.

The conversation went from opinions on expulsion to outside opportunities to gun violence.

At that, Parker said his students – like Chelsea last year – organized a walkout for school safety.

He said he believes in supporting student voices – something that has grown to be very important to students at the high school over the last year. Students at Chelsea High have successfully organized the walk-out, and also successfully advocated to move graduation back outside on the new turf field.

"I walked out with them," he said. "We knew it was happening and supported it. It was a genuinely student-led effort. We need to support that even if we disagree with that they want to do. I think if a district didn't support students on that particular situation, I think they missed out."

When it came to challenges between suburban Weston and urban Chelsea, Parker said he would likely have a learning period with getting community and parent participation – which often lacks in Chelsea but is strong in Weston.

"If our parents cannot make meetings or conferences because they are working multiple jobs or are too busy, then we need to go to them," he said. "I would spend time finding out where they are and where I need to go to engage them."

The process with the School Committee next week on Monday, Tuesday, and Thursday is open to the public

MBTA AWARDS CONTRACT FOR RAIL STATION

CHELSEA - The MBTA's Fiscal and Management Control Board approved a \$32.3 million contract that will result in the relocation and construction of a new, fully accessible Chelsea Commuter Rail Station.

When complete, the new Chelsea Station will be an intermodal facility that connects the Newburyport/Rockport Commuter Rail Lines to the Silver Line 3-Chelsea service, which began operating in April 2018.

"This is a key investment in our Commuter Rail infrastructure that will allow for faster boarding and improved accessibility for people of all abilities," said MBTA General Manager Steve Poftak. "Once complete, the new station will serve as a multimodal connection that will give our customers the choice of traveling to North Station on the Commuter Rail or South Station on SL3 from a single point."

Featuring high-level platforms, canopies, benches, and windscreens, the brand new station will also include new sidewalks, landscaping, stairways, lighting, communications systems, and structures for maintenance and bus operations personnel. The project also includes the demolition of the existing Chelsea Station, upgrades to railroad signal systems, and new traffic 'SEUSSICAL'

signal system installations at local intersections.

The project to construct and relocate Chelsea Station aims to relieve traffic congestion and overcrowding on existing area bus routes in Chelsea while also providing better transit options to environmental justice populations through improved accessibility to employment opportunities in downtown Boston and the Seaport district.

The project also includes the installation of transit signal priority improvements for the SL3-Chelsea along with improved operational efficiency and the incorporation of green operations elements at the new Chelsea Station. Greenhouse gas emissions will also be reduced by increasing the transit mode share and decreasing the idle time of commuter rail and BRT vehicles.

The Chelsea Commuter Rail Station Project was advertised in February 2019 with bids open in April 2019. After six bids were received, the Chelsea Commuter Rail Station contract was awarded to A.A. Will Corporation for \$32,367,200.

Construction could start as early as this summer, with project completion estimated for late 2021.

FORMER SUPERINTENDENT PLEADS NOT GUILTY TO SEVEN COUNTS

EVERETT - Former Supt. Fred Forestiere pleaded not guilty to seven counts of assault on teachers in the Everett Public Schools in Malden District Court on Friday, April 26.

With his attorney, Gerard Malone, and an entourage that included his wife, Dorothy, and several community members at his side, Foresteire stepped up from the au-

dience to the microphone Friday morning to say he was not guilty of the charges leveled against him, which include six counts of indecent assault and battery and one count of assault and battery. The charges were brought earlier this year, and Foresteire was only just now arraigned on those charges – which followed a lengthy Everett Police investigation.

Among the charges described at the arraignment were "mouth on breast," "hand on buttocks," and "pulling clothes down to expose the body." There are three victims making the allegations.

Judge Benjamin Barnes presided over the arraignment session and let Foresteire, 76, go on his own personal recognizance – meaning no bail was imposed. He was ordered not to have any contact with victims or witnesses, and not

or school events.

Attorney Malone told the Independent they had no additional comment for the moment on the charges, and courthouse silently while swarmed by television reporters from Boston.

He did not speak at the arraignment either.

Attorney Malone did ask for permission for himself, and his investigator, to get entry into the School Administration Building so that they could see where the allegations were made.

While the prosecution objected on principle, Judge Barnes allowed them access with 48-hours notice.

All of the information regarding the charges was impounded from the public by Judge Barnes, a move to protect the alleged victims from public disclosure.

A Pre-Trial hearing was established for Aug. 8, which would be Foresteire's next official court date.

Attorney Tara Swartz, who represents some of the victims, said she didn't have a comment after the arraignment.

Attorney Mark Rotondo, who also represents some of the victims, said he believed it was time for a complete overhaul of the Everett Public Schools' administration as a result of the charges brought against Foresteire. Rotondo is also an Everett native and a former School Committee-

"The allegations speak for themselves, and a jury will dictate Foresteire's guilt or innocence," he said. "What needs to be done is there needs to be a serious indictment of the Everett Public Schools including the current administration, which has perpetuated the code of silence for more than 30 years. The members of the School Committee should give serious consideration in determining whether or not current administrators should

the conclusion of their investigation of the alleged wrongdoing of the administrative staff. As a former member of the Everett School Commit-Foresteire walked out of the tee, the fiduciary duty is one of the duties held in highest regard. They owe it to the taxpayers, students, parents and teachers in the district."

SEVERAL GANG MEMBERS ARRESTED

EVERETT - Federal agents descended upon Everett, Malden and other locales April 25 to arrest 14 members of a violent Brazilian street gang with one member being apprehended in the garage of Councilor Wayne Matewsky.

Members and associates of Primeiro Comando da Massachusetts (PCM) - most of whom were in the country illegally - were charged April 25 in federal court in Boston in connection with perpetrating violent crimes in Massachusetts, including drug and firearms trafficking, robberies and kidnappings.

Three members were apprehended in Everett, including one on Lewis Street, another on Vernal Street and a third on Hancock Street. "Violent gangs that prolif-

erate violence are a scourge on our communities," said United States Attorney Andrew E. Lelling. "Over recent months, members and associates of Primeiro Comando da Massachusetts have been committing serious, violent crimes: brazenly robbing community businesses, dealing drugs, trafficking illegal firearms, and even kidnapping a young woman. We will not standby and allow these criminals to disrupt the safety and peace of our communities. Let today's arrests and charges be a message to gang members and their associates: if you threaten the safety and well-being of Massachusetts residents, we will arrest and prosecute you using all of the federal resources at our disposal."

On Thursday morning, federal agents and State Police swarmed the City, particularly on Lewis Street at the home of Councilor Matewsky. Officers located Joao Pedro Marques Guimares Gama, a/k/a "Bahianinho," 21, in Matewsky's garage, and took him into custody.

Police said it appeared he had been living there for about a week.

Matewsky said he had no idea that the man was in his garage, and that he had hired him to do some work in the yard – as he is transforming his backyard from hardscape to grass.

"I had met him and he told me he was a landscaper and I was going to have him plant some grass in the backyard," he said. "I had no idea he was in there. I've installed a lock on my garage and better lighting in the backyard. I'd like to thank the police for getting rid of the guy from my garage."

Gama, who is in the country illegally, was charged with RICO conspiracy, conspiracy to commit robbery, engaging in the business of dealing in firearms without a license, and being an alien in possession of a firearm.

The following defendants, in addition to Gama, were charged.

•Alvaro Dos Santos Melo, 22, a Brazilian national illegally residing in Everett, was arrested and charged with RICO conspiracy, conspiracy to commit robbery, and conspiracy to distribute controlled substances. He was taken into custody on Vernal Street;

•Marcio Costa, a/k/a "Marcino" and "Marcinn," 28, of Malden, is the alleged leader of PCM and was arrested and charged with RICO conspiracy, conspiracy to commit robbery, conspiracy to distribute controlled substances, and engaging in the business of dealing in firearms without a license.


