Plans are in the works for a new Point of Pines Fire Station

The process that will result in a brand-new Point of Pines Fire Station on the site of the old station located at 140 Lynnway is well underway.

During his remarks to the City Council about "the long-awaited feasibility study" for the station, Mayor Brian Arrigo said that Winter

did the feasibility study) has recommended that the old fire station be demolished and a new fire station be constructed - rather than a rehabilitation project for the current structure.

"I cannot stress enough how important that this is for not only for the Point of Pines, but for the eastern part of our

Street Architects (the firm that city in providing great service and public safety to our community," said Arrigo. "I want to thank Chief [Chris] Bright and Deputy Chief [Paul] Cheever for the great work they've done in pushing this forward and making this a reality."

Bright endorsed the construction of a new station.

"I'm very pleased to be before you with the results of the study," said Bright. "I've been very anxious to see this. As fire chief the past three years, I've really seen first-hand the need for this facility. We've

had some storm surges down along Revere Beach, the Atlantic Ocean just coming in – Mills Avenue, Pearl Avenue, Beachmont. These storms are happening all the time now."

There are now only two weekends left of live horse racing at Suffolk Downs on June 8 and 9 and June 29 and 30 before the track shifts to simulcasting.

For horse racing enthusiasts, simulcasting will be offered through next year at the Clubhouse.


"We are looking forward to staying in the building for year-round simulcasting and perhaps sports betting in the near future should the legislature authorize that. We believe that's a real opportu-

nity for us and our workforce either as a component of the HYM development or at the Wonderland property (site of the former Wonderland Dog Racetrack) that is still owned by our operating company," said Chip Tuttle, Chief Operating Officer at Sterling Suffolk Racecourse.

"Suffolk Downs ownership has extended their lease to have simulcast to the end of this year and possibly into next year," said Doug Manz, partner and director of development of The HYM Invest-







Councillor Rizzo seeks traffic officers for busy North Shore Road intersection

The City Council approved a motion by Councillor-at-Large Dan Rizzo that Mayor Brian Arrigo instruct the chief of police to assign officers at the intersection of North Shore Road and Revere Street during peak hours of traffic.

Rizzo said he has personally experienced the traffic

Route 1A.

"Over the weekend coming down 1A, the traffic was backed up to the Wharf Restaurant," he said. "We should be utilizing traffic enforcement pulling traffic at peak hours. Get some police officers out there whether it's in conjunction with the State Police or the Revere Police Department.

'We need to have more

backups on Revere Street and than just the lighting doing a regular cycle," said Rizzo. "We need to utilize manpower to pull that traffic because people are getting extremely frustrated waiting.'

Rizzo said there are problems with heavy, vehicular traffic across the city.

"The city right now is in gridlock," said the councillor. "This city is in gridlock almost all day long with the exception of a few hours in the middle of the day."

Ward 5 Councillor John Powers said he has be in touch with MassDOT officials about the traffic situation.

"The explanation that I received is that they are going to put in some wooden poles that they can put the lights on - they would expect to have the lights on early next week," said Powers.

Eric Lampedecchio of Taft Avenue thanked Councillor Rizzo for presenting his mo-

"It's an absolutely safety hazard on North Shore Road," said Lampedecchio. "A lot of people are disregarding the cones and taking that left in to the oncoming two lanes of traffic. It's only a matter of time until somebody gets hurt. MassDOT has been extremely slow to respond to this. It's been over five weeks since residents could take a left on

to Mills Avenue."

"I'm tired of hearing that traffic is a regional issue and there's nothing we can do about it," said Lampedecchio. "I think manually adjusting the traffic lights during peak hours is a great idea. We see on Route 1A northbound in East Boston a police officer controlling the lights in Orient Heights. I'd like to see something like that on Revere Street."

DCR TRAFFIC ADVISORY: REVERE BEACH BOULEVARD IN REVERE

THE 'T' TOWER COMES DOWN AT BEACHMONT



This past weekend the MBTA removed an icon of the T in Beachmont. The 25-foot high glass-block and steel tower had structural issues. "The removal of the tower had nothing to with a development at Suffolk Downs," Joe Pesaturo, executive director of the MBTA. "The tower was removed over the weekend because it was past its useful life. After an assessment earlier this spring of the tower's structural integrity, a decision was made to remove the tower, and therefore eliminate any potential safety issues. The tower existed for aesthetic reasons only and served no function in the delivery of transit services." The MBTA has no plans at this time to replace the structure.

would require a two-thirds bond-authorization vote of the City Council.

The clubhouse life is extended because it is not part of Phase 1 and the developers are considering a possible interim use of the building.

"We also want to think of the employees who have jobs there, and support the local community," Manz said. "The simulcast won't interfere with our project."

The HYM Investment Group purchased the 161-acre property, split between East Boston and Revere in May 2017 for \$155 million. Plans call residential, retail and commercial property.

The Suffolk Downs Redevelopment received its special permit from the city of Revere in December 2018. The Revere portion of the development will be 50 percent commercial and 50 percent residential development.

Phase 1 includes demolition of the horse barn area with 30 horse barns, stables and associated equipment on the property. There is also a drainage system and utilities associated with the barns that will be cut and capped in place.

Phase 1, the Beachmont area of the property will have a hotel, an innovation center and the beginning of the residential units.

"Our goal is that they all open at the same time in summer of 2022," Manz said.

Suffolk Downs was built by Joseph A. Tomasello for a cost of \$2 million in 1935 by 3,000 workers in just 62 days when Massachusetts authorized pari-mutuel wagering. The historic track has been a showcase for some of the most famous names in Thoroughbred racing history, including Seabiscuit, Whirlaway, John Henry, Cigar and Skip Away.

Revere resident can join race enthusiasts for live racing, food trucks and family fun activities on Saturday and Sunday, June 8-9 and June 29-30.

"Demolition of the barn area should begin after Labor Day," Manz said. "The Clubhouse and the grandstand are probably a few years out."

Construction is expected to begin in summer 2020.

"We've engaged architects for the first phase, so we are in design," Manz said.

Julia Tran named Revere High School Class of 2019 Valedictorian

This evening at Harry Della Russo Stadium Revere High School senior Julia Tran will take the stage and deliver her Valedictorian address.

Tran, an honors student and AP scholar with distinction, will graduate with 465 of her fellow classmates and, after her summer break, head off to the prestigious Ivy League School, Dartmouth College in New Hampshire.

Tran, who grew up in Revere, is the daughter of Vietnamese immigrants that moved to the U.S. before Tran was born.

"Honestly, it's a little overwhelming but at the same time I've never been one to focus

everything on academics,"

said Tran. "I'm no way the smartest or worked the hardest. Being the valedictorian was never my highest priority nor was getting super high grades. Through my whole high school and school career all I wanted to is try and find a passion and meaning. I still haven't found that yet."

While she may not have found her exact path to the future Tran said she is excited about attending Dartmouth in the fall.

"That's exciting, right?" she asks. "It's going to be cold though so if anyone wants to send me blankets I'll send you my PO address in New Hampshire."

Throughout her high school career at RHS Tran has compiled an impressive resume.

She was a National Spanish Honor Society Plata Award winner, a Questbridge College Prep Scholar, Questbridge College National College Math Scholarship recipient, recipient of the Massachusetts Superintendent Award and a Ugo Evangelista Medal winner for excellence in math.

Tran said she's leaning towards majoring in English and Literature once she gets up to Dartmouth but like most students her age she's just glad to not have to get up in the morning for high school.

"I'm happy I won't have to get up at 6 a.m. to go to school and sit through 80 minute class periods," she jokes. "The one thing I think I've been craving is freedom and that has influenced a lot of

my decisions and choices in high school like what classes I would take and clubs I'd join because it's hard to find that in high school. I'm excited for more freedom in college. Most important part of any place is the people and I really do like the people here at RHS so I will miss all the people here."

Tran lives at home with her mom, dad, grandmother and older sister and they are all excited she's off to college-even if they're not sure about the school's prestige.

"When I told my parents where I was going they had no idea what Dartmouth was," she laughs. "But I told them I had mostly a full ride so they were content."

In the meantime Tran said

she's going to use her summer break to try and learn something new everyday before heading off to college.

"I'm going to work but I really want to create something new, start a new hobby, learn another language," she said. "I want to learn something new every day--it doesn't matter what--I just want to learn it like building a chair or making guacamole or learning how to roller skate."

As for her fellow classmates Tran said a lot have gotten into really great schools and are going to do big things in life.

"You're going to be reading in like 20 years about former students of this class and the things they accomplished," she said.

Mayor Thomas Ambrosino has submitted a budget of \$128.417 million, an increase of 1.3% over last year's budget, which is the smallest percentage increase in many years. By contrast, the city's budget increased by 8.3% in 2006, 7.% in 2007, and 4.6% in 2008. 



CONGRATULATIONS TO THE CLASS OF 2019

Graduation Day is one of the few occasions that brings a smile to the faces of everyone in a community, regardless of whether they know a graduate. It is an occasion when all of us share in the joy -- and pride -- that graduation day marks in the lives of our young people. For older folks, graduation day recalls a time when we too, were young and full of life.

However, graduation day marks a bittersweet moment for parents, friends, family, and teachers, as well the grads themselves. As befits every turning point in our lives, it is a time of mixed emotions of joy, sadness, and reflection. Although the graduates and those close to them are looking forward to the exciting future that lies before them, they also will be looking back on the passing of their carefree youth and the experiences that have shaped their lives to this point.

The young women and men who receive their diplomas no longer are considered "youths" in the eyes of the world. They are full-fledged adults who have been deemed ready to assume all of the rights -- and responsibilities -- that adulthood implies.

The graduates, most of whom have turned 18, can vote, run for public office, enter into contracts, be tried fully as adults in the criminal justice system, and fight and die for their country.

For the parents of the grads, watching their "little boy or girl" proceed to the podium to receive his or her diploma will be a poignant moment. No doubt every parent will be thinking of the sentiments expressed in the song Sunrise, Sunset from Fiddler *On The Roof:*

Is this the little girl I carried? Is this the little boy at play? I don't remember growing older When - did - they? When did she get to be a beauty? When did he grow to be so tall? Wasn't it yesterday when they - were - small?

Although economists these days tell us that the value of a high school diploma is not what it was a generation or more ago, the graduates should keep in mind, as they contemplate venturing out into an uncertain future, that their mere presence on the podium has proven that they have the ability and the determination to achieve whatever goals they may set for themselves.

We came across a news item from one of our sister publications, The Winthrop Sun-Transcript, from June 24, 1898. The article, which reprinted the Class Ode for the Winthrop High Class of 1898, is as timely today as it was 121 years ago, and sums up the feelings of all of us on Graduation Day.

The years pass by in swift array We cannot check their onward flight; The moments that were ours today, Have passed forever from our sight.

Yet while the course of life moves by We too, must never lag behind; But work and strive as best we may To aid and benefit all mankind.

This we must do, or soon too late We think in sadness of our loss, For "Each is Master of his Fate, Though some must bear a heavy cross.



A Green New Deal of Action

By Jack Clarke

Massachusetts needs its own Green New Deal – but it needs to be a deal of action.

Although not a law but more a resolution expressing the will of the Congress on the necessity to address the climate crisis and economic inequality, the Green New Deal, filed by New York Congresswoman Alexandria Ocasio-Cortez and our own Sen. Ed Markey, was killed by the Senate in a vote following no review and analysis by legislative staff, no expert testimony or committee hearings, and no floor debate. The message was clear: the U.S. Senate does not want to discuss the climate's breakdown. So we at the state level will.

The name harkens back to the New Deal and its social and economic reforms, and public works projects, undertaken by President Franklin Roosevelt in response to the Great Depression.

The Green New Deal echoes Roosevelt's economic stimuli incentives and adds plans for renewable energy

and resource efficiency. FDR's New Deal was not realized in one bill in one year, but became law through various pieces of legislation over the first three years of his first administration. Beacon Hill lawmakers should also develop an ambitious multi-year

plan to meaningfully confront permits for the fuels they sell. climate change, the most urgent threat of our lifetime, in their version of a Green New Deal – but it needs to be more lic transit, electric vehicles, than a good idea. And it needs to pass.

Although the national Green New Deal is admittedly a vision statement, the Massachusetts version should be a statutory set of requirements with goals, targets, and reasonable dates that move us forward in addressing the climate breakdown.

Our version should start with and include at a minimum, laws establishing:

§ Zero net carbon emissions, meaning Massachusetts emits only the carbon emissions that it can capture or reabsorb - by 2050.

§ An annual increase in the amount of clean energy that utilities are required to buy, leading to 100 percent renewables - by 2047.

§ Environmentally responsible development of 6,000 megawatts of offshore wind energy, and quickly scaling up from there. This is well beyond the 1,600 MW required now - by 2027.

§ A carbon fee: Massachusetts and eight other states, along with the District of Columbia, are presently participating in the Transportation Carbon Initiative that would cap regional transportation emissions and require fuel wholesalers to buy pollution Revenues from the sale of the permits would then go back to states for investments in pubbike lanes, and other initiatives to reduce carbon emissions in the transportation sector – by 2021. And if the regional approach fails, Massachusetts needs to be ready to go out on our own and pass a statewide carbon fee.

§ Improved solar options: allow net metering not just for Massachusetts homes but for all non-residential solar facilities to free up Bay State businesses and communities to build more solar projects, create more jobs, and allow for millions of dollars of investments – by 2021.

§ Create green jobs: Mobilize the academic and research assets of the Commonwealth to more fully contribute to the innovation economy and create more green jobs. This will require increased investments of private and state funds in Massachusetts' 114 colleges and universities to research and apply advanced technologies in the fields of deep-water offshore wind energy, solar, carbon capture and re-use, and long-term high-quantity battery storage. This investment in education and innovation would unleash clean energy jobs. Although there are 110,700 such jobs in the Commonwealth workforce today, it's still just 3 percent of

Massachusetts employment. It needs to grow substantially by 2021.

§ Environmental, social and economic justice principles should be embedded in all newly passed state laws whereby the power of communities of color, low-income, rural, indigenous, under-represented and non-English speaking residents in Massachusetts would be harnessed to help eradicate environmental racism and classism, to create healthy, and sustainable communities – by 2019.

The changes we experience today, such as stronger storms, accelerated sea-level rise, and intense heat are just the beginning of what should be expected.

There needs to be a sense of urgency on Beacon Hill when it comes to our climate emergency, especially as recent reports from the Intergovernmental Panel on Climate Change and the National Climate Assessment warn we have only 12 years to figure out a solution before things really start to fall apart.

For my grandchildren, six year old Haley and her five year old brother Jack, who will be teenagers in twelve years, it is time for lawmakers to act, and to act now.


The Winthrop Marketplace turns 20

"Being a nurse and a para-





Pope John XXIII High School will close its doors on Thursday

When the 200 students walk out of Pope John XXIII High School for their final day of classes on Thursday (June 6), it will mark the final chapter in the 53-year history of the Catholic institution.

Ninety-two seniors had received their diplomas in the school's graduation ceremony on May 23. There will be a Mass Thursday at 5 p.m. followed by a farewell reception in the school cafeteria for students, faculty, parents, and alumni.

As previously outlined in a letter to Pope John parents from Head of School Carl DiMaiti, the school is closing due to "the unfortunate circumstances" that led to a \$1.3 million shortfall in the school budget for the 2018-19 academic year.

The deficit was caused by International Residence Management (IRM) "failing

to meet the obligations of its agreements with the school."

Principal Thomas Mahoney was a member of the first Pope John graduating class in 1970. He is a shining example of the many area students who chose Pope John for its outstanding Catholic education, its reputation for sending its graduates to the top colleges, and its athletic tradition that flourished under some superb leaders such as former football coach Bill Perkins and current coaches Paul Sobolewski, Leo Boucher, and Jake Feraco.

Father George Butera says his final Mass at St. Anthony's Church

Father George Butera bid a heartfelt farewell to hundreds of parishioners and invited guests at St. Anthony's Church as he celebrated his final Mass before retiring after nearly 51 years as an Archdiocesan Priest Saturday at St. Anthony's Church.



Despite the stubbornly chilly start to spring, Ipswich-based company Epoch Preservation recently began work on two projects at Rumney Marsh Burial Ground. The first of the two projects involves the temporary relocation of several gravestones that have been adversely affected by trees, roots, and stumps. After the removal of the trees and stumps, the gravestones will be cleaned and returned to their rightful places.


The second project aims to repair the gravestone of Captain Samuel Sprague, who led the local militia during the Revolutionary War. Sprague's gravestone has

been in two pieces for some time now. Epoch Preservation's Rachel Meyer chalked the damage up to a fallen tree limb, and was pleasantly surprised to find the pieces in such good condition. Meyer described the project as "a straight forward repair" which will "preserve a small part of Revere's history for the next generation."

When the repair is complete, Captain Sprague's gravestone will again be a highlight of any visit to the Burial Ground.

Irish Memorial dedicated on Deer Island

Nearly 1,000 people, many of them with Irish deep in their blood, gathered Saturday, May 25, on a tall hill overlooking Boston Harbor, the same harbor that was host to hundreds of ships, some known as "coffin ships" filled with Irish immigrants fleeing the famine in Ireland from 1845 to 1849.

People from all over came to show their pride and respect for the 850 men, women and children who died on Deer Island during the famine.

"It took my breath away when I first saw it," said Massachusetts Water Resources Authority (MWRA) head

Fred Laskey.

"This project started many years ago and with many good intentions, but to get it over the line I met with a remarkable group of individuals - Mike Carney, Mark Porter, Peter O'Malley, John Flaherty. Mark Porter who literally bulldozed their way through bureaucracy, and received wonderful help from the MWRA to make this event what it is today," Boston's Corporation Counsel Gene O'Flaherty said.

After 25 years of talking about an Irish Memorial at Deer Island, which is part of Boston, it was finally a group of Irish tradesmen who pulled it together to erect a 16-foot

Irish cross overlooking Boston Harbor. Boston Mayor Marty Walsh acknowledged the early efforts of the late William and Rita O'Connell who helped launch a memorial idea decades ago.

Robert Flynn of Pennsylvania was the stonecutter who created the cross. Feeney Brothers of Boston helped erect it and Local 25 also worked on the project. Maureen Keady sang the national anthems of both Ireland and the United States.

Among the speakers were John McColgan, Boston's city archivist, who recounted the history of the famine, including Deer Island where the sick were taken. Boston managed a

quarantine hospital at Deer Island in 1847 and it is well documented in the city's archives.

"An Gorta Mor, Ireland's Great Hunger saw an estimated 1.5 million people die of starvation and disease. Another 2 million immigrated, many perished from the plague that they fled, thousands on ocean journeys and thousands more already on the shores, and thousands in quarantine in places like Deer Island," said McColgan.

Patients were transferred from the Long Wharf to the hospital on Deer Island. Soon, ships with sick started sailing directly for Deer Island.

The first to be buried on Deer Island because of the Great Hunger was a one-yearold girl Mary Connell, according to McColgan.

"If it wasn't for Irish immigrants leaving Ireland, coming to Boston, meeting at the Hibernian Hall I would not be standing here as Mayor of the City of Boston," Mayor Marty Walsh said. "For the Irish from Ireland who are here today, thank you for your contributions to our city and our country."

Walsh noted that President John F. Kennedy spoke of the emerald thread in the tapestry of the Irish past and Deer Island is part of that past. Somehow by erecting the monument the thread is mended.

"It's unbearably sad to imagine the reality of what happened right here and in Boston Harbor," Walsh said. "Those who were lost here deserve a better fate."

Cardinal Sean O'Malley, compared the "orphan ships' in Boston Harbor to "children at the borders of our country, who are fleeing oppression and hunger, and whose parents are making the sacrifice to save their lives and give them a new future."

"We pray that immigrants coming today will receive a welcome from people who have made the difficult journey and are open to being brothers and sisters to those arriving from every part of the globe," he said.

Toward the end of the dedication the Boston Currrah Rowing club placed a wreath in Boston Harbor and two fireboats displayed plumes of





NEWS FROM AROUND THE REGION

COUNCIL APPROVES \$18 MILLION CIP

CHELSEA - With a few adjustments, the City Council approved City Manager's proposed \$18 million Capital Improvement Plan (CIP) budget for Fiscal Year 2020. About \$4.7 million of that proposal comes from the City's free cash reserves.

The Council held a special meeting Tuesday night, May 28, to pass the CIP before the June 1 deadline.

The major changes to Ambrosino's requests included paying for the second phase of the Mary C. Burke School roof project through \$825,000 in free cash rather than the school stabilization fund, and doing away with \$450,000 in the FY20 CIP for an updated Master Plan.

"Even though I am a huge proponent of the Master Plan, I think we should take a step back," said Councillor-At-Large Leo Robinson.

He said the City will be looking at some zoning issues in the near future, and should focus on that before it moves forward with a Master Plan update.

Earlier this year, City Manager Thomas Ambrosino presented the proposed 2020-2024 Capital Improvement Plan to the City Council. That document included 45 projects totaling \$18 million for FY20.

"It is my strong belief that this comprehensive Capital Improvement Plan fully meets our promise to invest the is intended to recognize and (MGC) in the afternoon. s strong reserves in projects that enhance the quality of life in our City," Ambrosino stated in a letter to the City Council.

The program areas addressed in the CIP for FY20 include equipment purchases including furniture, desktop replacements, and vehicles for the library; roadway and sidewalk improvements; improvement and expansion of open spaces, including the Mary C. Burke playground; replacement of police cruisers, radio communication equipment, and a new engine pumper; and nearly \$7 million for infrastructure improvements including utility replacement on Upper Broadway, mitigation of localized flooding and expansion of the City's lead service replacement program.

"This gives our City Manager the leverage to go out and continue to fix our sidewalks and roads and also help with school projects and water projects," said District 8 Councillor Calvin T. Brown. "It's a lot of money, but it needs to be done to improve the quality of life in Chelsea."

District 6 Councillor Giovanni Recupero voted in favor of the CIP, but questioned why the Council vote is necessary, since the City Charter already requires the annual adoption of the CIP.

"The charter is telling you it has to be approved," he said.

SUPT. BOURQUE **HONORED BY SSU**

CHELSEA - Chelsea outgoing Supt. Mary Bourque was honored as one of six 2019 Educator Award recipients in the State House – an award bestowed upon her from Salem State University.

The annual award from the Massachusetts State Universities Council of Presidents celebrate outstanding university educator alumni who work or have worked in a Massachusetts public Pre-K or K-12 school or higher education institutions. One individual is selected each year by each of the nine state universities to highlight the historically strong connection

between the teacher preparation programs and Massachusetts public schools. The state university system educates more than 52,000 students each year and has more than 225,000 alumni.

"I was honored to stand with six other 2019 Educator Award recipients Tuesday at the State House," said Bourque. "Of course it was Salem State College when I attended. I even brought my freshman ID to the event. I was 17 years old. I loved my years at Salem State. I was a commuter, living in Chelsea and working in downtown Boston. My Salem State education opened so many doors for me. I found my passion for teaching and learning at Salem State. I will be forever grateful for the education and the opportunities."

Bourque has been the superintendent of Chelsea Schools for several years, and has spent decades in the Chelsea Public Schools. She will retire this year, and is expected to remain very active in education issue in Chelsea and statewide.

WYNN RESORTS TO **PAY FINES**

EVERETT - Wynn Resorts announced last week it would not appeal its fine, and CEO Matt Maddox said he would not appeal his personal fine either – with both fines being delivered to the Massachusetts Gaming Commission

MGC Spokesperson Elaine Driscoll confirmed that both fine payments had been received by 3:15 p.m. Tuesday.

That fine, however, did not come without a verbal protest from the Board of Directors.

"The Board of Directors disagrees with a number of the Commission's comments and conclusions regarding Matt, and believes they are not supported by the evidence," read a statement sent out Tuesday. "Therefore, we would support his decision to exercise his rights and appeal the fine imposed upon him, and believe he would rightly prevail in his appeal. However, that appeal would delay the final conclusion of this matter, and therefore we appreciate Matt's decision to forego an appeal in order to allow closure for the Company. The Company will pay the fine imposed on him and has today delivered payment of that, and the Company's fine, to the Commission."

The Board did say it would not appeal any of the findings in Massachusetts, and it added that Maddox has created a new paradigm in the company. It defended him by saying that, unlike the MGC report, the Nevada Gaming Control Board praised the actions taken by Maddox since he took

"The Nevada Gaming Control Board, under whose jurisdiction the alleged activities of our founder occurred, conducted its own year-long investigation and recently reaffirmed Matt Maddox's good standing in Nevada, and praised him for creating a 'paradigm shift' and for taking 'corrective actions that [have] been impressive," read the statement. "We believe Matt's leadership has been, and will continue to be, essential in our transformation from a founder-led company to an innovative global corporation."

The statement concluded by indicating Wynn Resorts looks forward to working with the MGC, and is on track to open on June 23.

The MGC, for its part, recently put out a Request for Response (RFR) to procure an independent monitor to over-

eliminate the two-year-old Office of Organizational Assessment in its current City Budget request - a department created by Mayor Carlo DeMaria and headed up by former School Department employee Omar Easy.

The City Budget proposal was submitted this month to the Council, and Review Committee Chair Anthony DiPierro has led one meeting to review it so far, an all-day meeting on May 18. Another meeting was to take place tonight, Mary 29, regarding the School Department and the DPW.

The biggest news so far, however, has been the elimination of Easy's department in a budget that looks to show a fair amount of reorganization.

The Mayor's Office confirmed that they have "zeroed out" the department because it no longer needs to be a fulltime job.

As part of a re-structuring of municipal government in this year's budget, that department is being folded into Human Resources - where director Lara Wehbe will take on Easy's work.

Easy has not yet been before DiPierro's Committee to discuss the change, but is expected in short order.

DiPierro said he wasn't surprised to see the mission of the Office folded into Human Resources.



the effectiveness of City positions and the qualifications of those in every job. Full reports on each department were expected, with recommendations on how to streamline operations and make things more efficient.

Easy made headlines last year with the Wellness Center incident when he appeared before the City Council in a meeting that became quite confrontational. The School Department will once again be asking the City for a large sum of money over and above their minimum funding requirements – that coming mostly due to budget constraints from the state again.

This year the School Department will be asking the City for \$6.5 million above net school spending.

While similar numbers were quite controversial in the last two years, this time it seems like the City is ready to absorb the shortfall while the state leaders continue to argue over the best fix for urban school funding.




