MASSDOT EXIT RENUMBERING WORK TAKING PLACE ON I-93 IN BOSTON

Officials from the Massachusetts Department of Transportation (MassDOT) are announcing that it will begin installing new milepost-based signs at various times and locations on Interstate 93 northbound and southbound between Boston and Methuen. The sign installation operations will take place nightly during overnight hours from 8 p.m. to 5 a.m. the following morning. The work is expected to be completed in approximately four weeks.

The work on Interstate 93, between Boston and Methuen, is expected to follow the schedule below:

- Work between old exit 13 to exit 27 (South-east Expressway between Dorchester and the Tip O'Neill Tunnel) will begin on Sunday, May 2.
- Work between old exit 28 to exit 48 (between Boston/Somerville and Methuen) will begin on Sunday, May 9.

Candidates take out nomination papers for city election

Monday was an exciting day at Revere City Hall and the Revere Election Department as candidates in this year's city election began pulling their nomination papers.

Three incumbent councillors-at-large, Steve Morabito, Gerry Visconti and Anthony Zambuto, pulled their papers, an indicator that they have begun their campaigns for re-election.

Councillor-at-Large Jessica Giannino, who has

been a prolific vote-getter in past councillor-at-large elections, issued a statement Monday that she will not be a candidate for re-election to the Council. Giannino was elected state representative in November, succeeding RoseLee Vincent in the 16th Suffolk District seat. She represents parts of Revere, Chelsea, and Saugus on Beacon Hill. State Rep. Jeffrey Turco represents part of Revere and all of Winthrop in the 19th Suffolk District.

Ward 1 Councillor Joanne McKenna, Ward 2 Councillor Ira Novoselsky, Ward 4 Councillor Patrick Keefe, and Ward 6 Councillor Richard Serino have also pulled papers.

Interestingly, two candidates, Anthony Cogliandro and Michael Roncevich, have pulled nomination papers in the

Arrigo, Board of Health announce mobile vaccine initiative 'Mobile May'

Mayor Brian Arrigo and the Revere Board of Health announced "Mobile May," a campaign focused on bringing mobile vaccination clinics to different sectors of the Revere community. Mobile vaccinations have been utilized in Revere since early April when the Revere Board of Health brought their vaccination

clinic to the Northgate shopping center when eligibility opened up for essential employees. As vaccination rates increase, the City of Revere has seen case numbers and deaths drastically decrease. Currently, the 7-day case average 9.9 - the lowest average since before Columbus Day. 48% of Revere residents have re-

ceived their first dose and 31.2% of residents are fully vaccinated.

"The most important thing is getting our city vaccinated. Bringing the vaccination clinics to where our residents live and work makes the process more convenient and

Multimillion dollar infrastructure project at Town Line Brook

Donny Ciaramella, the city's chief of infrastructure and engineering, Joe Lake, DPW general foreman, and Kori O'Hara, special assistant to the Water and Sewer Department, took their first steps Monday in what is hoped to be a multi-million-dollar infrastructure project for the Town Line Brook.

Ward 6 Councillor Richard Serino accompanied the group on the walk along the path overlooking the Town Line Brook behind Griswold Park. The Brook extends from Malden and Everett through Revere and ultimately extends to the Atlantic Ocean. Revere's portion of the Brook, estimated at 3,200 feet, begins at the

Glendale Cemetery.

The concrete walls at the Brook and the drainage outfalls have been neglected for many years, according to Ciaramella.

"The structure of reinforced concrete has never been maintained," he said. "The sediment has never been removed out of the ditch to create excess for stormwater storage."

The debris and sediment in the Brook have contributed to flooding conditions in the Sargent Street, Washington Avenue, Asti Avenue, and Toscano Avenue neighborhoods.

"We need to clean out the sediments that have deposited in the bottom of the ditch over the last 60

McKenna says construction work is being done 'illegally' on weekends

Councilor requests hiring of part-time building inspector

When Ward 1 Councilor Joanna McKenna zeroes in on an issue affecting her ward or the city in general, the reaction and resolution are usually swift.

McKenna made a motion at Monday night's Council Council meeting requesting that Mayor Brian Arrigo hire a part-time building inspector to enforce the city's ordinances on the weekends.

McKenna believes "most of the illegal construction taking place without permits occurs on the weekends when residents know there is no in-

spector on duty."

She said that monies generated from fines would fund the position.

Prior to voting unanimously for McKenna's proposal, the councillors voiced their strong support of their colleague's concerns.

Ward 3 Councilor Arthur Guinasso said succinctly and rather dramatically, "This is probably the most important motion that can affect our community - ever."

"Since I've been sitting on the Revere City Council for 32 years, I've been saying that there's an abusive population that decides that they're going to circumvent the law and the law-abiding citizens

Guinasso concerned by appointees not showing up for subcommittee confirmations

Anyone who watched Ward 3 Councillor Arthur Guinasso’s earnest approach to city business during his reign as council president in 2019 knows how efficient he was at keeping the discussion moving toward a final vote.

That’s why it’s no surprise that Guinasso is irked by city appointees not showing up for meetings of the Appointments Sub-Committee that he chairs.

Appointees for four licensed drain layer positions went 0-for-4 in showing up for the subcommittee meeting Monday.

day.

“This is the second meeting that they decided not to attend and that shows a derelict of responsibility and a very poor representation of their business organizations,” said Guinasso. “The next meeting is May 17 and if they don’t appear, I’m going to ask the Committee of the Whole that we withdraw their names. For them to be disrespectful to the Revere City Council, I have an issue with that.”

Guinasso said he will ask the members of the Appointment Subcommittee - Councilors Jessica Giannino, Joanne McKenna, John Powers, Gerry Visconti, and Anthony

Zambuto – to go on record at the next meeting as requesting a withdrawal of the appointments.

An appointee to the newly formed Public Art Commission was a no-show at three recent Appointments Subcommittee meetings.

Guinasso basically apologized to viewers of the meeting for the appointees’ lack of attendance.

“This concludes the Appointments Subcommittee meeting of May, 2021, and I’m very sorry for those people viewing in that they didn’t have the opportunity to at least see who these individuals are,” said Guinasso.

years,” said Ciarabella.

“And we need to make repairs to the structure itself where you see the concrete has failed and erosion has occurred.”

Ciarabella said he and O’Hara are writing a letter asking the DCR to clean up the Brook and to make repairs to it.

“So it remains to be seen what’s going to happen here,” said Ciarabella. “This is a multi-million-dollar project that needs the collaboration of the three communities (Revere, Malden, and Everett).”

living next door suffer the pains of it.”

Guinasso noted that construction often “goes right through the weekend, Sundays included.”

“That’s an affront to all of us,” said Guinasso, adding that weekend construction has been a problem dating back several years and mayoral administrations. “Thank you, Councilor McKenna for a great motion.”

Ward 6 Councilor Richard Serino said that he would like to see a part-time building inspector enforcing ordinances during evening hours as well as weekends.

“I can tell you I have an issue in Ward 6 where there’s a home that heavy construction trucks enter into and out of the property in the early mornings and late at night,” said Serino. “It’s been a huge issue.”

Councilor-at-Large George Rotondo said, “We see it time and time again throughout the city. It gets dark on Friday nights and Saturday morning comes, and they’re doing the vinyl siding or the roof, or a porch in the back and the next day they’re gone. These contractors are ones who need to pay the fee so we can ensure that they’re licensed and insured.”

Ward 5 Councilor

John Powers commended McKenna for her motion. “This is something that is long overdue and should be put on as quickly as possible.”

Powers add that the part-time building inspector should be accessible by phone on weekends for potential enforcement situations.

Councilor-at-Large Steven Morabito also climbed aboard the McKenna hire-a-part-time-building inspector express.

“This is something that is necessary,” said Morabito. “What happens is you will have a resident who will do illegal building. And before you know it, it sets a trend and it’s like a domino effect. It’s very necessary to set an example with enforcement by having that extra

set of eyes responding to calls on weekends if there is a complaint.”

Ward 2 Councilor Ira Novoselsky was in agreement, especially so with Guinasso’s contention that illegal construction has been a problem for many years.

“I see it in my ward all time, even though a lot of the buildings come out nice,” said Novoselsky. “But they’re doing it wrong. You see all this construction going on with no permits. I hope the Mayor does put it (a part-time building inspector’s position) in the budget.”

Councillor-at-Large Gerry Visconti said, “We as residents also need to know who to call and make the inspector aware of that and take care right at the time on weekends,

because handling in on Monday a day late.”

Council President Anthony Zambuto, who expressed his support for the motion, stressed to contractors and homeowners that, “they need to post the permit. And perhaps the contractor should know that they’ll be fined if they’re not posting the permit.”

Regarding the motion presented by Councilor McKenna, Michael Wells, Director of Municipal Inspections for the City of Revere, said, “We appreciate the council’s efforts to advocate for additional resources for ISD as our city continues to grow.

We are receptive to all residents’ concerns and are looking to add additional resources in our upcoming budget.”

THE BIDEN DEAL IS LONG OVERDUE

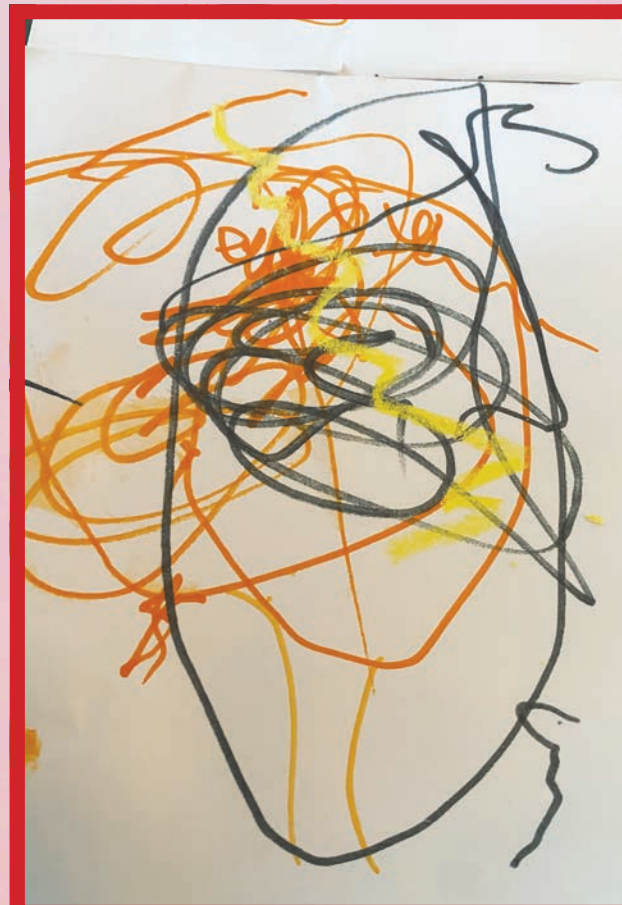

Chelsea Curves Construction look-ahead through May 15

Staff report

This is a brief overview of construction operations and traffic impacts for the Tobin Bridge/Chelsea Curves Rehabilitation Project. MassDOT will provide additional notices as needed for high-impact work, temporary ramp and street closures, and changes to traffic configurations beyond those described below.

ROUTE 1 TRAFFIC IMPACTS

•**ROUTE 1 SOUTHBOUND LANE TAKING** (4/12 - 5/7)

*From Monday, 4/12 through Friday, 5/7 Route 1 Southbound

where it passes through the Chelsea Viaduct portion of the combined Tobin Bridge/Chelsea Curves Rehabilitation Project will experience 24/7 closure of the right lane. The two other lanes will remain open throughout the closure period during peak travel times.

*The right lane closure will assist in completing work in removing temporary asphalt and waterproofing, milling and paving, and stripping the roadway.

•**ROUTE 1 NORTHBOUND:** Approaching the Tobin Bridge from Boston, the work zone begins in the right lane. 2 of

3 travel lanes will be open during daytime hours (5 a.m.-10 p.m.).

•**ROUTE 1 SOUTHBOUND:** Approaching the Chelsea Curves from the North Shore, the work zone is in the median. 2 of 3 travel lanes are open during the daytime hours (5 a.m.-10 p.m.).

LOCAL STREET CLOSURES

•**ORANGE STREET:** Beginning Monday, 5/3 to Friday, 5/7 Orange Street will experience daytime closures (7 a.m. - 3 p.m.).

WORK HOURS

•Most work will occur during daytime working

hours (7:00 a.m. - 3:30 p.m.) on weekdays. Some work will take place on a 2nd shift (2 p.m. - 1 a.m.) and overnight hours (9 p.m. - 5 a.m.) and on Saturdays (7 a.m. - 7 p.m.).

DESCRIPTION OF SCHEDULED WORK

•**ROUTE 1 NORTHBOUND:** Work includes installing strip seal joint, solid snow fence, milling, paving and rumble strip.

•**ROUTE 1 SOUTHBOUND:** Work includes installing solid snow fence, milling, paving and rumble strip.

•**UNDER-VIADCUT & STREET/PARKING**

LOTS: Work includes installing Fire Standpipe, drainage, underground electrical, grading parking lots, installing curb, placing sidewalks, painting, underdeck lighting and landscaping.

Traffic Commission approves fire lanes on Neptune Road

The Revere Traffic Commission, under the direction of Chair Paul Argenzio, approved the installation of fire lanes on both sides of Neptune

Road at its April 29 meeting.

Ward 3 Councillor Arthur Guinasso was the original sponsor of the proposal that addressed the crowded conditions on the roadway that runs

from Route 107 (off of Broadway Circle) to 405 American Legion Highway.

"Naples Road has been a long-time problem for the businesses that surround most of the area

and to the homeowners," said Guinasso, citing public safety for all as his top priority. "Deputy Chief Paul Cheever knows all too well about what goes on on Naples Road as he appeared on many occasions before the Revere License Commission. Unfortunately, we have seen too many business establishments in that area not being neighborly to one another and not being neighborly to the residents of the area."

Guinasso said that having fire lanes on both sides of Naples Road "will make the unbelievable conditions corrected."

"I think it's the simplest way and what it does it gives some teeth in the law to our Police Department to go out and issue tickets in violation of the terms of

what exists there."

City Council President Anthony Zambuto supported his colleague's declarations.

"This has been a disaster for years down there [on Naples Road]," said Zambuto. "I think we all know that. Now that we have a hotel [Avid Hotel] there, it makes it even more of a risk if something happens. You could never get an apparatus down that street with the way they park on both sides and sometimes double park and triple park. I think is the way to make this street safe and efficient. Businesses will keep the cars in their own lots and in their own property. I urge the Commission to take this seriously and vote favorably for it."

City Council Vice-President Gerry Visconti also

offered his support. "I'm in favor of this as well," said Visconti. "It is long over-due. I think there is a lot of parking abuse on both sides, which makes it difficult for cars and fire engines and apparatus to travel down there. A lot of complaints have come out of the new business that's down there now, so I think it's an easy solution. I hope the Commission votes favorably on this."

In addition to Argenzio, other members of the Traffic Commission in attendance were City Engineer Nick Rystrom, Fire Chief Christopher Bright, Police Chief David Calahan, Police Sgt. Chris Giannino, along with Revere ADA Coordinator Ralph DeCicco.

RPS holds visioning workshop

Last Tuesday night Revere Public Schools hosted a "Virtual Community Visioning Workshop" that focused on setting educational and architectural priorities for the new Revere High School project.

During the hour and half long workshop a good amount of time was spent on design patterns that were prioritized during prior visioning workshops.

During the virtual event, students and families had the option to like or dislike certain aspects of proposed design patterns.

At the very end of the presentations participants had the opportunity to rate the design patterns based on what was the most and least important.

The first pattern presented and the one that was rated most important by the viewing public during the meeting was the 'heart of the school'.

"The idea that there's a central Learning Commons, a place that brings the whole community together," said Davis Stephen, a consultant for Perkins Eastman. "In this particular example, and this is a school in Massachusetts, built through the MSBA process five years ago--West Bridgewater Middle/High School. You can see that their cafeteria is their heart of school, but it's also got a very nice carpeted stair area where kids can sit and use their technology. It's also a nice performance area and it connects to an interior courtyard that also has places to eat and outdoor classrooms."

The next pattern shown dealt with community access and again showed an example of West Bridgewater Middle/High School.

"You can see that the gym, the cafeteria, and the interior courtyard, the auditorium, the music area, the video lab, and the robotics and computer area are all accessible in this

community core, so it's safe and it's welcoming," said Stephens. "It can be used after hours safely and you can block off the rest of the areas of the school from this area so it really becomes a community center. It's a very pleasant space, West Bridgewater makes this area accessible to the community and they also use it as an income generating space (for the school).

The third pattern sealth with "classroom neighborhoods" or "clusters of learning".

"You can see in the diagram that there is, instead of a classroom, there is an open space," said Stephens. "There's also a teacher planning area here and special education rooms that are integrated fully into this classroom neighborhood. Now this could be a ninth grade neighborhood. It could be an English neighborhood, or a math neighborhood. Or it could be integrated across subject areas. So, this is one of the ways that we're looking at building on the connections between spaces. This could support a career pathway as well. And one important element of that is that there's some visual connection to this space. So this is a space that students can leave the classroom, they can do independent or small group work or you might gather a couple of classrooms out there for a presentation or an activity. So it gives you a lot of flexibility."

Stephens added that while traditional classrooms are still very important they need to have flexible furniture, good natural light and allow for different configurations so teachers and students can adapt to more traditional education delivery or small group work.

"Plastic chairs can be stacked and you can move things around, some of the table tops can go up and down so you can have standing tables as well," said Stephens. "There's good technology infra-

structure so students can be using their laptops."

In the next slide during the workshop Stephens talked about enrichment spaces at a new high school.

"We know that we're going to have these spaces in the building, and there'll be a good amount of square footage directed at them," said Stephens. "But we want them to be easy to access, visible, and centrally located so that these spaces connect to their ability to be used after hours by the community. We want to be able to support extracurricular activities, enrichment programming, afterschool programming, adult programming and have those programs easy to find. Also, we want them visually accessible because that's where some of the really interesting and fun stuff is happening in the school and we want to make sure that we can showcase that multi-use and flexible spaces."

There will also be an emphasis on STEM (Science, Technology, Engineering and Math) learning.

"We also want to be thinking about things like a maker space where science, technology, engineering and math, or project work can happen," said Stephen. "We also want to be thinking about project labs, connected career tech spaces and spaces where kids can be creative "

Stephens also highlighted outdoor learning spaces,

After the meeting the top three rated patterns of importance were Heart of the School, Community Access and the addition of Multi-Use and Flexible spaces.

In April 2020 the Massachusetts School Building Authority (MSBA) voted to authorize inviting the City of Revere to collaborate with the MSBA in conducting a Feasibility Study to build a new high school in the city.

MBTA bus driver charged with sexual assault, kidnapping

A Revere man contracted to drive an MBTA that was operating the route between Orient Heights MBTA Station in East Boston and Winthrop has been arrested and arraigned on charges of allegedly kidnapping, assault to rape, and indecent assault and battery.

Ali Ennab, 45, of Revere, is accused of attacking a woman after she boarded the #713 MBTA bus from Orient Heights to Winthrop on the evening of April 24. The alleged assault occurred and was captured by the surveillance system on board.

Ennab was arraigned in East Boston Municipal Court and John E. McDonald, Jr. set Ennab's bail at \$10,000 cash. Ennab was ordered to surrender his passport, stay away from the victim, not work as a bus driver or any transportation company for hire, and submit to GPS tracking. The Commonwealth also filed a motion to revoke bail on an assault and battery case out of Malden, which was allowed.

According to District Attorney Rachael Rollins the victim boarded the bus at Orient Heights and was heading to Winthrop just before 7:30 p.m. on April 24 but had missed her stop and was the only remaining person on the bus.

The woman, who does not speak English, was

talking on her phone and missed her stop and then used a translator app to ask the driver to take her back to Orient Heights. The bus driver allegedly began speaking to her and identified himself as Ali, but he did not return to Orient Heights. Instead, he stopped the bus at a stop near the beach in Winthrop, and the victim began to feel nervous because she was the only passenger.

According to the DA's office Ennab then allegedly shut the bus off, got up and sat next to the victim and put his arm around her.

"He then allegedly pulled her closer to him and kissed her cheek," according to the DA's office. "The defendant told the woman he could get her a green card. She responded that she has a husband and doesn't need a green card, then again asked him to open the doors because she wanted to get off the bus. He asked for her number and she called her phone from his phone so that his number would be there in case something happened to her. He then began eating his dinner and refused to open the doors to let her off the bus."

According to the DA's office, after eating, Ennab started the bus and the victim started walking toward the doors but Ennab turned the bus off again.

"She asked him to open the door and he lunged

at her, ripping her mask off and kissing her face," reported the DA's office. "He groped her body and put his hand down her pants. She begged him to stop and he continued assaulting her. She recorded audio of the assault on her phone. In the audio, the victim can be heard in Spanish begging the driver to stop and open the door. He responds, "Me, I'm boyfriend for you, it's okay." She continues to tell him no and to open the door. When an unidentified woman walked near the bus, she apparently caused Ennab to open the door allowing the victim to leave."

Rollins said a woman should be able to ride a public bus without fear of kidnap and sexual assault.

"Women, just like all people, have the right to not be harassed, violated, harmed, or objectified," said Rollins. "As I have said, fathers need to start speaking to their sons, and men need to tell their brothers, friends and colleagues about a new vision of masculinity where men are working to end violence against women and girls," District Attorney Rollins said. "The allegations outlined in this case are deeply disturbing."

Ennab, who is employed by Paul Revere Transportation LLC as a contract driver for the MBTA, was represented at arraignment by attorney Ross Schreiber. He returns to court May 25, 2021.

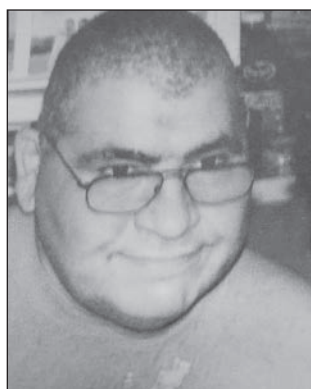
Richard Giordano

Successful sale of Green and Sustainability Bonds takes place

Staff Report

The State Treasurer’s Office officials announced that the Massachusetts Clean Water Trust (the Trust) has successfully completed the sale of approximately \$351.4 million in two series of new money Green and Sustainability Bonds. The Sustainability Bonds were the first such issuance from the Trust and the first in the nation for a state revolving fund. Additionally, it was the Trust’s sixth Green Bond issuance. The sale achieved a true interest cost of 2.099% with maturities ranging from 2022-2041. The Series 23A Green Bonds and Series 23B Sustainability Bonds (AAA/Aaa/AAA) sold to retail investors on April 28 with an institutional investor order period on April 29. The sale saw strong participation, with \$687 million in orders including five new investors and four ESG funds. Strong Massachusetts retail investor participation generated \$93 million of orders. “This sale illustrates the strong investor demand for municipal bonds with positive environmental and social impact,” said State Treasurer Deborah B. Goldberg, Chair of the Trust. “The Clean Water Trust team is leading the nation in the state revolving fund municipal markets. First, with their groundbreaking green bonds, and now with this sustainability bond issuance. We will continue to stress the importance of utilizing these opportuni-

ties in support of our local communities and our environment.” The proceeds from the sale will finance projects that are selected based on criteria that identify the most relevant public health and environmental related projects while adhering to the standards of the federal Clean Water Act and the Safe Drinking Water Act. The Series 23A Bonds are designated by the Trust as “Green Bonds” and are expected to provide environmental benefits. The Series 23B Bonds are designated by the Trust as “Sustainability Bonds” and are expected to provide both environmental and social benefits. The bond proceeds will finance projects in communities identified as the most disadvantaged, based upon affordability criteria developed by the Trust and support additional reductions in interest rates, mitigating the construction costs of these critical infrastructure projects. The criteria apply an Adjusted Per Capita Income (“APCI”) formula based on per capita income, employment rate, and population change. The communities selected are those with an APCI metric lower than sixty percent of the Commonwealth’s APCI. The Trust’s State Revolving Fund Bonds, Series 23A and Series 23B underwriting syndicate was led by Morgan Stanley as the book-running senior manager and Jefferies and RBC Capital Markets as the co-senior managing underwriters.

May 4, 2011
Revere residents joined the rest of the nation in taking satisfaction that justice finally has been served with the dramatic announcement by President Obama this past Sunday evening that a team of Navy SEALs had killed Osama bin Laden in his Pakistani hideaway earlier that day. It has been almost 10 years since the tragic 9/11 catastrophe that claimed the lives of more than 3,000 innocent Americans. Among those killed was a young Revere woman, Mary Ann MacFarlane, who was on the second plane hijacked out of Logan Airport.

The Revere Journal writes that it was arguably House Speaker Robert DeLeo’s finest hour last week when the House passed a bill giving cities and towns the right to put their municipal employees into the state’s Group Insurance Commission that will reduce premiums paid by cities and towns, while at the same time providing those employees with great health insurance.

Mayor Tom Ambrosino said this week that he believes a trash fee for local residents is unavoidable within the next year or two. Although the mayor, who is not running for re-election, said he will not be taking up a proposal for a trash fee before he departs in December, he predicted that the next mayor will have to face up to the city’s dire financial straits and that a trash fee is an “easy option for raising a couple of million dollars.”

After several months of discussion on a state whistleblower lawsuit precipitated by current and former employees of the Resco (Wheelabrator) incinerator on the Rumney Marsh, state officials reported late Monday that the company agreed to a \$7.5 million settlement to resolve the case. Wheelabrator, in a statement to the Journal, denied all allegations of wrongdoing and stated they just didn’t want a court battle. A joint press release from Attorney General Martha Coakley and the state Department of Environmental Protection (DEP) on Monday disclosed the settlement and the particulars. Wheelabrator was accused of emitting ash through holes in its roofs at the Rumney Marsh facility and another facility in Andover. It was also accused of failing to properly treat and dispose of its ash, repeatedly dumping wastewater into the Rumney Marsh, and failing to report a sudden release of hazardous material to the DEP.

The race is on for the vacant House seat created by the recent election of former State Rep. Harry Della Russo to the Senate, with 12 Democrats and four Republicans filing nomination papers. Della Russo won the seat in a special election to succeed Harold Canavan, who was appointed to a judgeship in the Boston Municipal Court in January by outgoing former Governor Foster Furcolo. The effort to resurrect the issue of a new Revere High School was defeated when the School Committee voted 4-3 against the proposal. In one of the most heated sessions in many months, the School Committee voted 4-3 to name John E. Sullivan, 56, who taught English for 25 years in the Revere school system and who presently is an Associate Professor of Education at Worcester State College, as the new Superintendent of Schools. Sullivan is a graduate of B.C. High and Boston College and has a Master’s in Education from Harvard University. A two-alarm fire at 47 Nahant Ave. has left three families homeless. The City Council elected Councilor Edward R. White Jr. as the new mayor on the eighth ballot. Councilor Harry Della Russo had been serving as Acting Mayor since the death last December of Councilor John M. Liset. The City of Revere finally won the battle with the state, which has been ongoing since 1922, over who is responsible for maintaining the stretch of Squire Rd. from the Revere Drive-In to the Linden line, with the State DPW finally taking over the care of the roadway. Eight of the city’s schools still are open, even though the State Building Inspector has denied the issuance of safety certificates, which could result in the School Committee being held liable both civilly and criminally if necessary action is not taken. Cpl. Ralph S. Holt, who has been wounded in action four times in Korea, where he has been serving since the war’s inception, is home on a 30-day furlough to visit his mother at 178 Foley St. Holt is the recipient of the Bronze Star for valor in action and the Purple Heart. Five local soldiers have been killed in Korea and 12 others wounded.

The COVID ambassadors are also assisting the Revere Board of Health in door-knocking campaigns and outreach for the Mobile Clinics.

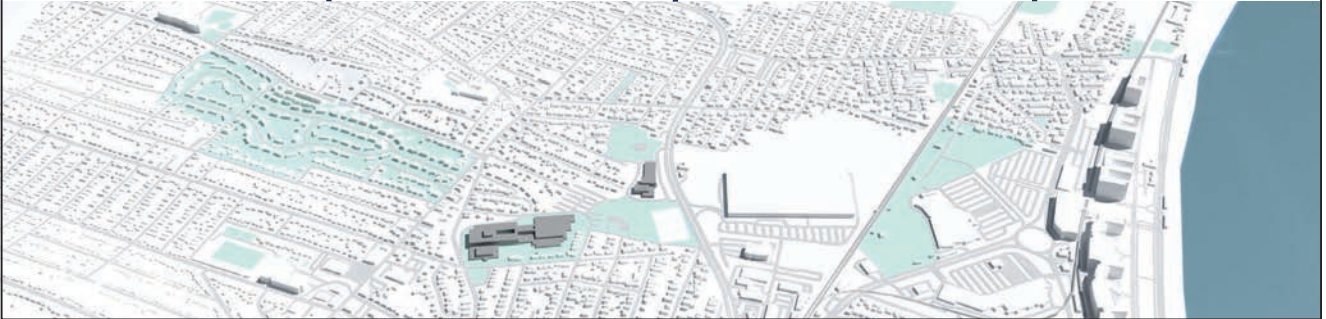
The City of Revere also launched its vaccination information page, which includes data, clinic information, and a calendar of Mobile May destina-

Revere beats Lynn English to set up GBL showdown with Everett

The Revere High School football made it a sweep of the GBL's two Lynn teams Friday night, rolling to an impressive 38-22 victory over Lynn English on Senior Night at Harry Della Russo Stadium.

Revere, who had defeated Lynn Classical in the season opener, is now 2-0 with its sights set on what many are calling the high school football game of the year: a showdown for the Greater Boston League title with Everett Friday at 6 p.m. at Everett Memorial Stadium.

The Boston Globe recently picked Everett (1-0) as the team that would

have played Central Catholic in the Division 1 North finals if the season weren't so dramatically altered by the COVID-19 pandemic. With John DiBiasi's Catholic Memorial team and Xaverian High School the top-ranked teams in Division 1 South, it could be reasonably argued that the winner of the Revere-Everett would merit the title as the unofficial Massachusetts state public high school champion among all divisions.

How far has Lou Ciccatelli taken his Patriots' football program? Very far and maybe to the top of the Bay State following a historic 10-1 season in

Gambardella returns to the boxing ring on May 18

Revere professional boxer Travis Mazac Gambardella will resume his quest for a world title in a middleweight bout scheduled for May 18 in New Hampshire.

Gambardella (8-1, 6 KOs) suffered the first loss of his career to Joey Spence last September at the Staples Center in Los Angeles. Gambardella is training at the Broadway Boxing Club in Everett under the guidance of trainer Joe Ricciardi and manager Dennis Willcox.

“This will be a first six-round fight,” said Gam-

bardella. “I’m coming off my first loss ever, but I’m focused and ready to go. I’m living in Revere where I grew up. This past fall I joined the Local 7 Ironworkers Union and I’m working at Boss Steel in Cambridge. I work hard every day and I go to the boxing gym every day after work.”

Gambardella said he’s doing his roadwork on the streets of Revere. “You can catch me going down Washington Avenue over to Newhall Street and Linden Square. I run 3-5 miles a day.”

Gambardella said his goal to win three fights

this year and get “a national-stage fight” in 2022.

Travis thanked his mother, Carla, for her continuing support of his boxing career.

“I couldn’t do anything without my Gambini – that’s what I call her – my mother, she supports me 150 percent,” said Travis. “She helps me sell T-shirts, organize fundraisers, and sell tickets to my fights. My trainer, Joe Ricciardi, and manager, Dennis Willcox, are huge helps in my career. I couldn’t be more thankful for my family, my friends, and the team behind me.”

Face coverings continue to be required on MBTA vehicles, stations and platforms

Staff Report

The MBTA is reminding customers that face coverings continue to be required while onboard vehicles, on station platforms, and within the MBTA system for all riders, including those who

have been fully vaccinated. On April 27, both the Centers for Disease Control (CDC) and the Baker-Polito Administration updated guidance regarding face coverings for fully vaccinated individuals. While the CDC

and the Commonwealth's guidance relax the need for face coverings in some settings, face coverings are still required while riding MBTA vehicles and within the MBTA system. This includes outdoor bus stops and all outdoor platforms for the Commuter

Rail, subway, and trolley systems. Effective April 30, civil fines related to MBTA face-covering enforcement efforts are no longer in effect, though those who refuse to comply with the face covering requirement may be denied

boarding of or be removed from MBTA vehicles and the system. There continue to be exemptions to the face-covering requirement for individuals with certain medical conditions and those who are so exempt do not need to produce

Resident sentenced for money laundering and drug charges

Staff report

A Revere man was sentenced in federal court in Boston yesterday for cocaine possession and attempting to launder money to Colombia. Jairo Agudelo, 34, was sentenced by U.S. District Court Judge Leo T. Sorokin to 57 months in prison and three years of supervised release. In December 2020, Agudelo pleaded guilty to money laundering conspiracy, substantive money laundering and possession with intent to distribute cocaine. In February 2019, investigators seized approximately \$200,000 in cash from Agudelo when he attempted to launder drug proceeds from Massachusetts to Colombia. When investigators executed a

search warrant at a Revere apartment used by Agudelo as a stash house for his cocaine distribution, they located approximately 400 grams of cocaine, as well as drug packaging materials and over \$11,000 in cash. Acting United States Attorney Nathaniel R. Mendell; Brian D. Boyle, Special Agent in Charge of the Drug Enforcement Administration, New England Field Division; and Ramsey E. Covington, Acting Special Agent in Charge of the Internal Revenue Service's Criminal Investigation Division made the announcement today. Critical assistance was provided by the Boston Police Department; Massachusetts State Police; Revere Police Department; U.S. Immigration and Customs

Enforcement, Enforcement and Removal Operations; and the United States Marshals Service Assistant U.S. Attorneys Lauren A. Graber and Jared C. Dolan of Mendell's Narcotics and Money Laundering Unit prosecuted the case. This investigation, dubbed "Operation Týr," is part of an Organized Crime Drug Enforcement Task Forces (OCDETF) operation. OCDETF identifies, disrupts, and dismantles the highest-level criminal organizations that threaten the United States using a prosecutor-led, intelligence-driven, multi-agency approach. 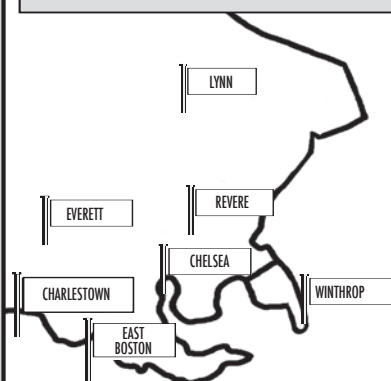

MBTA Control Board commits to funding the Transit Priority Group

Staff Report

The FY22 budget, approved April 26 by the MBTA's Fiscal and Management Control Board, includes a commitment to fully fund the T's Transit Priority Group, a special unit dedicated to delivering bus lanes, transit signal priority (TSP), and collaborative planning programs with service-area municipalities. The four-person team has dramatically accelerated the MBTA's planning and project delivery capacity for bus priority projects, which are proven to make transit faster and more reliable.

Since its creation in 2019, the MBTA Transit Priority Group has been funded with generous grant support from the Barr Foundation as a part of their philanthropic commitment to addressing climate change and advancing equitable mobility in Metro Boston.

"In the last few years, the MBTA's bus priority network has gone from a couple streets along the Silver Line to a robust web of corridors spanning ten cities and towns across our service area. These targeted improvements, which are aimed at making

bus service more reliable on some of the region's most congested roadways, are a key component of the MBTA's Better Bus Project, a broad-ranging, multi-year initiative aimed at transforming our bus system," said MBTA General Manager Steve Poflak. "The MBTA would not have been able to make these advances without the steadfast commitment and partnership of the Barr Foundation."

Since the Transit Priority Group's launch in 2019, 13.6 miles of bus lanes have been constructed on Metro Boston roadways, bringing the total region-wide network to nearly 20 miles. These reliability benefits have had a far-reaching impact. While 3 percent of passenger miles travelled are in bus lanes, reliability benefits extend to 41 percent of passenger miles travelled systemwide.

"A decade ago, rapid, reliable, high-quality bus service was something few in Metro Boston had even heard of or believed was possible here. Now, it's becoming a reality with potential to improve the transit experience for thousands of bus riders every day," said Senior Program Officer at the

Barr Foundation Lisa Jacobson. "The Barr Foundation was pleased to help launch the Transit Priority Group at the MBTA to bring world-leading ideas to help solve congestion, access, and climate challenges in our communities."

Notable projects spearheaded by the Transit Priority Group since 2019 include:

- A first-of-its-kind transit facility in Metro Boston: a center-running bus lane project currently under construction on Columbus Avenue in Roxbury and Jamaica Plain to

dramatically improve bus service reliability, accessibility, and rider comfort.

- An unprecedented regional joint procurement effort led in partnership with MAPC to significantly reduce construction costs for quick-build transit and active transportation projects for 13 metropolitan area municipalities, which the MBTA estimates will save taxpayers a projected \$2 million over the course of this year.
- In response to COVID-19 service needs leading to the implementation of the MBTA's Rapid Response Bus Lanes Program, a partnership with the cities of Boston, Somerville, Everett, and Chelsea to build up to 14 new bus lane miles on critical transit corridors.
- Working with MassDOT and six different municipalities to deliver 10 Shared Streets and Spaces and Shared Winter Streets and Spaces projects.
- Expanding bus priority projects to several new municipalities, including Chelsea, Malden, and Lynn.
- Continuing previously initiated projects such as implementing TSP on the

Green Line in Brookline and Boston.

In the next several months, the Transit Priority Group is working closely with four municipalities to deliver more than four miles of bus lanes, standardize the preferred design approaches through a bus speed and reliability toolkit, and kick off a regional collaboration to define the next generation of TSP for Metro Boston.
