Conservation Commission to take enforcement actions

The Revere Conservation Commission took up a number of matters at its monthly meeting last Wednesday in the Joseph Del Grosso City Council Chambers.

Chairman John Shue and fellow commissioners Zachary Bisconti, Heather Legere, Nathalie Pardo, and Joseph Lavalle were on hand for the meeting.

Although the meeting was relatively-uneventful, the commission voted to take enforcement actions against three homeowners who had undertaken projects in their backyards, which abut wetland areas, without first receiving permission from the commission to perform the work.

The agenda items, followed by the commission members' discussion and vote on each item, were as follows:

1) PMA DEP File #061-0774 - Abbreviated Notice of Resource Area Delineation - area off Muzzy Street - Hayes Engineering, Inc.

Discussion and vote:

Anthony Capachietti from Hayes Engineering appeared for the petitioner, which owns the property off Muzzy St. Capachietti's purpose in coming before the commission was to seek the commissioners' approval of the wetland line that his firm had mapped out on the property.

Superintendent Kelly offers suggestions for \$575,505 in carry forward funding

Each year the Revere Public School Committee takes a look at how much 'carry forward' funding flowed from the previous fiscal year and decides whether or not to spend some, all or none of the money.

In a typical fiscal year some of the money budgeted will go unspent and it's the School Committee's responsibility to appropriate that free cash carried forward and see

where it can best be used in the current fiscal year.

This year there was \$575,505 in carry forward money and Revere Public School Superintendent Dr. Dianne Kelly offered several suggestions on how to spend the money at Tuesday's School Committee Ways and Means subcommittee meeting.

Kelley aks included \$50,000 for a new Parent Information Center (PIC)/English Learners (EL) secretary, \$60,000 to redesign the school's PIC office, \$180,000 to hire three EL teachers, \$15,000 for NEASC Committee Expenses, \$10,000 for Transportation Leads stipends, and \$150,000 for

new cameras for Rumney Marsh Academy and the Paul Revere schools for a grand total of \$465,000.

"There are several requests from different administrators that I did put together," said Kelly. "We worked with the administrative team to identify any

Revere Reprecincting Committee presents updated map to the Revere City Council; hearings scheduled

After about 150 submitted comments and public testimony on www.revere.org/redrawingrevere, a new map has been created and submitted to the Revere City Council. Based on the results of the 2020 Census, Revere is one of the fastest growing cities in the state. Revere has also shifted from a city with a population that was 62% Non-Hispanic White in 2010 to 45% Non-Hispanic White in 2020 - a significant shift.

The Revere Reprecincting Committee has worked significantly over the last few months comparing numerous ward maps, delving into data

sets, logging public comments from the redrawing survey, and hosting information forums. The new map was presented by Committee Member Reuben Kantor at the November 8 Revere City Council Meeting. Residents are encouraged to attend public hearings on November 15 at 4:00 PM and November 18 at 6:00 PM in person at the Revere City Hall Chambers (281 Broadway). All hearings will be available to watch on RevereTV.

By law, the City is required to ensure every ward and every precinct on the map is sized within 5 percent of the average size. In addition, the City may not dilute racial

or ethnic groups' voting strength, nor may it make race the predominant factor in repredrawing. The Reprecincting Committee took all of these factors and legal requirements into consideration in developing the maps. After over 150 responses to the Redrawing Survey, the Reprecincting Committee has created a new, updated map. The revised map reflects several changes - many of these modifications will be explained in detail at the public hearings. Residents can view, make comments on, and download a PDF version of the revised map now on www.revere.org/redrawingrevere.

D'Ambrosio donates School Committee salary back to city

Anthony D'Ambrosio is earning plaudits from colleagues in city government for his decision to not accept his salary for being a member of the Revere School Committee.

D'Ambrosio, who is in his first term as a member of the Committee after topping the ticket in the 2019 election, has not ac-

cepted his approximately \$6,000 annual salary and benefits for the past two years.

"It was a decision that I immediately made after getting elected, especially because I came in wanting to fund certain mental health initiatives and equity initiatives, knowing that education is a chronically underfunded field," said D'Ambrosio.

Ward 4 Councillor Patrick Keefe praised D'Ambrosio for not accepting a salary.

"I think it's an admirable feat," said Keefe. "I don't think many people are aware of it. It's a very generous thing for Anthony to do. Hopefully, the funds were used toward something good."

Human Rights Commission holds November monthly meeting

The Revere Human Rights Commission (HRC) held its regular monthly meeting last Thursday (November 4) in the City Council Chambers.

HRC chairperson Janine Grillo Marra and fellow commissioners Lynn Alexis, Rev. Timothy Bogertman, Fire Chief Chris Bright, Police Chief David Callahan, Chai Hossani, Rachid Moukhabir, Kourou Pich, and Kathi Anne Reinstein were in attendance for the meeting.

The commission heard presentations from two members of the Revere community.

Kathleen Heiser told the committee of a project, Planting Seeds for Reconciliation, that she is undertaking. Heiser, the current President of the Beachmont Improvement Committee and a former first-grade teacher in the Revere schools who has lived in Revere for 26 years, said the twin purposes of her project are to seek storyboards from all members of the com-

munity that can be placed in the schools and in other locations in the city and to make the schools more-welcoming to incoming students, particularly those who are recent immigrants.

"I felt compelled to do this because I felt as though I had to do something concrete," said Heiser. "The project will reach out to thousands of people. There is a story to be had from everybody because everybody is an immigrant."

"Some of the old-time second or third generation residents may have forgotten how hard it was for their families when they first arrived here," Heiser continued. "I would like the older generations to share their stories with the new ones. The older generations are not as sympathetic as they could be because they've forgotten. I want a storyboard in which residents tell where they came from and why they left that can be displayed in the lobbies of the schools for such occasions as parent-teacher nights."

Heiser also explained

that she is seeking to "make the lobbies in the schools more friendly to new students and parents, with comfortable chairs and tables with translations that will provide a virtual tour of their new school. Ideally, there could be QR codes for their language. If we want to be inclusive, we have to make them feel welcome enough that they will join committees in our schools and community."

The members of the commission were effusive in their support of the project.

"I'm encouraged by your vision," said Alexis, who pledged her support for the project.

"I want your support and I want you to encourage people to make their storyboards," said Heiser.

Rev. Bogertman added, "This is a great idea to move forward with," and suggested that Heiser incorporate her project into religious organizations throughout the city.

"You are just a gem," said Reinstein. "I think the world of you. You are incredibly selfless and we are fortunate that you end-

ed up here in Revere with us. Perhaps you can work with the city to reach out to the community, including the Senior Center."

"We're honored to hear all of your great ideas," added Pich.

"This is great timing," said Bright. "We really need something like this in the city, the storyboards of our older citizens and the new immigrants."

Moukhabir, who described how he first came to know Heiser when she helped him to organize the first Moroccan Festival, added, "This is a very wonderful project. Anything we can do to support you, let us know. Maybe there can be a big map in City Hall with each person putting a pin where they're from to make everyone feel welcome."

"I would propose that students of that school explain their experience in their own language," said Hossani.

"This sounds like a great idea," said Callahan. "This would be very good for the community. We're very diverse here. We can share with each other and

learn. "We can put storyboards in the police lobby," Callahan continued. "We have a lot of people who come in and out. Everybody from the city comes to the police station for something."

"I'm thrilled with your responses to me and looking forward to working very hard," Heiser concluded at the end of the discussion. "I feel passionate about it."

The commissioners next heard from Reuben Kantor, the chairperson of the city's Reprincincting Committee.

"This process was begun in April and we're in the homestretch," said Kantor, who presented the committee with the map of the new boundaries of the city's wards and precincts that his committee filed at City Hall that day. "The biggest shift is in Ward 2. All wards must be within the five percent of the average population of all the others. Ward 2 had to shrink and Ward 6 had to grow."

"The City Council will take it up Monday to start

the process," Kantor continued. "We had 150 people participate in the process with their comments. We think the ward demographics are in line with the changes in our city's population over the past decade."

"We also worked hard to create 'natural' boundaries in terms of major roadways separating wards, rather than splitting-up neighborhoods, as happens under the present configuration," Kantor added.

The committee members thanked Kantor for all of his and his committee's hard work.

Prior to the presentations, Reinstein informed her fellow commissioners that she would be stepping down as the chairperson of the Cultural Holidays and Celebrations Subcommittee because of her work commitments. Grillo informed the commission that Hossani, the current vice-chair of the subcommittee, has accepted the chairmanship.

The next meeting of the committee is set for this Thursday, December 2.

NOVEMBER IS NATIONAL FAMILY CAREGIVERS MONTH

The month of November is National Family Caregivers Month which offers an opportunity to honor the countless family caregivers that work tirelessly each day to attend to their family mem-

bers' needs. Mystic Valley Elder Services (MVES) is pleased to provide affordable and accessible services needed by these caregivers through the agency's Family Caregiver Support Program.

"Through this program, hundreds of caregivers are helped every year," says Kathy Learned, MVES Caregiver Support Coordinator. "When a new caregiver signs up for the program, a support coordinator sets up an appointment with them to go over an individualized action plan. We understand that every caregiver's situation is distinct from others which is why the plan is uniquely tailored to each caregiver's needs."

According to Learned, this plan comes at little or no cost to the caregiver. During the meeting, the coordinator will discuss

the different kinds of services provided by MVES such as one-on-one assistance, peer support groups, family meetings, and community resources.

MVES' services range from support groups where a caregiver can form friendships with other caregivers to workshops focused on raising awareness to the issues a caregiver faces throughout their day. Many caregivers who have taken part in the program have befriended other caregivers who are in similar situations. The support group engages in thoughtful conversations about the difficulty of being a caregiver and the situations they can face. It also brings awareness to common diseases so that the caregiver doesn't feel alone in their journey.

"Some services may be needed at the home that the caregiver may not have which is why we have adaptive home equipment to support the family. From bed rails to a shower curtain, MVES strives to meet an individual's needs on an everyday basis," says Learned.

She continues: "We also understand that a caregiver may feel like their needs are delayed when taking care of others which can lead to a burn-out. Therefore, we have services tailored to giving some relief to the caregiver. This assistance, if caregiver is eligible, provides supportive services such as adult day health, companions, and helping find private duty assistance. These services are just a phone call away."

CLARK RELEASES NEW DATA ON CHILD TAX CREDIT'S IMPACT ON MA FAMILIES

Assistant Speaker Katherine Clark (MA-5) highlighted a new fact sheet from the Joint Economic Committee that outlines how the Democrats' Child Tax Credit (CTC) is already meeting the urgent needs of Massachusetts families by helping parents make

ends meet and positioning the economy for stronger growth for generations to come.

"The American Rescue Plan's tax cut for families is working! This pandemic and its economic fallout have brought many Massachusetts families to their breaking point but since Democrats passed the American Rescue Plan last March, the extended Child Tax Credit — one of the largest tax cuts for families in U.S. history — has helped provide support to over 70,000 children in Massachusetts' Fifth District," said Assistant Speaker Clark. "Through the Build Back Better Act, House Democrats are continuing our work to help families and our economy to recover and thrive. The Child Tax Credit and the Build Back Better Act put the needs of families first and are key to building a just, inclusive, and equitable America."

In October 2021, new Child Tax Credit data shows that 72,000 children received payments totaling over \$24.3 million in the Fifth District. Another monthly payment will be sent on November 15, 2021.

D'Ambrosio said he does not get to choose the area in the school budget where the funds from his salary will go. "Anything helps in preserving the overall, larger budget of the school district," said D'Ambrosio. "For me, School Committee was very much a public service action. It was a public service for me. It was a public service for my community. And I didn't feel comfortable accepting any compensation when that compensation could have gone to educating children or providing the services that we needed."

D'Ambrosio's decision was especially impactful

because of COVID-19's financial impact on the school budget. "Coming into COVID-19, we had to make some serious budget adjustments," he said. "There were shortfalls everywhere, and we didn't end up getting the Student Opportunity Act funding that we needed as quickly as we thought we were. It was important to me to donate my salary during a time when the resources were lacking in the district."

D'Ambrosio was not a candidate for re-election to the School Committee in the Nov. 2 election. A graduate of Yale University, D'Ambrosio is running

for the State Senate seat in the First Suffolk and Middlesex District that encompasses Revere, Winthrop, and parts of Boston and Cambridge. The Special Election is Dec. 14.

"Serving on the School Committee has been the honor of a lifetime," said D'Ambrosio. "It's been a tremendous opportunity to enact change on the mental health front, on the equity front, on the curriculum front. I wouldn't trade it for anything. Obviously, COVID-19 presented huge challenges to all of us and the district as a whole. But I was very lucky to be surrounded by a group of students, a

group of teachers, staff, and administrators, and fellow members of the School Committee that rallied around that hardship and did something quite extraordinary that not a lot of other cities in the state did, and still put together a good product for our school system."

D'Ambrosio said he will miss serving with his colleagues, "especially Carol Tye, who has been a mentor and an absolute titan of everything good and just in the City of Revere over the direction of her career."

Capachietti explained that the owner of the property presently has no plans to develop the land, which Shue described as a "hilly and rocky area," primarily because the land is accessible only through a residential neighborhood in the Town of Saugus, which has not given its approval to any development as of this time.

"We're seeking to have the wetland line be set ahead of moving forward with a project," said Capachietti. "There is no project in the pipeline because we need to get access through Saugus. There is nothing imminent because there are problems with access through the residential neighborhood."

However, Capachietti explained that if the property owner should get permission to move forward with a project in the future, having the wetland line already established will speed up the process.

The commission voted 5-0 to accept the wetland line as presented by Hayes Engineering.

2) MA DEP File #061-0688 Request for Certificate of Compliance; Existing Conditions – As-Built Plan, 245 Revere Beach Parkway; Site As-Built Plan, 205 Revere Beach Parkway; and 2021 Mitigation Monitoring Report, 205 Revere Beach Parkway.

Discussion and vote: Rick Lentini, a civil engineer, appeared on behalf of the applicant. Three members of the commission had performed a site visit to the property at 205 Revere Beach Parkway, which is a residential

apartment building, prior to the hearing.

The main issues before the board pertained to parking and the proper removal of snow from the parking lot.

"What kind of plan do you have in case of a 100 year flood for parking?" asked Lavalle,

"Do the tenants know their parking is in a flood plain?" Bisconti queried.

"Where will they pile snow?," Shue asked. "The issue is piling it up against a back fence (which abuts wetlands) and letting it melt without a treatment system."

The commissioners also wanted to see maintenance logs for the property. A representative from the property owner noted however, that there was a change of the property manager in June and therefore there were only a few months of property logs available.

"I think we should make it a condition of compliance that they provide quarterly maintenance plans and must make arrangements for snow to be trucked away from the site," said Shue, who noted that, "Everything else has been done in substantial completion of the conditions."

The commission then cited 5-0 to approve the Certificate of Completion with the added conditions.

3) Donation of land from Joseph Festa Construction Co., Inc. for conservation purposes. Lot C Emanuel Street – Blk-Pcl-Unit 018-324G-001B

Discussion and vote: "We always are interested in land to protect for conservation purposes," said Shue. "The city would like to do it in case it needs to trade land with the state DCR for another purpose in the future. The City Council needs a letter from us accepting this property and donation."

The commission voted 5-0 to accept the property and send the appropriate letter to the City Council.

4) Potential Enforce-

ment Action – 630 Revere Beach Boulevard.

Discussion and vote:

This matter pertained to work performed by the owners of 630 Revere Beach Blvd., who appeared on behalf of themselves. The issue for the owners is that they had attempted some self-help to alleviate a flooding problem on their property without obtaining permission from the Conservation Commission.

The homeowners told the commission that they have owned the property for about a year, but have had flooding in their garage and basement during heavy rains because of the pitch of the property.

They dug out their backyard to alleviate the problem, but did so without the necessary permits.

"I issued a notice of warning of potential violation and that we needed them to come here to explain to us what they're doing," Shue explained to his fellow commissioners. "They have done a bunch of work. A lot of soil has been removed without a permit from the commission."

When asked by the commissioners whether they have a plan, the owners replied that they wish to remove the soil and replace it with crushed stone.

"Our concern is that the back of the lot is near the turning circle to get to Riverview with a wetlands and drainage," said Shue. "We want to control sediment before it runs off the property. If you had come to us ahead of time, it is likely that you would have been approved."

"But the sides need to be stabilized and the final elevation needs to be adhered to," Shue continued. "We need a plan of what that's going to look like. You must file a notice of intent with proper notice to abutters."

After the owners explained that they had no intention of doing further work in the near-future,

Shue explained, "We're trying to work with you, but we need a timeline that is sooner rather than later. We want to address this at our January meeting, which means you must have a drawing and a Notice of Intent (NOI), with advertising in the newspaper, by mid-December."

"The issue is proximity to wetlands and we need to bring this back into compliance," Shue concluded.

Shue then brought before the commission another potential enforcement action for the properties at 8 and 10 Marsh View Terrace, a cul de sac located in No. Revere behind Rumney Marsh.

Shue explained that the owner of 10 Marsh View Terrace had obtained a permit from the city to fill in his backyard, in order to extend it, after seeing that his neighbor had done so and had installed a patio on the premises, with possible plans for a swimming pool.

"I was asked whether this falls within the commission's jurisdiction and after doing some research, I determined that this is in an Area of Critical Environmental Concern (ACEC)," said Shue, who said he had consulted with the State Dept. of Environmental Protection (DEP) to determine the appropriate enforcement mechanism by the commission.

"Rumney Marsh is nearby," Shue continued. "Construction debris and rubble cannot be used as fill, which is what they've done. This requires an enforcement order in order to tell them what they need to do to correct the problem."

"Since their property drains into Rumney Marsh, an erosion sediment barrier needs to be out up and the owners

must hire a wetlands scientist to restore the wetlands with native species to replace the invasive species that are there now," Shue added.

The commission voted 5-0 to accept the DEP's recommendation to proceed in this manner. The commissioners signed an enforcement letter ordering the homeowners to appear at the commission's next meeting on Decem-

ber 1 with a plan and that all work must be completed no later than March.

In their final matters on the agenda, the commissioners acknowledged the resignations from the commission of Bisconti, effective at the end of the meeting, and Pardo, effective November 30. Shue noted that they are pursuing career opportunities in Washington, D.C. and South Africa.

RESPONDING TO THE EDITORIAL "IF TAIWAN IS ATTACKED, SHOULD WE DEFEND IT?"

The Revere Journal published an opinion piece on Taiwan last week that asked the question, "If Taiwan is attacked, should we defend it?" My hometown newspaper concluded that, in their view, "Taiwan is not worth shedding one drop of American blood." This is a dangerous point of view, and it required a response.

There's no denying that politically, Taiwan is a stain on the Chinese Communist Party's resume and that tactically, the People's Republic of China's efforts to unite the Republic of China (Taiwan) with the mainland through measures like economic intimidation and political maneuvering have backfired (support for Taiwanese independence is continues to gain traction on the island). There's also no denying that China

is publicly posturing for war considering it abandoned the "one country, two systems" policy in Hong Kong to reclaim control over the port city and as recently as October 1st-4th, China dispatched a record-setting number of sorties into Taiwan's air defense zone. Further, the United States recognizes that it has "few credible options" to respond if China were to seize a set of islands administered by Taiwan in the South China sea.

But does this mean China will truly invade?

A successful invasion of Taiwan requires an element of surprise (China is currently openly posturing for war) as well as a massive well trained amphibious invasion force and the ability to maintain shipping lanes between mainland China and Taiwan. Further, to even make it to the island, the People's Liberation Army would need to make an eight-hour trek across the Taiwan Strait through the heart of

Taiwanese defense with limited areas to land troops since roughly only 10 percent of Taiwan's coastline is suitable for an amphibious landing. This means Taiwan could mass troops and artillery on these specific landing zones to exact a heavy toll on the PLA's force while waiting for western allies to help close the strait and prevent the mainland from resupplying the first few waves of the island assault. These facts do not account for the elephant in the room in that Chinese forces have minimal experience with amphibious operations and an invasion such as this is extraordinarily complicated for a force with such limited expertise in combining ocean and land war combat.

The Revere Journal failed to realize, like many pundits, Taiwan is a red herring. An invasion of Taiwan makes little sense, because above all, the likelihood of failure is too great and taking the island by force would not solve

China's existential strategic problem - the United States and her allies can deny China access to global oceans. It's difficult to display without a map, but the United States directly or through her partner nations control every major sea lane along China's coastline. What's really happening: China is pushing buttons to get away with what it can while working actively to undermine U.S. relations with key nations such as Indonesia and the Philippines. Their focus is on driving wedges between us so that western resolve in supporting Taiwan wanes and or we turn our back on each other. Now, more than ever, we need to double down on our commitment to our Pacific friends and stand with Taiwan. It's this unified global resolve against the Communist Part of China that keeps them at bay and anyone with an isolationist mentality directly undermines that.

Honor and Care for our Veterans

During World War II, on April 9, 1942, 75,000 United States soldiers and Filipino soldiers were surrendered to Japanese forces after months of battling in extreme-climate conditions.

Soon after the bombing of Pearl Harbor on December 7, 1941, Japanese forces began the invasion of the Philippines. The capture of the Philippines was crucial to the Japanese. It would bring them one step closer to the control of the Southwest Pacific. The Philippines were just as important to the U.S. Having troops in the Philippines gave the U.S. footing in the Southwest Pacific. After the invasion of the Philippines, U.S.-Filipino troops defended the crucial lands.

These brave soldiers were responsible for the defense of the islands of Luzon, Corregidor, and the harbor-defense forts of the Philippines. They fought in a malaria-infested region, and survived on little portions of food. Some lived off of half or quarter rations. The soldiers lacked medical attention. U.S. medics did what they could to help their fellow soldiers. They fought with outdated equipment and virtually no air power.

The soldiers retreated to the Philippine Peninsula when Japanese forces were reinforced and overwhelmed the U.S.-Filipino soldiers.

On April 9, 1942, the U.S. and Filipino soldiers surrendered after seven months of battle combined with exposure to the extreme elements, disease, and lack of vital supplies.

The tens of thousands of U.S. and Filipino soldiers were forced to become prisoners of war to the Japanese. The soldiers faced horrifying conditions and treatment as POWs.

The soldiers were deprived of food, water, and medical attention, and were forced to march 65 miles to confinement camps throughout the Philippines.

The captive soldiers were marched for days, approximately 65 miles through the scorching jungles of the Philippines. Thousands died. Those who survived faced the hardships of prisoner of war camps and the brutality of their Japanese captors.

The POWs would not see freedom until 1945 when U.S.-Filipino forces recaptured the lost territory.

In 1945, U.S.-Filipino forces recaptured the Philippines and freed the captive soldiers who were suffering in the confinement camps. These soldiers would be impacted by the poor conditions of the camps and the mistreatment by their Japanese captors. About one-third of the prisoners died from health complications after they were freed. (The above information is from Bataan.com).

My wife's grandfather, Lyle C. Harlow, was one of the thousands who lived through the 65-mile march and almost four years as a prisoner of war. When he and the others who survived were freed, he came back to his wife in Kentucky who had also survived and a daughter born right after his departure overseas. He returned

broken, weighing less than a hundred pounds and had to rebuild his life essentially from zero.

Harlow like thousands of others, never received a dime from the United States government after his release from the military. He received some VA medical benefits and would later die in a VA hospital. Until the last few years the VA has been a very undesirable place for medical attention but there has been improvement in recent years.

He and so many others had to rebuild their lives with no help from our country. This makes it difficult to understand how our government can consider handing out thousands of dollars to illegals pouring into our nation. Do we just hand them the American dream simply because they made it across our border?

Most Americans are charitable people. We do more than any nation to help others. Yet, when our homeless Veterans are sleeping on America's streets while shelters, medical insurance and even cash are made available for those who are unwilling to salute our flag, hate our culture and despise many of our values, then something is seriously wrong.

The Friends of Belle Isle Marsh dedicated an Education and Research Station in memory of founding member, Kermit Norris, a pioneer advocate for the conservation of Belle Isle Marsh. Following the November 6 ceremony, friends and family joined for refreshments and a walk through the meadow.

“I wish Kermit could be here because the research station would give him extraordinary pleasure,” said Norris’ wife, Debbi, who generously donated funds to build the shed. “Kermit’s relationship with Belle Isle Marsh and its importance to the local environment were ever-present in his mind. This is a reason to celebrate.”

Norris, an East Boston resident, served as the president of Friends of Belle Isle Marsh during its conception in 1985,

during a time when the land was abandoned and unhealthy. Belle Isle Marsh was surrounded by a dilapidated metal fence, and littered with beer cans and fast food wrappers. Plastic bags were stuck on the branches of trees.

Norris’ friend and founding member, Gail Miller, described him as warm, knowledgeable, and passionate about preserving the environment. Norris was committed to protecting the “finned, furry, and feathered friends” that live in the park’s habitat.

“Kermit relished giving tours,” said Miller, who remembers first meeting Norris during his presentation of exotic birds living in Belle Isle Marsh. “You felt his passion for this sacred environment, which he hoped to inspire others with. Kermit believed this place had to be protected for current residents and generations to follow.”

City Council approves special legislation on firefighters’ retirement benefits

The City Council unanimously approved special legislation: An Act Relative to the Reserve Time of Public Safety Personnel in the City of Revere at its meeting Monday night.

Revere Firefighters Local 926 President Kevin O’Hara appeared at the Council Ways and Means Subcommittee meeting to answer questions from Council members prior to the vote about the measure that affected the future retirement benefits for firefighters. Several members of the Revere Fire Department were in attendance.

Ward 6 Councillor Richard Serino sought a clarification from President O’Hara that the Council’s \$1.7 million appropriation for the legislation “was already appropriated but it was taken away from you guys.”

“The number of \$1.7 million that’s being accounted for, from the Retirement Office – we had an evaluation done and when this ruling took place in February, 2020, there was a misinterpretation of the PERAC [Public Employee Retirement Administration Commission]. They took away time from the reserve time

for firefighters. I want the citizens, the councillors, and the mayor of Revere that this isn’t extra money they’re putting towards it. This is already money appropriated for. There are 65 firefighters that are affected by this.”

Before voting on the matter, councillors universally praised the firefighters for the work they do in protecting the safety and well-being of Revere’s residents every day. The department, led by Fire Chief Christopher Bright, has been commended particularly for its exceptional efforts during the unprecedented COVID-19

health crisis that hit the city hard. The department also battled major fires in Revere in 2020 and 2021 in adverse weather conditions.

“This is an easy lift, the answer is yes,” said Councillor-at-Large George Rotondo before casting his vote. “You entered people’s homes with minimal PPE at one point. This is a yes all day long. You’ve got my full support for this legislation.”

Ward 4 Councillor Patrick Keefe said, “We talk very often about how we can support our public safety officials, and this is an opportunity for the

Council and the residents to actually act on supporting those public safety officials, and not just talking the game.”

Ward 2 Councillor Ira Novoselsky asked whether the \$1.7 million appropriation would be a one-time appropriation.

“It’s going to be \$1.7 million – it’s not every year going up and up, that’s the number that they appropriated for the retirement system that they’re using,” said Novoselsky, adding that the Revere Fire Department is “the best and you get my vote.”

Councillor-at-Large Gerry Visconti said the

Fire Department had a difficult year because of the pandemic. “The fires that have happened in the city over the last 10-11 months has been quite a bit, and you guys have gone through a lot the last 18 months – so the fact it’s not money that’s costing the taxpayers now, it’s already been set aside – you have my support and I think it’s something you guys deserve,” said Visconti.

The firefighters were accorded a standing ovation by the councillors following the vote.

unmet needs that they’re seeing already in the school year. And I know, one of the things is the increase in enrollment of English Learner students. We are way behind in some areas of paperwork with our ESL department, but we also really do have a need to increase our EL staff right now because the classes are already bursting. We anticipate, as we do every January, that we’ll have a large influx of students after the first of the year.”

In asking for the re-

design of the PIC office, Kelley said right now it feels very chopped up and secluded.

“It’s not like a welcoming environment,” she said. “We had talked about making it more of a place where families would come in, sit down at a table with one of the employees and go through all of the paperwork together. We’d like to really get a good chunk of the registration process taken care of in person and have it be more of a customer service kind of program than

a drop off papers, isolated environment.”

Kelley said the committee should consider hiring a Director of Social, Emotional and Physical Health and Wellness, Director of Fine Arts and a Director of Academic Technology.

However, these three positions combined would cost \$360,000 and when added to the previous asks for the carry forward funding would total \$825,000 or \$249,495 over the available carry forward funding.

“These are other ‘asks’ that I think are import-

ant but the committee can consider whether these things should happen now or maybe in the summer or not at all,” said Kelly. “These three positions come out to another \$360,000 which would give us a grand total of \$825,000 and would exceed the available carry forward by almost \$300,000. So that’s definitely something that the committee is going to need to consider—whether or not those are positions that you want to fund.”

Ways and Means Committee member Carol Tye

said she was very much in favor of the first set of spending outlined by Kelley totaling \$465,000 as well as hiring a Director of Social, Emotional and Physical Health and Wellness at a cost of \$120,000 but was of the opinion that the School Committee should wait to hire a Director of Fine Arts and was on the fence about hiring a Director of Academic Technology.

Ways and Means committee member Fred Sannella said over the years RPS has been accused of

being “top heavy with directors” and wondered if this was the right time to add three more.

“We’re trying to save money to cover shortages in the future,” he said. “So I question adding another \$360,000. My recommendation would be for the proposal as submitted by the superintendent, with the exception of the three directors.”

The School Committee will vote on what to spend the carry forward money on during their next scheduled meeting.

The counting of ballots in the city's second-ever

Plan E election of proportional representation finally was completed last week. The counting did not go as smoothly as it did in the first Plan E election in 1949, thanks to arguments and interruptions during the counting process. Frederick G. Reinstein, who received the most number one votes with 1762 first-place votes, was the first candidate to reach the required 1884 votes in the City Council race. Reinstein reached his quota after candidate Leonard Ginsburg was eliminated and his second-place votes were distributed to the other candidates. Harry Della Russo, who had 1746 first place votes, was the next candidate elected, followed by Edward R. White, who was elected after the 17th counting of the ballots, Raymond W. Carey, Thomas U. Kelley, Louis Kirsten, and newcomer Carmine DiPietro. Incumbents Gerald Woodland and Joseph DelGrosso,

both of whom had joined with Carey in an attempt to remove City Manager Edward C. Monahan earlier this year, were rejected by the voters. Carey himself received 27 percent fewer votes than in 1949. Altogether, 26 candidates had vied for the seven council seats.

In the School Committee race, incumbents Mrs. Ida Webber, Paul Buonfiglio, Mrs. Grace Rizzo, and John J. Riley will be joined by newcomers Mrs. Katherine Collins and Francis H. Farrell. The seventh member of the School Committee will be the City Council member who will be elected mayor by his colleagues.

# Massachusetts National Guard concludes School Transportation Mission

Staff Report

The Baker-Polito Administration announced on Monday that the Massachusetts National Guard has successfully completed its school transportation mission. From September 14 - November 5, 2021, nearly 200 Guard members drove thousands of routes and travelled over 300,000 miles, ensuring nearly 15,000 safe pick-ups and drop-offs for students throughout the Commonwealth.

In response to requests for assistance by local government officials, Governor Charlie Baker

activated the Massachusetts National Guard to support school districts amid an unprecedented, national shortage of bus drivers. Governor Baker's order made available 250 Guard personnel for transportation assistance. With the local school districts who had requested assistance now able to meet transportation needs through civilian drivers, the Guard is now able to conclude its mission.

"The Commonwealth is grateful to the men and women of the Massachusetts National Guard for answering the call and supporting the safe trans-

portation of students in communities across Massachusetts," said Governor Charlie Baker. "By working collaboratively with local districts who requested assistance, the Guard was able to provide critical school transportation support at a time when schools, students and families needed it most."

"Time and again throughout its history, the Massachusetts National Guard has stepped up to serve the communities of our Commonwealth, and that has never been more true than during the last year and a half," said Lt. Governor Karyn Polito.

"We appreciate the professionalism and dedication of the members of the Guard who supported this mission, and thank them for their service."

In total, the Guard provided school transportation support in 13 districts, including Brockton, Chelsea, Framingham, Haverhill, Holyoke, Lawrence, Lowell, Lynn, Quincy, Revere, Wachusett (regional), Woburn, and Worcester.

Final Mission Metrics:

- 236 Soldiers participated in the mission
- 14,626 student pick-ups and drop-offs
- 329,224 miles driven

- 3,002 total routes
- 13 total municipalities supported

To successfully perform this mission, more than 190 members of the Guard completed the driver's certification process to operate transport vans known as 7D vehicles. In accordance with school transportation worker requirements, the orientation process included vehicle training, background screening, as well as a thorough review of all health and safety measures.

Beyond those certified as drivers, approximately 40 members of the Guard

provided operational support for the mission.

The Massachusetts National Guard trains regularly with law enforcement, civilian, and other military agencies to provide a broad spectrum of services in support of security, logistics, disaster relief, and other missions. The Guard has a proven track record of success supporting civilian authorities. Their frequent side-by-side training with state and local first responders makes them well-suited for a variety of missions.

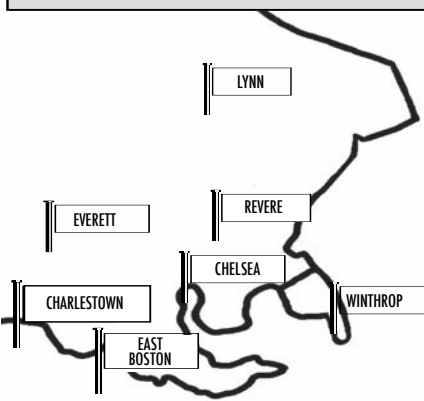
