#### POSTAL SERVICE CLOSED CHRISTMAS DAY AND NEW YEAR'S DAY

Post Office locations nationwide will be closed on Christmas Day, Saturday, Dec. 25, and New Year's Day, Saturday, Jan. 1,2022.

All Post Office tions will be open, and regular mail delivery will resume, on Monday, Dec. 27, 2021, and Monday, Jan. 3, 2022. Some Post Office locations may have extended hours leading up to the holidays, while others may have limited hours on Christmas Eve, Friday, Dec. 24. There are currently no plans for limited hours on New Year's Eve, Friday, Dec. 31. Customers are advised to always check with their local Post Office for hours of operation.

# Visconti likely has the votes to be the next president of **Revere City Council**

After a highly productive first term on the Revere City Council that included one year as vice president, Gerry Visconti reportedly has the votes to

become the new president of the Council when it reconvenes in January.

While Visconti would not confirm his imminent ascendancy to the top position on the 11-member Council, sources close to the Council indicate that Visconti is the choice of his colleagues to lead the Council in 2022.

Visconti served one term on the Revere School Committee before running successfully for councillor-at-large in 2019. He was the chair of the Council's Ways and Means

# Three community-based organizations receive grants through Raise Up Revere Fund

#### Special to the Journal

Last week, Mayor Arrigo and representatives from both Amazon and United Way of Massachusetts Bay and Merrimack Valley presented three grant awards to community-based organizations who continue to go above and beyond for Revere residents. The Raise Up Revere fund, which was established in April of 2020, is focused on meeting the immediate needs of Revere families and small businesses that have been most severely impacted by the COVID-19 pandemic, as well as longer-term strategies and innovative ideas that will continue to move Revere forward as a community. Recipients this year include HarborCOV, CAPIC, and

the First Congregational Church Food Pantry.

"The three organizations chosen today continue to step up to the plate when our residents need them the most," said Mayor Brian Arrigo. "We started the Raise Up Revere fund at the beginning of the pandemic to support community-driven organizations that work to give back to our residents. I'm proud of how we've utilized these connections so far and am excited to see the fund continue to build capacity over the coming years."

In 2020, four nonprofits and organizations were awarded grants through the fund. This year, due to a generous \$35,000 donation from Amazon

Chairman Robert Selevitch and fellow commission members Daniel Occena and Linda Guinasso were on hand for the meeting.

The chief highlight of the meeting was the approval by the commissioners of a license for a new

taqueria restaurant on No. Shore Rd., to be operated by the present owner of Esquite Taqueria on Shirley Ave.

The commission also approved, with two exceptions, a host of licenses for 2022.

# HAVE A MERRY -- AND SAFE -- CHRISTMAS

The holiday season usually is the most wonderful time of the year.

But Christmas, 2021, is anything but wonderful, even for those of us who are among the most fortunate in our society.

Our collective stress and anxiety levels are at an alltime high thanks to the recent arrival of the Omicron variant of COVID-19, which has upended the holiday plans for many of us.

Each and every day, the virus is killing almost 1300 Americans, a statistic that has become mind-numbingly routine. That figure still is well below the 3000 deaths per day a year ago at this time, but still, it translates into 500,000 deaths per year.

Hospitals once again are at full capacity in many states, with coronavirus patients filling emergency rooms and crowding-out those who have other health issues.

This was not the scenario we had envisioned a few months ago, when it appeared that we had COVID-19 under control.

For those of us who are fully-vaccinated with three shots of the Moderna or Pfizer vaccines (or one J&J plus one of the those other two), the effects of the Omicron variant are proving to be fairly mild, akin to having a bad cold.

But for anyone who is unvaccinated, infection with the Omicron variant is proving inescapable thanks to its high-degree of transmissibility. And as the statistics demonstrate, the chances of becoming seriously ill are dangerously-significant.

Although the pandemic has eviscerated the usual holiday celebrations that bring together family, friends, and colleagues, adding to our mental health issues, especially for older Americans, the toned-down holiday season offers us an opportunity for reflection, a chance to reach an appreciation for the things that really matter in our lives: The health and safety of ourselves and our loved ones, as well as the urgent need to assist those who find themselves in dire straits this holiday season.

We hope that all of our readers will heed the warnings of our public health officials and that those with the means to do so will help the vast numbers of our less-fortunate fellow Americans.

We wish all of our readers a merry -- and safe -- Christmas.

Watershed Council was founded 30 years ago in 1991 to protect and restore the natural resources of the Saugus River watershed. The organization works to improve water quality, restore river habitat and fisheries, educate students about the environment, and promote public access and enjoyment of the watershed. I am so thankful for this distinction, and I look forward to working with the watershed in the future to protect this important environmental asset in our community."

Debra Panetta, president of the Saugus River Watershed Council, and Jackie Mercurio, treasurer, praised Giannino during the award presentation ceremony.

"I am happy and thrilled that we have Rep. Jessica Giannino here tonight receiving one of our awards," said Panetta. "She has been a tireless advocate for our environment and our community."

Mercurio said she was honored to present the 2021 River Stewardship Award to Giannino.

"Tonight we honor Massachusetts State Rep. Jessica Giannino," began Mercurio. "Rep. Giannino has spent the past year hitting the ground running, listening to our constituents' environmental issues, concerned about our community's health issues, working to pass legislation to preserve our waterways, and even volunteering to teach seventh-grade science classes about what happens when plastic fills our waterways, and the importance to reduce, reuse, and recycle."

Mercurio said that Giannino had "big shoes to fill" as the successor to Rep. RoseLee Vincent, "a fierce advocate for our area's environment, who brought our voice to the State House for years."

"Rep. Giannino has picked up right where Rep. Vincent has left off, without missing a beat," said Mercurio, noting Giannino's key testimony for environmental bills protecting local communities.

"Rep. Giannino is bold and a force to be reckoned with," said Mercurio.

# City departments respond to letter from Disabilities Comm.

The Revere Commission on Disabilities held its regular monthly meeting last Tuesday evening, December 14.

Chair Ralph DeCicco, vice-chair Pauline Perno, and members, Mario Grimanis, Jason Barone, and Enza Goodwin were on hand for the meeting that was held via Zoom.

The principal discussion of the evening centered around a letter that the commissioners had sent to various city departments last month asking for the departments to enforce the city's ordinances pertaining to matters that affect the ability of persons with disabilities to use the city's sidewalks

safely. The letter was sent to the mayor's office, the Department, Parking and the Inspectional Services Dept. (ISD). The

commissioners outlined a number of specific issues that create hazardous conditions for persons with disabilities, including the placement of trash and recyclable bins on side-

and supplemented funds through an anonymous donor, the fund is able to award each organization with a \$20,000 grant – totaling \$60,000 that will be reflected through community-based work. Existing partners who have received the award in the past include The Neighborhood Developers (TND), Union Capital Boston, Moroccan American Connections in Revere (MACIR), Women Encouraging Empowerment (WEE) Revere, and The First Congressional Church of Revere Food Pantry. The Raise Up Revere Fund also funded five \$10,000 "Shot at a Healthy Future" scholarships - awarded to fully-vaccinated residents to boost incentive around the

vaccine. "The Raise Up Re-

resilient than before," said Bob Giannino, President and Chief Executive Officer at United Way of Massachusetts Bay and Merrimack Valley. "Throughout the Covid-19 pandemic, we have seen the power of municipal, business and community leaders coming together to raise up the needs of their residents and catalyze the resources needed to address them. We're grateful to Mayor Arrigo for his continued partnership and to Amazon for the generosity they have demonstrated throughout our region." The First Congregational Church Food Pantry is another 2021 recipient - the \$20,000 grant will be used to further efforts at the weekly Food Pantry by assisting in IT and computer relief. Throughout the course of the pandemic, the First Congregational Church Food Pantry operation grew exponentially. Now the Food Pantry is combined with the City of Revere "Food Hub" team and operates out of the Food Hub at 200 Winthrop Ave (the previous League for Special Needs building). The pantry continues to see a record number of families during their weekly food events.

CAPIC (Community Action Programs Inter-City, Inc), is the third and final recipient of this year's award. Through the utilization of \$20,000 in Raise Up Revere funding, CAPIC will provide comprehensive emergency support services to atrisk Revere individuals and families who are in crisis mode; specifically, temporary emergency placements, such as hotel placements. CAPIC's Emergency Assistance Program will also provide support to individuals and families once they obtain permanent housing, such as gift cards to purchase food, furniture, and basic household items. Although none of the city officials who received the letter were able to attend the meeting, chairperson DeCicco told his commissioners fellow that Michael Wells from ISD said his employees are working to resolve issues with the trash containers and with the Building Dept. to resolve construction equipment on sidewalks.

The Parking Dept. also said it is trying to resolve the issue of vehicles overhanging driveways and parking on sidewalks.

A communication was received from the mayor's office regarding the availability of forms for senior citizens and disabled citizens to apply for a reduction in their property tax bills and their water and sewer bills if they are facing financial hardship.

A person may receive up to \$200 in relief. Funding comes from voluntary contributions by Revere taxpayers. Appli-

Beverly was the daughter of the late Lena R. "Lee" (Aldorisio) Bailey, Francis J. Bailey and William Quinn; the be-





Just like he dealt with all experiences in life, Thomas E. Doherty managed his illness with strength, valor and grace and wanted to spend as much time with his loved ones as possible.





# **Revere Public School hosts community forum webinar**

In the wake of an alleged sexual assault outside of school and subsequent student protest where 10 percent of the Revere High School student body walked out and staged a protest at City Hall, Revere Public School officials held an emergency community forum webinar Monday night to address some concerns and answer questions.

Again, like the statement sent home to parents, RHS Principal Dr. John Perella did not go into too much detail of the incident but assured the public that it was reported to the proper authorities and protocol was followed once allegations came to light. However, as rumors and some misinformation of the incident began to spread on social media it caused an unfortunate firestorm of backlash and criticism of school staff and administratorspainting a picture that they were not doing enough to address the issue.

'Unfortunately in the vacuum of not knowing what happens or what is happening causes increased anxiety and fear for what is taking place," said Dr. Perella. "I can share with you as a parent who has kids in school right now I know how that must feel. As I had mentioned earlier, the confidentiality component (in this case) is really challenging. Specific to the accusation we did communicate, as best as we could. I can say that this is a challenging time for our school and there are lots of issues and concerns in our community and in our country. So there are a lot of things that are taking place. Our number one priority is to do as we are doing tonight, to communicate with all of you to share as much information as we're able to but also to listen to questions. I can acknowledge that we need to do a better job of communicating quickly with as much information as we're able to."

RHS Social Worker Magaret Sullivan said that

prior to the alleged incident a lot of students were already dealing with a lot of social emotional stressors in their life that can be easily triggered by an alleged sexual assault. However, in the recent incident Sullivan echoed Dr. Perella's comments that all protocols that exist that deal with a very serious issue like sexual assault were followed.

"In the last two years we've moved into a pandemic and that has exacerbated stressors for students," she said. "Students are now back in school and being asked to be in a normal regular school day. So that's been quite a challenge. They have heightened anxiety about the uncertainty that's going on in our society and in their world, as well as the adjustment of being back in school and all the other stressors that are going on. So when these issues come up for students in terms of sexual assault it's brought to us, the social workers, or if it's brought to an administrator or teacher and the

social workers are brought in to be a support throughout the whole process."

Perella said there are also situations in which the administrative team and the school counseling team, particularly the school social workers, work in collaboration and in tandem.

"The school social workers are in the role of supporting the students and are often doing outreach to the individual families about the needs of students in these situations," he said. "Whereas the administrator that works with that students at different grade levels is the one that often takes the lead in the investigative piece and connect some of the different guidelines that are set by the state by the federal government in terms of how different scenarios are investigated, how they're connected with different outside agencies-whether that's Revere Police, the department of children's families, or the other agencies that the school has an ongoing relationships with.

The Assistant Principal for the class in a school is very often, when situations like this arise, working very closely with a school social worker for that student, and we are communicating with that person to make sure that the student has support in these situations and kind of make sure that our responses are appropriate to our role and that the school is address the needs of students when different situations arise."

Going back to a point that Dr. Perella made earlier in the webinar, Revere Superintendent Dr. Dianne Kelly said administrators are now 'decision makers' when it comes to situations like sexual assault whether on or off school property.

"We immediately involve the authorities because they are the experts who know how to work with any sexual assault victim," said Dr. Kelly. "One thing I'll say is the Revere Police has a great group of officers who specialize in this area. And even though they are not school resource officers, they've been hugely helpful. When a student discloses that they've been sexually assaulted, they come in and they know how to do forensic investigations and really work with the students to make sure they're safe and protected–especially if it's a student who's under 18."

In the end Dr. Perella said, "We have to find a way to thread the need to support confidentiality and the sensitivity on many of the topics we're talking about, as well as continuously share and engage the community so they know what's happening in the school. And that's a real challenge for all schools and one of the things that we are dedicating ourselves to right now and throughout the rest of the school year and moving forward is to further engage with all of you and to continue to have these conversations and address specific concerns that are in the community."





# Leftover safety: extending your holiday meals

Enjoying terrific food is one of the highlights of the holiday season. However, all good things must come to an end, including the holiday celebrations. But holiday meals often bring leftovers and leftovers can help stretch out your holiday cheer. According to Mystic Valley Elder Services Registered Dietician Candace Quigley, it's important to assess the safety of the foods that are leftover. "If perishable foods, such as meat, poultry,

cooked foods, cheese, cut up fruits and vegetables, were out for more than two hours, they should be discarded," she says. "The last thing your winter season needs is a bellyache or worse—caused by improperly stored leftovers. And after the holidays, you may find yourself with a particularly full refrigerator."

To keep your food tasty and free of nasty bacteria, follow these food safety tips (adapted from the Federal Food Safety Service): Keep food out of the danger zone: Bacteria grow rapidly between the temperatures of 41° F and 140° F. After food is safely cooked, hot food must be kept hot at 140° F or warmer to prevent bacterial growth. Make sure to refrigerate the food within 2 hours of cooking food or after it is removed from an appliance keeping it warm.

Cool food rapidly: To prevent bacterial growth, it's important to divide large amounts of hot food into shallow containers so it reaches the safe refrigerator-storage temperature of 41°F or below as fast as possible. Cut large items of food into smaller portions to cool. Cut turkey into smaller pieces and refrigerate. Store turkey and stuffing in separate containers.

Wrap leftovers well: Cover leftovers, wrap them in airtight packaging, or seal them in storage containers. These practices help keep bacteria out, retain moisture, and prevent leftovers from picking up odors from other food in the refrigerator. Immediately refrigerate or freeze the wrapped leftovers for rapid cooling.

Store leftovers safely: Leftovers can be kept in the refrigerator for 3 to 4 days (gravy should be used within 1-2 days) or frozen for 3 to 4 months. Consider marking your leftovers with the date.

Reheat leftovers safely: When reheating leftovers, be sure they reach 165° F as measured with a food thermometer. Reheat gravy, sauces, and soups by bringing them to a rolling boil. When reheating in the microwave, cover and rotate the food for even heating. Arrange food items evenly in a covered microwave safe glass or ceramic dish, and add some liquid if needed. Be sure the covering is microwave safe, and vent the lid or wrap to let the steam escape. The moist heat that is created will help destroy harmful bacteria and will ensure uniform cooking.



# MBTA Board approves contract with Boston Carmen's Union (Local 589)

#### Staff Report

The MBTA Board unanimously approved of a new contract between the MBTA and the Authority's largest union, the Boston Carmen's Union (Local 589).

"This contract acknowledges the invaluable contributions of thousands of MBTA employees charged with providing safe and reliable service on a daily basis," said MBTA General Manager Steve Poftak. "I want to express my sincere gratitude to all of the Authority's unionized employees. The successful contract negotiations reflect our joint desire to maintain and grow a workforce that will allow the MBTA to deliver the levels of service necessary to meet ridership demands, today and in the future."

The contract and its provisions are in effect for two years, beginning July 1, 2021, and lasting through June 30, 2023. Included within the contract are provisions for annual wage increases of 2.5% on July 1 of 2021 and 2022.

The contract also includes a provision for a "pandemic payment." Every Local 589-represented employee employed during the declared pandemic period (March 15, 2020, to July 1, 2021) will receive a one-time payment of \$2,000. Employees who retired during this period will receive a pro-rated share.

The new contract also addresses the current staffing challenges facing the MBTA. In order to

recruit new hires into the positions of bus and train operators, the MBTA may offer a signing bonus of any amount, to be paid in a manner set by the Authority. Should the MBTA pay such a bonus, the same bonus shall be offered to any incumbent who was hired within the preceding six months from the time the hiring bonus is paid to any new hire.

This new contract increases the training wage paid to MBTA recruits as they get their Commercial Driver's Licenses (CDL), learn to be an operator on the MBTA system, and play a vital role in getting the people of Massachusetts to work, home, and everywhere in between. Under this new contract, people with good driving records and a high

school diploma or General Educational Development (GED) test can in eight weeks receive their CDLs and become MBTA bus drivers making over \$33,000 per year with the opportunity for overtime, tuition reimbursement, medical and dental benefits, a pension, and career growth opportunities.

The contract also includes a provision for a "diversion payment." Every Local 589-represented employee who is on the active payroll on March 1, 2022, will receive a onetime diversion payment of \$2,500. In return for this payment, the MBTA is permitted to outsource diversion/shuttle bus work beyond the limits outlined in the December 2016 Letter of Understanding. This exemption is tempo-

rary and expires on February 28, 2024.

The contract included an update to paid holidays. Juneteenth National Independence Day will replace Bunker Hill Day as a guaranteed paid holiday under the Agreement.

The contract also included an update to paid personal leave. Effective January 2022, all full-time and part-time employees will receive two paid personal days per year, which are not subtracted from sick leave, regardless of the employee's service and sick leave usage. Previously, employees received one day, provided they had two years of service and 50% of their sick leave bank unused; the personal day was also subtracted from the individual's sick leave bank.

The contract was also updated in an effort to reduce the number of part-time employees. The MBTA currently employs 470 part-time Operators represented by Local 589 Under the Management Rights Statute, the Union is prohibited from negotiating any limit on the MB-TA's right to hire part-time employees. The contract provides an incentive for the MBTA to convert parttime Operators to full-time Operators by establishing "Special Class Runs." A Special Run will be picked and performed under the same terms as all other full-time assignments, including a 40-hour weekly guarantee, overtime, and full benefits.

# District Attorney Rollins releases updated guide for homicide survivors

As Survivors of Homicide Awareness Month comes to a close. District Attorney Rachael Rollins released an updated Survivors of Homicide Victims Resource Manual designed to ensure that those who have lost loved ones to violence have access to vital information and resources.

"Serving survivors is central to the work of the office I lead, not just during Survivors of Homicide Victims Awareness Month, but always. We honor those who have been stolen and support the loved ones left behind at every step of their long journey toward accountability and healing," District Attorney Rollins said. "In the wake of their loved one's violent death, homicide survivors encounter prosecutors, victim witness advocates, police detectives and service providers - all of whom offer vital information to survivors as they are reeling and experiencing profound trauma and grief. This newly updated manual is a tool that survivors can use and refer to on their schedule to ensure they always have information and access to the services and resources they are entitled to and may

require."

The manual was first drafted in 2003 under the leadership of former Chief of SCDAO's Victim Witness Assistance Program (VWAP) Kara Hayes. Hayes is a valuable partner in this space and currently serves with distinction as the office's Director of Restorative Justice a valuable resource, with details on service providers, contact information for involved agencies and the team assigned to their loved one's case, other guidance and helpful information.

Current VWAP Chief Charlene Luma led the effort to update the manual. The new edition now includes information for survivors of individuals who die during encounters with members of law enforcement. It also provides information on the Project for Unsolved Suffolk Homicides (PUSH), an initiative launched by District Attorney Rollins to review unsolved homicide case files with fresh eyes. Since the inception of PUSH, SCDAO staff have reviewed approximately 200 case files and the office has secured indictments against three individuals in unsolved homicides that occurred in the 1980s and 1990s.

The previous manual was only available in

English. Now, the updated manual will also be available in Spanish, Cape Verdean Creole, Haitian Creole, Chinese and Vietnamese. This will ensure that more Suffolk County families that unfortunately experience the tragedy of a homicide will have equal access to information and resources. In addition, under the Rollins Administration and the excellent management of Luma, approximately 50 percent of the outstanding VWAP staff speak at least one language in addition to English.

As part of her office's recognition of homicide survivors, District Attorney Rollins earlier this month hosted the SCD-AO's 11th annual Survivors of Homicide Breakfast. The event is held each year during Survivors of Homicide Victims Awareness Month, which runs from November 20 to December 20. This marked District Attorney Rollins' third year hosting the event and the second year that the breakfast was forced to be held remotely due to the pandemic. District Attorney Rollins and members of her office were joined on the virtual event by Boston Mayor Michelle Wu, who spoke during the ceremony; incoming Boston City Council President Ed Flynn; Boston City Councilors Michael Flaherty and Kenzie Bok; Senator Sal DiDomenico; as well as numerous members of law enforcement, community partners and service providers. During the event, District Attorney Rollins honored three survivors of homicide who have turned their profound grief into action serving fellow survivors and their communities. This year's honorees were Beverly Parham-Jordan, Debra Johnson and Ruth Rollins. This year marked the first time any awards were presented during the event.

"The holidays can be one of the most difficult times of the year for survivors of homicide. It's important that we remember those stolen by violence and their loved ones left behind to pick up the pieces. It is important that we honor victims and survivors," District Attorney Rollins said. "No matter my title, I will always stand beside those who have lost loved ones to violence and ensure that they have the support and resources that they are entitled to and often desperately need. I'm grateful to our partners in law enforcement – especially the **Boston Police Department** Homicide Unit and the

Suffolk County State Police Detective Unit - for their tireless and diligent work supporting survivors and holding accountable violent individuals that harm and have taken a life."

During 2021, the City of Boston has experienced a decrease in serious and violent crime, including a large drop in homicides. To date, there have been 43 murders in Boston during 2021 - notably lower than the five-year average of 51 murders a year. These reductions are a testament to the strong partnerships between local, state and federal law enforcement agencies.

"But one homicide is too many," District Attorney Rollins said. "These numbers are in no way meant to minimize the trauma and harm survivors of homicide endure. Rather, we strive to continue disrupting violence with The Crime Strategies Bureau - instilling hope with PUSH and the indictments we have secured - and offering transparency - with the first-in-thenation Discharge Integrity Team."

Tragically, this year Suffolk County has also experienced 37 motor vehicle homicides; the hate-fueled double homicide of Staff Sgt. Ramona Cooper and retired State Trooper David L. Green in Winthrop; and three murders in Chelsea, including the domestic violence murder of Paula Andrea Ortiz Ramirez whose estranged husband is expected to be arraigned tomorrow on a murder charge in his hospital bed at a local hospital, the beating death of Geraldo Mendoza Bonilla and the fatal stabbing of Cyndell Rodriguez.

Homicide and acts of violence deeply impact entire communities. The Boston Public Health Commission's Boston Trauma Neighborhood Team (NTT) provides access to support through its 24/7 hotline by calling 617-431-0125. The NTT offers immediate support services to those impacted by community violence. referrals for behavioral health services, community outreach and healing groups and a variety of other services.
