### AG HEALEY ADVISES PUBLIC ABOUT 2022 MINIMUM WAGE INCREASE

Attorney General Maura Healey is reminding employees and employers that the state's minimum wage increased to \$14.25 per hour beginning Jan. 1.

The AG's Office has also made available its wage and hour poster that employers are required to display in both English and any other language that is spoken by five percent or more of the employer's workforce and for which a translated notice in that language is available from the AG's Office. The poster is available in seven languages and in formats that employers, workers, members of the public, and organizations can easily access, free of charge.

"Our Fair Labor Division remains committed to protecting the rights of workers and ensuring they are being paid the wages they are legally entitled to, especially as we continue to work our way through the COVID-19 pandemic," said AG Healey. "We are issuing this notice and providing multilingual resources so that employees and employers are aware of the upcoming minimum wage increase in Massachusetts and worker rights under our wage and hour laws."

In June 2018, Massachusetts...

### Tye begins seventh decade serving school committee

Carol Tye began her work in the Revere school system as a substitute teacher in the spring of 1960.

"I was hired the following year and began teaching at Revere High School," related Tye. "I taught English and geography then. The next several years I taught English and Latin, and then strictly English from then on."

Tye became assistant superintendent of the Revere schools and was appointed superintendent of schools for the 1994-1995 academic year.

Monday night at the city's inauguration ceremony, Carol Tye took her oath of office as a member of the Revere School Committee. Interestingly, Tye was the first newly elected official to arrive for the ceremony, entering the Council Chambers more than a half hour in advance of the 7 p.m. ceremony.

### Revere Schools reopen after winter break on time

While some school districts delayed reopening after the winter vacation because of staff shortages due to the COVID-19 pandemic, all Revere Public School reopened Tuesday without a hitch.

Revere Superintendent Dr. Dianne Kelly reported that 76 percent of all students returned from the break and 90 percent of the staff.

With Revere's seven day COVID case average at 263, daily new cases at 276 and a 14 day positive test rate at 11.1 percent many feared school would be heading into uncharted territories in the wake of the ongoing winter surge. The worst fear among some parents was that schools may begin examining a return to remote learning until the ongoing

Committee Monday night. "Aisha Milbury Ellis was one of my most brilliant students," said Tye. "She was in my sophomore honors English class. She was a wonderful girl, a real star."

Looking at the new City Council, Tye said she taught Ward 3 Councillor Anthony Cogliandro's

mother, Doreen, when Doreen was a student at Revere High. "I also taught with Doreen at the high school," said Tye.

# Special State Senate final Election is set for Tuesday

Revere residents will go to the polls Tuesday, Jan. 11, for the Special State Senate Final Election.

Boston City Councilor Lydia Edward is the lone candidate on the final ballot, having won the Dec. 14 Democratic Primary.

School Committee member Anthony D'Ambrosio also sought the Democratic nomination in what was an exciting election. There is no Republican candidate on Tuesday's ballot.

Edwards will succeed Joseph Boncore as state senator for the district that includes Revere and Win-

throp, and parts of Boston and Cambridge.

Election Commissioner Diane Colella said that all polling locations in the city will be open from 7 a.m. to 8 p.m.

**Colella's final election as commissioner**  
Tuesday's State Senate

election will mark the final chapter in the outstanding career of Election Commissioner Diane Colella, who is stepping down after 21 years as the head of the Revere Election Department.

New Election Commissioner Paul Fahey is succeeding Colella in the key

leadership position.

"It's been an honor and a pleasure," said Colella. "It's bittersweet. It's mostly all the wonderful people you meet, that have helped me so much. I want to thank all the workers at City Hall. I'm very happy that the staff and the electoral process are going to

be in good hands under Paul's direction. And it's nice knowing that my poll workers and everything is going to be okay here."

Colleagues will honor Colella at a farewell celebration Friday, Jan. 14.

# Supt. Kelly eyes using some school days for student-teacher engagement

After the better part of the 2019/2020 and the 2020/2021 school years being remote due to the ongoing COVID-19 pandemic it is no secret the return to school this year has not been easy for students and teachers.

"I am becoming concerned as I think you've all heard across the country, that teachers are incredibly stressed out," said Revere Public School Superintendent Dianne Kelly at the last Revere School Committee meeting. "And

I think part of that has to do with the fact that the kids are really stressed out. I feel like the school district is just in a pressure cooker and one thing is going to set it off. We've all heard a lot from parents about the anxiety that kids are experiencing and the perception that there is a lot of strife happening in the schools. We know our staff is stressed and we see in their attendance rates that they're stressed. That has been kind of having a cyclical effect. If teachers are out and we don't have enough subs, the teachers

who are left are having to hold everything up. Then they become more stressed and more tired and I just think we should really think about creating a little bit of relief for everybody."

An idea that Dr. Kelly and Revere High School Principal Dr. John Perella have been mulling repurposing some of the 182 required school days as an opportunity for teachers and students to connect on different levels.

"There's been some movement around this in other parts of the state and

other parts of the country," said Kelly. "If we could capture some time and maybe think about doing some half days—we still need to do the same number of hours—so I'm not looking to forgive days. What I would like to do is repurpose some of that time and do half days. This idea actually came from talking to Dr. Perella after what happened with the student (walk out) at the high school and we were thinking it would create opportunities not just for teachers to do professional development but also time for students and teachers to engage in ways that are different than they do right now—more on relationship building and how how students and

teachers can partner together with administrators to foster a kind of building culture where everybody does feel safe and included and heard."

Kelly said by giving students, teachers and administrators the time to do some relationship building work and do some social emotional learning it would be beneficial to everybody.

"I'm not looking for this decision to be made right now," said Kelly. "I think we have some time to think about it. I think March, when we have that long stretch of no vacation time from February to April, might be a good time for us to look at it. But I wanted to discuss that idea with the School

Committee tonight so that you'd all have time to think about it and talk to your constituents and see what people think."

The suggestion to the School Committee was applauded by member Carol Tye.

"I think that's an excellent idea," said Tye. "There's all kinds of education and it doesn't have to be a day where everybody's in class and doing Math or English or whatever. I can see the crying need so I certainly would be really very happy to participate in finding a schedule that we could work with. I think the suggestion about the half days is really a good one."

surge of the Omicron variant of the virus slows.


However, Tuesday was smooth sailing according to Kelly who said, "all went well" as thousands of students returned to school.

One initiative that may have helped a safe return to school was the deliv-

ery of 7,000 Covid-19 self test-kits to all Revere Public School students ahead of the break by Mayor Brain Arrigo, Revere Public Health Director Lauren Buck and Kelly. This pro-action was designed for the many contacts students and their families may encounter over the

holiday vacation. Each kit had two tests with health officials asking that one of the two be kept for the day of returning to school.

Similar efforts were taken in neighboring cities like Boston in order to ensure a safe return to school after winter break.

## IF COVID-19 HAS A BRAIN, IT'S MUCH SMARTER THAN US

We don't pretend to be experts in biology -- and maybe we've been watching too many science fiction movies these days -- but the ability of the COVID-19 virus to mutate (or shape-shift, in the lingo of sci-fi fans) in order to make itself both more transmissible and more evasive of vaccines makes us wonder: Does COVID-19 possess intelligence?

If COVID-19 has a brain, it clearly has a much-higher IQ -- and more common-sense -- than the large number of human beings who refuse to get vaccinated and who do not take precautions to avoid the disease.

New statistics reveal that the death rate has risen particularly sharply for middle-aged white people. COVID-19 now accounts for a much larger share of all deaths for that group than it did before vaccines were widely available. To paraphrase the motto on New Hampshire license plates, some people choose to live free -- AND die,

There always will be a certain number of humans who do stupid things every day that result in their own deaths -- and those who are unvaccinated by choice fall into that category.

But in most places, the unvaccinated thankfully represent a small minority of people.

On the other hand, the new Omicron variant is sickening even those who are vaccinated at a rate much greater than at any time since the start of the pandemic. Up until the past few weeks, vaccinated persons were told they could feel fairly confident in the immunity supposedly conferred by the vaccines.

While it may be true that vaccinations still are hugely successful in limiting the number of deaths and serious illnesses requiring hospitalization, Omicron has upended the best-laid plans of even the most-cautious and health-conscious among us as we try to return to normal life.

The onslaught of the Omicron variant has affected almost every aspect of our daily lives, from travel to schools.

So does COVID-19 have a brain? Who knows?

But what we do know is that no matter what we throw at it, COVID-19 always is one step ahead of us.

## ON THE BRIGHT SIDE.....

The lengthening of the daylight hours is imperceptible at first.

The least amount of daylight occurred on December 22, clocking in at nine hours, seven minutes. But by the end of this week, January 8, we'll have nine hours and 19 minutes of daylight, an increase of 12 minutes.

That may not seem like much, but it's noticeable when we go outside to take our sunset photos and realize that the sun is setting later each and every day.

The trend toward longer days will begin to accelerate, so that on January 30, we'll have exactly 10 hours of daylight.

Public health experts tell us that the next six weeks or so will be very difficult because of the impending widespread impact of COVID-19 thanks to the Omicron variant.

But as our days get longer and we get to enjoy more daylight, at least we will have something to brighten -- literally and figuratively -- the dark days that lie ahead.

Massachusetts enacted a law that set the minimum wage to increase each year until it reaches \$15.00 in 2023. Tipped employees will also get a raise on Jan. 1, 2022, and must be paid a minimum of \$6.15 per hour provided that their tips bring them up to at least \$14.25 per hour. If the total hourly rate for the employee including tips does not equal \$14.25 at the end of the shift, the employer must make up the difference.

The Attorney General's Fair Labor Division enforces laws that protect workers, including minimum wage, timely payment of wages, overtime, earned sick time, child labor, Sunday and holiday premium pay, and the public construction bid and prevailing wage laws. During the Fiscal Year 2021, the Division assessed more than \$8.1 million in restitution and penalties against employers on behalf of working people in Massachusetts.

## PRESSLEY TESTS POSITIVE FOR COVID-19

Congresswoman Ayanna Pressley (MA-07) is-

sued the following statement after receiving a positive COVID-19 test result.

"After experiencing COVID-like symptoms, this morning I received a positive, breakthrough COVID-19 test result. Thankfully, my symptoms are relatively mild, and I am grateful to be fully vaccinated and boosted. I am currently isolating and following all health protocols in order to mitigate further spread and keep my loved ones and community safe.

"Vaccines save lives. With this unprecedented pandemic continuing to rage, I am deeply grateful for the scientists, researchers, and frontline healthcare workers who have worked tirelessly to develop vaccines that are safe and effective, and ensure that our communities are protected. I encourage everyone to do their part by getting vaccinated, boosted and masking up. I wish everyone a safe and happy new year and look forward to continuing to fight for the robust relief our communities in the Massachusetts 7th need and deserve."

## TRIAL COURT ANNOUNCES CHANGES TO COURT OPERATIONS

In response to the current situation in the Commonwealth with respect to COVID-19, the Trial Court today issued an order that outlines changes to court operations. Massachusetts trial courts will remain physically open to the public to conduct business and will operate in accordance with protocols that enhance the health and safety of court users and personnel.

The order and related operational guidance issued to the Trial Court today include the following:

- Remote court operations shall be used whenever possible. Courts may continue to hold in-person proceedings in matters where a virtual proceeding is not practicable or would be inconsistent with the protection of constitutional rights.

- Trial Court departments shall reduce the number of staff working in person to no more than 50% of the total number of staff at a time and should separate their staff into not less than two teams that will alternate their time working in-person and remotely as deemed necessary by the department head. Security, Facilities and ELMO shall be exempt from the 50% reduction based upon job function.

The Trial Court also issued additional health screening protocols and updated information on masking in courthouses. Beginning on Monday, January 3, 2022, the Trial Court will re-introduce the use of screening questions to determine if anyone entering a courthouse, including court staff and the public, has a temperature, is feeling unwell, or has received a positive COVID-19 test, has been exposed to COVID-19, or has symptoms.

The Trial Court mask requirement will remain in effect. Employees, court

users and other individuals who work in or visit a courthouse must wear masks that completely cover the nose and mouth and fit snugly against the sides of the face with no gaps. The use of gaiters, bandanas, or face shields will not be allowed as a substitution for a mask. Court Officers will enforce the requirement to properly wear a mask for court visitors. The Trial Court will provide a mask to those who do not have an acceptable mask when entering a courthouse once the Trial Court Security Department has a sufficient quantity for distribution.

## SUPREME JUDICIAL COURT ISSUES NEW ORDER PAUSING

In response to the current situation in the Commonwealth with respect to COVID-19, the Supreme Judicial Court (SJC) today issued an order pausing all jury trials in Massachusetts state courthouses until January 31, 2022. All courts otherwise will remain open for in-person business, with a continued emphasis on conducting matters remotely whenever possible.

Today's order partially amends the existing order regarding court operations during the pandemic, which was issued by the SJC on July 1, 2021 and became effective July 12, 2021.

### Baker-Polito Administration announces release of the 2021 Ocean Management Plan

Staff Report

The Baker-Polito Administration announced the release of the final 2021 Massachusetts Ocean Management Plan. Authorized by the Oceans Act of 2008, the ocean plan protects critical marine habitat and important water-dependent uses, and sets standards for ocean-based development. Under the Oceans Act, the ocean plan is required to be reviewed at least every five years, and the 2021 ocean plan now supersedes all previous plans.

“The newly released 2021 Massachusetts Ocean Management Plan provides important updates to the Commonwealth’s framework for balancing ocean uses and resource protection,” said Governor Charlie Baker. “This update and amendment effort ensures the ocean plan continues to incorporate the best science and evolving policy perspectives for sound ocean resource management.”

“Ocean resources are of critical importance to our economy and way of life in Massachusetts,” said Lieutenant Governor Karyn Polito. “The 2021 ocean plan showcases our Administration’s commitment to proactively and constructively manage evolving ocean uses to meet the needs of our citizens and communities.”

The original Massachusetts Ocean Management Plan, released in 2009 in response to the Oceans Act of 2008, established protections for critical marine habitat and important

water-dependent uses in the Massachusetts Ocean Management Planning Area and set siting and performance standards for specific ocean-based development. The Oceans Act requires the Executive Office of Energy and Environmental Affairs (EEA) to review the ocean plan at least once every five years — a process led by the Office of Coastal Zone Management (CZM) and supported by input from the Ocean Advisory Commission, Ocean Science Advisory Council, technical work groups and a significant public engagement process. The final 2021 ocean plan contains revised maps of special, sensitive, or unique resources and water-dependent uses, a current assessment of the status and trends in ocean conditions and a Science Framework to ensure progress on key ocean management priorities over the next five years.

“Through the release of the 2021 ocean plan, the Baker-Polito Administration affirms its dedication to the responsible stewardship of ocean resources, which are critical to the state’s prosperity and to the protection of state ocean waters,” said Energy and Environmental Affairs Secretary Kathleen Theoharides. “The 2021 ocean plan would not have been possible without the dedication of many individuals and organizations, and I would like to personally thank all of these contributors for their commitment to ensuring the ocean plan meets the needs of

the Commonwealth’s citizens, today and into the future.”

“The Massachusetts Office of Coastal Zone Management is committed to balancing the impacts of human activity with the protection of coastal and marine resources,” said CZM Director Lisa Berry Engler. “We at CZM are proud to play a leading role in ensuring the ocean plan remains an evolving document, revised periodically to adapt as better information and science is developed, policy goals evolve and experience in applying the management and administrative framework is gained.”

The review and update for the ocean plan was initiated in 2019. The process was led by CZM on behalf of EEA and supported by the Ocean Advisory Commission, Ocean Science Advisory Council, technical work groups, stakeholder groups and public participation. In December 2020, the Review of the 2015 Massachusetts Ocean Management Plan was completed and published, launching the development of the 2021 ocean plan through continued expert and public input. Then on September 22, 2021, CZM issued the Draft 2021 Massachusetts Ocean Management Plan for public review, including four hearings and a 60-day public comment period, leading to today’s release of the final 2021 ocean plan. 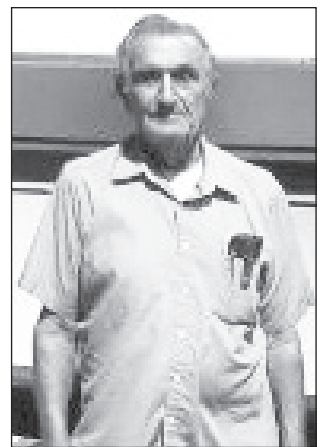
### Thomas Ciulla

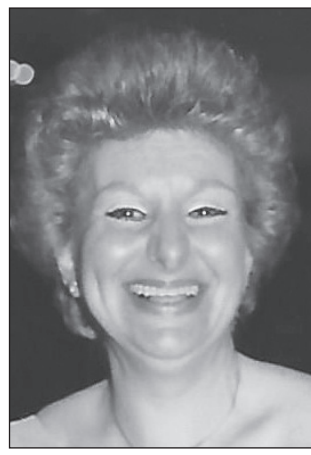

### 10 years ago Jan. 4, 2012

Dan Rizzo's inaugural Monday night inside the Revere High School auditorium was an extraordinary affair by every standard of measure. A festive, well-dressed throng packed the huge auditorium, with very likely close to 1,000 people on hand. Rizzo's inaugural kickoff dwarfed similar events staged many years ago by former mayors Robert Haas and Tom Ambrosino at the beginning of their respective administrations. The giant crowd stood and cheered as the new mayor led the members of the City Council and the School Committee down the center aisle onto the stage. Everyone was given their oaths by District Court Justice Roberto Ronquillo. Rizzo delivered a speech that outlined a handful of new initiatives and promised that Revere's finest days were yet to come. Probably most notably, Rizzo said he was excited about the prospects of casino gaming coming to Revere. Rizzo is the 27th mayor of Revere and the first new mayor to take office in more than a decade.

The Revere City Council inaugurated two new councilors – including the youngest citywide councilor in history – and nine incumbents at the grand inauguration ceremony Monday night. Coming on as new members of the council were Brian Arrigo

and Jessica Ann Giannino, with Giannino being the youngest ever elected citywide. Both are at-large councilors. Taking the oath as incumbents were Ward 1 Councilor Richard Penta, Ward 2 Councilor Ira Novoselsky, Ward 3 Councilor Arthur Guinasso, Ward 4 Councilor Stephen Reardon, Ward 5 Councilor John Powers, Ward 6 Councilor Charlie Patch, and at-large councilors Bob Haas, Tony Zambuto and John Correggio. The Revere School Committee also took the oath of office on Monday, and the all-incumbent field included Michael Ferrante, Dan Maguire, Donna Wood Pruitt, Stacey Rizzo, Fred Sannella and Carol Tye. The ceremony began with rousing vocal numbers by Sgt. Dan Clark – a former State Trooper and former U.S. Marine. Clark, who has performed for many years on Veterans Day at the Paul Revere School, did hand-clapping renditions of songs related to the armed services and the patriotic favorites. The ceremony on Monday was officially in tribute to the country's armed services.

### 30 years ago Jan. 8, 1992

Robert J. Haas Jr., was sworn in as the city's third Plan B mayor Monday. Haas promised in his inaugural address an open and innovative administration. The ceremonies saw the return of the tradition-

al inaugural ball, the first since 1973, with 1000 persons on hand at Wonderland Ballroom. The event was paid for by the new city officeholders, who each contributed \$100.

Ward 2 City Councilor Robert Penn is the new President of the City Council and Thomas Ambrosino is the new Chairman of the School Committee.

### 40 years ago Jan. 6, 1982

Austere swearing-in exercises were held Monday. Mayor George V. Colella was sworn in for his sixth term as the Plan B mayor. Colella said in his inaugural address that city workers will bear the brunt of the budget cutbacks which are being imposed because of Prop. 2 and 1/2.

Police arrested several persons who were drinking in the parking lot at Jacob's Ladder as part of a crackdown on drinking in parking lots at liquor establishments in the city.

### 50 years ago Jan. 6, 1972

New Mayor William G. Reinstein pledged in his inaugural address to be responsible to the people as he took over the reins of city government as the second Plan B Mayor in impressive inauguration ceremonies held in the City Hall auditorium. Reinstein noted at the start of his address that his 11 month-old daughter, Kathi Anne, had to leave the hall because even though she

normally is a quiet baby, she starts to talk and gets louder and louder whenever her father begins to speak. More than 5000 people then crowded into Wonderland Ballroom for the traditional Inaugural Ball in the evening. Francis Doris, the top vote-getter in the election, was elected president of the City Council.

The 27th Lancers Drum and Bugle Corps put Revere on the map with their performance at halftime in the Orange Bowl on national TV at the AFC championship game between the Baltimore Colts and the Miami Dolphins. The Lancers were given a stellar introduction by TV announcer Curt Gowdy.

Defeated mayoral candidate and former City Councilor William DiCarlo was elected to the School Committee to fill the unexpired term of Louis Cheako Ciarlone at a joint meeting of the School Committee and City Council.

### 60 years ago Jan 4, 1962

Revere's city officials were sworn into office on Monday, New Year's Day, before a capacity crowd in the City Council chambers. Only one ballot was cast by the council to elect a mayor, but all members voted for themselves, thus necessitating further balloting at a later date.

## Unemployment Insurance Trust Fund Reconciliation Report released

Staff Report

The Commonwealth of Massachusetts today released a report from KPMG, LLP summarizing the findings of a reconciliation project that examined the finances of the Unemployment Insurance (UI) Trust Fund. The Executive Office of Labor and Workforce Development commissioned KPMG to conduct this independent assessment to determine the impact of federal pandemic relief programs and other effects of the COVID-19 pandemic on the financial status of the Commonwealth's unemployment system and the UI Trust Fund balance for the period from the beginning of the pandemic in March, 2020 through November 30, 2021.

The report outlines the steps KPMG took to evaluate the balance of the UI Trust Fund and provides an overview of the current status of the fund, including the effects of several outstanding financial obligations on the Trust Fund. These obligations include the necessary repayment of federal advances that ensured the Fund's solvency in 2020 and currently outstanding employer credits resulting from a mid-2021 downward adjustment in UI rates. The report also identifies the need for a one-time transfer of approximately \$300 million from funds currently held in the UI system to the federal government to reconcile state and federal accounts now that emergency programs implemented under federal authority in 2020 and 2021 have come to a close.

As of November 30, 2021 the unadjusted UI Trust Fund balance was reported at \$2.94 billion. The KPMG analysis concludes that this reported balance needs to be assessed in light of outstanding federal loan obligations, outstanding employer credits, and a future additional reimbursement due to the federal government. When these adjust-

ments are factored in, the KPMG analysis concludes that UI Trust Fund had a \$115 million structural deficit at the time of the reporting period. The details of these adjustments are as follows:

- Outstanding Federal Loans: Massachusetts owes \$2.3 billion in outstanding loan obligations, due in November 2022, to the federal government to repay necessary borrowing during the pandemic.
- Outstanding Employer Credits: The reported UI Trust Fund balance includes \$415 million in employer credits that were the result of the mid-year reduction in 2021 employer UI rates. Net 2022 Employer contributions will be reduced by application of these 2021 Employer credits.
- Future Federal Adjustment: The Commonwealth anticipates it will need to make a future one-time transfer of approximately \$300 million to the federal government to reconcile automated bank returns of benefits issued from various state and federally funded UI programs. EO-LWD is currently awaiting guidance from USDOL regarding administrative procedures to process this reconciliation.

This report does not include the effects of legislation recently signed by Governor Baker that will invest \$500 million to stabilize the UI Trust Fund. The report's assessment of the UI system's current financial position underscores the importance of this investment, given the unprecedented impact of the pandemic on the unemployment system and the need to ensure continued solvency to be able to pay claims in the future.

The comprehensive accounting of the UI Trust Fund balance and financial position will also inform the Commonwealth's efforts to issue bonds that will support the repayment of the federal advances that were authorized in 2020 and begin to restore the UI Trust Fund to a more solvent level.

## Wellness, not weight loss: Advice for starting the new year off right

For many of us, New Year's resolutions like quitting smoking, getting organized or losing weight are sweeping lifestyle changes, which often fail after a few days or weeks. At the Center for Weight Management and Wellness at Brigham and Women's Faulkner Hospital, experts in nutrition and wellness coach patients to focus on making changes that can be sustained for improved health in the long-term.

Registered dietitians Jenna Koroly, MS, RD, LDN, and Ema Barbosa Brown, MPH, RD, LDN, offer this advice: When considering your goals for the new year, start with small changes.

"If you are not currently in an exercise routine, setting a goal of working out five times per week for 30 minutes can be intimidating and challenging to maintain," says Koroly. "Instead, start with small bursts of physical activity that you enjoy, such as 10 minutes of walking each day or a 15-minute Zumba video three times per week."

When it comes to nutrition, the advice is the same:

Increase the amount of vegetables and fruit you eat per day. Vegetables and fruit contain beneficial vitamins, minerals and naturally occurring compounds called phytochemicals that help to reduce chronic disease risk. One serving of vegetables is 1 cup of raw vegetables or ½ cup of cooked vegetables. One serving of fruit is about ½ to 1 cup. See if you can gradually increase to 3 to 5 servings per day of vegetables, and 2 to 3 servings per day of fruit. Try meals such as zucchini noodles with turkey meatballs, a cauliflower rice stir fry or oatmeal

with berries to increase you intake of vegetables and fruits.

Try something new. If you don't like vegetables or generally don't add them to your grocery list, try adding one new vegetable to your grocery list each week for four to eight weeks alternating between red/orange, purple and other colors, leafy greens and root vegetables. Vary the ways you prepare your vegetables for interest and palatability. You may choose to eat them raw (green salads, celery/cucumber/carrots with low fat dip), steamed (broccoli and zucchini), stir-fried (yellow bell peppers, sugar snap peas, carrots, mushrooms, baby corn, water chestnuts), roasted (sweet potato, red onions, bell peppers, scarlet turnips, beets, snap peas), baked (acorn squash, sweet potatoes) or added to stews and soups (yuca, collard greens, yellow squash, yautia/malanga, Brussels sprouts).

Vary your micronutrients and fiber. Do the same with fruits regarding color, taste and texture to vary the micronutrients and fiber they provide to enrich your eating pattern. Try a new fruit each week for several weeks until

fruit becomes part of your weekly grocery list. Eat fruit as a snack, dessert or as part of a meal such as a fruit/yogurt smoothie for breakfast, cut up fresh fruit or canned fruit added to your salad or mashed bananas in your pancakes.

Make nutritious snack options more accessible. Keep a bowl of fruit on the kitchen counter, pre-portioned packages of nuts towards the front of the cupboard or in a drawer at work and Greek yogurts in the fridge to encourage yourself to reach for the healthy options. Consider a cupboard cleanout so there are nutritious options for everyone in the family.

Aim for mini sweet treats. The first few bites tend to be the most satisfying as our taste buds fatigue with additional bites. This can help you stay on track with your goals without depriving yourself of your favorite foods.

Koroly and Brown say the small changes approach can also be applied to other areas of your life.

"Stress management is key to a healthy lifestyle," says Brown. "I encourage my patients to aim for 10 to 30 minutes of self-care per day depending on their schedule. Deep breath-

ing, meditation, physical activity, laughing with loved ones and listening to soothing music can all help to manage stress. Self-care may also include taking a nap when needed, going to sleep earlier or taking a warm bath."

It's also important to stay connected with friends and family by eating one daily meal together. If you live alone, try connecting with loved ones at a mutually agreed upon place (restaurant, place of worship, library, mall, park) or via video chat.

With these small changes, you'll be sure to enjoy 2022 from January through December!

#### RHS GIRLS DEFEAT DANVERS IN TOURNEY

The Revere High girls basketball team turned in a solid, two-way performance to earn a 42-35 victory over Danvers in the consolation game of the North Reading Holiday Invitational tournament last week.

The triumph marked a nice rebound triumph for coach Chris Porrazzo and his squad after falling to host No. Reading in the opening game of the tournament. In that encounter, the Lady Patriots battled well through the first period and for half of the second, but No. Reading went on a run before the half to turn what had been a closely-fought, four-point contest into a 27-9 advantage for the host team at the intermission.

Although Revere cut into the deficit in the final 16 minutes of play, the Lady Patriots were unable to overcome the large No. Reading lead.

"We worked hard in the second half, but ultimately came up short," said RHS head coach Chris Porrazzo.

Skyla DeSimone led the way for Revere in the scoring column with 13 points.

The Lady Patriots then took on Danvers, which had dropped its tourney-opener to Wakefield, in the consolation game and bounced back to claim a victory over their former rival from the Northeastern Conference.

Revere was in control for most of the game, opening up as much as

a 13-point lead, but the Lady Falcons fought back to move out to a two-point advantage late in the fourth period.

However, that's when RHS sophomore captain Haley Belloise stepped up to the free throw line and sank two clutch free throws to tie the game. Revere made a strong defensive stop on Danvers' next possession and with under two minutes to play, freshman Belma Velic kicked out a beautiful pass from the post to senior captain DeSimone, who knocked down a three to give the Lady Patriots the lead back for good.

"We were disappointed with our performance against North Reading, so we knew we had to come back and make a statement in our consolation game against Danvers," said Porrazzo. "We were determined to prove to ourselves that we belonged with the other three talented teams that were a part of the tournament.

"I was so proud of us for competing in this game and pulling out a win," the coach added.

DeSimone finished with eight points and five steals and was named to the tournament all-star team.

Belloise hit for 14 points to go with six rebounds and two assists. Belma Velic was a force at both ends of the floor. Belma turned in a nice double-double with 10 points and 10 rebounds and blocked five Lady Falcon shots.

RHS BOYS BASKETBALL TOPS PIONEER CHARTER IN DAVID GREEN TOURNEY

The Revere High boys basketball team traveled to Winthrop High School last week to compete in the first annual David Green Memorial Holiday Tournament, which is named after the Winthrop native, who was a retired State Trooper, who was shot in a heinous hate crime last summer in Winthrop in which Green and another Black person, Ramona Cooper, were murdered by a 28 year-old Wareham native who had white supremacist literature in his personal belongings. Green was a star athlete for the Vikings' basketball and track teams in the early 1970s.

Coach David Leary and his crew took on former Northeastern Conference (and former Greater Boston League) rival Peabody in the opening round of the tourney last Tuesday, coming out on the short end of a 43-40 decision

that went down to the final seconds.

The Patriots, who had not played a game in 16 days because of a postponement against Lynn Classical the week before Christmas, came into the contest without their full team because of health and safety protocols.

"We had some guys out because of injury and illness, but we always talk about guys stepping up when opportunity knocks," said Leary, who had only eight players available for the encounter.

A slow pace at the start helped the depleted Patriots conserve energy. Peabody jumped out to a 5-2 lead midway through the first quarter as both teams struggled to find their shooting touch.

Revere senior tri-captain Jack D'Ambrosio had two nice fast-break layups and sophomore forward Glenn Kule made a free throw to give Revere the lead, 7-5, to end the frame.

The Patriots were doing a nice job in their zone press and seemed to confuse the deeper and more experienced Tanners, as the second quarter was more of the same with very little scoring. Junior forward Vincent Nichols (six points) made 4-of-4 free throws in the quarter, senior center Kenny Arango chipped in a free throw of his own, and junior guard Sal DeAngelis made a deep three-pointer to give Revere a slight (17-15) halftime lead.

Peabody came out in the second half with a distinct focus to rely on the three-point shot and the Tanners had success, sinking five treys to move out to a 29-19 lead with four minutes remaining in the third quarter.

Leary called a timeout to slow the Tanners' momentum and it seemed to work. Patriot senior forward Ramadan Barry (six points) drained a three-pointer and DeAngelis (18 points, five rebounds, four assists) began to get going,

sinking three baskets in the third, but Peabody led 33-25 heading into the last quarter.

The first few minutes of the final frame continued to be a challenge to score for both teams until Barry made a nice drive and junior guard Domenic Boudreau (two points, seven rebounds) made a nice put-back for the Patriots, cutting into the Peabody lead and making it a 39-35 affair with 2:21 to play.

The two teams had empty possessions on offense and then Peabody made a free throw to push their lead to five points with under a minute to play. Revere came out of a timeout and executed a nice set play to get DeAngelis open for a shot and he was fouled. Sal made both free throws and after a great Patriot defensive stop, DeAngelis pulled up for the tying three-pointer with 26 seconds to play, knotting the score at 40-40.

The Tanners chose not to use a timeout and brought the ball up to attempt the final shot, and with 3.6 seconds on the clock, Peabody guard Gino Forte drained a deep three-pointer to ultimately give the Tanners the victory, 43-40, after Revere missed their desperation shot to tie.

"We were proud that we didn't quit, but it was a missed opportunity," noted Leary. "A layup here, a free throw there, and we are on the right side, but that's basketball. We just need to keep grinding."

Leary and his crew returned to the Winthrop gym two days later to take on Pioneer Charter of Saugus in the consolation contest.

The Patriots were able to get some of their players back and were almost at full strength.

Revere employed a full-court press defense and created a lot of opportunities to score. Sophomore forward Glen Kule (four points) made two

layups, senior tai-captain Jack D'Ambrosio (nine points, seven rebounds) sank a basket and two free throws, senior center Kenny Arango made a power move inside, and junior guard Sal DeAngelis (seven points) made a fast break layup to move Revere out to a 19-10 advantage at the first buzzer.

The second quarter was played more evenly as both teams stayed on the attack. Patriot junior guard Alejandro Hincapie made a nice layup, plus the foul, to get things going and then the rest of the quarter belonged to senior tai-captain James Clauto (23 points, eight rebounds, four assists, seven steals), as James slashed to the basket a few times and then hit a buzzer-beater going into halftime to give Revere a 31-22 lead at the intermission.

The Patriots continued their hot shooting to start the second half. Clauto made a handful of free throws and then a three-pointer to push the lead to 18 points. RHS junior guard Domenic Boudreau (17 points, five rebounds, four assists) had a quiet first half, but exploded after the break, hitting for a trio of three-pointers in the quarter.

Pioneer did not give up however, getting the ball inside against the smaller Revere squad. D'Ambrosio sank two FT's and Boudreau made a nice floater in the lane to give the Patriots a 52-40 advantage heading into the final frame.

Patriots junior forward Ramadan Barry (five points) made a jump shot and a three-pointer to open the fourth quarter to extend the lead for Revere. Clauto, Boudreau, and DeAngelis made their free throws down the stretch to give Revere the 70-54 win.

Boudreau was voted to the All-Tournament Team in recognition of his two fine games. "We played much

more-balanced against Pioneer, which is always nice to see," said Leary, whose squad now stands at 2-2 on the season. "We should be getting the rest of our guys back next week and get into a better routine after the holidays. We just need to keep grinding, as always. I'm proud of this group."

With the GBL halting its athletic schedule this week, Leary and his crew hopefully will be back in action next week when they travel to Chelsea on Tuesday.

GBL HALTS ALL SPORTS FOR A WEEK

The Greater Boston League has ceased all interscholastic sports activities, including practices, for this week (January 3-7) because of the high prevalence of the COVID-19 virus in the GBL schools and communities.

The full announcement from the league that was issued on Monday (January 3) is as follows:

## Erika Cheever readies for hoop return, career in health field

While former Revere High basketball star Erika Cheever has maintained her academic excellence with a 4.0 grade point average in the Nursing program at Salem State University, the last stretch of her on-court career has been extremely challenging on a personal level.

Cheever, 20, who was a four-year varsity athlete at RHS, is sitting out her sophomore season at Salem State following surgery on her right knee that she had injured as a passenger in a motor vehicle accident.

Cheever's freshman basketball season at Salem State was wiped out entirely due to the COVID-19 pandemic.

Going back to her senior year at Revere High School where she was on pace to become a 1,000-point scorer, Cheever missed several games due to a pulmonary embolism. The 5-foot-5-inch guard and team captain

had averaged 25 points per game as a junior under the direction of head coach Matt Willis.

The good news is that Cheever is beginning a physical therapy regimen for her this month and hopes to return to the Salem State women's basketball program for the 2022-23 season.

### A superb outside shooter and guard for the Patriots

Known for her long-range shooting proficiency, Cheever made her varsity debut as a freshman for Coach Lianne O'Hara's team that raced to an 18-0 record and claimed the No. 1 ranking in Massachusetts.

In fact, Cheever had kept Revere's record perfect at 15-0 by hitting three clutch free throws in the final minute of a 55-53 victory over Lynn Classical. Valentina Pepic, Meaghan Gotham, Tatianna Iacoviello, Emily DiGiulio, and Pam Gonzalez were other standouts during that

memorable season.

"That season was a great experience, it was crazy," recalled Cheever.

As a sophomore, Cheever became a starting guard and averaged 10 points per game for a Revere tourney team. Her breakout season came as a junior when she led the league in scoring and three-point production and was named to the conference All-Star team.

She also excelled as an All-Star runner and captain for the cross country and outdoor track teams.

A pulmonary embolism, which is a blood clot that develops in a blood vessel in the body, sidelined Cheever for most of her senior basketball season.

"It's a condition that requires follow-ups every couple of months," said Cheever. "When I get sick, it's always the first thing doctors have to check to make sure I don't have any blood clots. When I had my knee surgery (Dec. 21), I had to take further precautions. It's a little bit

tedious, but it's something that I always have to keep in mind whenever I get sick or have any surgeries."

### Sideline for basketball season again

In August, 2021, Cheever was a passenger in the back, center seat during a motor vehicle accident in Revere.

"It happened on Broadway right in front of the fire station," related Cheever. "Someone went to take a left turn, but we were going straight, and the vehicles collided. The driver overcompensated and we hit another truck."

Cheever said she banged her knee off the car's console twice in the collision. "I felt my knee move. The lower half of my knee went one way, and the upper half went the other way. It dislocated my knee and there was other nerve damage. I had major fractures in my knee."

Cheever underwent physical therapy and upon completion of that rehabilitative process, she had knee surgery on Dec. 21, 2021.

"In surgery, doctors fixed a dislocated meniscus and they had to take out a bundle of nerves, because I had nerve damage," said Cheever.

She has begun physical therapy and will have to wear a knee brace after the stitches from surgery are removed.

"The goal is to be ready by next season," said Cheever hopefully. "I hope to be back on the

court for my junior year at Salem State."

Cheever's personal coaches have been former Revere High star athlete Jon DeMarco, who played football at Merrimack, and Tony Gallo, who excelled at Lynn Tech and Towson State and played professional basketball.

"Jon DeMarco and Tony Gallo are the main people who developed my basketball skills," said Cheever. "They're both great coaches."

### Pursuing a career in Nursing

Cheever is studying in the Nursing program at Salem State and will begin her clinical nursing experience this semester.

"My goal is to become a nurse practitioner," said Cheever.

She is draining three-pointers in the classroom with all A's, dean's list honors each semester, and membership in the Alpha Lambda Delta National Honor Society.

It's a continuation of her academic excellence at Revere High School where she earned membership in the National Honor Society.

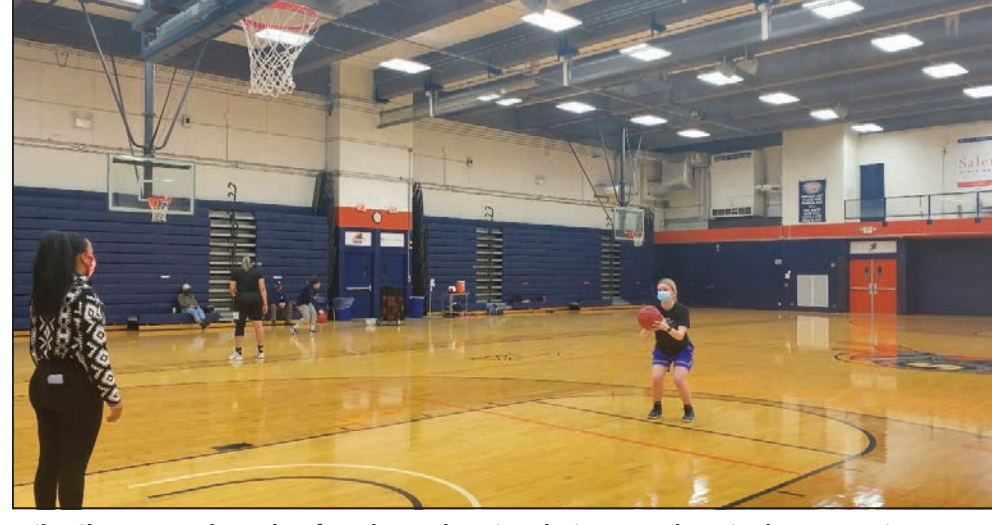
"I had some tremendous teachers at Revere High," she said. "My favorite teacher was Mr. [Don] Pinkerton. I really enjoyed his class in biotechnology. And Ms. [Allison] Kasper was another amazing teacher. I got to help other students as a writing tutor. I love to write stories."

Erika is currently working in a part-time job as a hostess at Jimmy's Steer House. "We have great food," she said. "My go-to dish is the steak and zucchini."

Erika is the daughter of Revere Deputy Fire Cheever Paul Cheever and Jennifer Cheever. She has a sister, Trisha, who is pursuing a master's degree at Salem State in urban planning. Trish competed in track and cross country on high school and at Worcester State University.

"My family has always been really supportive of all my endeavors," said Cheever.

And you can expect the family to be at Salem State next winter when Erika Cheever, an athlete, and a scholar, makes her triumphant return to competitive basketball after a three-year absence.

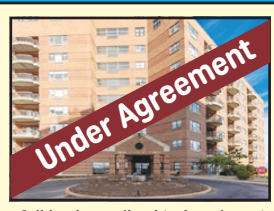

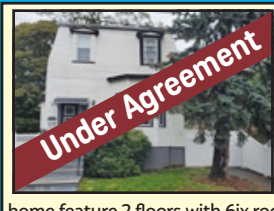

## Massachusetts RMV extending use of state-owned vehicles for road testing into 2022

Staff Report

The Massachusetts Registry of Motor Vehicles (RMV) is announcing the agency will continue with the use of Commonwealth-owned vehicles for Class D road testing services through April 30, 2022 and has delayed the return to the use of private passenger vehicles for road tests.

Due to the pandemic and health and safety protocols, since June of 2020, the RMV has deployed a fleet of Commonwealth-owned vehicles for road tests which are cleaned and sanitized on a regular basis. Plans to return to private vehicles have been delayed and existing protocols will remain in place:

All occupants of a vehicle used in a road test, including the applicant, sponsor and examiner will continue to be required to wear a face covering.

Windows will be open for ventilation.

All vehicles will be cleaned prior to each test beginning.

Applicants with scheduled Class D road tests appointments in the new year will receive an email from the RMV notifying them of the use of state vehicles. Applicants are given time to become familiar with the state vehicle they will be using in Class D testing. Applicants for a Class M, or Motorcycle license, will continue to supply their own motorcycle for testing. Road test applicants scheduled

for testing through a driving school should confirm they have access to their school's vehicle.

The RMV reminds all customers this winter season to visit Mass.Gov/RMV in inclement weather to ensure locations are open and honoring appointments and walk-ins. Cancellations and closures are posted on Mass.Gov/RMV.

The RMV has launched a new webpage to help applicants locate all information related to their road test, Mass.Gov/RoadTest. The page includes information on what to expect, videos to help prepare for the road test, links to checklists and applications to increase an applicant's chance of passing their exam.
