## McKenna expresses concerns about 5G antennas near Logan Airport

vices (MVES) Nutrition Services has the following good food choice tips

- Choose a variety of fruits and vegetables every day.
- Include whole-grain, high fiber foods such as barley, bran cereals, brown rice, buckwheat, corn, oatmeal, plain popcorn, quinoa, rye, whole wheat bread, wild rice, whole grain pasta.
- Consume fish at least twice each week, especially herring, mackerel, salmon, sardines, trout, or tuna.
- Choose lean meats and non-meat protein alternatives — chicken, turkey, fish, pork, lean beef, beans, nuts, egg substitutes, or egg whites.
- Select fat-free, skim or 1% milk, and low-fat cheeses and low-fat yogurt. (You can also try the new variety of non-dairy milks available, such as almond milk or rice milk, which have less saturated fat than dairy.)
- Minimize your intake of partially hydrogenated fats, such as butter or margarine.
- Minimize intake of

high-sugar, high-fat pastries such as muffins, donuts, cakes, pies, cookies, candies.

- Limit beverages high in added sugars such as soda, fruit punch, and sweetened coffee and teas.
- Choose & prepare foods with little or no salt.
- If you consume alcohol, do so in moderation. Dietary guidelines suggest one drink/day for women and up to two drinks for men.
- Be attentive to your portion sizes and the balance of foods on your plate. Changes in weight can put stress on your heart.

## HOUSE PASSES DRIVER'S LICENSE BILL

In an unprecedented effort to increase safety on the roads, the Massachusetts House of Representatives passed legislation that will allow applicants

who are unable to prove lawful presence in the United States to apply for a Massachusetts driver's license.

Under this legislation, the Massachusetts Registry of Motor Vehicles (RMV) will not inquire about immigration status when processing an application for a Massachusetts driver's license or registration, solely basing the issuance of driver's licenses to residents who provide required documents to prove their identity, pass the corresponding driver tests, and meet all other eligibility criteria.

"I'm proud of the significant step that the House took today towards bringing all drivers under the same licensing and insurance standards, regardless of immigration status," said House Speaker Ronald J. Mariano (D-Quincy). "In addition to increasing safety on our roads for all drivers, this legislation recognizes the essential role our immigrant neighbors play in our society and economy by ensuring that everyone has access to a driver's license. I thank Chair Straus, Chair Michlewitz, the bill's sponsors, and all my colleagues in the House, as well as countless supporters, immigration and labor advocates, and law enforcement officials for their tireless work to ensure its passage."

"In line with the 16 other states that have passed laws offering standard licenses to those providing secure identification documents, this carefully crafted public safety legislation will mean that all drivers using our roads are identifiable, competent and insured," said Representative William M. Straus (D-Mattapoisett), House Chair of the Joint Committee on Transportation.

"I'm extremely grateful for the tireless advocacy that led to this pivotal moment. I also want to thank Speaker Mariano, Chair Michlewitz, Chair Straus, and the House for their leadership on this important issue," said Boston Mayor Michelle Wu. "All Boston and Massachusetts adults deserve access to driver's licenses regardless of immigration status. I support the Family Mobility Act because it will make all of us safer."

"We cannot overstate our joy, pride and gratitude for today's historic vote in the Massachusetts House of Representatives," said the leaders of the organizations that co-chair the Driving Families Forward Coalition, Brazilian Worker Center Executive Director Lenita Reason and 32BJ SEIU Vice President Roxana Rivera. "We extend our deepest thanks to Speaker Mariano for his clear support in moving the bill through the legislative process, and we also thank the bill's four lead sponsors, dozens of co-sponsors and many thou-

sands of individual supporters. Today, all of them have helped move our state toward safer roads, stronger public security, better public health, and a more robust economy, while also taking a step toward transforming the lives of immigrants and their families across the Commonwealth."

"Immigrants without status are essential workers and card-carrying, dues-paying union members. Moreover, they are our neighbors, friends, and family and an integral part of our economy and community. With overwhelming support from law enforcement, this bill will provide greater public safety and allow workers to obtain and keep good paying jobs, all while making facets of everyday life that many of us take for granted, like getting kids to school, a reality. We commend Speaker Mariano and the entire Massachusetts House for voting to pass this important legislation that will result in safer roads for all Massachusetts residents," said Steven A. Tolman, President, MA AFL-CIO.

"I want to thank all those legislators, law enforcement leaders, immigration advocates and public health officials who worked tirelessly to advance this bill through today's historic vote in the House," said Middlesex Sheriff Peter J. Koutoujian. "Efforts on this issue date back to my time as a state representative. Then, as now, it was clear that this bill would improve public safety and public health. While I was supportive of this concept 20 years ago, it was the rigorous identification requirements in the final version of this bill that strengthened it further and made today's vote possible. I applaud Speaker Mariano for bringing it to the floor and the individuals who lent their stories and voices to this important cause."

To apply for a standard driver's license, applicants will need to provide at least two documents to prove their identity and date of birth. All documents written in a foreign language must be accompanied by a certified translation to English:

- Document #1: valid unexpired foreign passport or valid unexpired consular ID
- Document #2: valid US driver's license, birth certificate, valid foreign national ID card, valid foreign driver's license, ora marriage certificate or divorce decree

Residents who cannot prove lawful presence in the United States would remain ineligible for a "REAL ID" which requires documentation of U.S. citizenship or lawful status as a matter of federal law. To protect applicants' privacy, the legislation also prohibits the RMV from disclosing

any information about applicants for and holders of a standard driver's license except as authorized by regulations promulgated by the Attorney General. "An Act relative to work and family mobility" (H.4461) passed the House of Representatives 120-36. It now goes to the Senate for their consideration.

# Request for variance for two-family home in Beachmont is withdrawn after opposition

The Revere Zoning Board of Appeals held its regular monthly meeting last Wednesday evening, February 16, in the City Councilor Joseph A. DeGrosso City Council Chamber.

Chairman Michael Tucker and members Aklog Limeneh, John Lopes, and Hazem Hamdan were present for the meeting.

The principal source of discussion during the meeting occurred regarding the request for a number of variances by the property owner at 43 Pearl Ave. in order to construct a two-family home on the premises, which presently is the site of a small, one-family residence.

Two residents from the neighborhood spoke against the variances. After the board voted to reject the applicant's request for a continuance of the matter, the applicant withdrew his petition. (The agenda item, #A-22-04, and the full discussion and vote on the matter are below.)

The complete agenda and the board's discussions and votes on each are as follows:

#A-22-01: Durant Performance Coatings, Inc., 112 Railroad Street, Revere, appealing the decision of the Building Inspector and/or the Site Plan Review Committee on November 16, 2021 to approve the site plan application submitted in relation to 44 Railroad Street.

The applicant's attorney asked for a continuance, as had been done at the meeting in January. He informed the board that a traffic study presently being conducted eventually will go before the Site Plan Review Committee, which could make the matter moot.

An attorney opposing the application also appeared and stated that the

appeal does not fall within the board's jurisdiction.

The board voted against granting a further continuance.

Chairman Tucker then said, "The members and I discussed this," and proceeded to read from a lengthy statement, which had been drawn up before the public meeting, in which the ZBA essentially concluded that the matter does not fall within the purview of the board's authority.

The board unanimously voted to dismiss the appeal and place it on file.

#A-22-02: Cristina Napoli and Marcus Santos, 174 Endicott Avenue, appealing the decision of the Building Inspector to deny the applicants' request for enforcement of the Zoning Ordinances of the City of Revere with respect to the property located at 172 Endicott Avenue and owned by Thomas LaBrecque concerning the unauthorized expansion of a deck to less than one (1) foot within the required side yard setback of ten (10) feet. The applicants' request that the Zoning Board of Appeals reverse the decision of the Building Inspector to delay or withhold the enforcement of the Revere Zoning Ordinances and that Mr. LaBrecque be ordered to remove the deck encroachment into the side set back to the extent it exceeds what was existing previously at the property located at 172 Endicott Avenue.

The attorney for the appellant asked for a continuance.

However, the board denied the request for a continuance and once again Tucker read a statement which he began, "As discussed with the members earlier."

The board then voted to uphold the decision of the Building Inspector, essentially dismissing the appeal.

#A-22-04: Pedro Calcano, 43 Pearl Avenue, requesting the following variances of the Revised Ordinances of the City of Revere to enable the appellant to convert a single-family dwelling to a two-family dwelling on Lot 125 at 43 Pearl Avenue.

1. Noncompliance with Section 17.28.020 with respect to requirement for 4 parking spaces for a two-family dwelling.

2. Noncompliance with Section 17.24.070(A)(3) with respect to no parking allowed in the rear yard for single-family and two-family dwellings.

3. Noncompliance with Section 17.24.010 footnote (y) with respect to maximum height requirement of 30 feet for lots less than 5,000 square feet.

4. Noncompliance with Section 17.24.010 with respect to maximum of 2 1/2 stories for dwellings within the RB District.

5. Noncompliance with Section 17.24.010 with respect to minimum side yard setback requirement of 10 feet on one side and 5 feet on the other side.

6. Noncompliance with Section 17.28.050 with respect to minimum width of 20 feet required for driveways for two-way traffic.

7. Noncompliance with Section 17.28.040 with respect to minimum driveway aisle width requirement of 22 feet for 90-degree parking.

8. Noncompliance with Section 17.32.050 with respect to minimum screening area width of 6 feet between multifamily parking areas and other residential uses.

Attorney James Cipoletta asked the board for a continuance to allow the petitioner additional time to discuss the matter with Ward 1 City Councillor Joanne McKenna and the neighbors.

However, one of those neighbors, Eileen Mundis,

who lives across the street at 44 Pearl Ave., told the board that the scope of the project will add to the flooding and sewage issues that already plague the neighborhood.

Mundis also said that the level of privacy in the neighborhood will be invaded because of the proposed height of the new structure, topped by a rooftop deck. She also said that there could be a runoff problem because of the addition of four parking spaces.

Finally, Mundis said that the variance is not warranted because it does not meet the legal threshold for the board to issue a variance.

Another neighbor, Donald Comeau of 39 Pearl Ave., attested to the flooding situation that exists in the neighborhood.

"This is a very small lot and I don't see how you can get all of this into a postage-stamp lot," Comeau said.

One person, a resident at 25 Sigourney St., spoke in favor of the project on the basis that new housing

is needed in the city.

Regarding the request for a continuance, though three of the members voted yes, Mr. Hamdan voted no, thereby denying the request.

Cipoletta then stepped forward to present the merits of the application, but first asked for a reconsideration of his request to continue the matter. However, when the reconsideration failed, Cipoletta then asked for leave to withdraw the application without prejudice in order to submit a different plan.

The board voted unanimously in favor of that request and the matter will come up at a later date upon the filing of a new plan.

#A-22-05: Thomas L. Labrecque ("Owner"), 172 Endicott Avenue, appealing the Order of the inspector of buildings/zoning administrator which states in pertinent part: "This correspondence serves as my Order pertaining to the erected deck located at 172 Endicott Avenue. 1.) The

erected deck is not conforming as to zoning and is also not in compliance with the building code. 2.) The Department plans to await a reasonable amount of time for the Owner to bring the deck into compliance within zoning and the code and to comply with this order. The Owner appeals the Order of the inspector of buildings/zoning administrator which orders the Owner to cure the zoning nonconformity of the exterior modifications. The facts and circumstances support the Owner's position that no action is required respecting a zoning nonconformity, wherein the exterior modifications do not increase the nonconforming nature of 172 Endicott Avenue and said exterior modifications were properly allowed by right in concert with the issuance of a building permit.

This applicant requested a continuance and the board voted unanimously to continue the hearing.

The board then adjourned until its next meeting in March.

Ultra-Wideband systems, claiming it would soon be available for 100 million people in the U.S., including residents of Greater Boston," McKenna told the Council. "But the frequencies are very close to the ones used by the radar altimeters on planes, which use a radio signal to measure the distance to the ground and are vital to landing in the dark and in inclement weather. Interference from C-Band towers makes some radar altimeters dangerously inaccurate. This could be a catastrophe for Beach-

mont."

McKenna said she wants Cong. Clark to propose legislation prohibiting the 5G antennas from coming within a 2.5-mile radius of Logan Airport.

Ward 4 Councillor Patrick Keefe, a co-sponsor of the motion, said, "I don't want to be hypocritical. We all use cell phones, we all use the internet, and we all rely on this type of towers to support our internet activity.

"But I hate when some-

one says you can't say no, or we have no right to refuse things. This is a great example of major airlines refusing to fly into Logan International Airport for 5G cell towers in around the area. That tells you something's wrong out there," added Keefe.

Keefe said he is hopeful that the Council's action will lead to answers to the safety concerns and "give us the right to be able to choose whether we want these [5G antennas] in our community."

with the community, to do what we think is best for our students and our staff," said Rizzo before making the motion.

Masks will still be required in school health offices and on school transportation and RPS will determine if mask mandates need to be complimented or discontinued as the situation demands.

"I just like to say that I'm looking forward to a new chapter, a new dawn and a new day where we are moving away from this pandemic and learning to live with it responsibly," said Revere School Committee member Aisha Milbury-Ellis. "This will bring back a sense of some normalcy to these kids, and to the staff and our whole way of living. So I'm happy about this vote. I think it's going to restore some confidence that we're taking some proactive measures to bring that (sense of normalcy) to our families."

While School Committee member John Kingston voted to remove the mandate he argued that RPS should still provide masks free of charge to staff who still want to wear a mask in class.

"I would like to stress that I believe that the district should continue to provide masks to all staff that wish to have them," he said. "If a staff member doesn't want to wear

a mask, fine, but I think the district should provide that level of protection to the staff that wishes to wear it and I think the district should pay for it."

Prior to the vote, Revere Teachers Association (RTA) member and Seacoast teacher Eric Fearing reported that RTA members were split on whether or not the mandate should be lifted.

"The RTA did a quick poll of our membership over the weekend and we're not surprised to see it come out about 51.5 percent to 48.5 in favor of keeping the mask mandate," said Fearing. "Some concerns came up at an executive board meeting about whether teachers would be expected to enforce mask wearing for students who were coming back from an illness or whose parents wanted masks on. We just don't think that that's feasible.

It's going to be the honor system for our students if they don't have to wear masks. We can't know who's supposed to be masking again and who's not with any reliability. So we ask you to keep that in mind."

However, Fearing did say the original plan to end the mask mandate right after school vacation would have been bad timing.

"Doing it the day after February break did not seem like the time to make this change," he said. "A lot of students travel to places that may have a lower vaccine concentration than around here and they would have missed a week of pool testing. It seems like the delay of a week or two as many neighboring communities have already done would be prudent, but we're certainly not opposed to removal of the mask mandate."

## WHAT'S OLD IS NEW

As this is being written, a huge Russian Army is standing ready and poised, at the whim of Russian dictator Vladimir Putin, to invade the nation of Ukraine, potentially bringing death and devastation to Europe on a scale not seen since 1939 when Nazi Germany invaded Poland with a blitzkrieg.

As was the case in 1939, when authoritarian leaders in Germany, Italy, and Japan combined to form an Axis, Putin and his fellow dictator, Xi Jinping of China, are conspiring to set the world ablaze. Putin has Ukraine in his crosshairs and Xi likewise has his sights set on an invasion of Taiwan.

The big difference between now and then is that these dictators possess nuclear weapons, which makes an all-out war unthinkable.

That means that they can get away with pretty much anything. They know that the U.S., which is their only countervailing force, will be hesitant to engage them directly because of the threat of escalation into a nuclear conflict.

Another difference between now and then is that both Russia and China have the ability to wreak havoc throughout the world by means of cyber warfare. The world economy, including that of the U.S., is incredibly vulnerable to Russian and Chinese hacks.

Make no mistake about it -- if the U.S. imposes the severe economic sanctions on Russia that are being promised by the Biden administration, the Russians will retaliate with a scale of cyber warfare that will make the hacks of last year look like child's play.

Another key difference between 1939 and today is that Russia plays a huge role in the world's energy markets. Although the Russian economy is only a fraction the size of California's, Russia serves as the major energy provider for Western Europe. A shutdown of the delivery of Russian natural gas and oil to Europe will drive energy prices skyrocketing beyond their already-high levels.

Our so-called allies in the Middle East, especially Saudi Arabia, could help out, but they're in bed with the Russians. Their decision to keep oil output artificially low is creating an energy crisis not seen since the Arab oil embargoes of the 1970s and early 1980s.

In addition, U.S. oil producers have joined the Saudi-Russian oil-opoly by limiting energy production in this country, thereby keeping prices artificially high. If energy prices continue their upward trend, the Biden administration may have to order a nationalization of the oil industry to increase domestic output.

World history has shown that dictators do what dictators do. Putin, Xi, and MBS essentially are dictators for life and face no consequences for their policies and actions in their own countries. All three have cracked down brutally on political opponents and various ethnic groups that may pose even a remote threat to their regimes.

As they seek to expand their authoritarian regimes beyond their borders, world peace will be in peril.

Dark days lie ahead.

## Sen. Edwards kicks off talks with her Community Transition Committee

Last week Senator Lydia Edwards kicked off her Community Transition Committee through a virtual meeting to discuss housing. After being sworn in Edwards asks residents to advise her on constituent and public policy issues impacting the Senate district.

While last week's meeting focused on housing, the committee will cover issues including transportation, addiction and recovery, Massport, seniors, education/youth services, public safety, and environmental justice throughout 2022.

"I was elected and sworn in but it was during a special election so I didn't have the normal runway that other people have, where win in November, then they have a couple months to get adjusted and talk to people and then they get sworn in the following year," said Edwards of why she has formed the committee. "I got sworn in nine days after winning the election. So these are the conversations I would have had in the community, learning

from you and your priorities with this first meeting specifically about housing. The reason why I wanted to start off my representation through listening and learning is because the best ideas that I've ever had are the ones that have come from the people whose real lived experiences depend on creative thinking from their legislators, and active listening."

Edwards then took some suggestions of what sort of legislation committee members would like to see or initiatives the senator could work on.

"I'd like to see in the budget some stuff that can help people that are looking to become homeowners," said Steve Rousel. "As we know Suffolk Downs is going to be a huge generational project that's gonna be happening. I like to see more money put towards education and learning the rules of engagement if you're a buyer. I think education is important to the buyers. We should try to teach more about budgeting. Like with any budget, in order for you to become a homeowner, it starts with budgeting. I think that we

should be requiring this type of education in high school because having these young adults educated at an early age could head off a lot of problems they may have in the future."

On other housing issues Edwards said she will push for another shot at getting the Home Act signed into law.

The bill, which was vetoed last time around by Gov. Baker, would remove a person's eviction history from public record after three years.

"I worked on the Homes Act in the Boston City Council and was honored it got sponsored at the State House but was vetoed by the governor," said Edwards. "This bill is about removing that Scarlett Letter from a person's record who has been evicted in the past but has not had an eviction for three years and moved on with their life. I don't know that it should be public and permanent for which they will be judged for the rest of their lives and currently eviction records are public and permanent. I have refiled the Homes Act, which allows for people

after three years to seal their eviction records. This is the civil response to our state's CORI reform. Our CORI criminal reform that we did allowed people who had a misdemeanor to seal their record after three years and if you have a felony, you can seal your record after seven years. So to me, if you're able to move on from a misdemeanor and felony you should be able to do so if you missed rent during the pandemic, or during the last recession."

Edwards has also co-sponsored the extension for COVID relief.

"In terms of funding and stabilization, the money is still necessary, and a lot of our relief is ending for housing on April 14," she said. "That is a deep concern for me. I think we need to extend it."

In addition to Luongo, she also has several staff members at the Library. "Krystee Maniscalco is our Children's Librarian. Her role is to manage the children's collection materials. Basically making sure we take outdated books off our shelves to create space for new, current books and materials. She is also in charge of programming for the children. Either she hosts them or she brings in other vendors to perform. She also handles all our social media, including a monthly newsletter which gets sent out via email to our patrons who sign up, and is featured in the Revere Journal"

"Rhea Heaven is our Technical Services Librarian. To keep it simple, she catalogues all our books, runs the interlibrary loans services, database management and organizes all our shelving. She is our behind the scenes librarian!"

"Ross Croghan is our Collections Development Specialist. He handles all our collections, which includes books, online resources, and more. He also keeps our website up to date. We do not currently have an Adult Services Librarian, so he steps in a lot and assists in that area of services."

"Lisa Ferrara, Rachid Doukali, and Madison Yeomans are our newest employees. They are all assistant librarians. Their roles are to assist in all functions of the library. and working on a newly designed (YA) young adult space for those ages 12-18. The Revere Public Library has never had a space designated solely for YA, or a Young Adult Librarian who specializes in collections and programming for our patrons. One of my goals is to change that by bringing in someone who has the skills and qualifications to run and promote our new young adult space."

The Revere Public Library began operating on November 6, 1880. When a fire destroyed Revere Town Hall, the Library was also heavily damaged. Thanks to a campaign from the Revere Women's Club and the Revere Journal, Revere received a grant from philanthropist and steel magnate Andrew Carnegie in the amount of \$20,000 for the construction of a new library building. The Women's Club raised funds that were used to furnish the two main reading rooms of the new library. With one reading room dedicated to the adult collection and the other reserved for children's books.

According to its website, "The library building holds a significant place in

the history of the City of Revere. It is an excellent example of the freedom of design and commitment to service that the Carnegie libraries across America attempted to represent. The interior of this landmark building illustrates no less grandeur of style and attention to craftsmanship. The hand rubbed oak paneling and millwork are of a day gone by, and anxiously await the opportunity to once again be part of an active and responsive public library. The Revere

# PRIM Board to vote against directors at high-polluting portfolio companies

Staff Report

The Massachusetts Pension Reserves Investment Management (PRIM) Board, which oversees the state's \$104.1 billion pension fund, voted unanimously in favor to approve new proxy voting guidelines proposed by State Treasurer Deborah Goldberg. These guidelines are designed to allow the state pension fund to vote against directors at companies that are not aligned with the Paris Climate Agreement and Climate Action 100+.

The action comes as part of Treasurer Goldberg and PRIM's commitment to build and implement a comprehensive ESG framework with the proxy goals of limiting global warming to 1.5 degrees Celsius and/or establishing a plan to achieve "net zero" emissions by 2050.

"This vote not only benefits our retirees and taxpayers with its positive environmental outcomes, but has significant potential to increase our bottom line," said State Treasurer Deborah B. Goldberg,

who Chairs the PRIM Board. "It is a more active approach toward achieving our financial goals while having a productive long-term impact on our changing climate."

Over the past 10 years, PRIM has achieved an investment gain of \$70.6 billion – exceeding the benchmark return by \$12 billion over that time. In 2020, PRIM became the first founding member of the MIT Sloan School of Management's Aggregate Confusion Project, a research consortium with the goal of improving ESG measurement.

"Today's votes help keep PRIM out in front of major ESG trends in the industry," said Michael G. Trotsky, CFA, Executive Director and Chief Investment Officer of Mass-PRIM. "The new committee will build on the work we have been doing with our partners in the MIT Sloan School's Aggregate Confusion Project to become more impactful; to use the power of PRIM to advocate for important change."

Grassroots organiza-

tions, pension funds, and other investors have been working collaboratively with the Treasurer's office to develop policies where shareholders vote against company directors that are the most significant drivers of climate change. Additionally, the development of an investment approach that pursues an environmental, social, and corporate governance (ESG) frameworks into investment decision making will not only have better impacts on our world but better corporate outcomes resulting in greater returns.

The Board also voted to create an ESG Committee comprised of industry experts. This first-in-the-nation initiative will help to leverage the Fund to be a force that promotes worker safety, fosters diversity, fights against climate change, while still maintaining – and even increasing – returns.

"These voting guidelines are a great move for Massachusetts and other state treasurers and controllers should follow suit," said Mary Cerulli,

Founder of Boston based Climate Finance Action. "We know that Treasurer Goldberg's ESG committee will address the entire portfolio and she will work successfully with other large investors to improve and align the climate transition plans of high-emitting companies."

"We applaud the leadership of Treasurer Goldberg and today's actions by the PRIM Board," said Mindy Lubber, CEO and President of Ceres. "Companies and their directors have been put on notice by many of their shareholders that if they fail

to address climate change risks and implement climate practices and policies that will help bring about a transition to a net zero emissions economy, those shareholders will hold them accountable. Following the historic 2021 U.S. proxy season, directors now know they might be replaced if they are not doing their jobs in mitigating climate-related risks and capturing opportunities in the net zero transition."

The proxy voting guidelines do not restrict or determine which companies the pension fund invests in. Instead, they allow

the fund to use its power as a shareholder to advocate for policies that advance effective corporate governance and ensure sustained value for the fund, fostering long-term growth for its investments.

In prior years, the Treasurer proposed, and the PRIM Board unanimously approved a series of reforms, which, in addition to targeting climate change, also focused on renewable energy, human rights standards, executive pay, LGBTQ rights, board diversity and wage equality, and limiting the number of boards a director may sit on.

in American history, the Massachusetts Department of Transportation (DOT) will receive \$225.3 million for Fiscal Year 2022. Through the renovation of the Casassa Overpass, Revere will receive \$18 million.

"The Andrew A. Casassa Overpass is one of the 472 Massachusetts bridges in need of repair, said Assistant Speaker Clark. "I was proud to vote for the infrastructure law, bringing a record \$1.1 billion to Massachusetts to modernize our bridges, just like this one in Revere. With this funding, we are improving safety and commute times, lowering costs for drivers, and investing in our community's future. This is the heart of my work in Washington, and I am thrilled that this funding is making its way to Revere where the city is putting our plan for a strong infrastructure and a stronger tomorrow into action."

The Andrew A. Casassa Overpass was first built in 1931 and was the first overpass built in Massachusetts. Andrew A. Casassa was the Mayor of Revere from 1929 to 1934 - he was also the first municipal executive of Italian descent in the Commonwealth. Casassa also served in the Massachusetts General Court as a state representative and state senator. In the coming months, the overpass will

be replaced with an \$18 million investment from the Infrastructure Law.

"As municipal leaders, we know the power of investing in infrastructure," said Mayor Brian Arrigo. "I am thankful for federal and state partners like Assistant Speaker Katherine Clark for understanding

the importance of infrastructure funding – with ARPA money, the Infrastructure Investment and Jobs Act, and other grant opportunities from Governor Baker and Lieutenant Governor Polito, the City of Revere is in an unprecedented position to make lasting infrastructure change that will benefit all residents and visitors."

Last month, the U.S. Department of Transportation's Federal Highway Administration (FHWA) announced that the first round of funding from the Infrastructure Investment and Jobs Act's \$27.5 billion bridge formula program was distributed to states and Tribal communities. Over the life of the five-year program, Massachusetts will eventually receive \$1.1 billion for bridge replacement and repair projects across the Commonwealth.

**10 years ago  
Feb. 22, 2012**

Acting Police Chief Joseph Cafarelli will be ordering Revere's police captains, among the most highly-paid municipal employees on the city payroll, to return their city-owned vehicles and to begin using their own transport from their homes to the station. "It is time to change the way the department is run," Cafarelli told the Journal. "Our captains should be using their personal vehicles to get here and to return home. If I can do it, then they can." Last week, Mayor Dan Rizzo gave up his city-owned vehicle and said he would be driving his own car in order to set the example about the direction that city government is heading under his administration.

Though many thought the criminal case with a former School Committee member had found its way quietly to a resolution, this month it has taken on a new life. Chelsea police arrested the former School Committeeman - who is currently an employee of the School Department and is on leave without pay - at the end of January for defaulting on a court appearance, and the situation will likely lead to a revisiting of charges that were pretty much wiped away last October. The case was revisited, according to court records, because the defendant failed a drug test, failed to pay back his victim, and did not attend a mandatory drunk driving class - all three of which were part of his terms of probation.

The two members of the License Commission who were asked to step down last week by Mayor Dan Rizzo will decline to do so and will serve out their respective terms. Sources close to the situation told the Journal this week that



### John Cogliano Jr.


Loving Husband, Father and Grandfather

My parents lived in Revere all their lives. Their pictures should perhaps be on the wall of the new museum on Beach Street. We lived across the street at #91. As a young boy my father set up the pins at the Nautical bowling alley, before a machine came along and took his job. He grew up to be a left-handed bowler who won many trophies. Mum worked at the 5&10 on Shirley Ave., went to secretarial school in Boston, married her high school sweetheart, raised four girls and went on to work at the Revere Federal Savings Bank on Broadway. Both enjoyed growing up when Revere Beach was a dream of a place. If they weren't renting a boat off the pier, or digging clams, or grabbing a pizza from Anna's, they were strolling along down to the pavilion or riding bikes to Point of Pines. I got to enjoy it all too – the merry-go-round, roller coaster and arcades.

I'm sure some of you reading this will smile and remember" back in the day." I'm one of their four daughters and find that I have the task of writing an obituary of sorts. Yes, my parents are now both gone.

The day before dad went into the hospital, he was balancing the checkbook. All he did was fall on the rug and six days later he was, as my pastor says: "promoted to glory." It was a shock even though he was 92. I mean he only decided to give up the keys to the car three months before because the mechanic declared, "John, it's all rusty underneath." I said, "Aren't we all dad." And he smiled

My mum had many chronic ailments and in some ways, it was a relief to see God mercifully

take her home. It was on a day that was nationally celebrated. And I heard the infamous words, "Free at Last. Thank God I'm free at last." And it was fitting. It was a few weeks ago now, but when the matriarch of the family is no longer here – well, it is somewhat less of a home. She was a creative and charming woman – a lover of the bargain and a keeper of coupons. Our childhood was woven on a loom of a village. Need a few groceries, cigarettes or the paper? Cross the street and go to Eleanor and Tony's. Right beside them was a man named Sasha who was responsible for sharpening your skates. Down Pleasant Street you passed the Police Station and came to Broadway. On the corner, a family run pharmacy named Palladino's. Everyone trusted the two brothers Al and Peter to not only fill our prescriptions but explain them. They knew us all by name. Best ice cream sodas at Paone's Spa. Or there was Bill's Spa right across from the old Revere High, which was across the street from the Immaculate Conceptions School where the Anderson sisters went. Uniforms could be brought by jumping on the Beachmont bus and going into Boston. And of course, there was no other place to go for our shoes but Shirley Ave. Yes, Revere was more of a village back then and everything we needed was within walking distance. We could even go home every day for lunch.

Well perhaps I'm letting nostalgia get the best of me. But it certainly is a melancholy season now that they're gone. There was only four months between visits to the funeral home – dad in August and mum in January. They told me that spouses usually

follow close behind. And perhaps that's understandable. They were married for seventy years.

I feel the only thing that matters now is our faith. We have hope and confidence that we will see our parents again. You have in your hands a notification of a change in address for John and Lillian. They are no longer in Revere. They are now in Heaven.

But how can I be sure? We lived good lives and just hope the man upstairs considers it good enough. Who could ever know that for sure? Because of Christmas – Jesus's very means: God to the rescue. Salvation. And if not for the man upstairs coming down to us, we would all be in darkness with no hope. But he did come down and he made several outrageous claims. And so, I remind my heart of what Jesus said: "I am the resurrection and the life, he who believes in me, though he were dead, yet shall he live."

Now either Jesus was a liar, a lunatic, or what he said was the truth. Easter is right around the corner. It reminds us that Jesus rose from the dead and was seen by many witnesses. And he was the only man who ever did that. Because of the resurrection we can believe what Jesus said and take it to heart. When those you loved have died you reach out for a life preserver to grab onto. Is there any hope for a life beyond this one? Will I even see them again? Where are they now?

My parents are now as the Bible declares: "Away from the body, present with the Lord." And in the meantime, before we are united, I set my mind and heart on the Kingdom to come. Jesus had a lot to say about this Kingdom – a city made by God, not by man. Now that captures my Imagination. But now...we groan until the perfect comes. And we miss them of course. "Weeping may endure for a night, but joy comes in the morning." Another promise found in the Bible.

When I see my parents again, they will have cast off their mortality and put on immortality. I'm trying to imagine what it will be like to have them experiencing a world where

there is no more curse. Where everything is gloriously perfect – even their own broken humanity. A happy ending? Yes. That's the promise of a Christian worldview. Those of us left behind have to see it with the eyes of faith. This is not the end of the story for Sonny or for Lil. There really will be a happy ending for all who believe. Not now...but soon.

A week before my mum died, we were watching: Heaven is for real. It's a true story about a child who dies and comes back with many stories to tell.

I asked her half-way through the movie, "Hey mum, if you go before me do you want me to buy the movie and give it to everyone, so they'll know where you are? And even though she was very sleepy, she quickly answered "Yes." I was a bit surprised because I didn't know if she had heard me or not. "Really?" I asked again. "Yes, I do." She repeated. "Alright then, I'll do it!"

And so, I will give it away when we hold her memorial. Heaven is for real. She wanted everyone to know that.

Again, I consider this a change of address notification. Lil and Sonny are now in Heaven. And because Jesus said to the thief on the cross, "Today you will be with me in Paradise." I'm assured there was nothing on this earth that they experienced that can compare with what they're doing now. "No eye has seen, nor ear has heard, nor has it entered the imagination of man what God has prepared for those who love him." Another promise you'll find in the Bible.

Yes, "Weeping may endure for the night, but joy comes in the morning." It is now their morning. And somehow that does my heart good. Because of our faith week now...the separation is only temporary.

If you've never read the Bible, consider it, because it is the place to find hope. And it seems to me if ever there was a time people needed good news, it is now.




Walter Giampietro of Beverly, formerly of Revere, died on

*\$20,000 in Mini-Grants!*

The Revere CARES mini-grant program is for those interested in promoting healthy eating, active living, preventing substance use disorders, improving mental wellbeing, engaging young people in positive activities, and creating community connections.

These are the projects funded:

**Outdoor Classroom:** Awarded \$2000 to the Beachmont School Improvement Team to buy materials that will upgrade their courtyard space to an outdoor classroom. This space will promote social-emotional learning for both students and staff. It will also be used as a space to meditate, breathe in some fresh air, run restorative circles, and host discussions on issues that arise throughout the school day.

**Ward 4 Family Picnic and Pollinator Event:** Awarded \$600 to the Ward 4 members of the Covid Response Network Wellness Team to host a community event in May. This free event will treat families to a bounce house, music, and activities to learn small ways we can all support pollinators and create a healthy environment.

**An Evening of Dining & Entertainment in The Square:** Awarded \$600 to the Beachmont Improvement Committee to conduct a placemaking event that will include dining and entertainment at Kimmerly Park in Beachmont Square. The event will include meals ordered from restaurants in the Beachmont Square area, local entertainment, and activities for children.

**Boxing & Fitness for Female Students by Female Coaches:** Awarded \$1500 to coach April Freely. April will be starting a Boxing/Fitness program taught by female instructors for 20 to 30 female Revere high school students. Boxing improves fitness, strengthens motor skills, and provides self-defense knowledge.

**Healthy Cooking for Youth Zone Members:** Awarded \$3000 to Youth Zone (YZ). With this grant, YZ will provide a subscription to the ChopChop healthy cooking magazine to every student. YZ staff will cook the recipes with the members, helping them learn kitchen skills while exploring healthy eating and getting excited about making positive lifestyle changes. Members will bring their magazines home and share the knowledge with their families. Funding will also cover ingredients, customizable aprons, and a \$10 food store gift card for students to prepare healthy meals with their families.

**Coming to America Story Boards:** Awarded \$2680 to resident Kathleen Heiser. In this three-part project, at least 50 community members who are recent-to-4th generation immigrants will be invited to create a "story board" depicting their immigration story. These storyboards will be laminated and displayed in the lobbies of all eleven Revere Public Schools and other community venues, along with a large world map marking countries represented. This project aims to display Revere's cultural diversity, learn about our commonalities, and promote understanding.

**What We Eat Series:** Awarded \$1000 to For Kids Only to offer a new "We Are What We Eat" enrichment series for their members. This series focuses on educating Revere youth and families about how nutrition affects how we feel and helping them understand the connection between our daily choices and the relation to our emotions and mental well-being.

**School Counselors Office Improvements:** Awarded \$1367. The Covid pandemic has profoundly impacted the Garfield Middle School students. This grant will allow the Garfield Middle School counseling staff to create a more therapeutic environment in their offices.

**Great Body Shop Program:** Awarded \$790 to the Wellness Instructor at the Rumney Marsh to incorporate the Great Body Shop program into their instruction. This new curriculum covers many health education subjects such as becoming a lifelong learner, body systems, fitness and nutrition, social/emotional health, safety, and substance abuse.

**Revere Reads:** Awarded \$2000 to the Revere Public Library to support the first Revere Reads Family Literacy Day. The event for children aged 2-14 will include crafts and guest storytime readers. Families will be encouraged to sign up for library cards. Each child in attendance will receive a backpack with new books to take home (up to 200).

**Ward 6 Clean Up Events:** Awarded \$600 to the Ward 6 members of Covid Response Network Wellness Team to organize a series of clean-up events in the Ward 6 neighborhoods.

**Positive Youth Engagement:** Awarded \$3200 to The Revere Police Activities League to organize an activity that will promote positive youth/police relationships. The event at Revere High School will include a basketball game between police staff and youth, lectures and presentations, small break-out groups, and pizza.

**Iftar Event:** Awarded \$600 to the Beachmont Improvement Committee. This event for Beachmont families will include a traditional meal, educational discussion on Ramadan, and traditional music and dance presentations.

### RHS GIRLS BASKETBALL TOPS MEDFORD; AWAITS STATE TOURNAMENT OPPONENT

The Revere High girls basketball team concluded their regular season this past week, which included a 45-40 victory over Greater Boston League (GBL) opponent Medford. Together with gaining a forfeit two days later with Chelsea, the Lady Patriots ended up with a sterling 11-3 record in the GBL, good for third place behind 13-1 Lynn English and 12-2 Lynn Classical.

Coach Chris Porazzo's squad battled both English and Classical fiercely this season, defeating Classical, 45-36, in one of their encounters and narrowly falling to English, 38-37, in one of their meetings.

Leading the way for Revere in the win over Medford were the duo of Carolina Bettero with 19 points and Haley Belloise with 17 points.

"It was close all the way but our defense really helped bring the win home," said Porazzo.

Earlier in the week, the Lady Patriots came up short in a 44-27 decision at non-league foe Winthrop. Elaysia Lung reached double figures with 11 points against the Lady Vikings, who were celebrating their Senior Night.

Porazzo and his crew, who finished the regular season with an overall record of 12-8, automatically have qualified for the Division 2 post-season state tourney.

"We will find out who we draw in the Division 2 state tournament this Friday," said Porazzo. "In the meantime, we have multiple scrimmages planned and a full week of practice."

### GONCALVES IS THIRD, CUNHA FIFTH AT D-1 STATE TRACK MEET

The Revere High boys indoor track and field team sent a contingent of athletes to the Division 1 State Track Meet last weekend at the Reggie Lewis Center in Boston. The meet was a success for the Patriots, who brought home some med-

als with two boys, Ricardo Goncalves and JV Cunha, qualifying for the upcoming state meet.

Goncalves took third place in the 55 meter hurdles and Cunha finished fifth in the 600 meter dash. In addition, the Revere 4 x 400 relay quartet of Keny Guerrero, Goncalves, Tommy Desir, and Cunha earned an eighth place medal.

"Ricardo came into the meet seeded third overall with a time of 8.00 that he ran over a month ago," said RHS head coach Sam Ros. "There was a little uncertainty on how his hamstring would hold up. He competed and won the GBL title, but his hamstring was not 100% when he did that. He also had missed out on two weeks' worth of real workouts leading up to the GBL meet."

"The week of the state meet we worked on testing his hamstring out fully," continued Ros. "He was looking great during practices which gave us hope that he would be able to give 100%. Going for the win at the D-1 State Meet was going to be just out of reach as the top seed, Jordany Volquez of Lawrence, is a step above everyone else in this division."

"Even though beating Jordany was going to be a tough task, we knew from the past races between Ricardo and Jordany that Ricardo is step-for-step with Jordany up until the second hurdle. Our goal was for Ricardo to break eight seconds and finish top-three to auto-qualify for the All State Championships next week. If Ricardo could go toe-to-toe with Jordany as long as possible, those goals would be reached."

"For the prelims, they separate the faster hurdlers into different heats," said Ros. "In order for Ricardo to face off against Jordany, he would have to run fast enough to make the finals -- the top eight fastest prelim times make the finals. After the prelims, Ricardo was seeded fourth. In the finals, Ricardo took off out of the blocks. He was toe-to-toe with Jordany all the way through the third hurdle. With two hurdles left, Jordany was able to pull away. Ricardo pushed hard for the finish line and narrowly missed out on second place."

"The difference between Ricardo and second place came down to the thousandths. Both times were shown as 7.88, but second place was 7.873 and Ricardo's time was 7.877."

"Despite not getting second, he accomplished the goal of running under eight seconds and securing an auto-qualifier for the All States," said Ros. "He is actually seeded seventh for that meet. We're hoping for another PR with an outside shot at finishing top-five."

"JV Cunha came into this meet seeded seventh overall," said the coach. "His chance of finishing

top three and nabbing the All State auto-qualifier was going to be difficult. We knew that if he didn't place top-three, then his time would have to be fast enough to provisionally qualify. To do that, his time would have to be fast enough to be one of the next nine fastest times of all the divisions that are not a part of the top three of the respective divisions."

"Because JV was only seeded seventh, he missed out on the fastest heat," said Ros. "He and the rest of his heat had to run fast enough to be sure their times would beat out some of the runners in the fast heat. As the race started, JV went out fast enough to put himself in a position to run fast. He was right on the shoulder of the leaders after the first lap. He held his position by the end of the second lap. He made a move for the lead in the final lap, but it wasn't enough to take the heat."

"We were not disappointed as his time was a PR and he broke 1:25 for the first time," Ros added. "When the dust settled from the final fast heat, JV's time was fast enough for him to finish with a fifth-place medal. We knew this meet was the fourth of five divisional meets. With only one divisional meet left on Sunday, we knew that JV's time was more than likely fast enough to qualify him for All States, which was confirmed after the last divisional meet was run. JV is seeded 11th for All States. Our goal is to try to win his heat putting him in position to medal in the top eight."

"As for our 4 x 400 relay team of Keny Guerrero, Goncalves, Tommy Desir, and Cunha, they didn't have a PR race, but performed well enough to finish eighth, good enough to grab a medal. The boys finished third in their heat with only the fast heat containing six teams left. We kept our fingers crossed hoping that at least two of those teams had an off day for us to sneak into eighth. As it goes, luck was on our side, as indeed one team faltered in the last few yards and ended up running about one second slower, helping us to secure that eighth place medal."

In addition to the medal-winners, another strong performance for Revere at the meet came from Mark Marchese in the 55 meter dash.

"Mark's time was not fast enough to make the finals nor medal, but his time of 6.88 tied his second-best time in the event ever," noted Ros. "Mark was also a part of the 4 x 200 meter relay. Mark led off the race with Allen Hou second, Javan Close third, and Keny Guerrero as the anchor. Getting a medal in this event was tough, but we didn't help our cause

due to some sloppy hand-offs. Nevertheless, to make it all the way to the State Championships is an accomplishment itself."

"We are looking forward to the All-State Championships and hoping to get the Revere name on the podium," Ros concluded.

### YUONG WINS THIRD PLACE AT D-1 MEET

Freshman standout Liv Yuong took home a third place medal in the high jump at Saturday's Division 1 State Meet with a personal record (PR) jump of 5'-0". That jump leaves Yuong just one inch shy of the RHS school record. Her third-place finish qualifies her for the all-state meet next Saturday.

"The fact that she just started jumping in December and has already cleared five feet is incredible," said RHJS head coach Racquel Macdonald. "She was the top-placing freshman in this event at the meet, which is definitely not common for such a technical event like the high jump."

Yuong also took home a sixth place medal at last Tuesday's first annual Rising Championships in the 55 meter hurdles with a time of 10.56 seconds.

"With her talent in both the high jump and the hurdles, the sky truly is the limit for Liv," said Macdonald.

Junior Captain Alannah Burke also finished the Division 1 state meet with a PR in the 1000 meter of 3:23.00.

"Each week Alannah continues to improve and get stronger," said Macdonald. "She is truly coming into her own as a mid-distance runner. All the work she's been putting in this season for the 1000 meter will definitely carry over into outdoor training for the 800, where she is less than a second away from the school record."

Senior Captain Jerelys Canales was Revere's top finisher at the Rising Meet with a third-place finish in the long jump with a leap of 14'-2.75".

"Jerry is such a talented long jumper, but we



don't have the means to practice it during the indoor season," said Macdonald. "So the fact that she can still perform so well during competition is amazing. I can't wait to see what the outdoor season holds for her in that event. Jerelys also finished 11th in the 55 meter dash with a time of 8.12, a great final indoor meet for such a dedicated team leader."

Junior Kyra Delaney had a huge PR at the Rising in the 300 meter dash with a time of 47.29.

"Kyra has truly been improving each meet and I'm so proud to see her consistently running in the low-47 range," noted Macdonald.

Another huge PR was achieved by sophomore Rocio Gonzalez, who knocked an amazing 18 seconds off her mile time with a PR of 6:22.7.

"What a race this was for Rocio!" exclaimed Macdonald. "She went out so smoothly and had such a strong kick at the end. It was such a strong way for her to end the season and I know she will keep bringing that mile time down come the outdoor season."

Sophomore Yasmin Rizazi finished with another PR at the Rising in the 600 meter dash.

"Yasmin took almost a whole second off her previous best and came in at 2:01.44," said Macdonald. "She has been so consistent in this event all season and is right on the verge of that two-minute mark. It was so exciting to see her end the season with a PR."

Finally, junior Natalia Lopez finished off her shot-put season at Risings with a huge toss of 24'-2.00"

"Nat's really been working on getting her form down and you can tell with each throw," said Macdonald.

"Overall, these two meets were truly a great way to close out the season for most of our team," said Macdonald. "The girls performed so well and I feel so lucky to be able to coach such talented and hard working ladies. We are all looking forward to watching Liv next week at All States."

### RHS BOYS BASKETBALL STILL SEEKS ELUSIVE TOURNAMENT CINCHER

The Revere High boys basketball team entered the final quarter of their season with a 9-6 record, needing just one more win among their remaining five contests to clinch a .500 record and secure a berth in the post-season state tournament.

However, the Patriots came up short in three games this past week, leaving them at the .500 mark with a 9-9 record. Revere now has to win one of its two remaining contests. The first came last night (Tuesday) at the General George Patton Tournament when the Pats squared off against the host Hamilton-Wenham Generals in the tourney's consolation contest.

Revere defeated Hamilton-Wenham, 45-40, two weeks ago at the Boston Garden in the Andrew Lawson Tournament, but the Generals were set to have the home advantage in the rematch last night.

The Patriots then will conclude their 2022 regular season tomorrow (Thursday) evening against Lynn English.

All three of the Patriots' losses this past week were hard-fought encounters.

In a 65-58 defeat to East Boston last Tuesday before a packed Merullo Fieldhouse (thanks to a legion of Eastie fans), Eastie led by just a point, 50-49, entering the final period before pulling away.

Senior captain Jack D'Ambrosio led Revere with a double-double of 14 points and 12 rebounds. Senior Hamza Ghoul came close to a 2 x 2 with nine points and nine boards. Senior captain James Clauto also hit for nine points and Ramadan Barry added six.

Last Thursday, the Pats came up just short to Lynn Classical, 66-61. The teams were tied at 61-61 in the final minute when a desperation heave by a Ram player from three-point land as the shot-clock expired sank through the hoop with 0:20 to play.

In the opening round of the Patton Tourney this past Monday, Revere dropped a 52-45 decision to No. Reading. The Pats led 10-9 after the first period, but could not find their shooting touch thereafter as they made just one three-pointer on the day. They managed just four points in the second period to trail 19-14 at the half.

They trailed 36-29 after three periods, but never were quite able to overcome the deficit. Clauto led Revere with 14 points. D'Ambrosio (12 points) and Boudreau (10) also reached double figures for the Pats.

Tiorano lit the lamp twice at the 10:09 mark and then at 11:55 to give the Pats a 2-1 advantage. From there the game belonged to the Patriot defense and goalie Jon Papisadora, who held firm the rest of the way against Marblehead. Fitzpatrick performance also qualified him for the Emerging Elites National Championship Meet to be held on March 9-11 at the 168th St. Armory in New York City. On the girls' side, RHS star hurdler Racquel MacDonald came through with a strong 12th place finish in the large D-1 field. Her time of 9.16 was just short of the 9.05 needed to make the top eight to reach the finals, but was faster than the eighth place finisher's clocking of 9.19 in the finals.

RHS hockey captain Dom Cavallaro and sophomore defenseman Steve Cataldo have been named to the GBL all-star team.


RHS girls basketball junior Christa Margossian has been named to the GBL all star team. Margossian averaged 14.9 points per game.

Former Senator McGee was Chair of this same Committee when Crighton served as his Chief of Staff. During his time serving on the Lynn City Council, Crighton au-

thored a nationally recognized "Complete Streets" ordinance that mandates Lynn consider all modes of transportation (pedestrians, drivers, cyclists, those with mobility issues) when planning transportation projects.

As a Legislator, Senator Crighton has a record of supporting improved transportation. He joined the Lynn legislative delegation, local officials and community stakeholders in successfully advocating for the prioritization of his proposal known as the Environmental Justice Corridor (EJC). The EJC would electrify the commuter rail line from Bos-

ton to the North Shore and would increase frequency, which reducing costs to subway-like fares. While this project was approved, he continues to champion getting electrification funded and operational as soon as possible.

"We're thrilled to have Sen. Crighton as the new Chair of the Transportation Committee. Sen Crighton has been a leader in the fight for a more equitable public transit system, from low-income fares to Regional Rail electrification," said Jarred Johnson, Executive Director of TransitMatters. "We're looking forward to working with Chair Crighton

to build the sustainable, equitable, and affordable public transportation system the residents of the Commonwealth deserve."

Josh Ostroff, Interim Director of the Transportation for Massachusetts Coalition, congratulated Senator Crighton and said he looked forward to working with him. "He is a collaborative, thoughtful legislator who understands the need for ambitious transportation policy to help address our climate crisis, modernize mobility, and promote transportation equity across the state," said Ostroff.

# Despite reservations, License Commission renews licenses for the Quality Inn hotel

The Revere License Commission addressed a full agenda of items at the commission's regular monthly meeting last Wednesday, February 16.

Chairman Robert Selevitch and fellow commission members Daniel Occena and Linda Guinasso were on hand for the meeting.

The chief highlight of the session was the approval by the commissioners of renewals for the various licenses for the Quality Inn hotel on Morris St.

The hotel had been at the center of controversy last fall when then-Boston Acting Mayor Kim Janey had suggested that the hotel, which has been closed since the start of the pandemic, be used to provide housing for the homeless population in the encampment at the so-called Mass. and Cass intersection.

Mayor Brian Arrigo, other city officials, and residents pushed back strongly on Janey's suggestion, which ultimately never went forward. The new mayor for the City of Boston, Michelle Wu, has taken steps to clear the homeless encampment since she took office and has moved the individuals, most of whom suffer from mental health and substance abuse issues, into temporary housing in the city.

However, the possibility of the Quality Inn being used for the purpose of a shelter and drug treatment center for the homeless has lingered in the minds of city officials. Ward 6 Councilor Richard Serino submitted a letter to the License Commission, which chairman Selevitch read into the record, in which Serino stated, "There is trepidation (by the community) about the Quality Inn's long-term goals."

The commissioners questioned the representative of the hotel, Jamin Patel, at length about the future plans for the hotel and eventually gave their approval for the license renewals.

The full discussion of that agenda item (Item #9), as well as the commission's discussion and votes on the many other items that came before it, are as follows:

**Item #1:**

The commission unanimously approved both the inn holder and common victualler licenses, contingent on the final fire inspection, which was scheduled for the following day, being successfully completed.

"This is a family-owned business that also owns the building and the Guevara family has invested a lot of money to upgrade the block of buildings," said Cipoletta. "They also own a sports bar in Lynn which they have operated successfully since 2003. They will serve Caribbean food and they are ready to open."

The new establishment is on the location of the former Buster Bar.

"It seems like we're getting inundated with liquor licenses on Shirley Ave.," said commissioner Guinasso. "But we have them from the state and we have to give them out."

Guinasso complimented the applicant for the great amount of work that they've done to the real estate. She also noted this is a restaurant license, not a pouring bar.

There were neither opponents nor proponents and the application was approved unanimously.

Atty. Larry Simeone appeared with Mr. Patel to present the application. Simeone said that Mr. Patel presently operates a similar business in another community. There currently is a convenience store, Breadbasket, at the 535 Broadway location and that it is Patel's intention to purchase the existing business and convert it into a package store.

However, Occena raised a number of issues with the application. Chief among them is that there presently is a malt and wine license at the location, but the new owner is seeking a full liquor license, which means that the existing license will have to be turned back to the city and the applicant will need to seek a brand new license. There also were issues with the proper documentation that accompanied the application.

"We've applied this standard to other applications and to be fair, we should do so here," said Occena.

Guinasso agreed that the paperwork has been confusing, but suggested that the license be granted contingent upon receipt of the paperwork.

However, Occena was

adamant that the application should not be approved without the proper paperwork being filed first.

Selevitch also had questions about the paperwork that had been presented to the commission.

There were neither proponents nor opponents and the commissioners then discussed the issue.

"In the past I have been in favor of granting licenses contingent upon receiving the proper paperwork," said Guinasso. "We will not be giving the license out until every 'i' is dotted."

However, said Occena, "There is no sense of urgency and the parties have plenty of time in order to get us the proper paperwork. I do not feel comfortable approving this application, contingent upon receiving the paperwork."

Selevitch added, "I don't like to see businesses not being given a license. I want to see everybody thrive in the city. But the process is important. The paperwork needs to be filed and put in properly. We can have a special meeting if we need to do so before the next monthly meeting."

**Item #9:**

Sudguru Hotel, LLC d/b/a Quality Inn, 100 Morris Street, Beth Scherer, Manager:

Application for Renewal of Common Victualler, Entertainment, and Innholder/Hotel Licenses: Application of Sudguru Hotel, LLC d/b/a Quality Inn, Beth Scherer, Manager, for renewal of existing Common Victualler, Entertainment, and Innholder/Hotel licenses. This matter is continued from the January License Commission meeting.

Jamin Patel presented the application and discussed the present plans for the Quality Inn, which has been closed since the start of the pandemic two years ago.

"We had hoped to have opened last summer, but that never materialized and then the Omicron variant hit in the fall, which resulted in a lot of cancellations in our business," said Patel. "We hope to reopen at some point this year, though we do not have a set date. Hotel bookings in the area have increased from 25% last year to 45% this year, so the trend is in the right direction. We want to reopen as soon as possible at some point this year. No one is more motivated to reopen than us because of the fixed expenses that we have to meet."

Selevitch asked about the reports of the hotel being converted into a temporary homeless shelter. "The neighbors have a right to know what's on the table for this property," Selevitch said

Patel acknowledged there had been discussions with state officials about using the hotel for a full-range drug rehabilitation program, but that he had not been personally involved in the discussions.

"This was presented to

us in a way that was different than what was reported in the media," said Patel.

Selevitch then read aloud a letter that had been submitted to the commission by Ward 6 Councilor Richard Serino.

Serino's letter, in pertinent part, stated, "I lean in to denying the application. Prior to COVID-19, the hotel had been a good neighbor. However, the relationship between the hotel and the neighbors has deteriorated. For almost two years, the hotel has not been operating as a hotel, even though other hotels have resumed operation. However, the Quality Inn has remained shuttered and has acted in a way that is unneighborly. It has not put the same emphasis on being a community partner with the No. Revere neighborhood and the city of Revere as a whole. There is trepidation about Quality Inn's long-term goals."

"What are you going to do to change that perception?" asked Selevitch.

"I understand the concerns," said Patel. "But the hotel industry is far from getting beyond the pandemic. When we had tried to remain open, there was a problem with abuse that was terrible for our staff regarding mask-wearing. We had thought this was only going to be a short-term closure.

"But without a license renewal, we'll be set back even further from reopening," Patel continued. "We're hoping to be back in business as a community partner and bring jobs for local people. We're a family-run business and want to partner with the community once again by helping the community as we have done in the past."

"There is a concern that it will not be a hotel," said Selevitch. "But your reassurance that it will be a hotel going forward is good for re-establishing that neighborly feeling for the community."

Other than Serino's letter, there were no proponents and no opponents to the application.

The commission voted 3-0 to approve the application for the license renewals.

**Late application:**

Local resident Diana Cardona appeared before the commission to seek a one-day entertainment license with food trucks at RHS on Sat., March 12, from 7-10 p.m.

"About 600 people are expected," said Cardona. "This will be a comedy show with a comedian from Colombia. He is touring in America and will make a stop here. It will be a family event. Tickets will be \$30-\$50."

Cardona previously had received a similar one-day license for an event that was held at the high school for Hispanic Heritage Month last October.

The commissioners asked about security and were told that there will be four custodians for the event. However, the com-


