Revere holds groundbreaking for new state-of-the-art DPW facility

Mayor Brian Arrigo led the city's groundbreaking ceremony for a new state-of-the-art Department of Public Works facility Monday at the site located at 319 Charger Street.

Construction on the new, one-story 39,000 square-foot facility will be completed in the fall of 2023. The facility will

have more room for office space, training rooms, maintenance bays, and storage.

Julie Leduc of Hill International, the owner's project manager, said, "It is very exciting for us to be here today to break ground on such a momentous occasion. These DPW workers are the heart and soul of your city, and I have to

say that they are well deserving of this beautiful facility that we're going to build for them."

RPS Extended School Year summer program incorporates music therapy

Students in the Revere Public School Extended School Year Program (ESY) spent their summer school days enjoying a musical component. Each week, each class was treated to a 30 minute music therapy class provided by Roman Music Therapy, a contracted agency funded through Revere SEPAC.

The ESY program included 136 students ranging in age from 3 years to 22 years old and included 75 teachers, paraprofessionals, and therapists. Students enrolled in ESY have varying abilities and needs. ESY is not designed for specific disabilities, rather ESY provides services that are individualized to help each student maintain their skills and included in a student's

ConsComm gives approval for Global tanks to come down

The Revere Conservation Commission held its regular monthly meeting last Wednesday evening, August 3, in the City Council Chamber.

Chairman John Shue and commissioners Robert Cassidy, Ann Raponi, Joseph LaValle, Heather Legere, and Brian Averback were on hand for the meeting.

After approving the minutes from the commission's July meeting, the

commissioners tackled a light agenda of various items.

The principal matter before the commission was the continuation of the public hearing from last month regarding the filing of a Notice of Intent (NOI) by Revere, MA, Owner, LLC, (DEP #061-0784) to demolish the tank farms at the former Global Petroleum property at 101 Lee Burbank Highway in order to construct a state-of-the-art warehouse facility.

Chris Roller with Sara-

cen Properties, the developer of the site, presented the application to the commission. The removal of the tanks at the site will be done in two phases, of which only the first phase was before the commission.

Kevin Trainor, a geologist with Verdantas Co. in York, Maine, which will be responsible for any spills of hazardous material on-site during the demolition part of the project, told the commission of how Verdantas will be

overseeing this aspect of the project.

ment of Works for their efforts in the city.

“I want to thank and celebrate truly all the incredibly hard-working men and women of the Revere DPW,” said Arrigo. “We would not be here without all of you. As Julie said, you truly are the heart and soul of our community, and you are incredibly vital to the way that our city operates and the direction that the city is going. I admire your dedication to our city and on behalf of our residents, I want to thank you, because you always show up.”

Arrigo said for decades the community had watched as the old DPW building “deteriorated before the eyes.”

“Now fast forward to today, where the memories of that building are long gone, and we have a brighter future,” said Arrigo. “Today officially marks a new chapter, both for the city of Revere and for our Department of Public Works because we are officially breaking ground on a new DPW. This brand new, state-of-the-art facility will obviously allow for better office space, training rooms, and the proper maintenance of equipment. But truly it’s about showing the respect for the men and women who work on behalf of our residents throughout every crisis, throughout every snowstorm. Every major event that we have, they’re first

responders.”

Rep. Jessica Giannino, who was a councilor-at-large when the project was first proposed and then eventually approved, and State Rep. Jeff Turco also praised the Revere DPW for its vital, day-to-day work on the city.

“On days like this, if it’s 100 degrees outside, or if it’s negative 20 and we’re in a blizzard, they’re on the front line,” lauded Giannino. “Under Don Ciamarella [Chief of Infrastructure and Public Works] and Paul Argenzio [DPW Superintendent], they make it happen, so thank you, guys.”

Rep. Turco said to the DPW workers standing behind the podium, “When you think of the work you guys do in sub-zero weather, in blistering heat, it’s previously amazing, from the big to the small projects, we thank you for your works on behalf of the residents in Revere.”

Turco also credited Arrigo and the City Council for advancing the project.

“You got a mayor and a city council that said, ‘this is critically important to the well-being to the City of Revere, that we have the best situation we can for our DPW workers, to have a building that’s state of the art, and we’re going to invest in that infrastructure as our city grows’.

“I want to thank you, Mr. Mayor, because it would have been easy not to spend the kind of money that we’re spending to build this facility. It would have been easy to spend on other things that the public likes politically, but you and the City Council made a commitment to the people of Revere and to the people that make this run day-by-day.”

Ciamarella thanked Mayor Arrigo, the City Council, and residents for their support of the DPW and the Water and Sewer Departments.

“I especially would like to thank the Mayor’s Administration for helping

Resources (MDAR) Commissioner John Lebeaux, along with state and local officials, are spending the week touring farmers markets throughout the Commonwealth to highlight the impact these markets have on their communities, serving as a vital link for the public to buy direct from local farmers.

“Farmers Markets offer us all with the opportunity to support the Commonwealth’s many farms – big and small, and to meet and engage directly with our farmers and their staff,” said Energy and Environmental Affairs Secretary Beth Card. “That special relationship between farmer and consumer highlights how local food is embedded in the culture of so many communities across the Commonwealth. The Baker-Polito Administration is proud to continue to support the state’s growers and producers.”

In addition to the local food that they provide, farmers markets afford the public a chance to learn about the local food supply and how their food is grown. They are educational for all ages, allow-

ing consumers to understand and recognize the hard work that goes into growing and harvesting food.

“While we support them in every season, now is an especially fantastic time to go out and support your local farmers market,” said Department of Agricultural Resources Commissioner John Lebeaux. “It is the perfect time to be celebrating farmers markets during the height of summer as Massachusetts is currently in the midst of its peak harvest so consumers will find a vast and varied array of fruits, vegetables, and other wonderful, delicious products at their local farmers market.”

Over 7,200 farms in Massachusetts keep approximately 491,000 acres of land as open space and produce over \$475 million in agricultural goods each year. Massachusetts ranks fifth in the nation for direct market sales with over \$100 million annually, which accounts for 21.1% of the state’s total sales of agricultural products—the highest proportion in the country. Additionally, there are approximately

216 summer and fall farmers markets and another 37 winter farmers markets in communities across the Commonwealth.

Increased access to the healthy foods available at farmers markets is made possible through partnerships and programs such as Supplemental Nutrition Assistance Program (SNAP), Healthy Incentives Program (HIP), the Women Infants and Children (WIC), and Seniors Farmers Market Nutrition Programs. Furthermore, farmers markets provide direct access to the state’s agricultural sector, help build a strong sustainable local food system, serve as public and community gathering places, and foster a closer connection between the consumer and the food that they consume.


FY 2022 REVENUE COLLECTIONS TOTAL \$41.105 BILLION

The Massachusetts Department of Revenue (DOR) Commissioner Geoffrey Snyder announced that preliminary revenue collections for June 2022 totaled \$4.143 billion as of August 4, 2022, which is \$470 million or 12.8% more than actual collections in June

2021 and \$780 million or 23.2% more than benchmark.[1] June 2022 revenue collections were impacted by the recently enacted elective pass-through entity (PTE) excise. After adjusting for PTE excise, June 2022 collections are \$213 million or 5.8% above actual collections in June 2021, and \$710 million or 22.3% more than benchmark.

Revenue collections for FY2022 were \$41.105 billion, which is \$6.982 billion or 20.5% more than collections in FY2021, and \$3.438 billion or 9.1% more than the benchmark. After adjusting for PTE excise, FY2022 collections are \$4.932 billion or 14.5% more than collections in FY2021 and \$2.668 billion or 7.3% more than benchmark.

Since FY21, when sales tax acceleration was implemented, entities subject to sales tax acceleration make estimated payments in June for which returns are due in late July, and only once those returns are filed can DOR assess the split between taxes that are collected on behalf of the state, versus local option taxes that go to municipalities and taxes owed to the convention center fund.

CITY EMPLOYEES PAID IN FULL; NEW LOAN EXPECTED

BRIDGE PROJECT PLACED ON NEW FEDERAL ROSTER

Construction Of Point Of Pines Span Still Being Sought; Connery May Aid

Although the Point of Pines bridge project struck a snag when it was set aside for projects involving a greater number of workers, Representative Augustine Airola of this city was assured this week by Herman McDonald, Associate Commissioner of Public Works, that its construction could be started within two months through a \$10,000,000 loan which the State is to receive from the Federal Government within the next month.

The bridge failed to be included in the first list of public works sanctioned by Federal officials, Representative Airola states, because its construction would not involve the number of workers other projects being considered would, and the other projects were granted first.

During the past week Representative Airola conferred with Congressman William P. Connery over plans for Federal acceptance of the proposed bridge.

The project has been the subject of much discussion in State circles for the past two years and time and

5 YEAR OLD BOY KILLED IN TRUCK FALL NEAR HOME

Paul Capano, 11 George street, this city, five-year-old son of Mr. and Mrs. Vincenzo Capano, was almost instantly killed yesterday morning when he fell from the rear of a truck owned by Josephine Melchionno, 40 Temple street, and operated by Antonio Melchionno.

According to the police who questioned Melchionno, he had stopped this truck near the Capano home and a group of young children clambered on the rear of the vehicle. Before he started forward he warned them to get off.

Scanning the rear of the truck he could see no one on it, he stated, and started forward, coming to a stop when he heard a scream of pain. He saw the boy's body in the road and rushed him to the office of Dr. Harry L. Masters.

The physician ordered the lad's immediate removal to the Chelsea Memorial hospital, but upon arrival at that institution young Capano was pronounced dead.

Theresa Capano, sister of the victim, witnessed the accident.

A further investigation may be undertaken.

ASK GOVERNMENT SUPPORT IN LOCAL WORKS PROGRAM

A huge public works program entailing a cost in excess of \$1,000,000, was discussed at an informal conference in City Hall Wednesday evening at which Mayor Andrew A. Casassa, City Engineer James A. Lockhart, and the City Council were present and it is understood that a petition for Federal aid for the program here would be asked.

The work set forth in the extensive program does not include any improvement which can in any way be considered a luxury, consisting mainly of sewer, drain and street construction.

The entire project was debated for more than two hours and official action is expected to be taken on the matter at next Monday night's meeting of the City Council.

Funds are to be made available for public works project under the National Industrial Recovery Act and the program here is being drawn up with a view to asking Federal support for a \$1,418,000 worth of improvements, it is said.

The Town of Winthrop, it is contended, has asked for \$774,000 under the same act, and local officials deem the Revere estimate as fairly conservative, inasmuch as much work is necessary in the low, easily flooded sections of Beachmont, and because of the palpable condition of roads and streets throughout the city.

Before support can be obtained, four separate steps must be taken: (1) approval of municipal bodies; (2) approval of the State Emergency Finance Board; (3) approval of ex-Governor Alvan T. Fuller's local administration board; (4) approval of Federal authorities at Washington.

DELLA PORTA HOME VISITED BY PAIR OF GUNMEN MONDAY

Two armed men forced their way into the home of Anthony Della Porta, one of the four men indicted last week with Mayor Michael C. O'Neill in connection with alleged graft and corruption in Everett, at 78 John Mooney road, this city, shortly after ten o'clock Monday night. They left after making a careful search of the house. Della Porta was not at home.

The maid, Miss Mary Brachanow, reported that one man first rang the doorbell. When she opened the door, she said he forced his way in, gun in hand. He was quickly followed by a second man, also armed. During the search of the house, one of the men took the youngest Della Porta child from his crib and placed him behind a door.

Another member of the household told police a third man was waiting in a machine outside. Police are still investigating the matter.

Della Porta was indicted on a charge of conspiracy to permit gambling implements to be used. His indictment was in line with the government's contention that slot machine and other gambling devices are allowed to operate in Everett.

With the voluntary appearance at the East Cambridge courthouse Monday of Mayor O'Neill and John A. Grover, of 134 School street, Everett, all seven defendants named in the indictments returned by the Middlesex County Grand Jury have been accounted for.

Indicted with Della Porta on the slot machine charge was Anthony Cataldo of 27 Hutchinson street, this city. Both Della Porta and Cataldo were taken into custody by Frank G. Hale, state officer, and are released in bail of \$2000.

Mayor Asks Councilmen To Approve New Appropriations

The Revere City Council, at its regular meeting Monday night, was asked to approve appropriations totalling \$30,000 by Mayor Andrew A. Casassa, who sent communications to that body requesting amounts ranging from \$1000 to \$11,500 for various purposes. At the conclusion of the meeting the requests were still before the Council's committee on finance and will be acted on next week.

The principal items of the requested appropriations were \$10,000 for teachers' salaries, \$11,500 for street lighting, \$2400 for gasoline, oil and tires in the public works department, \$3000 for new police cars and \$1000 for extra clerk hire in the Collector's office.

Another appropriation of \$5000 to cover the salaries of five investigators already at work in the public welfare department was also asked. The five men are John Malcolm MacAulley, Fred Miskelly, J. Buckley, Walter Sweeney and Fred Hilman.

In his letter to the City Council asking for the appropriation, Mayor Casassa stated that the re-organization of the welfare department was recommended by the State Emergency Finance Board as a condition on which the \$285,000 loan was recently granted.

In another urgent letter, Mayor Casassa asked the appropriation of \$350 to meet the electrical expenses of the Pines pumping station in order to keep the Pines sewerage system in operation.

The communication set forth that during the time of the flood and the high tides the pumps at the station were worked overtime, with an additional expense for electricity.

In answer to a request of the City Council, James A. Lockhart, city engineer, appeared before the council, in accordance with section 37 of the city charter.

Councilman Thomas U. Kelley immediately questioned the city engineer regarding several orders of the council at previous meetings this year. Lockhart advised that he had no information and no answers to these orders of the council at the present time.

During a heated debate with his questioner, Lockhart stated that he would answer only such orders as were approved by His Honor, the Mayor, or requested by him to do so. Councilman William J. Gallagher requested information regarding appropriation for tires in the public works department, of which Lockhart is acting superintendent. The information was provided, but a later request by Councilman Kelley for data regarding abatements on water bills as requested by the council, brought forth the retort from Lockhart that he had received no instructions from the Mayor to present this information.

The meeting was a lengthy one, adjournment taking place at 1:15 a.m. Complete record of the council meeting follows on page three.

HOME LOAN BANK IN CHELSEA WILL AID OWNERS HERE

Plans are now under way for the establishment of a branch of the Federal Home Loan Bank in Chelsea to cover loans in that city and Revere.

The Home Owners' Loan Corporation, which was created by an Act of Congress on June 13, has established Boston offices and will, it is understood, branch out into nearby communities.

No official announcement has been made with regard to the establishment of such an institution, but it is said that two Chelsea men have been mentioned as managers of the branch. Their appointments are said to have been Chelsea's share of federal patronage.

These men have been seeking quarters in the Chamber of Commerce building in Chelsea, at city hall, and in one Broadway building, near a Chelsea bank.

Furniture is being selected for the quarters, and arrangements will be made to employ a young woman as stenographer and clerk for the officials.

The new organization was created to deal entirely with individual home owners and is separate from the Home Loan Bank Corporation, which deals with banks. It is primarily for the relief of the distressed home owners, who through inability to pay taxes, or interest on a mortgage, may apply to the new organization for aid.

The law specifies, however, that the owner of the property must be threatened with foreclosure or loss of his home in some other manner before he is eligible for assistance through the act.

RUNAWAY TROLLEY WRECKED; WOMAN HURT IN MISHAP

A runaway trolley car backed off the rails at the end of the Beachmont terminal on Winthrop avenue Monday afternoon, tore over the concrete roadway of the thoroughfare, down a steep grade for about 200 feet, and then crashed into a large tree with such an impact that the vestibule was demolished, while the tree was wedged tightly into the roof.

Three persons were on the car when it started to roll backwards, the motorman, William S. Pike of Garfield avenue, Chelsea, George Levine, employed as a guard by the Boston Elevated Street Railway, and Miss Mary McDonald, superintendent of nurses at the John Adams hospital, Soldiers' Home, Chelsea.

Miss McDonald was badly shaken and bruised, and was driven from the scene of the accident in a taxi cab.

Levine jumped from the car just as it started on its wild flight down the hill so as to warn pedestrians who might be in the pathway of the trolley. Pike, the motorman, who is 65 years old, appeared to be unhurt, although he was badly shaken up.

The car is on a line running between Malden square and Beachmont. Pike had changed ends on the car preparatory to starting the return trip to Malden. The brakes were set, he said. The nurse boarded the car and just after Levine boarded it Pike stood at the controls ready to start forward. Suddenly the heavy car, weighing about 25 tons, began rolling backwards.

Despite Pike's attempts to stop it

800 RECEIVE BACK WAGES; FIRST PAY DAY SINCE APRIL

O'Brien To Confer With Banking Officials Tuesday For Authorized Loan

The office of City Treasurer James M. O'Brien in City Hall was a busy spot yesterday with 800 employees of the city of Revere, both regular and part-time, wearing a path to the financial sanctuary to receive wages due for five months, totalling in excess of the \$287,000 loaned to the city by the State Finance Commission.

The regular employees numbered 640 men and women, including school teachers, policemen, firemen, laborers, clerks, etc. Approximately 160 "substitute" and part-time workers, largely election officials, made up the rest of the payroll roster.

The money was brought to City Hall Tuesday under a large police guard, and was kept in the City Treasurer's office up until the time it was delivered to the various city employees. At all times it was under the surveillance of well-armed police officers.

Following its receipt, treasury department workers toiled ceaselessly getting the payroll in order and ar-

MAN FOUND DEAD IN MARSH HERE; NATURAL CAUSES

The object of a police search for a day and a night, Roman Dambroski, 40, of 34 Chestnut street, Chelsea, employed as a track laborer for the Boston & Main Railroad, was found dead yesterday in deep grass about 25 feet north of the spur track being built across the North Shore cutoff in this city.

Dambroski went to work as usual at 7:30 a. m. Wednesday morning and was last seen about that time by his foreman, John Reilly, 23 Hyde street, Revere. At 9:30 that morning it was noticed that he was not present on the job.

Reilly called his lodging house and when Dambroski's landlady claimed to know nothing of his whereabouts, the police were notified. His description was furnished route men, and when he was still absent yesterday morning a searching crew of track laborers was appointed by Reilly and the area around the construction job was scanned.

When no results were obtained from the search, Reilly again went to a phone to notify police authorities. Shortly after the phone call was made the body was found by Asluk, who notified Antonio Scobbo, 153 Everett street, East Boston, his foreman.

Police investigation disclosed that Dambroski had been in good health apparently and never complained of any illness. Reilly stated that he worked steady and was a good worker.

The medical examiner was notified and Patrolman James J. Dugan went to the scene pending removal of the body to the Northern Mortuary. Death was apparently due to natural causes.

A brother of the dead man, residing in Chelsea, was notified to claim the body.

horrors of this pandemic, I think nothing's more obvious than the need to think about culture, think about community and think about the way that we need to intentionally build culture."

Bowen said when he thinks about his purpose in school he truly believes that what happens in classrooms every day has the power to change the world.

"I think that we need to be mindful of how we're empowering our teachers to kind of latch on to that passion and give voice to our communities and our families and our kids—to empower them to do just that," he said.

"So I think that it's related very much to what it means to be a leader for social justice. I see schools as centers for social justice and we need to think when we're making decisions, when we're thinking about choices, how we put those individuals, those students in particular, who have been most marginalized by society in the schooling process, at the center of the reforms we are making."

Bowen said there are some very concrete ways that schools can do that.

"We've got a great faculty here who are very mindful of that," he said. "There's a lot of wonderful ways that target interventions—through programs that are clearly defined—can really support all students. Not just those who need those programs, or who benefit from them,

but everybody else in the school."

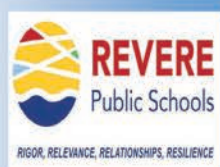

August 8, 2012**

School Superintendent Paul Dakin said the McKinley School has received a very competitive Extended Learning Time grant from the state that will allow the school to have a longer day and a longer school year. Starting this year, the McKinley will start the school year five days earlier than the rest of the district, on Aug. 21st for grades 1-5, and will also extend the school day, going from 8 a.m. to 3:40 p.m.

State School Building Authority (MSBA) executives and board members visited Revere City Hall on Monday to deliver the message that Revere needs a new high school very soon. Meeting with Mayor Dan Rizzo and Superintendent Paul Dakin in an unsolicited gathering, MSBA Executive Director Jack McCarthy and several MSBA Board members informed the city that it needs to start thinking about a total replacement of RHS, even though the high school is less than 40 years old.

The Revere Moose Lodge has trimmed its antlers and kicked some bad habits, namely cigarette smoking. The recently-troubled club has gone through some major organizational changes since nearly dissolving last January, and last week the lodge made a major move in becoming the first private club in Revere to prohibit smoking within its building.

August 14, 2002**

The Boston Archdiocese has announced that Fr. Anthony J. Rebeiro, 71, who had been assigned to St.. Anthony of Padua parish until last July, has been placed on administrative leave after allegations that he sexually abused a child at a Natick parish 30 years ago. Rebeiro is the latest Catholic priest to be accused of molesting a child.

A 25 year old Charlestown man, who allegedly was driving drunk, has been charged with dragging a State Trooper in a stolen minivan and then slamming the minivan into a parked car on a busy Revere St. in the midafternoon.

The Revere Board of Health has voted to ban smoking in local restaurants, eliminating smoking sections which had been permitted previously. Revere smokers are complaining about the tax increase of 75 cents imposed by the legislature, which will bring the total cost of a pack of cigarettes over \$5.00.

A veto of spending for local aid in the state budget by Gov. Jane Swift will mean \$800,000 less in local aid for the city. “The governor croaked us on her vetoes,” said a disgusted Mayor Thomas Ambrosino.

A report from the State Lottery Commission shows that Revere resi-

dents spent \$4 million on lottery tickets in 2001.

Friends of Boston City Councillor Brian Honan, who was a candidate for Suffolk County District Attorney, are mourning his passing. Honan, 39, died from complications of surgery after a malignant tumor was removed.

Immaculate Conception parish sent a contingent of its parish youth to Toronto to partake in World Youth Day activities at which Pope John Paul II spoke to them.

August 12, 1992**

The scandal involving former Catholic priest James Porter continues to reveal new details involving Revere, where Porter was born and raised. Revere Police Officer Michael Casoli said that in 1966, he responded to a report of the molestation of a young boy that had occurred in a local park. However, no police report of the incident was filed because according to Casoli, the boy’s father did not want to press charges. Casoli and his partner, the late George Hurley, found Porter at a card game that night at the Knights of Columbus and their conversation with Porter was described as “wacky” by Casoli, though Porter never denied the allegations outright. Casoli and Hurley also spoke to Rev. James Bono at the Immaculate Conception and Bono promised that Porter would get treatment.

The Land Court has set a date of August 14 for a hearing to resolve an ongoing dispute between the city and a developer, the Richmond Company of

the Charter Development Corp., concerning its proposal to build 24 single family homes with in-law apartments.

Firefighter Union President Christopher Bright says that the layoffs of firefighters have been disproportionate to the number of layoffs of other city employees.

State Senator Thomas Birmingham announced this week that state funds will be available for the repair of Cronin Rink.

Area residents and the developer of the former Grover Manor Hospital property have reached an agreement for housing at the site, according to Ward 6 City Councilor Steve Colarossi. The plan calls for 25, single-family homes with in-law apartments and with each lot to be 8000 sq. ft. Seventeen of the lots will be on a cul-de-sac opening to Sargent St. The developer will minimize traffic congestion and alleviate sewage concerns. The new plan is in stark contrast to the original plan calling for condos and duplex housing that was rejected by the Revere Planning Board two years ago.

Mayor Robert Haas traveled to Washington, D.C., to join with Congressman Edward Markey to support a bill that would make Revere Beach part of the national park system.

Trainor said the work to be done in the decommissioning and demolition of the above-ground tanks will be conducted principally outside of the wetlands buffer zone, though some portion of the project will encroach on the buffer zone.

Trainor told the commission that ultimately, "There will be a tremendous environmental benefit with the removal of these tanks."

Trainor noted that there have been more than 60 documented releases of petroleum products by Global in the operation of its tank farm over the years. Five of the spills were inherited by the new owner, all of which are underneath the tanks and have not been addressed in the past, as part of the transaction.

Trainor indicated that testing will be conducted for the ground underneath the tanks themselves as each of the tanks is demolished.

Trainor pointed out that development of the property is deed-restricted to avoid identified areas of the property where there is known contamination that still exists. He said these contaminated areas are stable and will not be disturbed by the construction

Nick Scola, an engineer with VHB Co. of Woburn, explained how stormwater will be collected and treated during the demolition process and that the new system will be an improvement over what exists now.

Dan Connerton, a vice-president for development for the East region with Logistics, LLC, the actual owner of the property, added that his company has received awards from the federal and state environmental agencies for Logistics' environmental record in reducing carbon emissions and improving environmental resiliency with its projects.

"This type of project is what we do," said Connerton. "We try to unlock these environmentally-challenged sites to re-develop them, re-purpose them, and clean them up to turn them into state of the art logistics facilities that will bolster the local economies."

"You're in good hands with us," Connerton added.

The commission then voted to approve the Notice of Intent and issued the usual Order of Conditions, though with some minor additions particular to the project.

"For the record, this is a

great project and the long-term impact of the project will be a benefit to the environment," said Shue.

In other matters before the ConsComm, the commissioners heard a request from David Walker, a vice president for construction for Hines Construction Co., for confirmation that the proposed relocation of a transformer by National Grid does not have a significant impact that requires either amending the present Order of Conditions (OOC) or the filing of a new Notice of Intent (NOI) for the apartment construction project at 646 Ocean Avenue (DEP File #061-0730).

Walker explained that since the initial design plan was developed, National Grid has decided to place its transformers outside of the building, rather than inside.

Hynes has obtained a building permit from the city based on the outside location of the transformers, but National Grid has asked Hines to obtain a determination from the ConsComm that either a new NOI or amended OOC is not needed.

The members voted to determine that the change is not significant enough to warrant either a new NOI or an amendment to the OOC.

A similar request was presented for the construction project by Amazon for its warehouse at 565 Squire Road (DEP File #061-0745) for confirmation from the commission that a proposed change from National Grid to re-route a proposed underground electrical service to overhead is not significant and does not require an amendment to the existing OOC or a new NOI.

Matthew Costa, a civil engineer with Beals Associates, presented the request to the commission. Costa showed the commissioners a drawing of the project and explained that National Grid now wants an overhead line.

Costa told the commission that the entire project should be ready within a year.

The commission voted that the proposed change is not significant enough to warrant either a new NOI or an amended OOC.

In a separate matter, the commission learned that the new fire station at the Point of Pines will be delayed because the state has determined that the land essentially is a sand dune and therefore the new fire station must be constructed on pilings.

The commission next will meet on Wednesday, September 7.

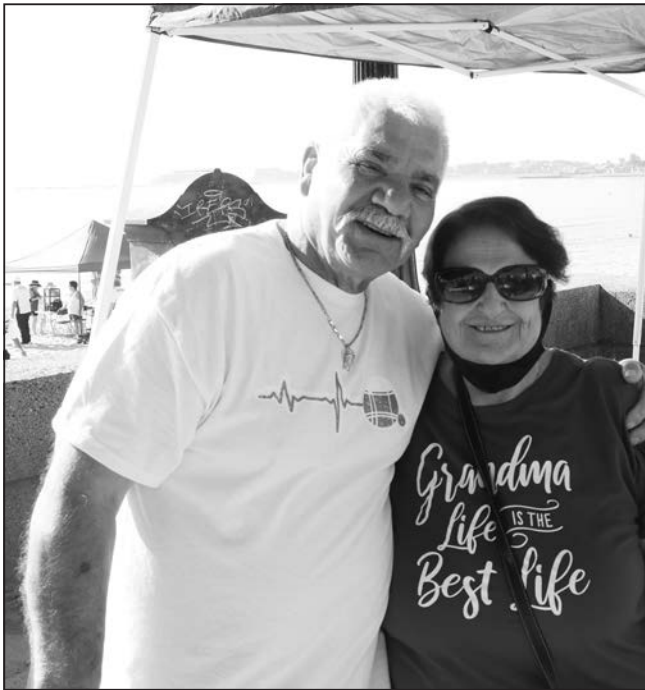

Two Revere firefighters graduate from state Firefighting Academy

State Fire Marshal Peter J. Ostroskey and Deputy State Fire Marshal Maribel Fournier, acting director of the Massachusetts Firefighting Academy (MFA), announced the graduation of 61 firefighters from the Massachusetts Firefighting Academy today. Graduates completed the 50-day Career Recruit Firefighting Training Program at three campuses: Class #303 trained at the Stow campus, Class #S28 trained at the Springfield campus and Class #BW21 trained at the Bridgewater campus.

“First responders are on the frontlines protecting their communities, and these newest firefighters are needed now more than ever,” said State Fire Marshal Ostroskey. “The rigorous professional

training they’ve received provides them with the physical, mental, and technical skills to perform their jobs effectively and safely.”

Basic Firefighter Skills

Students receive classroom training in all basic firefighter skills. They practice first under non-fire conditions and then during controlled fire con-

ditions. To graduate, students must demonstrate proficiency in life safety, search and rescue, ladder operations, water supply, pump operation, and fire attack. Fire attack operations range from mailbox fires to multiple-floor or multiple-room structural fires. Upon successful completion of the Recruit Program all students have

met the national standards of National Fire Protection Association 1001 and are certified to the level of Firefighter I and II, and Hazardous Materials First Responder Operational Level by the Massachusetts Fire Training Council, which is accredited by the National Board on Fire Service Professional Qualifications.

Today’s Firefighters Do Far More than Fight Fires

Today’s firefighters do far more than fight fires. They train to respond to all types of hazards and emergencies. They are the first ones called to respond to chemical and environmental emergencies, ranging from the suspected pres-

ence of carbon monoxide to fentanyl overdoses or a gas leak. They may be called to rescue a child who has fallen through the ice or who has locked himself in a bathroom. They rescue people from stalled elevators and those who are trapped in vehicle crashes. They test and maintain their equipment including self-contained breathing apparatus (SCBA), hydrants, hoses, power tools, and apparatus.

At the Massachusetts Firefighting Academy, they learn all these skills and more, including the latest science of fire behavior and suppression tactics, from certified fire instructors. They also re-

ceive training in public fire education, hazardous material incident mitigation, flammable liquids, stress management, and self-rescue techniques. The intensive, 10-week program for municipal firefighters involves classroom instruction, physical fitness training, firefighter skills training, and live firefighting practice.

The MFA, which marked its 50th anniversary last year, provides recruit and in-service training at three separate campuses and has graduated nearly 14,000 firefighters in more than 430 classes.

IEP, which is determined based on a team decision.

ESY differs from the traditional summer school hosted by students’ neighborhood schools. The ESY program focuses on individualized instruction and/or related services that are part of a student’s Individualized Education Plan (IEP). The services are intended to limit significant skill regression and provide for the carry-over of skills, instruction, and routines.

Revere SEPAC (Special Education Parent Advisory Council). was able to fund music therapy services two days per week during the 22-day program. Revere SEPAC provides access to relevant resources, laws and regulations, and activities that impact special education in the City of Revere. Revere SEPAC has funded Roman Music Therapy in the past (during ESY, after-school enrichments, and other social gatherings) and hopes to do so in the future for students in Revere.

Jaqualine Singer, the ESY Coordinator and RPS SEPAC Liaison, had high praise for the addition to this year’s ESY program. “Classes completed by Ro-

man Music Therapy are a wonderful enrichment opportunity provided by trained staff who support the needs of individuals with diverse needs. Revere SEPAC supports students receiving special education services and their families in the community. Revere SEPAC is always looking to partner with agencies to provide enrichment activities and opportunities for students and families in Revere. We encourage agencies to reach out to us if they have a service that would enhance the lives of our students and their families. MGC awards \$10.6 Million in grants from Community Mitigation Fund

The Massachusetts Gaming Commission (MGC) recently approved the award of over \$10.6 million in Community Mitigation Fund grants to numerous municipalities and other eligible entities across Massachusetts including more than \$2.3M for Everett Projects.

Since 2015, the MGC has awarded approximately \$37.7 million in grants from the Community Mitigation Fund. The fund, established by the gaming law, helps host and surrounding communities and other qualified applicants to offset costs related to casino construction and operation. Grant awards support a range of community needs including education, transportation, infrastructure, housing, environmental issues, public safety, and emergency services.

“The more than \$10 million in grants awarded through the 2022 Com-

munity Mitigation Fund is yet another example of the Commonwealth’s commitment to fully realize the benefits of its gaming industry as well as the Gaming Commission’s continued fulfillment of the mandate made by the Legislature to mitigate any unintended impacts tied to gaming in Massachusetts,” said MGC Chair Cathy Judd-Stein. The MGC is proud to support communities in the Commonwealth as they seek to improve government services and make advancements in road safety, tourism marketing, wellness and recovery services, public safety training and personnel, and job readiness programming. On behalf of the Massachusetts Gaming Commission, I extend congratulations to all of our 2022 grant recipients and look forward to the numerous ways those awards will make innovative, tangible improvements to the Commonwealth and its com-

munities.” The Community Mitigation Fund review team conducted a comprehensive review of all applications to ensure compliance with the 2022 Guidelines and made recommendations to the Commission over the course of several public meetings throughout the spring of 2022. After deliberation on those recommendations, the Commission voted to award the following grants:

- Revere Place-Making & Branding Broadway — Community Planning; \$100,000
- This grant provides funding for marketing efforts around the Broadway corridor in Revere related to district identity, brand association, improved public realm and cross marketing campaigns designed to stimulate economic recovery of the corridor while generating linkages to the district’s unique history and venues

One Person Dogs

There are breeds known for a tendency to be one-person dogs. These include Greyhounds, Shiba Inus, Cairn Terriers, German Shepherds, Afghan Hounds, Akitas, Australian Shepherds, Border Collies, Chihuahuas, Chows, Dobermans, and Basenjis. However, we have seen members of all these breeds who shared their love with multiple people. They may have a favorite human being, but most dogs do.

Clinging to one person can be a form of separation anxiety. Working to share the love with other family members and friends can also help with this issue.

What Makes the Dog Happy?

If you list everything you know that makes a dog happy, you can start having a person who wants to bond with a dog to provide that incentive. If a dog is food oriented, the less favored person should be the one giving food.

The much-loved person should give ordinary treats. The person trying to win the love should woo the pup with high-value treats. This might be a tiny piece of cheese or dried liver for some dogs. We knew a Lab that adored apples, and anyone who shared an apple with Lily would win her heart. Sharing an afternoon apple or

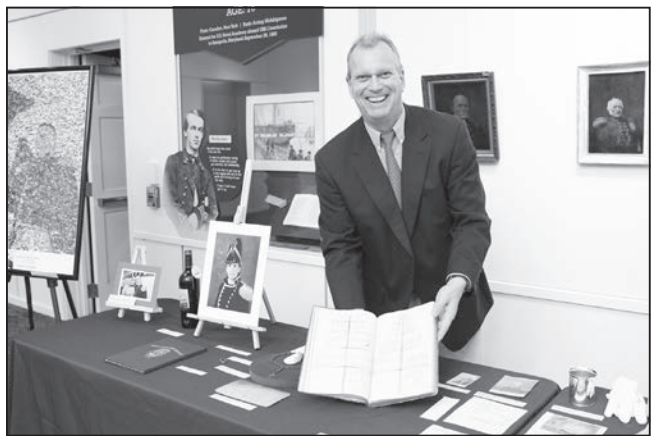
'The History and Future of the U.S. Marines and 'Old Ironsides' on August 16

On Tuesday, August 16 at 6 p.m., the USS Constitution Museum hosts From the Shores of Tripoli to the Decks of USS Constitution: The History and

Future of the U.S. Marines and "Old Ironsides." This in-person reception and panel discussion commemorates the role of United States Marines on USS Constitution.

The Marines were part

of Constitution's crew beginning with the Ship's earliest deployments to the Caribbean to fight French privateers. Marines from "Old Ironsides" played pivotal roles in that conflict, in the Barbary Wars in the Mediterranean, as well as in Constitution's battles with British frigates during the War of 1812. Marines continued to serve USS Constitution as part of the Ship's home port in the Boston Navy Yard. Today, there are calls to return a contingent of active-duty Marines to serve a ceremonial role on Constitution.

Carl Herzog, Public Historian for the USS Constitution Museum and Chief Petty Officer Elliott

Fabrizio, Public Affairs Officer for USS Constitution will discuss the history of the Marines and look at the arguments for returning them to the deck of "Old Ironsides."

Following the panel discussion, the Museum will hold a special commemoration aboard USS Constitution to remember LT William S. Bush. LT Bush died during Constitution's battle with HMS Guerriere on August 19, 1812, making him the first U.S. Marine Corps officer killed in combat.
