# Arrigo steps down April 21, Keefe to take over as Acting Mayor

On Monday, Mayor Brian Arrigo announced he is stepping down from office, effective April 21, to take a position as the new commissioner of the Department of Conservation and Recreation in Governor Maura Healey's administration.

Arrigo has served as mayor since 2016, and earlier this year, he announced that he would not be seeking a third term. He will take over at the DCR on April 24.

The announcement sets the stage for City Council

President Patrick Keefe to take over the reins at City Hall as the acting mayor. Keefe is one of four councillors who have already announced that they were seeking to replace Arrigo in the fall, alongside former mayor Dan Rizzo, Gerry Visconti, and Steven Morabito.

"First I want to congratulate my friend and colleague, Brian Arrigo, on his appointment by Governor Healey to become the next head of the Massachusetts Department of Conservation andRecreation," said Keefe. "This is an amazing opportuni-

ty for someone who has shown himself to be an incredible public servant. Governor Healey is lucky to have Brian join her in leading the Commonwealth, and I know that while Brian is moving on from his time in City Hall, Revere is better off from

For Arrigo, taking stewardship of the state agency that oversees state parks and beaches is a natural extension of some of the work he has done in Revere, home of the country's oldest public beach in Revere Beach.

"I'm honored to join the Healey-Driscoll Adminis-

tration at this pivotal time for our public lands," said Arrigo. "I believe DCR lies at the nexus of the climate crisis, economic competitiveness, public health, and equity. Access to well-maintained healthy outdoor space promotes tourism, builds healthy families, and helps us nurture the next generation of environmentalists We did this in Revere and I'm looking forward to stepping up our tree planting efforts, improving park maintenance, and ensuring that every Massachusetts resident can ac-

# Public hearing scheduled for home childcare zoning ordinance

The City Council is holding a public hearing on a proposed zoning amendment that will make it easier for home childcare businesses to operate in the city at its April 24

"The purpose of this

amendment is to make more affordable childcare options for residents throughout Revere by reducing zoning barriers and helping to develop more childcare businesses," said Councillor-at-Large Steven Morabito. "Currently, the city ordinance limits home childcare businesses to no more than four children per business and requires a special permit by the City Council. Under this amendment, the home daycares would be more in check with the state level to operate by right in 12 of the 19 zoning districts."

In 2021, the city led efforts to create a workforce development plan, and one

of the things that plan highlighted was the need to expand childcare availability throughout the city.

"I'm speaking both as a community development professional and a father of three young children of the importance of quality affordable childcare as a key component of workforce development," said Planning and Community Development Director Tom Skwierawski.

The city's workforce development plan specifically called for reforming the local zoning ordinance to better align with state regulations for childcare busi-

"We moved forward with a community strategy to reform our local zoning ordinance," Skwierawski said. "We worked with an advisory committee, multiple focus groups and had multiple community meetings. The end result was a zoning ordinance change."

Councillor-at-Large Marc Silvestri noted that the city's state legislative delegation is also working on potential changes that could make childcare more affordable both for businesses and residents.

"We do have to look at some of this stuff to create better jobs and more affordable care for those in our city," said Silvestri.

Under the proposed amendment, the home daycares would be able to operate by right in 12 of the city's 19 zoning districts. In addition, it would increase the limit for the businesses from four to 10 children, provided there is a second, certified childcare assistant at any business with seven or more children.

The revised ordinance would allow home-based childcare by right without having to go before the city council for a special permit. The one exception would be if there was a proposal for a home-based childcare business within 300 feet of another similar business. In that case, a special permit would need to be approved by the council.

Chronic obstructive pulmonary disease (COPD) is a long-term lung disease that makes it hard to breathe. A leading cause of disability and death in the United States, more than 12.5 million people have been diagnosed, and millions more may have the disease without even knowing it. While there is no cure, knowing COPD's early warning signs can lead to earlier treatment

and may prevent its progression. The American Lung Association, funded with support from the Centers for Disease Control and Prevention, is sharing the following insights to help Americans recognize the warning signs of COPD and take action:

# **Early Warning Signs of COPD**

Not everyone has the same COPD symptoms, but some of the more common early warning signs and symptoms may include shortness of breath, a cough that may bring up mucus or phlegm, chest tightness, fatigue and reoccurring lung infections. People may think these symptoms are because of aging, smoking or being out of shape and become less active to avoid experiencing them. These signs and symptoms shouldn't be ignored. Speak with your healthcare provider if you experience any of these symptoms and discuss any ac-

Anyone can develop COPD, but people aged 40 or older and those who smoke or used to smoke are at higher risk. Cigarette smoking is the leading cause of COPD, however 1 in 4 people with COPD never smoked cigarettes. Secondhand smoke, air pollution, workplace exposures to dust, fumes and chemicals, and a genetic condition called alpha-1 antitrypsin deficiency (AATD) are also causes and risk factors for

People are often diagnosed at later stages of COPD when the disease has progressed because they delayed sharing their early symptoms with their healthcare provider. Everyone with risk factors and those experiencing early warning signs should talk to their healthcare provider about any breathing issues. It's especially important for women to do so. Because COPD has been historically thought of as a "man's disease" or an "old person's disease," women are sometimes misdiagnosed or receive a delayed diagnosis. But overall, more women are affected by COPD than men and the death rate is higher in women. In addition, women tend to develop the disease at a younger age.

To diagnose COPD, the healthcare provider will evaluate symptoms, gather a complete health history, conduct a health exam and perform a pulmonary function test called spirometry. The results of the spirometry test can deter-

# mine if you have COPD.

Lifestyle Changes In addition to treatment, certain lifestyle changes may make a difference, as patients living with COPD know firsthand. After being diagnosed with stage 2 COPD in the wake of a COVID-19 infection, Bob F. partnered with his doctor and started monitoring his breathing at home and leaned into exercise. His hard work has paid off, with his last pulmonary function test showing that the disease has not progressed, and

he is in better overall shape than before. "Most of the advice you should follow is no different than what doctors tell us all. Eat right, exercise, sleep, drink plenty of water, manage your weight and don't smoke. If you do these things, you may slow the progression of your COPD," says Bob.

But you shouldn't wait until a COPD diagnosis to make these changes. Lifestyle changes like quitting smoking, avoiding secondhand smoke and reducing your exposure to air pollution may reduce your risk for developing COPD. If you are experiencing shortness of breath or other respiratory symptoms, do not delay talking to your healthcare provider about your symptoms or COPD risk factors. 

# THE MARATHON BOMBING, 10 YEARS LATER

This week marks the 10th anniversary of the tragic Boston Marathon bombing which occurred on April 15, 2013, when two brothers set off a pair of bombs near the finish line of the marathon, killing three persons (Krystle Marie Campbell, a 29-year-old restaurant manager from Medford; Lü Lingzi, a 23-year-old Chinese national and Boston University statistics graduate student; and 8-year-old Martin William Richard from Dorchester) and injuring 281 persons, of whom 16 lost limbs.

In addition, during the manhunt for the bombers in the ensuing days, the brothers shot and killed 27 year-old Sean Allen Collier, an MIT police officer, who crossed their path, and shot two Boston police officers, one of whom, Dennis Simmonds, died on April 10, 2014, from head injuries he received during the shootout in Watertown

One of the brothers was killed during the shootout and the other eventually was captured, tried, convicted, and sentenced to death, and now is imprisoned in a federal Supermax facility.

For those of us who are lifelong Boston-area residents, the horror of that afternoon, as well as the three-day manhunt for the suspects, will remain etched in our memories forever as no other local event ever has.

We will never forget the tremendous performance of

the medical and emergency crews on the scene and at our area hospitals, who miraculously saved the lives of scores of victims who otherwise might have died from their wounds.

Ten years leter the memory of that day gives all of us

Ten years later, the memory of that day gives all of us pause to reflect, both to remember the innocent victims and to honor those whose heroic actions saved lives.

# CLARENCE THOMAS: SUPREME HYPOCRITE

"I prefer the RV parks. I prefer the Walmart parking lots to the beaches and things like that. There's something normal to me about it." -- Judge Clarence Thomas in a recent interview.

The revelation this past week that Supreme Court Justice Clarence Thomas and his wife have been accepting luxury vacations from a Texas billionaire for the past 25 years, including a recent vacation that is estimated to have had a price tag of \$500,000 (that's not a typo -- there are no added zeros), is absolutely sickening.

For his part, this billionaire said he never discussed any cases with Thomas and reportedly never had any specific cases pertaining to him in front of the court.

However, among the other guests on these vacation junkets were top executives of major U.S. corporations, so it certainly is conceivable that some of these companies may have had matters that came before the Supreme Court during the 25 years that Thomas has been receiving these extraordinary gifts from the Texas billionaire.

However, the focus on whether any one of these wealthy and influential persons had any specific matters before the Supreme Court misses the point entirely, which is this: Thomas is hobnobbing with, and accepting gifts of immense value from, individuals who have a great deal of general interest in cases that come before the Supreme Court.

For example, the infamous Citizens United case in 2010 (in which the court held that the free speech clause of the First Amendment prohibits the government from restricting independent expenditures for political campaigns by corporations, thereby striking down a federal law that had placed a limit on donations by corporations) was brought by billionaires -- and who have been influencing U.S. elections ever since with what is known as "dark money" (because its source is unknown). Thomas -- surprise! -- voted with the majority in a 5-4 decision.

But beyond what constitutes an obvious conflict of interest by Thomas, this is just another example of the hypocrisy that has marked Thomas's tenure ever since he was appointed to the Supreme Court more than 30 years ago.

Thomas rates as the most unqualified person ever to sit on the court. He never tried a case in a courtroom and had no substantive legal experience prior to being appointed to a seat on the federal Appeals Court. (He was incapable of having been named as a federal district court judge because he would have been clueless as to how to conduct a trial.)

He often speaks and writes of his humble beginnings growing up poor on a farm in Georgia, but he never acknowledges that it was thanks to de facto affirmative action programs at Holy Cross and Yale Law School that gave him the opportunity to rise to the highest court in the land. Nor does he acknowledge that it essentially was affirmative action by President George H.W. Bush that elevated him to his judicial posts, because Thomas by any objective measure was unqualified to be a judge.

by any objective measure was unqualified to be a judge.

But here's the irony of Thomas's personal affirmative action story: He is among the leaders of the Supreme Court faction that no doubt soon will be striking down affirmative action programs that have existed for decades in universities across the country.

Thomas's stance on affirmative action is the height of hypocrisy — he benefited from programs that afforded him opportunities, but he is pulling up the proverbial ladder so that others cannot follow him— that goes way beyond taking expensive vacations in the face of his laughably stated preference for "Walmart parking lots."

# A climate resilient Boston needs Belle Isle Marsh

Nestled between the cities of Boston, Revere, and Winthrop lies a natural barrier to climate change, the 359-acre Belle Isle Marsh. A salt marsh is a low-lying, coastal area that mostly comprises grasses that are frequently flooded by ocean tides.

This wetland protects

coastal areas from flooding, destructive winds, higher tides, and increasingly intense storms. Plants in salt marshes help buffer the coast and reduce the impacts of storm surges, such as those generated during hurricanes. The Marsh delivers essential ecosystem services, which are important to help reduce climate change impacts caused by rising sea levels and severe weather events. Belle Isle Marsh provides critical habitats wildlife—including the 271 species of birds which have been documented there-and recreation areas for local communities.

## **Background**

In 1988, the Commonwealth of Massachusetts designated Belle Isle Marsh as an ACEC, or an Area of Critical Environmental Concern. This area once contaminated by industry is now one of the most biologically significant habitats in Boston, according to the U.S. Fish and Wildlife Service. Thousands of birds migrate to this area, and many endangered and threatened species can be found in the reservation year round.

The largest remaining

salt marsh in Boston Harbor, Belle Isle Marsh plays an important role in the prevention of flooding by delivering flood storage capacity. This capacity is lost when marshlands are filled or degraded via poor water quality from stormwater, which can also negatively impact public health, wellbeing, and safety to surrounding communities. Marshland filling accelerated in Boston during the expansion of Logan Airport in the

Investing in a wetland is investing in public health. Salt marshes contribute to positive physical and mental wellbeing; they clean polluted air and purify water. Also, they provide accessible green spaces for recreation, physical activity, and connection to nature, all of which are crucial for improved mental health.

Coastal ecosystems (mangroves, salt marshes, seagrass meadows) are also known as blue carbon systems. Salt marshes and seagrass beds can sequester carbon (like forests do) during plant photosynthesis creating a carbon "sink" (capture). If destroyed, these habitats would emit a large amount of carbon into the atmosphere. Preserving

these vital coastal systems is essential to reducing the effects of climate change and protecting vulnerable communities.

Given the enormous benefits of the Marsh to its neighboring cities, what is being done to conserve it?

#### **FBIM**

Local nonprofit and environmental advocacy group, Friends of Belle Isle Marsh (FBIM), has spent 40 years protecting and preserving critical conservation habitats, specifically Belle Isle Marsh. This group of volunteers and conservationists organized in 1983 to protect the Marsh from industrial use, and it continues to work in close partnership with the Department of Conservation and Recreation (DCR) and other regional conservation groups. FBIM's mandate is to protect the Marsh and its surroundings, to educate the public about the importance of salt marshes and barrier beaches, and to offer educational programming in

all areas of the reservation. Recently, the organization has partnered with the Mystic River Watershed Association, the Nature Conservancy, and the DCR to conduct an environmental inventory of Belle Isle Marsh, with technical assistance from the Woods Hole Group, to better understand the health of salt marsh's ecosystem and to measure how it has changed over time. This inventory helps inform how the Marsh will adapt over the next 50 years to climate change, sea level rise, and increasing storms.

What can you do to get involved to help protect Belle Isle Marsh?

First, come visit Belle Isle to go bird watching, enjoy a leisurely walk, watch the sunset, or climb the observation tower. Then, read more about the organization on our website (https://friendsofbelleislemarsh.com) and join in on upcoming events, including monthly birdwatching walks, summer kayaking expedition, art painting night, and tide pool explorations for children. Finally, become a member to advocate for local conservation efforts, and take greater action in your community.

#### Conclusion

Understanding the critical importance of protecting our natural habitats is a first step to preserving and cherishing them. Wetlands provide myriad ecosystem services that benefit surrounding communities and help cities fight climate change.

#### ON THE BOSTON MARATHON BOMBINGS

My son Ricky Jr., who has autism wrote this to-day as he remembers what happened 10 years ago in regards to the marathon bombing. This is how he remembers it and deals with it by putting his feelings and memories on paper.

"This is a special speech on what happened 10 years ago this month and what can we do to prevent these unexpected disasters from happening again.

It was one glorious Monday here in the Eastern Bay State. I was on a high school spring break during Grade 11.

Me and my father were going out to have lunch at Five Guys Burgers next to Square One Mall in Saugus which during that time, the nearby FLoor & Decor Store used to be a K-Mart.

Shortly after having ourselves a bite there, we decided to play a nice game of golf at nearby Cedar Glen which is a 9-hole course. In fact, I still have the score card from that day a decade ago this month.

All was going well and unfortunately by the time we've reached the starting point of the final hole, either the manager or the other players walked up to my dad, saying there's a bomb activated, and we replied: what bomb? So to make matters worse, we went into our car, turned on the radio, and there were not only disastrous reports of what's going on in Boston, but fire truck

after fire truck, squad car

after squad car, and am-

bulance after ambulance,

were all heading to the capital city of Massachusetts for an explanatory reason.

So not only were our local news teams there for the disaster: WBZ Channel 4 for CBS, WCVB Channel 5 for ABC, WHDH Channel 7 which used to be an NBC affiliate from 1995-2016, WFXT Fox 25, and NECN plus newspaper companies like the Boston Globe and Herald were also there for the investigation but also all of the mainstream media was there, especially several from around the world.

After several press conferences between Boston Police and the FBI, it was revealed that 2 boys linked with ISIS are the ones that caused the disaster.

For the whole week up until Friday night, the entire FBI, the SWAT team and the U.S. ARMY were on the hunt to track down the enemies of America that not only killed three innocent citizens and two deputies for the police department, but also injured over 50 Marathon runners which lost their arms and legs due to the explosions at the finish line.

In a message by the late Boston Mayor Tom Mennino and th Chief of the FBI, all of Massachusetts must be on 100% quarantine so that the SWAT team and the U.S. ARMY could track down and find the villains that want to seek vengeance on the U.S. after the 9-11-01 attacks. May. News cameras were rolling, the SWAT team and the ARMY have surrounded the area of the covered sailboat, and all of the TV screens were on for the most anxious moment in American history. At one point, nearly five officers in SWAT uniforms walked cautiously to the sailboat to break the tarp open so that the surviving ISIS member would sneak and be ready for war with the American police. Amazingly, the terrorist was covered in blood and could barely move any

# Revere Human Rights Commission holds monthly meeting

The Revere Human Rights Commission (HRC) held its regular monthly meeting last Thursday evening in the City Council Chamber.

Chairperson Janine Grillo Marra and fellow commissioners vice-chair Chai Hossaini, Kourou Pich, Fire Chief Chris Bright, Molly McGee, Dr. Lourenco Garcia, and Police Chief David Callahan were in attendance.

The HRC's Executive Director, Claudia Correa, who is the city's Chief Officer of Talent and Culture, also was on hand for the meeting.

After starting with the usual Land Acknowledgement (in which the commission acknowledges the Pawtucket Tribe as "the original overseers of this land"), Marra led the group through a brief meditative session to "arrive and settle" in order "to become more present in our body, heart, and mind" prior to getting into the business of the evening.

The commissioners then recited the HRC's Mission Statement:

"The Mission of the

Revere Human Rights Commission is to promote human and civil rights and empower all people of Revere by ensuring that everyone, especially the most vulnerable and mar-

Revere by ensuring that everyone, especially the most vulnerable and marginalized, have equitable opportunities, equal access, and are treated with dignity, respect, fairness,

The commissioners also recited their newly-created Vision statement which they adopted last month.

and justice."

"A thriving Revere where all community members live free of racism, poverty, violence, and other systems of oppression, and where everyone has equitable access, opportunities, and resources, as well as a sense of belonging."

In the Monthly Acknowledgements item on the agenda, HRC members made note of the ongoing observance of Ramadan (which began in mid-March) and that April includes Autism Awareness Month, Arab-American Heritage Month, Scottish-American Heritage Month, Celebrate Diversity Month, Sexual Violence

Awareness Month, Pass-

over, Easter, and Cambodian New Year.

Commissioners Hossaini and Pich briefly provided background information to their fellow members about Ramadan and Cambodian New Year respectively.

Dr. Garcia and Exec. Director Correa spoke about the 21-day Racial Equity Challenge that has been underway in the city since April 3. Marra noted that the HRC web page provides information about the challenge.

The commission then discussed the topic of the HRC's Group Norms/Shared Agreements for which the commission has held two mini-retreats. Marra presented a slide that showed a tentative list of the norms/shared agreements to be observed by the commis-

Marra said the issues facing the commission are whether to change the names and focus of these working groups and whether they still are relevant to the HRC's work. With regard to the latter issue, Marra said the Special Task Force for Public Mediations has been dissolved pursuant to a ruling from the City Solicitor.

The commission concluded the meeting by discussing the future direction of its working groups and agreed to continue the discussion at its upcoming meeting on May 4.

# Conservation Commission extends OOC for project at 646 Ocean Ave.

The Revere Conservation Commission (ConsComm) held its regular monthly meeting last Wednesday evening, April 5, in the City Council Chambers.

Vice-chair Nicholas Rudolph and fellow commissioners Joseph La-Valle, Brian Averbach, Robert Cassidy, and new member Samantha Woodson were on hand for the meeting, which proved to be a brief (about 11 minutes) session.

The commission first

The commission first approved a request for an extension for compliance with the Order of Conditions (OOC) by the developer of the 1.4 acre property at 646 Ocean Ave. When completed, the property, which is located across Ocean Ave. from the State Police and DCR facilities, will consist of a seven-story, mixed-use building with 209 apartments and retail space on the first floor.

Matt McCollem, a director at the global real estate firm Hines, said the OOC, which was issued on September 4, 2019, initially was set to expire on September, 4 2022, but because of the COVID tolling, now is set to expire on December 10, 2023.

cause of the COVID tolling, now is set to expire on December 10, 2023.

He said Hines is hoping to complete construction by the middle of 2024 and therefore is looking to extend the expiration of the

OOC to the end of 2024.

Rudolph, who together with Woodson walked the property with McCollem a few days before, noted, "Your environmental controls were intact, keeping debris away from the back of the wetlands and the train tracks, as well as from the neighbors on either side."

The commissioners had no questions and unanimously approved the extension of the OOC, which will run for another three years.

The commission next

took up a request for a Notice of Intent (NOI) from Scott and Jennifer Lanes, the homeowners at 28 Hayes Avenue (which is located at the Point of Pines in the neighborhood between No. Shore Rd. and Rumney Marsh), who are seeking to replace an existing inground pool and concrete decking with one of the same dimension, as well as install a new (464 sq ft) patio using pavers. "There is no change in

the footprint," Jennifer Lanes told the commission.

The commissioners had no questions and unani



former on a state championship team in 2022 and a Catholic Central League All-Star for the Division 3 state finalist Spartans this winter, falling a win shy of back-to-back titles.

But along the way, Anthony D'Itria became a high-level track athlete after deciding as a sophomore to take up the sport during a COVID-19-altered season.

Monday afternoon at St. Mary's during a National Letter of Intent signing ceremony attended by his parents, Mike D'Itria and Tami D'Itria, Anthony announced his decision to attend Colby College in Waterville, Maine, where he will compete in track and field.

Colby is one of the most prestigious, private liberal arts colleges in the country, and D'Itria's excellent academic record (he's ranked 11th academically in the Class of 2023) along with his prowess as a high jumper and triple jumper - led to his recruitment as both a scholar and an athlete.

"I toured a few schools during the summer, but after talking with the coaches and getting on campus, Colby was definitely my top choice out of all of them," said Anthony, 18. "St. Mary's has really prepared me well for college. I especially like my AP Government Class. My teacher Ms. [Sarah Hashikawa] does a great job teaching the subject in a way that I enjoy learning

#### 'A great all-around athlete'

St. Mary's track coach Tristan Smith remembers Anthony D'Itria beginning his track career as a sophomore during the "extra" season that was created due to the pandemic.

"Anthony fell in love with track, and the coaches fell in love with having him on the team immediately," said Smith.

D'Itria quickly displayed skills in the high jump event. "He qualified for the State Meet in his first year, but he's been adding so much more now to his repertoire, and he's really passionate about the triple jump, which is a really tough and technical event, and he's not afraid of a challenge. I think Colby will utilize him in jumping and sprinting events, because they're getting a great all-around

athlete and a really hard worker.

"I know it was a tough decision for him between basketball and track, so I'm thrilled with the decision, and I hope Anthony is as well. "Colby is a great school and has a great track program, and we're so proud of him," concluded Smith.

St. Mary's Principal David Angeramo also expressed the pride felt by the school about Anthony D'Itria matriculation at Colby.

"As a school administration and school community, we're just very excited with Anthony continuing his education at Colby," said Angeramo, a former college baseball pitcher at Dartmouth. "Anthony is a special kid. He's one of our Garrity Scholars. Most importantly, he's a great person, and obviously a very good student and athlete, and we wish him the best in the next chapter of his career."

#### A career full of highlights

Anthony D'Itria said winning a state basketball championship was the highlight of his career, but there were other notable individual achievements in track, the sport he will compete in at Colby.

"I tried out for winter track because a lot of my friends were doing it, and we loved competing for Coach Smith," recalled Anthony. "I had participated in track in the sixth grade in the 400-meter hurdles. I played baseball in the seventh grade. I started doing high jumping as a sophomore. Coach Smith taught me how to high jump. It wasn't easy learning the form, but by spring track season I felt I had grasped the techniques. I'm grateful to Coach Smith, Coach Demo, and Coach D., and my trainer, Alex Rachmaciej, for all the improvement I've made."

As a junior, D'Itria competed in the high jump, triple jump, 4 X 100-meter relay, and the 400 meters, emerging as the team's leading scorer and receiving the team MVP award. He is the reigning CCL high jump champion and finished fourth in the state in the high jump in 2022.

Now a team captain, D'Itria claimed first-place honors in the high jump and the triple jump in the Spartans' season-opening

"My team goal is for us to beat Bishop Feehan and win the CCL championship," said D'Itria. "Individually, I'd like to high jump 6-3 (6 feet is his personal best) and triple jump 45 feet (42-6 is his personal best)."

### A supportive family

Mike D'Itria began coaching his son's Revere basketball team when Anthony was in the third grade. Anthony became part of Revere's Big Three in with Nick Martinez (Malden Catholic) and Domenic Boudreau (Revere High).

Anthony enrolled in St. Mary's in the sixth grade.

"It's been a great seven years and Anthony got to experience highlights that most athletes don't get to do, like being in the Garden, playing [in the state finals] at Tsongas Center," said Mike D'Itria, who is an assistant coach at St. Mary's. "Anthony took a liking to track, did pretty well in the jumping events, and took advantage of the opportunity."

Anthony's older sister, Nicolette D'Itria, set the high standards for the family at St. Mary's. Nicolette was a basketball star herself for the Spartans, becoming a team captain and winning a state championship. A Dean's List student, she is currently playing college basketball at UMass/Dartmouth and

studying Criminal Justice. "Academics wise and athletics wise, my sister was a very good role model for me," said Anthony. "I grew up watching her play basketball and looking up to het in a way. And when she won a state title in basketball at St. Mary's, I wanted to win one."

Said Nicolette, "I'm proud of my brother going to Colby. He was always really good at basketball. Our father coached us both in basketball. It's great that he'll be competing in track in college. I'm really happy for him. I'll have to make a few trips to Maine to watch his meets."

Interestingly, the most accomplished collegiate athlete to-date in the D'Itria family to-date is their mother, Tami D'Itria.

"Our mother competed in gymnastics at Northeastern and I know she set some records," said Nicolette proudly.

# Witter hits the pavement for Project Bread's 55th Annual Walk for Hunger on May 7

On May 7, Megan Witter, of Revere, will hit the pavement for Project Bread's The 55th annual Walk for Hunger. She will be among over 3,000 participants, both in-person and virtual, to walk the new 3-mile loop around the Boston Common or in their own neighborhoods. Back on the Common for the first time since 2019, the one-day fundraising event will raise more than \$1 million to support food assistance resources and sustainable policy solutions to end hunger across the Commonwealth.

Beginning in 1969, as the first pledge walk in the nation, Project Bread's Walk for Hunger brings together a diverse community dedicated to creating change. On Sunday May 7th, the annual fundraiser returns to Boston Common after 3 years of being virtual due to COVID-19 safety precautions. This rite of passage for people in Massachusetts returns in its 55th year with a shorter route and a fresh look. The mission of the time-honored tradition will never change. The fundraising goal this year is over \$1 million dollars.

"As we continue to recover from the pandemic and see federal emergency benefits such as expanded SNAP benefits coming to an end, 1 in 5 Massachusetts households with children are still struggling without enough to eat,' says Erin McAleer, Project Bread CEO. "That number jumps dramatically for Black, brown, and immigrant households. Participating in Project Bread's Walk for Hunger is one way we can all do something real to make sure our neighbors in need can get the food to meet their most

basic of needs.' Witter first participated in Project Bread's Walk for Hunger in 2006. She was inspired to walk by her first boyfriend when she was 16 years old. Almost 20 years later, the Revere resident has raised \$2,000 for the cause. For the past two and a half years, Witter has worked for the Community Health and Engagement Department's Food Hub in

food pantry of Revere. She

feeds approximately 500 families every week and hears stories from people that face food insecurity locally. Participating in the Walk for Hunger opened her eyes to what was happening in Massachusetts. Her goal is to raise \$5,000

"I've always wanted to give back to my community," says Witter. "Life is truly about the little things. Even just an hour here and an hour there, it is all important. After listening to people's stories at the food pantry, it pushed me to do what I could to get healthy, fresh, affordable and culturally appropriate food for these people. Many residents in Revere live paycheck to paycheck and struggled through the pandemic to have enough to eat. Food insecurity is real, and we need to combat it together."

Money raised through the Walk for Hunger is critical to Project Bread's statewide work to ensure kids reliably have enough to eat, provide one-on-one support for individuals and families who need food assistance, and work to prevent hunger in the first place by eliminating barriers to resources and implementing policies that make food more accessible. In keeping with the community-spirit of the event, In keeping with the community-spirit of the event, the Walk also provides a platform for organizations to fund the vital work they do fighting hunger locally. The Commonwealth is a joint fundraising program Project Bread launched in 2019. In 2022, 36 nonprofits raised more than \$123,000 to support

their own programs.

our fundraising season and

a celebration of community

efforts over the last three years of the pandemic to fundraise and walk to solve hunger," says McAleer. "We cannot wait to welcome the Massachusetts community -both new and returning – together in-person on the Common while continuing to engage those across the country making strides in the fight against

hunger locally." This 55th annual event will include remarks by McAleer as well as family-friendly activations on the Boston Common, such as live music, photo booths, giveaways and raffle prizes, lawn games, and a Kid's Corner with balloon animals and face painting. For the fifth consecutive year, Project Bread is inviting other anti-hunger programs to participate as co-fundraisers in the event through the Commonwealth Pro-

# Dr. Rocco J. Malfitano

Former Superintendent of Schools and School Committee Member

Dr. Rocco J. Malfitano, Retired Superintendent of Revere Public Schools, passed away on April 10 at the age of 86.

He was the beloved husband of Lorraine I. (Trunfio) Malfitano, with whom he shared 63 years of marriage. Born in Revere, the son of the late Domenico Malfitano and Marianna (Misiano) Malfitano, he was a resident of Revere for sixty-five years, later residing in Stoneham and Port St. Lucie, FL. He was the devoted father of Marc Malfitano of Swampscott, Roxanne Aiello and her husband, Richard of Stoneham and Monique Mallicoat and son-in-law Frank of San Francisco, CA; proud grandfather of Bianca Dunn and her husband, Stephen of Norwell, Alessandra Fedorka and her husband, Chase of San Diego, CA. and Christelle Black and her husband, Christopher of Bradford, VT; loving great-grandfather of Charlotte and Francesca Dunn and Juliette Fedorka; dear brother of Anthony Malfitano and his wife, Sheila of Revere and the late Tina and her husband, Pasquale Pisani, Mary and her husband, John Stasio and Vito Malfitano. He is also lovingly survived by many nieces

and nephews.



At the time of his retirement in 1994 from Revere Public Schools, he had served 36 years in the field of education. Dr. Malfitano was a proud graduate of Revere High School, Class of 1955. He co-captained the football team in his senior year. After receiving his Bachelor of Arts degree in 1959 from Suffolk University with a major in biology and minor in chemistry he returned to Revere High School as a biology teacher and freshman football coach. In 1960 he earned his Masters of Education degree from Boston State College. In 1962 he was appointed Elementary Science Advisor. At that point he began his career as a mentor to other teachers. In both 1962 and 1963, his work was recognized by the National Science Foundation. He was one

of twenty teachers selected nationwide to participate in the 1962 Summer Institute on Radiation Biology at the University of Wyoming. In 1963 he was one of thirty-five teachers selected nationwide to participate in the National Science Foundation Elementary School Earth Science Institute at Rutgers University.

In 1965 he was appointed principal of the Shurtleff School. His view of the principal as curriculum leader put him in the vanguard of educational change. In 1968 he was selected as principal of his elementary/junior high school alma mater, the Abraham Lincoln School, where he would serve for twenty years and earn his doctorate in Educational Administration from Nova Southeastern University in 1978.

As a principal, Dr. Malfitano fostered experiments in methods teaching, modification of the curriculum for individual differences, innovations curriculum and curriculum construction. His teachers were encouraged to try new techniques. He designed and implemented a resource room program with a team approach for children with special needs which was chosen as a model by the Massachusetts Federation of the Council for Exceptional Children. The model was presented at the 56th Annual International Convention in Kansas City, MO. He developed an English curriculum for grades seven and eight and a program for gifted and talented children.

Recognizing the remarkable talent, skill and energy which he has given unselfishly throughout his twenty three years in administration, the Honorable school committee named Dr. Malfitano as Deputy Superintendent in 1988 and Superintendent of Schools in 1991. Among his many achievements in that role was the implementation of the middle school concept. This innovation at the time was a response to the devastating financial constraints and demands for accountability. With the realignment of the elementary program all seventh and eighth grade students would receive equity in education in excellent educational facilities. In anticipation of the

demands of the 21st century for computer literate students who had learned

to live and work with diverse people from diverse backgrounds, he created a computer curriculum for the new Garfield Magnet School. Dr. Malfitano recog-

nized that the schools belonged to the community and opened forums for parental concerns and suggestions through individual school councils and the Superintendent's School Improvement Committee. In recognition of his extraordinary vision and service, of his shepherding the school system through financial disaster into a new age of education reform, and as an indication of the honor with which he was regarded by the entire educational community, he was named Superintendent Emeritus by the School Committee. He was honored to have the Abraham Lincoln School Library dedicated in his name, receive the Revere High School Distinguished Alumni Award and the City of Revere Certificate of Merit. Following his retirement Dr. Malfitano served as a member of the Revere School Committee. Dr. Malfitano was a member of the Massachusetts Association of School Superintendents, life member of the Nation Education Association, life member of the Massachusetts Teachers Association, life member of Massachusetts PTA/PTSA and the Retired State, County and Municipal Employees As-







His website describes this book as "...his ultimate homage to making your life simpler. Every recipe is cooked in just one pan, so is perfect for getting good food on the table fast.'

He simplifies what he calls his "hero ingredients" to "...olive oil for cooking, extra virgin olive oil for dressing and finishing dishes, red wine vinegar as a good all-rounder when it comes to acidity and balancing marinades, sauces, and dressings, and, of course, sea salt and black pepper for seasoning."

#### **Use More**

On the other side of this equation, he uses more high-quality pantry staples like canned tomatoes and beans, coconut milk, frozen vegetables, premade fresh pasta sheets, pie and pizza dough, frozen phyllo, and puff pastry.

He uses "flavor bombs" You'll also hear how to such as chutneys, cur-

ry pastes, black bean and teriyaki sauces, miso, and pesto instead of the many ingredients each contains. He'll add sausage, bacon, smoked salmon, and jarred tuna as proteins and flavor boosters.


