Council approves changes to Human **Rights Commission**, and other boards

The City Council approved several revisions to the ordinances governing city boards and commissions at its meeting on Monday night.

Chief among the changes is one that does away with the ability for the Human Rights Commission to act as a mediating board in the city.

"These ordinance updates were submitted to the council just over six weeks ago, and since then, I have appeared before this body explaining some of the general reasons for these revisions," said Claire Inzerillo, the city's policy analyst and writer. "To sum it up in two

words, I would say consistency and efficiency were the main goals here."

Some of the changes to the Human Rights Commission included providing a membership range to make it consistent with other city boards and commissions, and adjusting the term dates and quorum requirements.

"The big chunk that was changed was the mediation power," said Inzerillo. "Our Human Rights Commission in Revere has no judicial authority, this comes from adopting Massachusetts General Law Chapter 233, Section 8. Big cities like Boston or L.A. have this sort of pow-

The Revere Human RightsCommission(HRC) held its regular monthly meeting last Thursday in the City Council Chamber and via Zoom.

Chairperson Janine Grillo Marra and fellow commissioners vice-chair Chai Hossaini, Kourou Pich, Rev. Tim Bogertman, Fire Chief Chris Bright, Molly McGee, Rachid Moukhabir, and Dr. Lourenco Garcia were on hand for the meeting. Marra opened the session by announcing that she is stepping down from the commission, with this being her last meeting. Marra has served as the

chair of the HRC since it was reconstituted by former Mayor Brian Arrigo and has guided the HRC both adroitly during the pandemic and patiently during meetings that often were marked by disruption by those who have

More candidates pull papers as At-Large race heats up

The corridors of City Hall have remained busy as candidates for re-election and those seeking their first shot at public office continue to pull their papers and begin their campaigns.

There has been no

changes since our last report, as Councillor-at-Large Dan Rizzo has not yet pulled his papers, but is seeking the Mayoral seat.

Council President Joanne McKenna has pulled papers for re-election in Ward 1; Ward 2 Councillor Ira Novoselsky has also pulled papers.; In Ward 3, current Councillor Anthony Cogliandro has pulled papers. Paul Argenzio has pulled papers to fill the Ward 4 seat, and in Ward 6, Chris Giannino has pulled papers. These candidates currently run

Council approves several polling location changes

With a busy municipal election season already underway, the City Council unanimously approved several polling location changes that will take effect this fall at its meeting on Monday night.

Ward 1, Precinct 3 is

moving from the Beachmont School to the American Legion Post at 259 Broadway.

Ward 5, Precinct 1A has been reestablished at the Jack Satter House this year, thanks to a request from the City Council and approval by the state leg-

islature.

Ward 5, Precincts 2 and 3 are moving from the Turkish Cultural Center to the Paul Revere Innovation School gymnasium on Revere Street.

Ward 6, Precinct 3 is remaining at the A.C.

Council celebrates Rita Singer's 90th birthday

Rita Singer, one of Revere's first female City Councillors, looked and sounded like she was set for another go at the campaign trail as the council presented her with a certificate of commendation in recognition of the former Ward 1 Councillor's 90th birthday on Monday night.

Singer, joined by family for the occasion, used the opportunity to bang the president's gavel, take her old seat in the chambers (temporarily displacing At-Large Councillor Marc Silvestri), and speak out against overdevelopment on Revere Beach.

"Rita got involved in politics at a time when it was not really in fashion for women to enter politics," said Council-

lor-at-Large Dan Rizzo. "Not only did she enter politics, and not only was she extremely successful at it in getting elected, but I would argue that she left office ... in 1993 that the impact she left on this city with her constituents is remarkable. People still talk about the work that Rita Singer did when she was a city councillor, and I think that is an amazing tribute to the work ethic and what you meant to so many people during your tenure."

Current Ward 1 Councillor Joanne McKenna said Singer has been instrumental in her life since she was 13 years old.

"She has been a great mentor to me over the years and one of the strongest women I know," said McKenna, embracing

er, Revere does not."

She said the new language removed the judicial authority that was vested in the original language for the Human Rights Commission.

But they say one thing, I remember what you did, I remember what you did for my mother ... and I'm glad that they did come up to see me at the time."

Several councillors spoke to the truth about what Singer remembered about her service for the city.

"Rita, I remember what you did for my mother, and growing up in Beachmont, everyone knew that if you had a problem, Rita was the person to call," said Silvestri.

Ward 2 Councillor Ira

Novoselsky said he believed he was the only current councillor who served with Singer in the 1970s.

"We went through the Blizzard of '78 together, and I remember her and I walking down Broadsound Ave. with water up to our waists," he said. "It was a pleasure working with her, we had great councillors back then, we have good councillors now, but working with her was unbelievable. The things she pulled off, nobody will ever pull off again."

School Committee highlights the positive

The School Committee accentuated the positive during its meetings last week.

During the committee's regular and committee of the whole meetings, Superintendent of Schools Dr. Dianne Kelly and committee members highlighted a number of major student achievements at the high school and throughout the district over the past several weeks.

Topping that list was the NUTRONS Robotics Team, based out of Revere, which placed second in the world robotics championship in Houston recently.

"We're just really excited to come in second place in the world, to beat 600 other teams from, I believe, 65 countries," said Kelly. "It is an incredible honor. I think about them not having the best facilities to work out of and what they could do if they did have a nice, new state-of-the-art high school, they could go even

further."

Kelly said the district is blessed to have incredible students taking part in the robotics program with supportive families and terrific teachers. She also noted that the coaches have made the robotics program into a service project.

"One of the things that the robotics team is required to do is work with our middle school students, and they do it every Saturday, helping younger students understand the importance of robotics and the opportunities available through that program," said Kelly.

Kelly also noted that Revere High School held its first musical theater performance in nearly three decades with the recent presentation of "In the Heights."

"We're just incredibly excited, despite some other comments, we've had the first musical in 30 years, which was incredible, and then we had the robotics team," said Kelly.

Kelly also updated the

School Committee on the long list of colleges graduates from the Class of 2023 will be attending next fall, including Boston College, Brown, Emerson, Fordham, MassArt, Mass College of Pharmacy, MIT. NYU. Northeastern. Princeton, Rutgers, Smith College, Trinity, Tufts, Tulane, UPenn, Wellesley, and Worcester Polytech, as well as a number of other local and state universities and colleges.

"It's really exciting what is happening for our kids at Revere High School, and that's a tribute to the incredible teachers, the incredible staff, the incredible families, and the students themselves for all of their hard work," said Kelly. "We are really proud of everybody."

School Committee member Stacey Bronsdon-Rizzo said she spoke to some of the students in the high school musical, and they stated it presented them with an opportunity they never thought they would get.

"When you have the

opportunities for the students, the world is theirs," she said.

School Committee member John Kingston noted that he recently visited the Beachmonth School for its Inventors Club presentation, and said several of the fourth graders will be taking part in the Eureka Fest at MIT in June.

Acting Mayor Patrick Keefe, in his first meeting chairing the School Committee, thanked Kingston and Kelly for highlighting positive achievements in the school system.

"There's always going to be work to do, and there's always going to be opportunities, but to paint the Revere schools with a broad brush is very dangerous and we need to elevate the highlights," Keefe said.

Keefe added that the list of colleges that Revere High graduates will be attending in the fall can be stacked up against any public or private school in the area.

alleged human rights violations," said Inzerillo. "This we leave to law enforcement, and we also have the Massachusetts Commission Against Discrimination that exists for this purpose. The policy before you now reflects the advocacy and educational work being done by the Human Rights Commission with regards to completely voluntary educational events and awareness days."

Ward 6 Councillor Richard Serino said he was pleased with the revisions that were being made to the operation of the Human Rights Commission.

"The Human Rights Commission, in my opinion, should not be a judicial body," said Serino.

If there is a discrimination issue with a resident, Serino said the executive director of the Human Rights Commission should privately discuss the proper legal avenues to have it addressed.

"The Human Rights Commission should be, as Mayor (Brian) Arrigo explained to me originally when he asked for my support of it in 2020, that is should be a city board that plans and promotes diversity and hosts flag raisings for Pride Month or commemorates Black History Month or Women's History Month," said Serino. "I personally, as a had to entertain an anonymous complaint that the history museum, there was racism or whatever it was or was not.

"It really upset me that these volunteers who work very hard in that Revere History Museum to make something so special for our community had to be brought through that for a board or commission that quite frankly didn't have that authority in my opinion to do that."

Changes to the policies for other boards and commissions were more minor in nature. The Affordable Housing Board of Trustees will now allow for the chair to be rotated among members. There were some changes to the language regarding the responsibilities of the Board of Health, and there was a change in the membership count for the Council on Elder Affairs and the Board of Library Trustees. The Public Art Commission also saw some minor language changes and an update to its membership numbers.

"As the city's policy writer and analyst, it is my job to mitigate legal risk to the city to the greatest extent possible," said Inzerillo. "Our ordinances are the backbone of our legal structure and our everyday operations, therefore we need consistency and updated language across the board."

Hossaini then moved on to the monthly acknowledgements for May and mentioned that this is the month recognized for those of Jewish American, NAAPI, Haitian, and Indian South Asian heritages. May also is Older American Month and Mental Health Awareness Month.

The group then discussed the HRC's internal Norms/Shared Agreements, an ongoing conversation that the commission has been having for the past few months. After discussing the phrases such as "safe space" and "hate speech" and their the definitions, members voted to approve the Group Norms/Shared Agreements document.

The commissioners then revisited and reevaluated its Working Groups, which were created a year ago, and which is another topic that the commission has been discussing for the past few months.


The commission ultimately voted to create the following working groups: Cultural Events and Celebrations (Hossaini, Moukhabir, Bright); Education, Research, and Evaluation (Garcia, Mc-Gee, Bogertman) and Community Outreach and Organization (Pich and McGee).

The meeting concluded with Marra's colleagues presenting her with a Certificate of Commendation from the mayor's office in recognition of her service and leadership on the HRC. Chief Bright, who handed the commendation certificate to Marra, took a moment of personal privilege.

"You did this with a lot of grace and dignity and kindness and you will be sorely missed," said the chief.

"I want to thank each of you," said Marra. "It's been an honor to serve with all of you. I thank you all."

The commission then adjourned until its next meeting in June.

Janine's work with the HRC has played a large role in affording previously-silent voices in our community the opportunity to be heard. We thank her for her outstanding service to our city and wish her the best in the years to come.

DESANTIS VS. DISNEY: THIS IS WHAT AN AUTOCRACY LOOKS LIKE

The ongoing battle that Florida Governor Ron De-Santis has been waging against the Walt Disney Company not only demonstrates what a petty, vindictive, and mean-spirited little man he is, but also illustrates the danger that an autocratic ruler poses to our democracy.

In early 2022, former Disney CEO Bob Chapek took issue with a bill signed by DeSantis (the so-called Don't Say Gay law). Chapek did so in support of many of Disney's employees, who found the bill to be offensive.

In response, DeSantis simply could have said, "Disney is entitled to its opinion, but the voters and legislature agree with me," and that would have been the end of it. Instead, DeSantis has turned the disagreement into an all-out war on Disney, seeking to strip it of the special tax-status that has existed for almost six decades.

There are two important things to note: First, De-Santis had been governor for four years (and an elected Florida official for more than a decade) and never once had suggested that the long standing Disney-Florida relationship should be changed. It was only when Disney expressed an opinion in opposition to his law that De-Santis took retaliatory action.

Second, similar partnerships exist with other corporate entities in Florida (most notably Universal Studios), yet DeSantis is not suggesting that those agreements be undone.

Ron DeSantis's war on Disney in an obvious attempt to show that he is just as much a "macho man" as Donald Trump in an effort to appeal to Trump's extreme voter base. But as we all know, men who constantly feel the need to prove their masculinity are incredibly insecure — and when these small-minded men are in positions of power, this makes them incredibly dangerous.

Ron DeSantis's actions against Disney have achieved the impossible — he makes Donald Trump look like a reasonable person. If a voter does come to the wrong polling location, the poll worker will have to call the election department at City Hall to determine the correct polling location for that voter, Fahey said.

Leasing underway for initial retail space at Suffolk Downs

The Suffolk Downs developer has selected an exclusive retail leasing agent for Beachmont Square, the first phase of the Suffolk Downs redevelopment.

Last week, the HYM Investment Group announced that Blackline Retail Group will be the leasing agent. The retail group is kicking off leasing efforts now, with the first building, Amaya, containing 24,000 square feet of retail space and scheduled to be ready for operation in the summer of 2024.

Beachmont Overall, Square will comprise 1.7 millionsquare feet with a mix of uses, located in the heart of Revere's Beachmont neighborhood. The development will feature over 1,500 luxury residential units, 325,000 square feet of lab/office space, 85,000 square feet of retail space, a 159-key hotel and open space including a plaza and outdoor amphitheater.

The project will be situated directly across from the MBTA Beachmont Station and is designed to be an accessible, sustainable, and dynamic community that enhances the quality of life for its many residents and visitors, according to the developers. Construction of the first residential building, Amaya, broke ground in 2022 and is set to open in the summer of 2024. Amaya will feature 475 apartments and 24,000 square feet of ground floor retail.

"HYM is thrilled to partner with Blackline as we look to bring diverse and vibrant retail, lively food and beverage concepts and neighborhood resources to Beachmont Square," said Thomas N. O'Brien, Managing Partner and Chief Executive Officer of HYM. "Beachmont Square will intentionally serve and provide meaningful economic opportunities for the surrounding Revere and East Boston neighborhoods."

Blackline Retail Group is a commercial real estate brokerage firm specializing in the representation of landlords and tenants for retail properties throughout New England. Members of the Blackline team have been involved with the lease up of Boston's Fenway neighborhood, The Continuum in Allston, and many restaurant and retail deals throughout the city. Blackline currently leases some of New England's premier mixed use destinations including Patriot Place, Hingham Shipyard & Linden Square.

"We are thrilled to launch the retail leasing component of Suffolk Downs and be a part of the largest mixed-use projects in Boston's history. We look forward to working with the professional team at HYM to bring Beachmont Square to life," said Daniel Dori, President of Blackline. "We are confident that our expertise and knowledge of this asset class will help attract the best tenants and create a vibrant shopping and dining destination for the community."

In 2017, Suffolk Downs, located in both East Boston and Revere along two MBTA Blue Line Stops, was purchased by HYM and its investors. Plans for the 161-acre space at Suffolk Downs include 5.2 millions square feet of life science and of-

fice space, 10.15 million square feet of residential space, 450,000 square feet of retail space, 400,000 square feet of hotel space and over 40 acres of open space. Phase 1 of the redevelopment, Beachmont Square, broke ground in May 2022 on the Revere side of the site and will begin to deliver in 2024.

"Every day we can see more and more the vision of the future of Suffolk Downs," said Acting Mayor Patrick Keefe. "Today's announcement is a great step in the right direction for this project. 
They were welcomed home on Tuesday with a surprise police and fire escort down Broadway before returning to RHS.



intentionally Medford walked Straccia. However, Doucette made the Medford strategy backfire by blasting a three-run homer over the fence for an 8-3 Revere lead.


The Lady Patriots tacked on an extra insurance run In the bottom of the sixth when Straccia singled and came home on a double to the fence by Smith.



# City Health Dept. announces Sandler Square Mobile Market, bringing fresh produce, resources, and community to Shirley Ave

The City of Revere's Public Health Department today announced the Sandler Square Mobile Produce Market pilot program, set to launch Saturday, June 10, 2023 on Shirley Ave. The Market, which will be available biweekly in Sandler Square, will bring fresh, local produce to Shirley Ave and also provide continued support of SNAP food stamp benefits, WIC vouchers, Senior FMNP vouchers, and Health Initiatives Program (HIP) reimbursements.

The Public Health Department is working with community partners such The Neighborhood as Developers, Women Encouraging Empowerment (WEE) and Mass in Motion to bring a vibrant, locally-sourced market to Sandler Square in the Shirley Ave neighborhood every other Saturday starting June 10th from 11:00 AM - 1:00 PM (times subject to change). After consultation with multiple

vendors, the Department of Public Health made the decision to replace the Friday Farmer's Market on Broadway with the Sandler Square Mobile Market in efforts to encourage more vendor participation and provide a better day of the week and location for passerby foot traffic on Shirley Ave.

"The City of Revere remains dedicated to expanding food access for our residents, especially our senior population and those currently experiencing food insecurity," said Acting Mayor Keefe. "Throughout the pandemic, I worked closely with the Emergency Response Team to bring fresh food to our most vulnerable community members because we saw firsthand how pertinent the issue of food insecurity is to our region. This new pilot program is an opportunity to take something once only at City Hall and expand it directly to our neighborhoods to meet people where they are."

The market will provide residents with fresh produce sourced from hopeful this Mobile Pro-The Trustees, a local non-profit organization that farms on more than 2,500 acres throughout the Commonwealth of Massachusetts. They focus on preserving biodiversity and land stewardship techniques and operate their market on a not-forprofit model that helps bring down costs for customers. The market will also host a rotating assortment of local vendors selling healthy goods and products and a variety of resource tables focusing on city programs and services.

The Sandler Square area brings a host of benefits for market attendees and vendors, including closer access to public transit and increased foot traffic in the area. The Public Health Department will continue to work with WEE, who will offer free Zumba classes on Saturday before the Mobile Market and offer cooking classes using produce found at the market.

"We're working with State partners and are

# Simonetti applauds Chelsea Recovery Court's work at graduation ceremony

Michael Simonetti is a shining example of how the Chelsea Recovery Court changes people's lives. With his wife, Siobhan, sitting nearby in the packed courtroom at the Court's graduation ceremony last week, Simonetti spoke about the amazing guidance and support he received from the judicial professionals at the Chelsea District Court during his time in the program.

But before Simonetti addressed the gathering, one of the unsung heroes among many at the courthouse who clearly goes beyond the call of duty – First Justice Matthew J. Machera - talked about his initial interactions with Simonetti, which contained some "choice words."

But Simonetti's path soon changed to the positive, thanks to the efforts of the Chelsea Recovery Court.

"I would have to say that you are probably the most successful graduate I've ever known," said Machera. "I would say to you every week, 'you're doing great, I've never been so happy to see you doing so well."

Speaking to Simonetti directly, the Honorable Justice said, "You're in the union, married look at you, did you ever think you were going to get here? You and I went through a long journey, but you did all the work and proved me wrong, and I'm so proud of you."

Simonetti lauded the Chelsea Recovery Court, stating, "Their caring allowed me to change my life. When I came into Drug Court, I was broken. I was angry. I made myself

a victim in my own mind, my own circumstances.

"One of the things that this allowed me to do is be able to see my side of things and the part I played in the choices that I made. I became accountable. I became a man," continued Simonetti.

Simonetti, who now works as a foreman in a union, then directed his most emotional praise toward Justice Machera and the other professionals at the court who helped put his life on the right path.

"I love Judge Machera and everybody in this court," he said. "I needed to understand that this man was trying to help me, and it was a privilege to be in his Drug Court. And the decisions that I made were going to propel me to be able to change my life, and that's exactly what ended up happening. They showed me the deepest affection. I had to earn their respect, and that's exactly what ended up happening."

Simonelli singled out the positive influence of "Janelle Reppucci, Justice Machera, Katie O'Leary, Caitlin Gillespie" in his recovery and his life.

"They all did whatever they could to help

me," credited Simonetti. "They're giving their time and their effort because they care, and this disease has touched people in their lives, and they've seen it all too much. This Recovery Court has changed my life. The biggest weapon that we have in this whole process is love and compassion, and the only time that we should ever look down on anyone is if we're helping them up, and that's what I stand by today."

Four Chelsea Recovery Court graduates - Maxwell T. Delaney, Shaner V. Guerra, Luis A. Morales, and Dean Todisco - were honored during the impressive ceremony. In addition to Michael Simonetti, Alisha Cohen and Donna Puopolo, alumnae of the program, were recognized with a special graduation certificate.

Lynn man charged with threatening to kill former BJ's co-workers

A Lvnn man who worked at the BJ's Wholesale Club in Revere is being held on \$1,000 bail plus other conditions today after being arraigned in Chelsea District Court on charges that he threatened to kill two BJ's employees after he was fired for stealing from the store, District Attorney Kevin Hayden announced.

David Brown, 52, is charged with threatening to commit a crime, threatening a business, threats involving the use of a firearm, and two civil rights violations. Assistant District Attorney Amelia Singh requested Brown be held on \$50,000 bail with conditions that he stay away from BJ's, stay away from the victims and stay out of Revere, as well as be confined to his home with GPS monitoring.

Judge Holly Broadbent imposed \$1,000 bail and ordered Brown to stay away from BJ's and the victims, with GPS monitoring. She also ordered Brown to refrain from alcohol, to be enforced by screening. Brown will return to court May 30 for a probable cause hearing.

Brown has a 16-page Massachusetts record plus criminal offenses in Virginia and Maryland.

On Wednesday, May 3, Revere Police officers responded to the BJ's on Ward Street for a report of threats. Store employ-

ees told them that Brown had called the store earlier that morning and told the person who answered the phone "I am going to kill you and (name withheld). I plan on putting two bullets in your (racial slur) head." BJ's personnel told police that Brown had been terminated on Tuesday, May 2 due to previous larcenies from the store.

"Actual or threatened gun violence will not be tolerated. This arrest serves as a reminder for all, that the Revere Police Department takes these types of threats seriously, and there will be consequences for those who make them", stated Revere Police Chief David J. Callahan.

"I want to commend the Officers and Revere Police Detectives who worked quickly and diligently to arrest this individual," Callahan added.

"Being threatened in any way is frightening. But the terror factor is heightened in this case by the threats being made with such specificity and racial animus. I'm grateful for the BJ's management team acting quickly to call Revere Police and relay exactly what occurred, so this individual can be held accountable for his reprehensible conduct," Hayden said.

All charged individuals are presumed innocent until and unless proven guilty beyond a reasonable doubt.


# Clark visits Revere Head Start to highlight vital role amid GOP threats

On Wednesday, May 3, 2023, Democratic Whip Katherine Clark (MA-5) visited the Community Action Programs Inter-City, Inc. (CAPIC) Head Start program at the Irene O'Connell Community Center in Revere to highlight the devastating impact that funding cuts

in the GOP's Default on America Act would have on children and families across Massachusetts.

Every day, Head Start is making a direct, life-changing impact on kids and families here in Revere. Yet MAGA Republicans' Default on America Act would gut this vital resource – and at a time when families are



"Slashing Head Start funding would cut off comprehensive early childhood education and services to our communities' most vulnerable children and families at a time in history when they need it the most," said Dianne Curtin, Director of CAPIC Head Start. "Young children-who already experienced learning loss during the pandemic - would not have the supports and experiences necessary to close the gaps before go-

ing to kindergarten. And parents would no longer have a community of peers and professionals supporting them as they regain their economic footing. We should be doing the opposite: investing in Head Start."

In Massachusetts, Republicans' Default on America Act would eliminate 4,800 preschool and child care slots, leaving kids without care and preventing parents from being able to work. Nationwide, over 300,000 children would lose access to child care.

Whip Clark has long been a champion for kids and families, leading the charge for quality, affordable child care in Congress. As a member of the House Appropriations Committee, Whip Clark secured historic funding for early education and

child care in this year's federal budget. In 2020, she secured \$50 billion in pandemic relief funding for the child care industry, helping 200,000 providers keep their doors open to kids across the country. Just weeks ago, she joined

with Democratic leaders to reintroduce their Child Care for Working Families Act, comprehensive legislation that tackles the child care crisis and ensures families nationwide can access the high-quality child care they need.

# Zoning subcommittee wants further debate on childcare ordinance

The City Council wants further discussion on a change to the city's homebased daycare zoning ordinance before approving any changes.

The proposed zoning change would allow Revere home-based daycares to operate without a special permit from the City Council, and would allow for up to 10 children per business with proper staffing. The proposed zoning change would put Revere in line with state regulations, increase daycare openings in the city, and benefit the small homebased business, according to Tom Skwierawski, the city's Director of Planning and Community Development.

The proposal was before the council's zoning subcommittee on Monday night, but with other items on the agenda, councillors

said they did not have the time required to properly discuss and make a recommendation to the full council.

"We can do a little deliberating, but we've only got six minutes," said Councillor-at-Large and zoning subcommittee chair Anthony Zambuto.

During the limited time on Monday, Skwierawski said he wanted to address a few concerns that were raised by the council at a public hearing last month.

"Number one was the special permit threshold for approving home-based childcare," he said. "We did a state-level analysis ... and looked at what other communities across the Commonwealth are doing with this item."

Several councillors indicated that they were not against increasing the number of children allowed in the home-based daycares, but were concerned with doing away with the special permit process through the council altogether.

Skwierawski said the analysis split the smaller and larger home daycares to see how they were treated

"We looked at 53 communities in total, including all of those around us," he said, with 52 allowing small, home-based childcare by right, meaning those with six or fewer children. For larger childcare businesses of up to 10 children, he said 37 of the communities allowed them by right.

Several councillors also raised concerns about the ordinance allowing pools at home-based daycares. Skwierawski previously stated that the state allows pools at the daycares with proper safety regulations, further adding that none of the 53 communities surveyed had language ban-

ning pools outright.

"With that particular item, we actually suggested a tweak in the language, where I think before it said swimming pools will be allowed if they comply with applicable requirements, both local and state," Skwierawski said. "We just changed the language a bit to say no swimming pools located on the premises of the family childcare home will be allowed unless they comply with both the local and the state regulations."

He noted that there are already some existing childcare sites with pools, and the city needs to look at how it operates safely within the confines of the law. Skwierawski also said he hopes the council at least aligns with the other 98 percent of the communities the city looked at that allow smaller homebased daycares without a special permit.

Zambuto said there seems to be an appetite on the zoning subcommittee to keep the special permit process in place, but that it would be open for further discussion.

From an inspectional services perspective, Director of Inspectional Services Michael Wells said he would like to see measures in place where if the daycare property was not owned by the business owner, there would be a letter signed by the building owner. He said the property should also be in good standing with no inspectional violations.

Skwierawski noted that he believed there was going to be a vote on the zoning ordinance change on Monday night.

"I don't think we have enough information to vote on this tonight, not in my eyes, and I'm the chairman of the committee," said Zambuto.

However, Council lor-at-Large Steven Morabito noted that the presentation and information on the zoning change was provided more than a month ago.

"The question is, in the month span since you got that package, how much of that did you review and how many questions do you have?" Morabito asked Zambuto.

Zambuto stated that Morabito was not a member of the zoning subcommittee and was out of order.

"I will remember that," said Morabito.

In other business, the subcommittee zoning recommended approval of a special permit for a proposed five-townhouse project at 84 Arcadia, a recommendation that was later approved by the full council.


