## **DAYTIME BRIDGE** MACHINERY INSTALLATION AT **CHELSEA STREET** BRIDGE

Massachusetts The Department of Transportation (MassDOT) is announcing that it will be conducting work to install span guide roller machineries on the Chelsea Street Bridge in East Boston and Chelsea. This work is scheduled to take place Monday through Friday, during the hours of 9:00 a.m. to 3:00 p.m. This work is schedule to begin on Monday, September 25 and will conclude on Friday, November 17. There will be no weekend closures during scheduled Sumner Tunnel closures. The work will require off peak temporary lane and sidewalk closures. The bridge will remain fully operational during the installation of the new machinery and pedestrian access across the bridge will be maintained at all times. The schedule for this work is weather dependent and is subject to change without notice.

# The Race for Ward 4

Paul Argenzio, the top vote-getter with 702 votes, and Gregory Murray, 242 votes, topped the ballot in the Ward 4 preliminary election on Tuesday night, moving onto the Nov. 7 municipal general election ballot.

The candidates are seeking to replace Patrick Keefe, who currently serves as acting mayor and is running for a full term in the mayor's office.

Argenzio is а lifelong resident of Ward 4 who currently serves as the city's Superintendent of Public Works. He has also served as the chair of the city's traffic and parking commission for the past five years.

Argenzio stated that the city must ensure that its new

residents, along with families who have resided in Revere for generations, can continue to afford to live in the city, and that city services such as police, fire, and public works, grow to meet the needs of the rising population.

Murray said safety is his number one priority if elected to the council. He said there needs to be safety for students in school, as well as more programs for teens after school. In addition, Murray said there needs to be improved safety for the city's senior citizens, both in their homes and in the streets.

With the city growing, Murray said the city needs to increase its public safety personnel and give them the tools to succeed.

## The Race for Ward 5

Incumbent John Powers and Angela Guarino-Sawaya topped the Ward 5 preliminary election on Tuesday, moving onto the Nov. 7 municipal general election ballot.

Angela Guarino Saway, was the top vote-getter with 668 votes, with Powers coming in second with 432 votes.

Powers, who served as councillor for two decades has said that he is running on his long record of his past achievements for the ward, which most recently have included the building of the new Point of Pines fire station. He said he is proud of his service in Ward 5.

Guarino-Sawaya is a graduate of Suffolk University with nearly 20 years experi-

ence with the Boston Public Schools. She has volunteered with such organizations as the Revere Little League, Immaculate Conception School, and President of the Point of Pines Beach Association.

She stated that the most pressing issues facing Ward 5 today over-developare ment, traffic management, and coastal resiliency. She said she plans to stop overdevelopment by implementing a moratorium and enacting a sensible planning review.

The other candidates on the ballot were Ralph Celestin with 177 votes, and Randall Mondestin with 152.

## **Disabilities Comm. hears of Boston Brakes program**

The Revere Commission on Disabilities (CoD) held its regular monthly meeting last Tuesday evening, September 12, via Zoom. On hand for the meeting were chair Ralph DeCicco, vice-chair Pauline Perno, Jason Barone-Cichocki, Ellie Pagan-Vargas, and Mario Grimanis.

The guest speaker for the month was Colleen Flanagan, the Engagement and Outreach Specialist from the City of Boston Mayor's Commission for Persons with Disabilities.

Flanagan said that a new initiative in Boston, known as Boston Brakes, aims to raise awareness among automobile operators and others about the unique needs of pedestrians with disabilities.

"It is important to respect everyone's pace and speed," said Flanagan. She showed a one-minute video that aims to educate bicycle and automobile operators about the need to operate safely in the city and be aware of those "who move at different speeds."

Flanagan said that there are 80,000 Boston residents -- about 12 percent of the population -- with disabilities. She noted that the city's changing infrastructure, including outdoor dining, bicycle lanes, and electric auto charging stations to meet sustainability goals are presenting new challenges for persons with disabilities.

Many of the education-

al videos Flanagan presented were directed at operators of bicycles and scooters in order to make them aware that they must yield to persons, especially those with disabilities, on the city's streets.

It was noted that complaints about specific areas where there are safety problems for persons with disabilities should be directed to the 311 line both in Revere and in Boston.

Members of the commission agreed that education for motor vehicle operators and bicyclists about the scope of the laws pertaining to pedestrians with disabilities should be mandatory.

After Flanagan's presentation and questions from the members, DeCicco updated the commissioners on the motions that were made and approved at the August CoD meeting to send letters regarding Bills S.446 & H.7690 (the bills are identical) to support "An Act Expanding Access To Trails For People of All Abilities." These were letters sent by the CoD expressing the commissioners' support for "Unpaved Trails for All" in the two bills that will be included in the package that will be submitted to the Joint Committee on Environment and Natural Resources at the State House.

The commission also sent letters directly to the Chair and Co-Chair of the Joint Committee on Environment and Natural Resources. Letters also were sent to the local State House delegation, Representative Jeffrey Turco, Representative Jessica Giannino, and Senator Lydia Edwards, to ask for their support of the two bills. All three legislators responded that they would be supporting the two bills.

In addition, a letter was sent by the CoD to the City Council President Pro Tempore via the City Clerk's office to support, sign, and send a resolution in support of the legislation. However, DeCicco reported that the City Clerk's office, responded that this "was out of their realm" because there are no trails in the city.

DeCicco reported on the Commissions on Disabilities Alliance (CODA) monthly Zoom meeting that he attended on Wednesday, September 6. Among the issues discussed at the meeting were the lack of availability for the safe storage of wheelchairs and other equipment that are brought to beaches and similar facilities by persons with disabilities.

CODA also noted that the guidelines set forth by the Massachusetts Architectural Access Board (AAB) often are more rigorous than those established by the federal American with Disabilities Act (ADA). For example, the ADA deems surfaces consisting of wood chips to be "accessible," but the AAB does not, and in Massachusetts, the AAB's guidelines are what prevail.

DeCicco noted that October is National Disabilities Employment Awareness Month and it will be observed by the State Commission on Disabilities on October 5 at 11:00 AM in the Hall of Flags at the State House. Perno suggested that the commission should contact the city to acknowledge the month's observance and DeCicco said he would do so.

Perno concluded the meeting by reading the usual monthly announce-ment:

"The Commission on Disabilities office number 781-286-8267. Resiis dents can also call Revere 311 directly and speak to their staff Monday through Friday. They will be able to answer most questions, but if they are unable to or if you would like a call back from our department, please ask to be transferred to the disability office's voicemail and someone will get back to you as soon as possible.

"As always, please let us know if you would like something discussed or brought up and added to our monthly meeting agenda. You can let us know if you would like to speak on any issue or concern. The Commission is here to help and assist all the disabled residents and families of Revere."

The commission then adjourned until its next meeting (via Zoom) in October.

## PASSENGERS URGED TO PLAN AHEAD AS DETOURS EXPECTED AT BOSTON LOGAN

Due to ongoing roadway work that will impact

passengers using Terminals B, C and E roadways, the Massachusetts Port Authority (Massport) is urging departing passengers to plan for extra time if driving to the airport and/or utilize the various transit modes to get to and from Logan. Terminals B and C are Boston Logan's busiest terminals – B serves American. United. Air Canada, Spirit, Southwest, Boutique and Alaska, while C serves JetBlue, Aer Lingus, Cape Air and TAP Air Portugal. Ongoing roadway construction will revamp the current terminal roadway system to eliminate backups, enhance the passenger pickup and drop off process, and get passengers to and from the terminals faster, improving the overall customer experience at Boston Logan. During the 11-day period through September 25 (weather permitting), the roadway construction will require detours. Terminals C and E Departures traffic will be detoured to alternative roadways. Terminal

The general election is on Tuesday, November 7th and polls will be open until 8:00pm. RTV will be live on television and YouTube again on election night. Stay tuned to RevereTV between now and then to view candidate statements from those on the ballot in November. New and updated statements will be recorded over the next few weeks at the discretion of each candidate, and the videos will be posted to all RTV outlets up until the general election.

As election season continues, don't forget that it is still business as usual for meetings in the Council Chambers. Meetings air and stream live on RevereTV and then replay in rotation on RTV GOV. All covered meetings stay posted to YouTube to be viewed at your convenience.

The latest meetings playing on RevereTV include the Human Rights Commission, RHS Building Committee, Committee of the Whole, Legislative Affairs Sub-committee, Revere City Council, Commission on Disabilities, License Commission, and Traffic Commission. RTV GOV is channel 9 for Comcast subscribers, and channels 13 or 613 for RCN subscribers.

September 16, Terminal C and E Arrivals traffic will be detoured through Terminal B Arrivals. Additional signage is being installed and State Police and Massport Ground Transportation staff will be on site to assist drivers.

The roadway construction is replacing the aging roadway infrastructure along both levels between the terminals. When work is completed, Terminals C and E Departures traffic will be able to use the newly constructed roadway and will no longer have to merge with vehicles exiting Terminal B. The construction will also create more curb space at Terminal C - and reduce congestion on Boston Logan's roadways - by improving traffic flow and increasing traffic safety. This project is set to be completed this November.

We strongly urge passengers to take advantage of the various transit modes to and from Logan, such as MBTA's Silver Line (FREE from Logan), Blue Line and water ferry, Logan Express, and private bus lines. Massport operates four suburban Logan Express services including Framingham, Braintree, Woburn and most recently Peabody at the North Shore Mall.

For those picking up loved ones at Logan, we are encouraging the use of Boston Logan's two Cell Phone Lots, located on Service Road and in the area adjacent to the Rental Car Center, to prevent congestion at the terminal curbs. Drivers should follow the signs to either of the Cell Phone Lots, and park until the person or party being picked up is ready at the terminal curb. Each location has approximately 100 parking spots.

Additional customer benefits from this initiative include:

• Less queuing on roadways;

• Reduction of vehicle emissions associated with traffic delays;

• Increased infrastructure resiliency;

• Improved lighting and way-finding signage.

So we wish to offer our congratulations to all of the candidates for putting themselves out there for the good of our community and for running high-level campaigns that were a credit to themselves, their families, their supporters, and our city.

## The importance of keeping Revere covered

At the start of the COVID-19 pandemic, thousands of Massachusetts residents, and people throughout the country, lost their jobs and the employer health insurance coverage they relied on to stay healthy.

In compliance with federal law, MassHealth - the state's Medicaid program - was able to provide health insurance to keep people covered during this difficult time. Now following the pandemic, however, MassHealth is in the year-long federally required process of redetermining who remains eligible going forward. Because income and circumstances may have changed since they first enrolled in MassHealth, many people in Revere and across the Commonwealth are expected to lose MassHealth coverage over the next year and have become eligible for other coverage options. MassHealth members will receive a renewal form in a blue envelope in the mail to check their eligibility. All members should complete and return their renewal to receive the best health coverage they are eligible for. Some will remain eligible for MassHealth, and others may be determined eligible for health insurance through the Massachusetts Health Connector. The Health Connector provides affordable health and dental coverage to about 275,000 Massachusetts residents who do not already have coverage from an employer, spouse, or other source.

According to projections, communities of color and immigrant populations may be disproportionately impacted during this transition. With its diverse population of Spanish and Portuguese-speaking families, Revere is a top area of focus for state outreach efforts.

For those who need health insurance – whether they are coming from MassHealth, are new to Massachusetts, or need insurance for other reasons – the Health Connector is ready to help.

Many people who are losing MassHealth already have an account at MAhealthconnector.org. They can go into their account, update information, and then select a plan and get enrolled in new coverage. Many people will qualify for help paying for their coverage through subsidized premiums, along with low co-pays and no deductibles for those that qualify for Connector-Care. Due to a recently announced pilot expansion, more people than ever before are now eligible for ConnectorCare. For those who need assistance finding the right plan, along with local Navigators, people with questions can call 877-MA-ENROLL (TTY: 877-623-7773) and get help with their application and getting into coverage.

The Health Connector's goal is to help everyone stay covered so individuals and families can lead happy and healthy lives. Having access to reliable health coverage can make all the difference for a community: from improving physical and mental health, to preventing financial challenges due to medical emergencies.

Even otherwise healthy individuals, especially if they are overweight, run the risk of becoming seriously ill from the disease in the short-term and potentially suffering the lingering and debilitating effects of long-COVID, which has been well-documented, though it remains poorly understood.

Fortunately however, the CDC has approved the updated COVID booster vaccine that has been proven to be an effective and safe preventative measure against both catching the disease in the first place and, if infected, mitigating its most harmful effects.

The reasons we need an updated booster are threefold: First, the effectiveness of the vaccine diminishes over time. Thus, the shots we received last year are significantly less protective today than they were 12 months ago. Second, the virus has mutated in the past year and the updated vaccines will provide protection against this ever-changing virus. Third, as we enter the fall and winter months, families will be gathering, with many having traveled in airplanes and returning from school, which are breeding grounds for the virus, and therefore looming as potential threats for parents and grandparents. We would note that from January to July of this year, 88 percent of deaths from COVID-19 were among people who were 65 years or older.

We urge all of our readers, regardless of age, to get the latest COVID-19 booster as soon as possible, both for our own health and that of our friends, co-workers, and family members.

## Revere man charged with impersonating a police officer faces additional charges

A Revere man charged with impersonating a police officer is facing additional charges for allegedly shoving a TV reporter while leaving his July court date.

Byron Boisseau, 44, was arraigned in Chelsea District Court last week and charged with assault and battery on a person over 60. Judge Jane Prince ordered Boisseau to stay away and have no contact with the victim. Boisseau will return to court on November 1.

On July 23, Massachusetts State police received a report from an unidentified man driving on Ocean Avenue who noticed a white Ford Crown Victoria with amber lights driving close behind him, according to Suffolk County District Attorney Kevin Hayden's office. The man pulled his vehicle to the side to let the Crown Victoria pass and video recorded the flashing lights and registration. A BOLO broadcast was issued.

A trooper observed the white Ford Crown Victoria turn off Revere Beach Boulevard with flashing amber lights displayed on both the front and the rear of the vehicle. As the trooper approached the vehicle during a traffic stop, he observed two thin blue line stickers on the rear windshield and a black hat that read "security" on the top back seat. There were not any identifying markings or signs on the vehicle itself, according to the district attorney's office.

Upon speaking to the driver, later identified as Boisseau, the trooper noticed he was wearing a black polo shirt with "security" embossed on the front and noticed a silver badge in a holder hanging from the rear view mirror. Boisseau explained that he works as a security contractor for several cities and that he was armed with a mace gun and a BB gun.

As Boisseau stepped out of the vehicle, the trooper observed him touching the small black handle of a firearm protruding from his front thigh pants pocket. The trooper also observed Boisseau wearing a police style belt equipped with several pieces of police equipment such as an expandable baton and a Glock style handgun, later identified as a BB gun.

After a further search of the vehicle, police stated that they found numerous items such as a black bulletproof vest, a large black flashlight, a Rothco police supply catalog, an aluminum citation holder, a black winter ski mask, two pairs of bolt cutters, handcuffs, an alcohol breathalyzer, and a vehicle push bar bumper, a device often found on police vehicles.

Boisseau was arraigned in Chelsea District Court on July 26 on charges of impersonating a police officer, possession of burglarious tools, carrying a dangerous weapon, and disorderly conduct.

After the arraignment, a TV reporter attempted to get a statement from Boisseau as he was leaving the courthouse. Boisseau grabbed the reporter and shoved him multiple times, according to the district attorney's office. The victim was able to provide investigators with video footage that shows Boisseau pushing him.

The victim was evaluated at a local hospital but did not sustain any major injuries.

"Impersonating a police officer or any armed official is not only dangerous but also a crime," stated Hayden. "This individual chose to commit another crime right after answering on a different one. We all have a job to do. Use of force or violence against someone performing their professional duties will never be tolerated, as this individual has found out."

## EEE sightings increasing around State

Massachusetts The Department of Public Health (DPH) last week announced that Eastern equine encephalitis (EEE) has been detected in an additional mosquito sample collected on September 13 in Brimfield. This finding raises the EEE risk level to high in Brimfield, Sturbridge, and Holland and to moderate in Wales.

This is in addition to the six communities already at high risk for EEE: Douglas, Dudley, Oxford, Southbridge, Sutton, and Webster, Auburn Charlton, Grafton, Millbury, and dawn in the high-risk

Northbridge, and Uxbridge are at moderate risk.

"The forecast is for cooler temperatures which will start to reduce mosquito activity," said Dr. Catherine M. Brown, State Epidemiologist. "However, the risk for spread of EEE virus from mosquitoes to people is still present. Everyone in these moderate- and high-risk areas should take the recommended steps to prevent mosquito bites; this includes avoiding outdoor activity between dusk

communities."

EEE is a rare but serious and potentially fatal disease that can affect people of all ages. EEE is generally spread to humans through the bite of an infected mosquito. There were 12 human cases of EEE in Massachusetts in 2019 with six deaths and 5 human cases with one death in 2020. There were no human cases of EEE in Massachusetts in 2021 or 2022. No human or animal case of EEE has been detected in Massachusetts so far this year

# City and state working together to assist migrant families

Over the past several months, city officials have been coordinating with the state to help handle the influx of migrant families that are currently being sheltered in Revere, as well as other communities throughout the state.

At a meeting of the city's Community Response Network on Monday, Public Health Director Lauren Buck gave an update on the current status of migrant families in the city.

"The state has been coordinating the large influx of migrant families we have seen over the last three to four months," said Buck. "There are welcome centers where the families are hopefully being directed. None of the welcome centers are necessarily close; they are opening one in Quincy and there is one in (Jamaica Plain) I believe." Revere has families that have been placed through the EA (emergency assistance) shelter program, with the majority of families from Haiti, Buck said. In addition to migrant families, Buck noted that the EA shelter program in the state is also open to people who are homeless but not necessarily new to the country.

"Our role in this in the last three months we've been involved has been trying to coordinate and make sure these families are set up with all the appropriate resources, that they are connected with the Revere Public Schools, and they are making sure they have medical clearance and medical screenings."

Children from most of the families are enrolled in Revere schools or getting enrolled in early education programs such as Head Start, Buck said. ties, the state is sheltering the majority of the migrant families in hotels.

"We've had some very generous donations and done some clothing drives," said Buck. "We've worked with the state to help organize regular meals, because if you are living in a hotel room, you don't necessarily have access or the ability to cook meals."

Almost all of the families have been set up with SNAP and WIC benefits, Buck added.

"Because of the large influx of families, the National Guard was deployed by the governor," said Buck. "Although we haven't had the National Guard into some of our hotels, I believe they will be coming soon to help with organization. So far, we have not necessarily had any big issues; our families are doing really well and the kids are in school."

## Community groups form Plastic Free Mass

Over a dozen community and environmental groups have joined forces to form Plastic Free Mass. a new coalition dedicated to ending the use of polluting plastic. The group will push for new policies to protect our Commonwealth's residents and natural resources by ending our plastic addiction and moving us toward a cleaner future. The data couldn't be clearer. Nearly 40% of the plastic produced annually is for single-use plastics and packaging. Very little plastic - between 5-6% in the United States – is actually recycled. Plastic is toxic and polluting at every stage of its lifecycle - from extraction and manufacturing, to use, recycling, and disposal. Many single-use plastics can be easily reduced, redesigned for reuse, or replaced with nontoxic alternatives. "The Friends of the Malden River have sponsored many cleanups around and in the Malden River. The Malden River, a typical urban river, is inundated with plastic pollution due to its physical connection with the city's stormwater system. Volunteers have removed thousands of single use plastic items and pounds of degraded polystyrene from the waterway. It is

distressing. We have witnessed the contamination of the collected recycling at our local single stream recycling system. Typically, over 65% of Malden's collected recyclables are contaminated with plastic bags, household waste, and nonrecyclable plastics and metals. This contaminated recycling is incinerated at the Wheelabrator Saugus Plant. The Plastic Blight needs to end with state legislation and public awareness, " said Karen Buck, Friends of Malden River. Accordingly, we support legislation, policies, and programs that: phase out and avoid the production and use of any unnecessary single-use plastics, reduce and eliminate plastic packaging whenever possible, and modernize our state's beverage container deposit system to include reuse and refill targets. The members of Plastic Free Mass include Berkshire Environmental Action Team, Berkshire Zero Waste Initiative, Beyond Plastics, Clean Water Action, Conservation Law Foundation, Container Recycling Institute, Environmental League of Massachusetts, Friends of the Malden River, Just Zero, Metropolitan Area Planning Council, MetroWest Climate Solutions, Mothers Out Front, Oceana, Progressive Democrats of

Massachusetts, Seaside Sustainability, Slingshot, and Story of Stuff.

"The Commonwealth of Massachusetts is an environmental leader in so many ways, so it's particularly disappointing to see us fall behind in the area of solid waste. For example, our state is one of the only states in New England without a statewide plastic bag ban, and our bottle bill has one of the lowest redemption rates in the country. We must move quickly and decisively to remedy these shortcomings or we risk falling even further behind in the fight to curb the climate crisis, " said Kirstie Pecci, Executive Director, Just Zero Mara Shulman, Senior Attorney, Conservation Law Foundation added "It's time to finally address the plastics crisis in Massachusetts. From modernizing our antiquated beverage container deposit system, to banning single-use plastic bags at checkout, to making producers of plastic packaging responsible for reducing packaging and managing plastic waste at its end of life, there are several pending bills that will take us in the right direction. We stand with our elected officials and pledge to keep up the momentum because there is no time to waste in taking a bite out of waste."

#### 10 years ago September 18, 2013

The source of the problem is a compromised sewer main that lies some 20 feet below Winthrop Avenue next to the Mc-Mackin Park. About two weeks ago, the sewer pipe failed and for the past two weeks, crews have been running a pump to bypass the crumbled sewer pipe, but that has grown expensive with overtime costs, police details and equipment.

The news last week by Superintendent Paul Dakin that the new Hill School will be at capacity before it even opens (possibly in September 2015) has come as a shock to most residents and city officials, who have been stunned by the ever-increasing size of the city's student population.

The Immaculate Conception Church held its annual Family Festival on Saturday. Eleven countries were represented and fine cuisine from all over the world was served and enjoyed by all.

#### 20 years ago September 24, 2003

Robert Daigle, a 67 year-old Frye Street resident, has been charged with the murder of James Surette, 39, also of Revere, after an all-night drinking party. Daigle, who has been well-known over the years as an impersonator of Elvis and other celebrities at The Cove and Zeke's, allegedly confessed to stabbing Surette and then attacking him with a machete.

The corner of Malden Street and South Avenue was dedicated in honor of the late Angelo Costa, a WWII veteran who received the Purple Heart and the Bronze Star for his bravery at the Battle of the Bulge. Costa passed away in 1984. Members of the Shaughnessy and Hanlon families gathered to dedicate a memorial to Edward Shaughnessy, a Malden Catholic student, who died in an auto accident on Route 1 in October of 2002. The memorial is located at the Point of Pines near the MBTA bus turnaround. Revere native Francis M. Giardiello, M.D., has been named the inaugural recipient of the John G. Rangos Jr. Professorship in Adult Medicine at Johns Hopkins Hospital. Dr. Giardiello has been a member of the faculty at Johns Hopkins Medical School since 1986. Freaky Friday, The Italian Job, and The Fighting Temptations are playing at the Revere Showcase Cinemas.

challenger Revere Police Lieut. Edward Ryan received only 23 percent of the vote in last week's primary election compared to 70 percent for incumbent Robert Haas, Ryan said he is confident that support for his campaign will materialize in the coming weeks ahead of the November final election. Campaign records show that Haas outspent Ryan by \$49,838 in the primary.

The first Mayor's Walk to benefit the Revere Public Library is set for this Sunday and will cover 4.2 miles.

The city and the police union have fallen into a bitter standoff in their contract talks after the two sides appeared to have reached an agreement three weeks ago. Police union head John McRae has accused Mayor Robert Haas of reneging on key parts of the contract language.

Members of the City Council sparred publicly with Adele Toro, the head of the Citizens Against Municipal Mismanagement, over her group's petition calling for a ballot question that would substantially reduce the salaries of the city councillors.

Police are investigating an armed home invasion by three males at an Arcadia Street residence.

#### 40 years ago September 21, 1983

Tuesday's city primary election saw Mayor George Colella handily defeat his two challengers. Colella received 6203 votes to 1103 for Lorenzo "Larry" Torregrossa and 494 for Matthew Raia. Colella will face Torregrossa in the November final election. Only 37 percent of registered voters turned out for the primary election.

Samuel S. Granito, 76, of Revere, was one of five men arrested by the FBI this week and charged with racketeering. Others arrested by the FBI include Gennaro Angiulo, 64, of Nahant and three of the Angiulo brothers. Gennaro is a reputed leader of organized crime in the Boston area. Local Committeeman School William Cintolo Jr., a lawyer for Angiulo, has been named as an unindicted co-conspirator in the case, according to Justice Department officials. Local Catholics are mourning the passing of Humberto Cardinal Medeiros. Cardinal Medeiros, who succeeded Richard Cardinal Cushing as the Archbishop of Boston in 1970, was 67. Revere's Karen Maria Pisani will be in the cast of the Broadway musical A Chorus Line when it makes its record-breaking, 3389th show on Broadway next Thursday. Easy Money, Risky Business, and Eddie and the Cruisers are playing at the Revere Showcase Cinemas.

# Council approves grant application for Gibson Park project

For the second time in the past three months, the City Council approved a resolution that will allow the city to apply for a state grant to help pay for the first phase of the Gibson Park improvement project.

"If you think you have been here before talking

What is different with the Gibson Park project compared to past PARC applications is that for the past applications, the PARC grant covered the bulk of the improvements.

"In this case, the \$500,000 we'd receive would be but a fraction of the \$2-plus million project that will be taking place at Gibson Park," said Skwierawski. "So originally, when we put the motion in front of you in June, we

had just picked out a few discrete items that correspond to the grant application, such as turning the baseball diamond into an all-purpose field and adding lighting fixtures and adding an ADA accessible (walking path)."

Those items totalled about \$700,000, Skwierawski said.

But he added that the city does have the money necessary to cover the first phase of the project through an ARPA allocation that came through during Mayor Brian Arrigo's term. The new resolution passed by the council essentially shows that the ARPA funding is in place to complete the project.

Skwierawski said the city also has state and federal funding in place and is seeking additional funding for the larger overall Riverfront improvement project that will see a new Rte. 1 roundabout that will keep excess traffic away from the Gibson Park neighborhood, and environmental resiliency and flood mitigation efforts for the neighborhood.

Is the dog walker willing to meet you and your dog before scheduling appointments? This allows you to determine if the person is a good fit for your furry friend. Inquire about the number of dogs they usually handle. You might even request to accompany them on a walk to observe their handling of your dog within a pack.

If you have needs or requirements, make those clear from the beginning. A close friend hired a dog walker for her dog with the condition that the dog should never be tied up outside. She told us that if we ever saw her dog tied up, we were to take him home and notify her immediately. One day, Penny found him in a group of dogs outside a building and did as requested. That was the last time that person walked that dog.

## EOVS announces new appointments to the Veteran's Reintegration Advisory Committee

The Executive Office of Veterans Services (EOVS) proudly announces the revival of the Veteran's Reintegration Advisory Committee (VRAC) and the appointment of seven new committee members. VRAC is entrusted with actively investigating, studying, and scrutinizing various aspects of veterans' reintegration into civilian life. Its primary objectives include reducing suicide rates and addressing the profound effects of post-traumatic stress disorder (PTSD), depression, and anxiety among veterans. Furthermore, the committee will explore the impact of community peer liaisons on veterans' successful reintegration into society and delve into the critical link between isolation and veteran suicide.

"We remain steadfast in our commitment to veterans' well-being. The EOVS team and I are wholeheartedly dedicated to standing up this Committee, which comprises renowned leaders from the healthcare community. I eagerly anticipate the Committee's findings and recommendations," said Secretary Jon Santiago of the Executive Office of Veterans Services.

VRAC's establishment directly results from the statutory mandate outlined in S3097, the "Act addressing barriers to mental health care," enacted on August 10, 2022. The committee will comprise a diverse group of individuals, including representatives from prominent organizations such as Massachusetts General Hospital's Home Base Program, the Wounded Warriors Project, the Mass Mentoring Partnership, Inc., the Massachusetts Coalition for Suicide Prevention, the Massachusetts Psychological Association, Inc., as well as esteemed professionals and experts from various fields.

The inaugural meeting is scheduled for October to Director for the Division 10. World Mental Health Day.
