## **City Council approves bond** authorization for new high school

#### By Adam Swift

Monday night, the city council voted 9-2 to move forward with a bond authorization of just over \$493 million to build a new Revere High School at the 30-plus acre Wonderland property.

Monday night's vote came a little more than 15 months after the council voted against moving forward with the project at Wonderland due to some councillors raising concerns about the financing and transparency of the process.

Councillors Anthony

Zambuto and Michelle for the city's largest bond Kelley cast the two no votes against the bond authorization at Monday night's meeting.

Over the past year, the School Building Committee and consultants were asked to consider building at the current high school site. But the building committee came back again with a recommendation to build a new four-story high school at Wonderland. That recommendation was later backed by the school committee and the council.

"Tonight, we are before you for the humble request authorization ever for the future of our Revere High School and our entire Revere educational system," said Mayor Patrick Keefe. "Over the past four years, the council, former councillors, and myself have worked relentlessly to ensure that we made the best choice."

Over the past six months. Keefe noted that his administration has worked with the council to make sure any and all questions about the project from the council have

been answered.

Last month, project manager Brian Dakin of Leftfield said that the state grant from the Massachusetts School Building Authority (MSBA) would be slightly higher than initially estimated. After accounting for the MSBA grants, the total cost of building on the Wonderland site to the city had been estimated at about \$285.5 million, according to the project team.

Ward 1 Councillor Joanne McKenna discussed her reasoning for voting against the project in 2023, but voting for the bond authorization this year.

"Do not be fooled by my vote tonight, it has nothing to do with how I was treated last year by my friends, some of whom I have known since I was a kid," said McKenna.

McKenna said she was



subjected to nastiness, meanness, and threats following her vote last year. She said she voted no at that time because of the extreme cost projections, as well as the lack of transparency and education she said the council received.

"It was my duty to put the city and our people first and to protect this city from going into bankruptcy or a vote for a Proposition 2-½ (debt exclusion) to finance this," said McKenna. "The council and the city needed this year to look at how we are going to pay for this school. We

## In major milestone for New Revere High School, City Council approves bond authorization

On May 20, in a monumental 9-2 vote, the Revere City Council approved a \$493 million bond authorization for the new Revere High School, approximately \$238 million of which is bolstered by MSBA Grant funding. The historic vote comes with a recent momentum shift for the new Revere High School project, the planning process of which has taken six years thus far.

The origins of the projtect date back to 2018, Now, the project has received the required funding to move forward. The City and School Building Committee anticipate that the school will have a useful life of at least 50 years.

"I am very proud of all of our elected officials for making this courageous decision," said Mayor and School Building Committee Chairperson Patrick M. Keefe Jr.

The decision comes after months of financial review meetings hosted by Mayor Keefe and CFO Rich Viscay, "I worked closely with elected officials to make sure that all of the financials, as well as the building process, were clearly spelled out. It is important to me that each person made an informed decision." Mayor Keefe added, "It says a lot that

we all were able to share our input and work together for a common goal, with our students and faculty in mind."

Mayor Keefe continued, "One of the greatest status symbols of a city is a strong, well-equipped public school system. This decision does not only benefit the future students and teachers of Revere, but future families and property owners who may choose to plant their roots in our community."

Council President Anthony Cogliandro, a key proponent of the project, added, "History was made on Monday night, and I am honored to be a part of it. Anything good takes time. I have full faith we will all work together for the benefit of the children of our community."

"I believe the high school is going in the right place," said Silvestri. "Is it scary? Absolutely; we don't live in a perfect world, but our students need perfect education, and that is what we are

Councillor-at-Large Michelle Kelley said she would wholeheartedly like to see a new high school built, but that the factors for her were cost, timing, and unknown risk factors.

"Specifically, I would have liked to see the cost of the new school scaled back in terms of bells and whistles so that costs were at a more manageable level, especially since history tells us that projects always end up costing more


m." than originally estimated," rge said Kelley.

Councillor-at-Large Anthony Zambuto said the process this time around was transparent, but said there were still many unknowns, including the final cost of the Wonderland land. The land was taken by eminent domain for \$29.5 million, but the former owners are taking legal action against the city to get more money for the property.

Council President Anthony Cogliandro commended each of his fellow councillors for their commitment to becoming informed about the project over the past year. "There has been a ton of information thrown at us, and you've all done a great job and I appreciate it and I've loved working with every single one of you on this," said Cogliandro.

The council president also praised Keefe for the administration's openness during the process.

"I also want to say, for me, this is about me trusting the ability of the administration that they are going to do everything in their power to make sure we find the right ways without burdening the taxpayers to pay for this school," said Cogliandro.



## License Comm. takes up a wide range of matters

The Revere License Commission held its regular monthly meeting last Wednesday, May 15, in the City Council Chamber. Chair Robert Selevitch and fellow commissioners Daniel Occena and Liliana Monroy were on hand for the session and addressed a wide range of matters.

The first item on the agenda was an application from Royal Food Enterprises, Inc., 91 Centennial Ave., Mohammed Fdal, manager for a change of d/b/a from Sabrine Bakery & Café to Crown Fried Chicken & Pizza, A representative for the establishment told the commission that they felt that a change of its business from a bakery to a fried chicken and pizza restaurant made sense for that area.

There were no opponents and the commission unanimously approved the application.

Ralph DeCicco from the Blessed Mother of the Morning Star Parish at St. Mary's Church, 670 Washington Ave., presented an application for a 1-day Malt/Wine, Common Victualler & Entertainment License to be exercised in the Lower Church Hall on Saturday, June 15, from 5 p.m.-10 p.m. for a Doo-Woop Dinner Dance with an expected attendance of 85-95 persons.

DeCicco, the Mr. vice-president of the Holy Name Society, told the commissioners that the society regularly holds themed dinner-dances for the parishioners. There will be catered food and a DJ. There were no questions, no opponents, and the commission unanimously approved the application.

Steven Morabito, Revere's Director of DEI, next presented an application for a 1-day Entertainment License to be exercised at Waterfront Square on Sunday, June 23, from 2 p.m - 7 p.m. for the third annual Revere Beach Pride Event. The expected attendance is 1000. Morabito explained that the westerly side of Waterfront Square will feature a DJ and music. "These are important traditions that the city has been doing to celebrate diversity, inclusion, and community spirit," said Morabito. He said there will be no alcohol served by the event, though the adjacent Fine Line restaurant will be open for service. There were no opponents and the commission unanimously approved the application.

tion from H & R Partners, Inc,. d/b/a Valsos Table & Bar 139 Shirley Ave., Alexander Herrera, Manager, for an Alteration of Premises to add outdoor seating for 15 patrons from 10 a.m.-12 a.m. seven days per week.

Mr. Herrera told the commission that the outdoor seating area will be contained within the restaurant's own property and will not encroach on the public sidewalk. He also noted that there will be a small speaker for background music only. He said that the establishment has done this for the past two years. There were no opponents and the commissioners unanimously approved the application.

Revere Hotel Realty, LLC, d/b/a Avid Hotel Boston Logan Airport-Revere, 405 American Legion Highway, presented an application for a Change of Manager to Ian Galloway from Bernie L. Auch, III.

Mr. Galloway informed the commissioners that he has been in the hotel business for more than 12 years and that there will be no changes to the operation of the business. There were no opponents and the commission unanimously approved the application.

Revere Lodge #1171 of the B.P.O.E. of U.S.A., Inc., 198 Shirley Ave., presented an application for a Change of Manager from James Hannon to Anessa Schena. Ms. Schena told the commission that Mr. Hannon is retiring. She said that she has been a bar manager in the past and is TIPS-certified. There were no opponents and the commission unanimous;y approved the application.

Ms. Schena also presented an application on behalf of the Elks Lodge for a change of officers to reflect the recent annual club election. The request was approved without discussion.

Diane Cardona, the proprietor of Chocolaffee, LLC, 9 Dehon St., presented an application for a Common Victualler License to be exercised from Sunday-Saturday 5 a.m.-11 p.m. with requested seating of 15. Ms. Cardona said her new business will offer baked goods and empanadas and "will provide some Columbian essence in our coffee."

ness out of the way, the commission held a lengthy hearing pertaining to Noah Autobody Repair & Sales, Inc., 1095 Broadway, Raymond Desamours, Manager "to inquire into the operation and status of the licensed business." This matter had been continued from the April meeting.

At issue is that Mr. Desamours has not been operating his business as required by the terms of his license for at least 30 hours per week. "Your client has had the license for a year or so and there has been no sales, no activity, no business activity at that location, which is in violation of the license," said Selevitch. "So we want to see what his plans are and if he plans on opening."

Atty. James Nyman of Boston represented Mr. Desamours. Atty. Nyman said that Mr. Desamours had been unaware of the hearing last month and only became aware of the May hearing recently. Mr. Nyman asserted to the commission that an adjacent business has been trespassing on the property and presented an affidavit from Mr. Desamoiurs, the crux of which is that he has been "frustrated in trying to sell cars" by the adjacent business's trespassing on his property.

Nyman said he has written a cease-and-desist letter to the other business owner, but Nyman alleged that the trespassing has increased, including the parking of vehicles that have been obstructing the entrance to the property.

In response to a question from Selevitch, Nyman acknowledged that there is a dispute about the property lines which is the genesis of the problem between the parties. The commission also heard from the owner of the adjacent property, Mike Zaccaria of Action Emergency Management Services.

"We absolutely are not on their property. We do

## Memorial Day program in Revere to honor Fallen Heroes

The City of Revere is set to honor its fallen heroes with a solemn and respectful Memorial Day program on Monday, May 27 at the American Legion Lawn located at 249 Broadway. The event will feature a series of tributes and ceremonies aimed at remembering and honoring those who have sacrificed their lives for the nation.

The program will commence with a cadence by the Guardian of the Flag, presented by the Revere Police and Revere Fire departments. Isaac McDaniel, Director of Veteran Services, will serve as the Master of Ceremonies for the day.

The Revere Fire/Police Department Honor Guard, along with the RHS Army JROTC, will perform the Presentation of Colors. Aubrey Vaudo will lead attendees in the Star-Spangled Banner, setting a patriotic tone for the day's events.

Tyler DeAngelo of the National Guard and the Revere Fire Department will perform the ceremonial lowering of the flag from full staff to half staff, followed by an invocation by Reverend Tim Bogertman of the First Congregational Church of Revere. Mayor Patrick M. Keefe Jr. will deliver the Welcome Address, highlighting the importance of remembering those who served. Noor Ashour from Rumney Marsh Academy Middle School will read the Memorial Day Proclamation on behalf of Governor Maura T. Healey.

#### LEST WE FORGET...

Although the Memorial Day weekend signifies the start of the summer season and is observed by families and friends who gather for barbecues and similar festivities, we should keep in mind that Memorial Day is our most solemn national holiday in which we remember those who gave their lives in defense of our country.

Their sacrifice in the many wars our nation has fought since our country's founding should serve as a reminder that freedom isn't free.

Although today we technically are at peace, the world feels anything but peaceful. Totalitarian adversaries either are wreaking havoc, most notably Russia in Ukraine and Iran in the Middle East, or are threatening to do so, No. Korea and China being the most prominent.

If the lessons of the past and present teach us anything, it is that we cannot take our freedom for granted. Our military men and women who at the present time are providing humanitarian and military aid in far-off places around the globe could be called upon to engage in a far different and far more dangerous mission at a moment's notice.

We should keep in mind too, that the willingness of our military personnel to serve in defense of our country not only places them in harm's way, but also imposes great sacrifices upon their families.

This realization made us think back to the roots of Memorial Day, which originally was known as Decoration Day in the aftermath of the Civil War, with the proclamation by Gen. Logan on May 5, 1868, in which he declared:

"The 30th day of May, 1868, is designated for the purpose of strewing with flowers or otherwise decorating the graves of comrades who died in defense of their country during the late rebellion, and whose bodies now lie in almost every city, village, and hamlet churchyard in the land. In this observance no form or ceremony is prescribed, but posts and comrades will in their own way arrange such fitting services and testimonials of respect as circumstances may permit. Let us, then, at the time appointed, gather around their sacred remains and garland the passionless mounds above them with choicest flowers of springtime; let us raise above them the dear old flag they saved from dishonor; let us in this solemn presence renew our pledges to aid and assist those whom they have left among us as sacred charges upon the Nation's gratitude, the soldier's and sailor's widow and orphan."

In the aftermath of World War I, the term Supreme Sacrifice came into the national lexicon to describe those who gave their lives in that terrible conflict and has been associated with our wars for the past century.

However, prior to that time, President Abraham Lincoln coined a different phrase -- the "last full measure" -in his speech at Gettysburg to honor the Union soldiers who fought and died to preserve the nation in that epic battle that turned back the Confederate Army.

Lincoln's brief oration rates as the greatest-ever testament to those who have given their lives in defense of their country. We never tire of reading his plain yet profound words, and as the years pass, they seem to take on new meaning. Similar to the state of the nation when Lincoln delivered his speech on November 19, 1863, at the official dedication of the Soldiers National Cemetery at Gettysburg, Pennsylvania, we are divided along lines that seem irreconcilable. Not only are we facing challenges to our democratic ideals abroad, but here at home as well.

"But, in a larger sense, we cannot dedicate, we cannot consecrate, we cannot hallow this ground. The brave men, living and dead, who struggled here, have consecrated it, far above our poor power to add or detract. The world will little note, nor long remember what we say here, but it can never forget what they did here. It is for us the living, rather, to be dedicated here to the unfinished work which they who fought here have thus far so nobly advanced. It is rather for us to be here dedicated to the great task remaining before us that from these honored dead we take increased devotion to that cause for which they gave the last full measure of devotion that we here highly resolve that these dead shall not have died in vain that this nation, under God, shall have a new birth of freedom and that government of the people, by the people, for the people, shall not perish from the earth.'

We hope our readers appreciate the eternal truths of Lincoln's sentiments, which are as relevant today as they have been since the founding of our nation.





to American Legion Park to watch the pickle ball games.





## Council votes to rename Liberty Park in honor of Lt. John Jones

Liberty Park in North Revere will soon be known as Lt. John Jones Memorial Park.

Monday night, the city council unanimously voted to rename the park in honor of Jones, a lifelong resident of North Revere who served in the Air

Force and was one of the first Black police officers in the city of Somerville.

Ward 6 Councillor Chris Giannino said Jones was born and died in North Revere, living across the street from the park as he raised his family. Giannino said that in addition to his military and police service, Jones was deeply in-

volved in youth sports and other activities in Revere, and that he and his family were and remain fixtures in the city.

Councillor-at-Large Marc Silvestri said he grew up with Jones' sons, and that the family had a huge impact on him and others of his generation in Revere.

"He took so many others in like they were his own," said Silvestri. "I couldn't think of a better name for this park."

Councillor Robert Haas, III said he grew up with and played travel basketball with Jones' son J.J.

"His dad was a great man and he was a staple in North Revere and the city," said Haas.

Haas noted that when his father was mayor in 2005, he dedicated a memorial to Jones shortly after Jones died.

J.J. Jones was present at Monday night's council meeting and thanked the councilors for supporting naming the park in honor of his father.

"My father was born in the woods steps away from the park ... during the massive blizzard of Jan. 26 of 1943," said Jones. "He died just steps away from it as well in the family house that he built and raised his family in."

In the Air Force, Jones said his father was a midair refueler who served in Vietnam.

"When he came back

## Massachusetts House passes information technology bond bill

The Massachusetts House of Representatives passed An Act to provide for the future information technology needs of Massachusetts, also known as the FutureTech Act. This bill authorizes \$1.23 billion in bonded spending and utilizes an additional \$400 million in anticipated federal funding to bolster critical information technology projects across the Commonwealth. The initiatives included in the bill aim to modernize the Commonwealth's information technology infrastructure, enabling agencies to operate with enhanced efficiency while also upgrading cybersecurity efforts. By investing in these advancements, Massachusetts seeks to broaden access to vital services and information, ultimately enhancing the digital landscape and user experience for all residents.

"Ensuring that the Commonwealth is investing heavily in our technology infrastructure is critical, as protecting against cybersecurity threats, and enabling state agencies to operate with an increased level of efficiency, are vital aspects of our effort to make Massachusetts more safe, effective, and prepared in a world dominat-

ed by increasingly sophisticated technologies," said House Speaker Ronald J. Mariano (D-Quincy). "I want to thank Governor Healey for filing this legislation, as well as Chairs Michlewitz and Finn for their critical input, and for guiding this bill through the legislative process. I am grateful to all of my colleagues in the House for recognizing the importance of this bill, and for voting to pass it."

"The FutureTech Bond Bill will make state government more accessible and more effective for everyone in Massachusetts by ensuring our IT systems are up-to-date, safe and secure, and easy to use. This will put Massachusetts in a stronger position to take advantage of new innovations, like applied AI, in ways that benefit our residents, businesses and economy. Finn (D-West Springfield), House Chair of the Joint Committee on Bonding, Capital Expenditures, and State Assets.

The FutureTech Act not only ensures the seamless operation of essential government functions but also lays a foundation for future innovation. Key initiatives include the implementation of transformative projects like the Business Enterprise Systems Transformation (BEST) and the Commonwealth Digital Roadmap, both aimed at enhancing administrative workflow efficiency and streamlining state operations.

The bill also supports a new project to consolidate and modernize the Division Occupational Licensing (DOL)'s licensing database. This project will replace the current outdated infrastructure, which relies on paper files as well as manual data entry and review, resulting in delayed application and renewal processing.

The bill also includes authorizations for the continued rollout of the Employment Modernization Transformation (EMT), a project which will provide both employers and those seeking unemployment insurance with a new portal to conduct state-facing employment activities, facilitating a streamlined claims process for uploading information with a mobile-friendly design and increased accessibility features.

In addition to addressing the Commonwealth's immediate needs, the FutureTech Act embraces a forward-looking strategy to position Massachusetts as a leader in current and emerging technologies. By allocating funds for future

AI projects and supporting initiatives like the Municipal Fiber Grant Program, the bill not only ensures our state's technological competitiveness today, but also supports innovation at the local level, ultimately saving towns and cities money through enhancements to their networks.

places. There are parks in front of 1 Harrison Avenue and by the Chinatown Gate with tables and seats to enjoy an outdoor meal.

#### **Buy Dessert First**

We begin with an attitude of Carpe Diem and buy dessert first. You'll find bakeries scattered around the neighborhood. We have a few favorite items, but try something new each visit to expand our Asian dessert experience. Custard and Portuguese tarts are always on our list. We suggest you buy a sampling of these treats from several bakeries and find out which best satisfies your sweet tooth. Top Bread and Great Taste usually have both tarts.

One thing we love about the desserts from Chinatown is that they are often less sweet and heavy than the Western versions. This is especially true of cakes. Consider one from this neighborhood if you want to end a meal with a celebration cake. In many cases, they will offer both individual and full-size cakes. You can buy one portion before you order a larger one. In addition to sweets, many bakeries have selections of savory items. (We love barbecue pork buns.)

For many years, we shopped at a large Chinatown market. Then, Penny took a "Boston Chinatown Tours - Food, Fun, Fables" with Jacqueline Church and began shopping at Jia Ho Supermarket on Washington Street. This is a much smaller market with excellent produce and

We'll stock up on chicken feet and ground pork at the meat counter. If you buy chicken feet, ensure the butcher understands you want 12 feet, not 12 pounds. Penny uses Google Translate on her phone to clarify things and ask questions.

The produce section has herbs by the bunch. Thai basil, scallions, garlic, ginger, galanga, garlic chives, Chinese cabbage, Persian cucumbers, and Asian pears are often on the Chinatown list.

Then we'll tour the rest of the store, adding fresh and dry noodles, sauces, different kinds of vinegar, and a few housewares items to the cart.

## Revere's Oulaya Louaddi is building community for nursing students

The fourth-year Penn nursing student from Revere, who is about to graduate and start work in a cardiac intensive care unit, has been heavily involved in the Minorities in Nursing Organization all four years at Penn.

Oulaya Louaddi, a fourth-year School of Nursing student at the University of Pennsylvania with minors in global health and East Asian languages and civilizations, is preparing to begin a graduate nurse position in a cardiac intensive care unit at Massachusetts General Hospital in Boston, near her hometown of Revere.

She says that being a daughter of immigrants from Morocco is a big part of who she is, that she felt her parents had given her so many opportunities, and that it was up to her to decide what to pursue. Her parents, Louaddi says, have been supportive but their lack of higher education, coupled with her attendance at a public school with limited resources, meant she had to be resourceful in navigating the college landscape.

In her second year of high school, she took a dual-enrollment course at Salem State University on health care in the U.S., and the instructor talked about health care workforce shortages and how nurses could fill the gaps in rural communities. Louaddi says this stuck with her, and she knew she wanted to go into medicine, but she didn't yet know what. Participating in the Agress Summer Health Corps Program at Beth Israel Deaconess Medical Center convinced Louaddi that nursing was the best path for her.

"There's a lot of flexibility, a lot of options with what you want to do. You're never pigeonholed into a certain specialty, which is great," she says. "There's also a lot of opportunities to take leadership positions in the hospital and to go back to school to become an advanced practice registered nurse."

After arriving at Penn, her first research experience was through the Penn

Undergraduate Research Mentoring Program, working in the Annenberg School for Communication's Health Communication & Equity Lab on projects about a tobacco flavor ban in Massachusetts and anti-tobacco marketing to LGBTQ teens. As a research assistant at Penn Nursing, she helped create motivational interviewing workshops to address COVID-19 vaccine hesitancy among health care providers. Louaddi has also been involved in the Arab Student Society and Muslim Students' Association.

Four years ago, shortly after coming to Penn, Louaddi became a liaison to the Minorities in Nursing Organization (MNO), letting the board know where first-year students could use the help of thirdand fourth-year students, such as with a vital signs assessment or microbiology exam.

She became vice president for half a year and then president for two years. Transitioning to the top job, Louaddi picked up the work of her predecessor in planning the Red and White Ball, a semi-formal charity event bringing together Penn Nursing faculty and students. She thus helped revive an event halted during the COVID-19 pandemic.

Louaddi also worked to eliminate barriers to involvement in MNO and says she slowly started seeing more attendance at events. That includes study breaks, panel discussions for difficult classes such as anatomy and physiology, Christmas card writing for nursing home residents, and an event with the ReAwakening Agency to create self-care packets for formerly incarcerated people reacclimating to society.

Nurses are "the first person that a patient sees and the person that spends the most time with the patient," Louaddi says, "so beyond the science a lot of it is making people feel safe, making people feel that they're heard and that they're seen and that their worries and concerns and stresses are valid, seeing a person for who they are as a whole and not just one illness or one symptom." She has learned this from MNO and hopes others are, too.

Louaddi says she never had a lecture class before coming to Penn or the pressure of a course grade relying on one test, but in MNO she found people from similar backgrounds. They helped each other, and she says amid the most difficult classes the group provided stress relief.

As president of MNO, Louaddi says she also wanted to advocate for fellow Middle Eastern and North African students, having not always felt seen in a group that hasn't even had a census designation, but also to build a space that was welcoming and provided support to everybody.





## Plan B on Malden Street: A 21-unit apartment building

With developer Louis Porrazzo and a group of neighbors in legal gridlock over the development of five two-family homes on Giannino's Greenhouse, Porrazzo took out a foundation permit on June 30 to build a 21-unit apartment building on the same site.

"I don't believe there's anything

we can do but go ahead," said Attorney Larry Simeone, who represents Porrazzo, adding they were scheduled to close on the property at 404 Malden St. last Friday.

Meanwhile, a lawsuit in Suffolk Land Court brought by neighbors Michael Gravallese and Rob and Rita DeMattia has stalled the alternative plan to build five two-family dwellings on the 28,119 square foot site. Despite a healthy amount of neighborhood opposition, the plan got Zoning Board of Appeals (ZBA) approval on April 28, but was soon blocked by the lawsuit.

Since then, both parties had attempted to find a resolution, making the foundation permit from last Wednesday all the more mysterious

"All I can report now is both parties have set up a meeting to discuss possible resolution of the issue," Swampscott Attorney George Richardson, who is representing the neighbors, said last week. "We don't know where it will go or if it will get anywhere, but there's going to be an effort made."

Simeone said that there is a meeting this week between the parties, and that his side would rather see a resolution to the matter than build the apartment building.

"Our intention is to resolve the matter and build what was pro-

Marcos explained that

Onigiri is like a sandwich in Japan and was born about 2000 years ago, when rice farming was introduced to her native country. The dish became instantly popular, and samurais would bring onigiri when they went into battle. About 400 years ago, when the Japanese started traveling longer distances, onigiri was often used as a 'travel food."

During the show, Marcos and Rodriguez provided viewers at home with some insights into Japanese culture. Japan is only one of the many countries honored during AAPI Heritage Month.

"The biggest thing in Japanese culture is respect for others," said Marcos. Marcos also provided a link between diet, education, and spirituality in Japanese culture.

"Eating healthy is one of the most important parts of education in Japan," she
