Council tables vote on marijuana legalization

The city council tabled a vote on legalizing recreational marijuana at its meeting on Monday.

Earlier in the evening, the legislative affairs subcommittee voted to recommend the legalization.

However, the zoning subcommittee voted to keep a zoning ordinance that would dictate where marijuana dispensaries could operate was kept in that committee. Councillor-at-Large Michelle Kelley has presented several amendments to the zoning ordinance that the subcommittee wished to discuss further.

During the subcommittee meetings, a number of residents spoke against legalization and noted that many of them had only

Public health department updates council on opioid settlement funds

The city's public health and SUDHI (Substance Use Disorder and Homelessness Initiatives) offices plan on using about \$150,000 in opioid settlement money in FY25 on several opioid abatement

At Monday night's city council meeting, representatives from the office updated the council on past, current, and future funding for opioid initiatives funded through the settlement money.

As of Sept. 30 of this year, public health director Lauren Buck said the city

has received \$670,000 in settlement funds. In FY24, the city spent approximately \$97,000 in settlement funds, primar-

ily on Naloxone boxes

throughout the city. Naloxone can be used to reverse the effects of opioid over-

Taking in the past and current fiscal year, Buck said the city currently has \$427,000 left in the opioid settlement funds and can expect approximately \$1.5 million over the next decade-plus in additional

Since rolling out the Naloxone boxes in May, SUDHI program manager Carrieann Salemme said 620 doses of Naloxone have been taken from the boxes. The most used boxes include those near the Dunkin Donuts on Shirley Avenue and Joe's Market near the Northgate plaza.

'We do weekly checkins on the boxes every Monday and restock them." said Salemme. "We haven't had any issues with vandalism or theft, and we have two anecdotal reports of inthe-moment use of the boxes to reverse an overdose."

Ward 2 Councillor Ira Novoselsky said he has heard some concerns from residents and businesses in the Shirley Avenue area about people congregating near the boxes.

Salemme noted that the boxes are a way for people to avoid the stigma of taking the Naloxone, and noted that there are boxes in all locations throughout the city that get a decent amount of use.

Councillor-at-Large Anthony Zambuto said he

RTA votes to enter into work-to-rule

As Revere teachers continue to work with an expired contract, the Revere Teachers Association has joined with other educator unions in the North Shore in participating in a workto-rule.

The educator unions in Beverly, Gloucester, Marblehead, and Revere all voted overwhelmingly to enter into work-to-rule, starting on Friday, Oct. 4.

Entering work-to-rule, educators will cease performing non-customary duties outside contractual responsibilities to protest stalled contract negoti-

ations and demonstrate how much educators routinely go beyond what is required of them, according to union officials.

Revere teachers have been without a contract since June 30.

The work-to-rule action began with morning standouts and walk-ins at the Rumney Marsh Academy last Friday, Oct. 4. Since then, the work-to-rule actions have rotated among the schools in Revere.

representatives have stated that they are seeking smaller class sizes, paid parental leave,

Extension for Suffolk Downs project approved

The Revere Conservation Commission held its regular monthly meeting last Wednesday evening, October 2, in the City Council Chambers. Chair Nicholas Rudolph and fellow members Brian Averback, Joseph LaValle, Bernardo Sepulveda, Wilson Correa, Amelia Viscay, and Thomas Carleton were on hand for the session.

After welcoming new members Amelia Viscay and Thomas Carleton, the commission took a moment to honor the late Robert "Toby" Cassidy, a long-time member of the ConsComm, with a moment of silence.

Averback noted that Cassidy "was a really good person whom you could trust and talk to. He will be missed."

"I never will forget our

baseball talks at site meetings," noted Rudolph. "He truly will be missed. May he rest in peace."

The meeting itself began with a continuation of the hearing for a request for a Notice of Intent (NOI) from the Massachusetts Water Resources Authority (MWRA) regarding the MWRA's plans to replace a portion (known as Section 56) of the auxiliary water main that threads through No.

Revere to Lynn. The old Section 56, which was removed a few years ago because of its poor condition, formerly crossed directly underneath the deck of the General Edwards Bridge. However, the MWRA is proposing to run the new line under the bedrock of the Saugus River via a process known as hori-

forts, the city is putting out requests for proposals for contractors to do the outreach.

The city has run warming shelters for the past two winters, but Buck said there have been issues about where they can be located.

Councillor-at-Large Marc Silvestri raised some concerns about the possibility that the opioid settlement funds were supplanting funds for current or past services the city already provided.

Salemme noted that the business outreach has never been done on a formal basis, but that outreach workers might visit a business if an overdose was reported there as part of post-overdose outreach.

"It seems like a few things are ideas that we have already presented," said Silvestri. "It probably seems like I'm giving you a hard time, but the reason I am is because there have already been cities in Massachusetts that have had to pay back their funds, and I

don't want to see us walk down that path. The only reason I am bringing attention to this is not only do you have to pay back the money that has been spent and used, you have to give back future monies."

Ward 5 Councillor Angela Guarino-Sawaya said she had some concerns about the location of the warming shelter in her ward and would like to sit down with the public health and SUDHI office for a longer conversation about it.

HRC members voice support for Indigenous Peoples Day

The Revere Human Rights Commission held its first monthly meeting since May last Thursday, October 3, in the City Council Chambers.

On hand for the session were chair Chaimaa (Shay) Hossaini and fellow members Dr. Lourenco Garcia, Kourou Pich, vice-chair Herby Jean-Baptiste, Molly Mc-Gee, and Somaya Laroussi. Steve Morabito, the city's Director of Diversity, Equity, and Inclusion (DEI) who serves as the HRC's Executive Director, and local resident Ed Terrell, an invited guest, also were on hand for the meeting.

Hossaini opened the session with the usual Land Acknowledgement, in which the Pawtucket tribe was recognized as the original holder of the land in Revere.

The members then offered their reflections on the Visioning B.E.A.R. (Balance, Equity, And Respect) Circle seminar that the members attended in June that was directed by Strong Oak Lefebvre. The HRC members gathered in chairs in a circle and passed around a microphone to share what they learned at the seminar, as well as the things for which they are grateful (among other topics), with Dr. Garcia and Pich leading the discussion.

Garcia presented an article written by an Italian-American group that supports replacing Columbus Day with Indigenous Peoples Day in Massachusetts. A lengthy discussion ensued, with the members focusing on the injustices perpetrated upon indigenous people from the time that Columbus arrived.

Laroussi suggested that celebrating and honoring Columbus is a white supremacist statement. The history has been sanitized. His arrival in the Americas was the beginning of the genocide. He was bad not only from today's point of view, but in his own time as well, when he was imprisoned for his crimes. He was a bad person yesterday and he's still a bad person today who should not be representing Italian-American heritage.

"I understand and have a lot of appreciation for the people who have advocated against

the discrimination that Italian-Americans have faced," Laroussi continued. "I've really enjoyed growing up in this city and learning the history of Sacco and Vanzetti and the history of discrimination against Italian-Americans. What does Italian heritage pride look like? When we choose to accept Columbus as an icon for Italian-Americans, that is a direct connection to white supremacy and colonization. I don't see any pride in being Italian if you are not accepting of your proximity and your influence on all of these other people, these people of color, you're basically being discriminated against at their expense. "

Hossaini made the point that Christopher Columbus was funded by the king and queen of Spain, unlike the Italian immigrants who later came to the United States who were escaping dire poverty and who survived hardships upon coming to America. Hossaini also compared Columbus to Osama bin Laden, stating that they both were terror-

Garcia spoke of the "confusion between the celebration of Italian-American Heritage Month and Columbus Day that has been historically propagated by our schools indoctrination. through It's not about not recognizing the heritage of any people, it's the confusion that Columbus discovered this continent. Columbus never was in North America. We need to educate

people."

Hossaini wrapped up the session by adding a disclaimer. "We do not condone any hate to any side, whether that be the Indigenous Peoples or the Italian-Americans who live in our city. We're just here to voice our opinions to make Revere a better place to live and grow."

She concluding the meeting by reading aloud the

"The Mission of the Revere Human Rights Commission is to promote human and civil rights and empower all people of Revere by ensuring that everyone, especially the most vulnerable and marginalized, have equitable opportunities, equal access, and are treated with dignity, respect, fairness, and justice."



zontal directional drilling (HDD) that presumably will have no impact on sea life in the river. The project also will not affect the salt marsh in the area bordering the river.

The hearing on the NOI had been continued because the MWRA was awaiting a report from the Natural Heritage and Endangered Species Program (NHESP) on the project's possible effects on marine life.

Jennifer Doyle-Breen, Wetlands Scientist with the international infrastructure consulting firm AECOM, told the commissioners that the NHESP's report, which was filed in mid-September, concluded that the project will have no impact on marine life in the

Ward 5 City Councillor Angela Guarino-Sawaya, whose district includes the Point of Pines, requested that the ConsComm appoint an independent oversight company that would report directly to the ConsComm and to herself as the ward councilor in order to ensure that the MWRA is complying with the Order of Conditions. However, Peter Grasso

from the MWRA responded this ordinarily is not done, and Rudolph further pointed out that the ConsComm will periodically ensure that the project is compliant with the Order of Conditions.

The commission, which previously held three meetings with the MWRA at which residents testified, then approved the issuance of the NOI.

Next up was another continuation of an NOI for 23 Putnam Rd. regarding the repaving of one driveway and extending another driveway on the same lot. French drains will be installed around the driveways to prevent runoff onto the neighbors' properties.

The homeowner, Francisco J. Arriaza, appeared on his own behalf and answered questions from the commissioners to their satisfaction. The commission unanimously approved issuing the NOI.

The commission then heard a Request for a Determination of Applicability (RDA) from Irving Oil Terminals Inc., Arcadis U.S, 40 Lee Burbank Highway, for proposed pipeline inspection work.

A representative from Arcadis explained the scope of the project, "which is a routine inspection of underground pipelines that will entail a shallow excavation project in two local areas."

The commission determined that the excavation work, which will have runoff controls, will not constitute a permanent impact along the path of excavation and approved a negative Determination of Applicability, which means that the project will not fall within the ConsComm's jurisdiction.

The commision heard a request for another RDA from the Highway Division of the Massachusetts Department of Transportation (DOT) for "repaving along an approximately 1,700 linear foot section of Bennington Street in Revere to install separated bike lanes, improve pedestrian crossings, and install dedicated turn lanes for motorists."

Alyssa Jacobs, an environmental consultant for MassDOT, said that the Revere part of the project will connect with the East Boston portion of work further along Bennington St. The project will create a separated, two-way bike lane on the east side of Bennington St. and will reduce the traffic from four lanes (two lanes in each direction) to one lane in each direction with a center turn lane. In addition, parking will be limited to the west side of the roadway.

Jacobs said that there will be no impacts to resource areas. Rudolph agreed, noting that he had walked the site. The commission unanimously voted for a negative RDA.

The commissioners then heard a request for an NOI from Marcia Lenta, 630 Revere Beach Boulevard, for an addition to her single family home that is on land subject to coastal storm flowage and within the 100-year flood plain, as well as within the buffer zone of the saltmarsh in the

Rick Salvo with Engineering Alliance, LLC, explained the scope of the project to the commissioners. He said that the owner previously had performed work under the auspices of the ConsComm for grading the backyard in order to correct drainage problems. The addition will consist of a garage, an office space, a mud room, and a handicap ramp, a project that already has been approved by the Zoning Board of Appeals, which imposed the condition of a six-foot privacy fence along a neighbor's

property. Salvo said there will be flow-through foundations for the additions that will exceed both the building code and FEMA requirements.

Lavalle asked some questions about the elevations, which Salvo answered. However, the commissioners were unable to take a vote because the city had not received a file number from the State DEP (which is a statutory requirement) in time for the meeting. A vote to issue the NOI will be taken

next month. The commissioners then heard a series of three requests from McClellan Highway Development Company, LLC, for an extension for compliance with the Orders of Conditions "related to Phase 1-R and 1R-E Roadway and Infrastructure, Building R-10, and Building R-11 of the Suffolk Downs Redevelopment to October 18, 2027.

Abigail Middleton with HYM Investments, LLC, the owner of Suffolk Downs, said the extensions for the three individual parcels are needed to allow for the completion of infrastructure work, which consists of the improvements to what was a bare race track. HYM initially came before the ConsComm in October, 2021, when it obtained the original Order of Conditions.

"I'm just wondering whether we will be back here in three years and I'm very nervous about giving another three-year extension," said Averback. "As someone who lives in Ward 1, and this is right down the street from me, I'm wondering about 'the dream' that's been promised by HYM and I'm concerned about this continuing to be vacant land and maybe a story for the end of a time of, 'What happened at Suffolk Downs?' and approving another three years for what is just a cemetery at this point."

After Middleton explained the vast scope of the infrastructure work, which involves coordinating with the utility companies, the commission approved the extensions for three years.

Salvo also came before the commission seeking a Certificate of Compliance on behalf of Mario Zepaj for the completion of the construction of a four-story (25-unit) apartment building at 344 Salem Street.

"This has been a major improvement to this property," said Rudolph. The commissioners, some of whom also had walked the site, unanimously approved issuing the certifi-

cate. The commission lastly approved an after-the-fact **Emergency Certification** for the work to replace a faulty railing at a DCR beach that presented an imminent public safety hazard. The agenda item stated, "Winthrop Parkway Railing Repair -- railing repair for an access staircase that had become detached at this location and needed to be replaced to provide safe access to the beach area. The staircase was closed and would have continued to pose a public safety issue until a new railing was installed."

The commission concluded the meeting with a discussion of the upcoming MACC Fall Conference, with chair Rudolph urging the new ConsComm members to attend the conference.

LETTER to the Editor

10/7, ONE YEAR LATER

The barbaric attack a year ago this week by the Iranian-backed Hamas terrorist group shocked and horrified the world. The brutal slaughter, rape, and torture of 1250 men, women, children, and elderly Israeli citizens, plus another 300 who were taken captive, by Hamas invaders who poured across the northern Gaza-Israeli border, affirmed that Iran and its terrorist proxies, Hamas, Hezbollah, and the Houthis, know no bounds in their hatred for Jews and their stated aim of wiping Israel off the face of the map.

The attack and its aftermath accomplished a number of goals of the Iranian-backed terrorists. Not only did 10/7 deal a blow to Israelis' sense of security, but it also destabilized Israel politically and economically. More than 100,000 Israeli citizens have been displaced both along the Gazan border and in northern Israel, where Hezbollah has been shelling northern Israeli communities. Israeli citizen-soldiers have been fighting for a full year, with no end in sight.

The attack of 10/7 predictably unleashed a devastating military response by Israel on the Gaza Strip, a narrow piece of land that is about 140 square miles and home to two million people, of whom half are children, in its effort to kill every Hamas fighter. (By comparison, Boston and Suffolk County consist of about 120 square miles with 750,000 people, of whom 20 percent are children). After a year of ceaseless Israeli bombardment, the Gaza Strip has been laid to waste, with more than 40,000 Gazans killed, tens of thousands more maimed for life, and the entire population facing mass starvation. The Israeli government now seems bent on replicating the same devastation in Lebanon from where Hezbollah has been shooting its rockets onto Israeli communities.

The Israeli government, which itself is controlled by religious extremists, fell into the trap set by Iran and its proxies by waging its brutal assault on Gaza. When images of the Middle East are shown on our TV screens each night, it is the horrors being endured by Gazan children that we see. It is their plight (as well as those of Palestinians who are being attacked by Israeli settlers on the West Bank), not that of the Israeli victims, that is garnering the world's attention and sympathies.

Finally, the bloody attack of 10/7 and the military response by Israel achieved another of Iran's major goals by creating political fissures both in the Western democracies and in Israel itself, as well as upending plans for a treaty among Israel, the U.S., and Saudi Arabia.

Just as 9/11 changed our world, so too has 10/7. A year later, with a wider war all but certain, it is clear that peace in the Middle East is more elusive than ever with an outcome that will reverberate across the globe today and for generations to come.

THE MOST PATHETIC GAME IN NFL HISTORY?

We don't mean to keep harping on our poor Patriots, but their contest this past Sunday with the Miami Dolphins has to rate as the most pathetic excuse for a professional football game we've ever seen in our lives -- and we've been Pats' fans since the 1960s, so we've witnessed quite a few sorry performances.

The Pats entered the game as the #31 offensive team in the NFL, exceeded in futility only by the Dolphins at #32 -- and the game lived up to the low expectations of both teams, featuring a variety of miscues that normally you might see once in an NFL game, not multiple times.

In the first half alone, the Dolphins missed a midrange field goal that bounced off the goal post, dribbled a snap back to the holder on another field goal attempt, snapped a ball over their quarterback's head, and had a punt blocked.

The Patriots missed a short field goal, shanked a punt, allowed hapless veteran quarterback Jacoby Brissette to be hit countless times, and committed 12 penalties for 105 yards.

It was a performance by both teams not worthy of even a JV high school game -- and fans paid hundreds of dollars for a ticket for that sorry demonstration. From the perspective of long-time Pats' fans, we'd like to chalk it up to just a tough week, but it is clear that this will be a season that is only going to get worse.

VOTE YES ON QUESTION 2

Dear Editor,

As a mother of a son who had to take the 1st MCAS test to graduate (2003), as a Revere School Committee member and Massachusetts Association of School Committees (MASC) Executive Board, I ask the voters to vote YES on the Ballot Question 2: Elimination of MCAS as high school graduation requirement.

As a member of MASC I respect the fact that education stakeholders and the community at large views the high-stakes graduation tests different-

We recognize that the public is widely confused over this issue because it a complex one. Many Bay Staters hear the term "MCAS" and most believe it is nothing other than a single, high stakes test. It is, in fact much more, and we support many of the facets of the Massachusetts Comprehensive Assessment System.

MCAS is, in fact, a system of curriculum frameworks that describe curricula, measures of testing to determine how

much students are learning, and gathering data to measure the progress students, classroom teachers,

schools, and school districts are making learning the curricula.

The MCAS program prescribes a lot of testing

at various grades and for particular subject matter. A student might take several different MCAS tests during one's K-12 years. We believe that these tests can be invaluable guides to assist educators in improving outcomes for students. Subject to collective bargaining, the data may also be used to help educators improve their skills in the classroom or to influence compensation. We support the use of MCAS data as one of several criteria for appropriate purposes, including determining the effectiveness of curricula, classroom performance, educator proficiency, and student learning.

The high-stakes 10th grade tests that determine eligibility for a high school diploma are but one facet of a very large and complex system. It is these high-stakes test being used as barriers to graduation that we oppose. There are better alternatives. They have been discussed at length. Unfortunately, the 10th grade high stakes tests have been the subject of misleading political rhetoric designed to confuse the public.

Less appreciated is the fact that the 1993 Education Reform Act required that the state set proficiency standards for graduation, but did not specifically authorize a high stakes test - that was created by the Board of Education, now the Board of Elementary and Secondary Edu-

It is time to rethink this

Finally, the existence of the high-stakes tests represents an element of the kind of regulation and punishment culture that permeates educational public policy in Massachusetts. Perhaps the authors of the original Reform Act felt it was necessary to make the threat of failure to graduate an element that needed to be implemented. Such a strategy has never been, and does is not now an appropriate motive to impose on students.

The state and local districts can find highly suitable alternatives that could include:

- Successful completion of a minimum number of courses in English Language Arts, Mathematics, Social Studies - including US History and Civics, the arts - including music, dance, and physical education.
- Completion of a minimum number of courses required to graduate.
- Some form of civic engagement or community service.

To argue that eliminating the high stakes tests graduation would leave us without meaningful criteria for proficiency or without standards at all is a deceitful argument and the public should not fall for it.

MCAS is a voluminous set of standards, rules, regulations, and tools for the state to oversee the work of local districts. It would benefit from periodic rethinking, and, for that reason, we call upon the legislature to authorize such an initiative.

was speaking as a private resident in opposition to legalization of recreational marijuana. However, she noted that the board of health was never consulted to make a recommendation to the council on legaliza-

"I am asking as a resident to take a pause and consider everything and make sure you are all on the same page," said Catano. "Many residents just found out about this this weekend. We could have multiplied the signatures we gathered in four days."

Kelley also asked about the process for the council voting on the legislative affairs subcommittee recommendation when the zoning ordinance remained in the zoning subcommittee.

"Obviously, this is a sensitive situation," said

Ward 4 Councillor and legislative affairs chair Paul Argenzio.



RHS junior Adam Ashour has his sights set on a career in law

His name is Adam Ashour, and he is a junior at Revere High School. However, a few years from now, people may be calling him Attorney Ashour.

Adam, a stellar student at RHS and member of the math team, mock trial team, robotics team, and debate team, spent last summer interning for Suffolk County District Attorney Kevin Hayden.

"I've wanted to be a lawyer for a long time, because my father used to be a lawyer in Egypt," said Adam. "He gave me two passions, law and computer science."

Adam said he wants to combine those two passions into a career someday and learned a lot about the different types of law during his internship with the DA's office. Adam has his sights set on a college, and law school, that can fulfill both those passions.

"I want to go to college and law school somewhere where I can balance both computer science and law," he said. "I'm not sure which school that would be just yet, but I've been looking at universities mostly around Massachusetts."

He added, "I knew about traditional law and the court system that most people see on TV. However, during my internship I learned there are lawyers that do mainly investigative work and that requires knowledge about computer science."

While at the DA's of-

fice, Adam split his time between Chelsea Court and Suffolk Superior Court in Boston. He said he enjoyed the internship because he learned a lot about the court system and the roles of prosecutors and judges.

"My work mostly centered around learning about the justice system,' said Adam. "In the Boston office, I was doing a deep dive into the key components of our juridical system. For example, I didn't know there is a separate court for interpreting the law. I learned about all these little complexities that are not taught in law school like learning when to prosecute and learning when not to prosecute, because both are just as important."

Adam said he gained insights into the human aspects of prosecutors and the importance of diversion programs and worked

with individuals involved in diversion programs, learning about the options available for people facing legal issues.

"I really enjoyed it, because I learned a lot more about the court system than I ever knew before," he said. "Going to court doesn't just mean that you're going to jail. Not everybody that goes to court goes to jail. I would say most of the people who I saw in court didn't go to jail. It was nice to see that because you learn the district attorneys are human--they're not some robot that are trying to get things done and put everyone in jail. They're good people and actually care about the people they're prosecuting. While they have a job to do and make sure people doing serious crimes get prosecuted, they recognize that they

are humane."



longer lunch and recess time for younger students, and a living wage for all staff.

"Educators do an immense amount of work beyond their contractual hours," said Revere Teachers Association Co-President Jane Chapin outside Rumney Marsh Academy on Friday.

Chapin said the RTA and the other North Shore educator unions are bringing awareness to the amount of extra work teachers do while also dealing with staffing issues, such as classrooms without core content teachers.

Chapin added that the schools are in crisis and that the school committee has the ability to solve the

problems immediately. "It's extremely frustrating that we have had 10 bargaining sessions and we are still talking about the same proposals, the same crisis over and over again," said Chapin.

According to the RTA, some examples of work that educators typically take on that do not fall into contractually obligated duties include sending out weekly newsletters, volunteering for committees or field trips, chaperoning events, and offering extra help outside of contract hours.



More than 200 Revere High students marched on City Hall to protest conditions at the new Revere High School. Nancy Forgione, speaking for the students, said, "This is a demonstration peaceful to show Mayor Reinstein that we're fed up with the technical difficulties which in some cases have posed hazards to students' safety. We'd like some of the equipment to work. In most rooms, there are not enough desks, equipment is not in working order, and we're not even allowed to park our cars at the school." The following week, some 300 students filled the City Council Chamber to air their problems. The City Council previously has approved a motion filed by former mayor and present County District Attorney to investigate the contracts for wiring, fencing, and furnishings for the school.

Indictments reportedly will be handed down soon by the grand jury that is investigating the alleged misappropriation of funds from the School Department's hot lunch program.

Mayor William G. Reinstein said that the Columbus Day parade Saturday will be "the largest such affair the people of Revere ever have seen."

McHugh said it is costing him \$250 per month for maintenance crews for the Revere dumping alone, which up to now had been offered to the city free of charge.

The council previously had voted in June to name the overpass in Brodbine's honor, but rescinded its vote to name it in honor of Snow at the urging of the women's group.

Both pride and sadness mingled in one Revere home this week. Announcement first was received by the Larkin family of the award of the Combat Infantrymen's Badge to Sgt. Sydney Larkin, 29, for his bravery in the battle of Bougainville in the South Pacific, where he was wounded. However, the War Department later in the week informed the family that his brother, Maurice, 25, a tail gunner on a U.S. bomber, was listed as missing in action over France.
