# Council votes to support ending MCAS graduation requirement

The city council voted in support of a state ballot measure that would eliminate the MCAS test as a graduation requirement in Massachusetts at its meeting last week.

The motion was presented by councillors Juan Pablo Jaramillo, Angela Guarino-Sawaya, and Marc Silvestri.

"I am excited to stand in support with our public school teachers who are working really hard to do some education around Question 2," said Jaramillo. "As we know, our students are more valuable than what a test can dictate, and unfortunately, for some 20 years, we have been telling them that they are not (as valuable) if they fail this test." A repeal of the MCAS graduation requirement would mean that teachers would be able to teach real courses without having to teach their students how to pass a test that is tied to their graduation and future prospects, Jaramillo said. "It's unfair and it is cru-

el to tell a child who is plain and simple a bad test taker that they cannot go to university, they cannot graduate when they may be brilliant otherwise," he said.

Jaramillo said it is also unfair to teachers who might otherwise be gifted and are told they are doing a poor job if not enough of their students pass the MCAS exam.

"Teachers are doing a great job and they are committed to maintaining and raising the standards, and I know that to be true and they are doing that in the city of Revere," said Jaramillo. Guarino-Sawaya said she agrees with the Massachusetts Teachers' Association, which is supporting the Yes on 2 campaign to end the MCAS graduation requirements. She said the test is unfair to students with disabilities or who speak English as a second language. "It is important that we begin teaching our students what is necessary to succeed in life, not by an MCAS test that is absolutely irrelevant when they graduate from school," said Guarino-Sawaya.

Silvestri said teaching to the MCAS test forces many teachers to make students memorize information rather than letting them learn.

"As we all know, each one of us has a different style of learning, and tests do not always show how a kid can shine," said Silvestri.

Council President Anthony Cogliandro said he supported the motion.

# Council seeks to improve traffic hearing notifications

Ward 4 Councillor Paul Argenzio wants residents to be better informed about the traffic commission's public hearings.

At last week's meeting, the council approved a motion introduced by Argenzio asking the mayor request the traffic commission coordinate with 311 to send out a robocall to alert residents to commission public hearings that could result in a major change to parking or traffic patterns that affect an entire street or area of the city. The alerts would include, but not be limited to, parking restriction changes or changing a street to a one-way.

The calls would only need to go to the particular area that would be affected by the hearing.

"I was chairman of the traffic commission for six years, and this was the biggest complaint that when major changes were made that there was a small little blurb in one of the local papers and people didn't know about it," said Argenzio. "Things that affect parking, the direction of streets, it should be conveyed to the residents so that they can come up and speak on whether it is something they are in favor of or opposed to."

In other business, the council moved a requested change in the food truck ordinance to a public hearing.

The request was made by Councillor-at-Large Juan Pablo Jaramillo to allow not more than one food truck at a new location in the parking lot at 108 Beach St., directly abutting the Revere History Museum and facing Sonny Myers Park.

Ward 5 Councillor Angela Guarino-Sawaya added an amendment to the motion seeking to limit the hours of operation of the food truck to 3:30 p.m. to 7 p.m.

"The location is inconvenient for the Immaculate Conception School; it is in the parking lot where they park their vehicles," she said.

Limiting the hours would ensure that there is not a conflict when people are picking up their kids at school, Guarino-Sawaya said.

### AHTF discusses down payment assistance program

The board of trustees of the Revere Affordable Housing Trust Fund (AHTF) held its regular monthly meeting last Wednesday, October 9, in the City Council Chamber. Chair Joe Gravelese and vice-chair Claire Inzerillo were on hand for the session, along with fellow board members, Laila Pietri, Deb Frank, Matthew Wolfer, and Lori Manzo. The board first took up n update of the а

SEEPARE ID FOR A STRULL THROUGH TIME 2004 EDITION First-Time Homebuyer Downpayment assistance program for which nine applications have been received since the process opened last month. The AHTF contributed \$25,000 to the program last fall, matching a \$25,000 grant from the state, for a total of \$50,000 to be awarded to five applicants at \$10,000 each.

Gravalese said some of the nine applicants received thus far were not eligible either because of a failure to meet the income (80 percent of the Area Median Income) or residency requirements (applicants must be residents of Revere for two years). The applicants also will have to pre-qualify for a mortgage and enroll in a first-time homebuyer workshop.

The qualifying applicants will receive a letter confirming eligibility and then will have six months to enter into a purchase and sale agreement to buy a home, a time frame that may be extended by the AHTF.

The assistance is paid out in the form of a forgivable loan if the applicant maintains the home as their primary residence for five years. The first five qualifying applicants will receive the \$10,000 grants. However, said Gravalese, "The problem these types of programs face is that given all of the restrictions, there is a very narrow subset of persons who are eligible.

# Council supports motion to improve traffic island

The city council is backing a motion to restore the Welcome to the Point of Pines/Shaughnessy Memorial Island at the bus turnaround at the rear of the Point of Pines Fire Station.

Councillors Angela Guarino-Sawaya and Paul Argenzio introduced the motion at last week's meeting asking that the mayor request the allocation of funds to reconnect the water line that services the island.

The irrigation was previously fed from the former fire station, but the connection was inadvertently left off the plans for the new fire station, according to the council-

# Senatorial candidate Jenna Tamas appears at Meet The Candidates Night in neighboring Winthrop

Jeanna Tamas, the Republican nominee for the 3rd Suffolk District seat in the Mass. State Senate, attended a Meet The Candidates Night Oct. 8 at the Robert A. DeLeo Senior Center.

The event was hosted by the Winthrop Republican Town Committee.

Before taking the podium for a question-and-answer session, Tamas greeted residents from the district who attended the event. Revere Councilor-at-Large Anthony Zambuto was in the audience.

Tamas felt she was able to articulate her message well during the program that was moderated by WRTC Chair Paul Caruccio.

One resident asked about charter schools in

"Our children are our No. 1 priority," said Tamas. "The availability to have a family choose as to where their child goes to school – I feel it's a choice every American should have, particularly here in Massachusetts where we are the hub of education, and we attract such talent. Let's get those kids bright and early and allow the families to choose where their child goes to school."

Tamas said if elected senator, she "will be on the ground meeting my constituents and ensuring that their message gets up to Beacon Hill."

Tamas is seeking political office for the first time. She has volunteered on other political campaigns, notably that of former Massachusetts governor Charlie Baker.

Tamas was asked if she has been a member of a Republican Town Committee.

"I'm just a community member that is fed up with the failed leadership on Beacon Hill," she replied. Tamas has worked as a project manager in the construction industry for the last ten years.

Carruccio said he was "highly disappointed" that Sen. Lydia Edwards chose not to attend the Meet The Candidates Night. He personally extended the invitation to her in early September.

Edwards said in a statement to the Revere Journal, "I was invited to the Winthrop Republican Town Committee Meet The Candidates Night. While I appreciate an opportunity to present my case against my opponent, I firmly believe it should be in a neutral forum not hosted by either political party."

The election is Tuesday, Nov. 5.

lors. They stated that the island not only welcomes residents and visitors to the Point of Pines, but also serves as a memorial location for Edward Shaughnessy, Jr., for Point of Pines military personnel who lost their lives in World War II, and for another young Point of Pines resident.

"It's the memorial of my next-door neighbor's son, so it is really important to me that this gets passed," said Guarino-Sawaya.

Argenzio noted that

Shaughnessy was his nephew who was killed in a car accident while he was a senior at Malden Catholic nearly three decades ago.

"It has become important to the people of the Pines and it has become the Welcome to Point of Pines island," said Argenzio. "There is another resident (from the Point of Pines) that has a memorial bench, and just recently, the military stone was put there in honor of World War II veterans that passed

away from the Pines."

The water line used to come from the old fire station, but the line was left off the new plans, Argenzio said, noting that the motion is just to reestablish the line that previously served the traffic island.

"I went by it the other day and the grass is dead, the vegetation is dying, so I'd like to see it refurbished," said Argenzio.


Councillor-at-Large Marc Silvestri said he supported the motion. "Last year, the fami-

ly of the veteran on the memorial and Councillor Sawaya called me down there while I was still the Veterans Services Officer, and we worked with Councillor Argenzio when he was still on the DPW and few other members of the DPW to have the stone removed from an island which was no longer in the plans, so it was moved to the island they are trying to get irrigation to," said Silvestri.



"In addition, navigating the maze of other programs for which a person might be eligible is very difficult," added Gravalese, though he also noted that the local program and other down-payment assistance programs are "stackable," which means that applicants can take advantage of other programs and resources that are available on top of the local program.

Gravalese added that the application portal for the local program still is open and that two or three slots still were available as of the meeting date last week.

In other business, the board briefly discussed the ongoing disposition of city-owned/tax title properties, which the ATHF is looking to develop for affordable housing once the lengthy tax-title process has been completed.

Gravalese noted that eventually there will be an RFP process in order to evaluate possible buyers for their ability to develop affordable housing on those lots. However, he noted that the lots also could go to the highest bidder even without an affordable housing plan, with the AHTF receiving all of the funds, which the board could then use toward other programs.

Gravalese said that there presently are five lots that may be available for transfer to the AHTF, which he said are developable most likely either as two-family or single family homes.

"It's an opportunity either to add affordable




units, bring in some revenue, or do both, and it's exciting to see this move forward," summarized Gravalese.

Gravalese informed the board that the city is moving forward with an application to the state to create Housing Development Incentive Program (HDIP) districts within the Suffolk Downs and Shirley Ave. neighborhoods. The HDIP is a program from the state that provides tax incentives to help spur the development of housing.

According to the state website, "An HDIP provides Gateway Cities with a tool to develop market rate housing while increasing residential growth, expanding diversity of housing stock, supporting economic development, and promoting neighborhood stabilization in designated areas."

Gravalese said the AHTF would explore how to use the program specifically to try to add affordable housing units in those neighborhoods. Both Shirley Ave. and Suffolk Downs have seen explosive growth with a plethora of housing developments in recent years, but those projects have not added affordable housing units.

The board then adjourned until its next meeting in November.

# HAS FLORIDA BECOME **UNLIVABLE?**

The damage caused by Hurricane Milton, the latest major hurricane to strike Florida, raises a very basic question: Is Florida no longer safe or affordable for human habitation? That may sound a bit extreme, but the reality is that extreme weather has moved from the realm of a rare occurrence to the norm in Florida.

Significant hurricanes have been a way of life in Florida forever, but the intensity, severity, and frequency of these catastrophic weather events have been increasing over the past few years thanks to the startling rise in both ocean and air temperatures because of climate change. Warm water is the jet fuel for hurricane development and Milton was a perfect example of that interaction. Milton originated in the Gulf of Mexico, just off the Yucatan peninsula, and intensified from a Category 1 hurricane to a Category 5 within 24 hours, the fastest-ever hurricane to do so.

Not only did Milton spawn tornadoes across Florida even before it made landfall that resulted in death and destruction far from where it came ashore, but it also caused record flooding in the middle of the state which still has yet to fully recede. There are areas in Florida where those who bought their homes only a few years ago are unable to sell them, even at steep discounts, in the aftermath of the hurricanes of the past few years.

Even for those whose homes have been relatively untouched by the catastrophic weather, the cost of home insurance has skyrocketed. The Wall St. Journal reports that home insurance rates in Florida are twice the national average and auto insurance is more than 50% above the national average. There is no doubt that as hurricanes continue to pound the peninsula, these costs will continue to rise exponentially, effectively making living there unaffordable for many Floridians, especially for senior citizens who are on fixed incomes.

The possibility of losing everything -- your home, your cars, and all of your belongings -- has made many question whether Florida is a desirable place to live, especially in one's so-called golden years. You may escape the worst effects of a hurricane for five or 10 years, but all it takes is one occurrence to lose everything you have.

We have written previously that there is no place on the planet where we are safe from climate change -- the devastating effects of Hurricane Helene in serene western North Carolina, hundreds of miles from the ocean, being the most recent example -- but Florida has become the proverbial canary in the coal mine, the forewarning of much-worse times to come.

The trifecta of wind damage, flooding, and the high cost of living have turned the Sunshine State into the State of Danger & Despair -- and with climate change bringing ever-higher ocean and air temperatures with no end in sight, the future promises to be truly apocalyptic.

Living in Florida these days is like playing Russian Roulette, with Mother Nature in the role of the house. And as we all know, the house always wins.

# **Disabilities Comm.** learns of programs offered by the Community Music Center of Boston

The Revere Commission on Disabilities held its regular monthly meeting last Tuesday evening, October 8, via Zoom. Chair Ralph DeCicco, vice- chair Pauline Perno, Mario Grimanis, Annemarie Fiore, Ellie Vargas, and Barone-Cichocki Jason were on hand for the session.

The guest speaker was Rachel Chao, the Community Engagement and Clinical Manager at the Community Music Center of Boston (CMCB), which is located in the South End, who told the commissioners of the opportunities offered by the CMCB for persons with disabilities. Chao, a native of Texas who is a certified music therapist and a graduate of Berklee College of Music, said she has been with the center for about two years. She works both with individuals and in groups, ranging from children, to teens, and to adults, with an emphasis on those with autism and autism spectrum disorders (ASD). Music therapists are board-certified and licensed.

100 years and serves about 2000 students weekly, offering lessons on virtually every instrument and voice, as well; as music production and songwriting. The CMCB offers financial aid.

"Music therapy is an evidence-based discipline that uses music to accomplish and address non-musical goals, including communion, fine and gross motor skills, self-expression, improving mental health and coping skills, pro-social behaviors, and supporting independent living skills and activities of daily living (ADL)," said Chao. 'Music therapy is a fun way to engage in these things." "Music therapy has been shown to be effective in addressing depression and anxiety, generalized mental health needs, pain management, supporting developmental milestones, self-regulation, and motor skills and movement," Chao said, noting that Boston hospitals use music therapy to achieve these goals. Chao described how a music therapy session works, explaining that there is a wide range of approaches to meeting the particular needs of individual students. She also

said that the number of sessions, and the length of each session, can vary depending on each person's needs.

DeCicco inquired about external group sessions sponsored by municipal entities (such as the Disabilities Commission) and indicated that he would like to connect with the CMCB about organizing a group session for Revere residents. Fiore suggested that the Revere SEPAC (Special Education Parents Advisory Council) might be interested in developing a program. Perno also asked about programs for teachers and parent groups who might be interested in learning about the benefits of music therapy, with Chao indicating that the CMCB has worked with such groups. In other business, DeCicco provided a report on the October monthly Zoom meeting of the regional Commissions on Disabilities Alliance (CODA). The meeting noted that in September Gov. Healey signed a bill to improve quality oversight of long-term care that also included estate recovery reform.

The Ride, and the Flex program. Baron-Cichocki noted that there are still problems with The Ride and the Flex programs, especially with regard to the lack of vehicles with wheelchair accessibility and inefficiencies in the system.

Perno read the commission's monthly reminder: "The Commission on Disabilities office number is 781-286-8267. Residents can also call Revere 311 directly and speak to their staff Monday through Friday. They will answer most questions, but if they cannot or if you want to talk to our department directly, ask to be transferred to the Disability office. Please leave a detailed message, and someone will get back to you soon. "As always, please let us know if you want something discussed or added to our monthly meeting agenda. You can let us know if you would like to speak on any issue or concern. The Commission is here to help and assist all the disabled residents and families of Revere."

The Revere Fire Department celebrated Fire Prevention Week with an open house at their headquarters, located at 400 Broadway, on October 12. This year's theme is "Smoke Alarms: Make Them Work for You," a campaign to educate residents about the simple actions that can keep their homes and loved ones safe.

"We're trying to make sure people are aware and alert about their smoke detectors operating correctly, said Firefighter Joe Trichilo. "If any of them are not working, properly replace them."

Three out of five fire deaths occur in homes with either no alarms, or no working smoke detectors. The Revere Fire Department encourages everyone to install smoke detectors in each bedroom, outside each sleeping area, such as hallways, and on each level of the home, including basements. Testing smoke alarms at least once a month by pushing the test button, is suggested. Replacing smoke alarms when they are 10 years old or are unresponsive when tested is also important.

In addition to the fire alarm safety message, firefighters offered tours of the firehouse, where children explored the ladder truck and learned about equipment and tools.

"The firehouse has things that I never noticed, like a big truck," explained aspiring firefighter, Cecilia Aborn, 11, about the high-water rescue vehicle. "Firefighters save people, and it's so interesting."

# All White and a ton of Green Al Petrilli's annual bash raises \$150,000 in one night for the Marie C. Petrilli Cancer Fund

There is one word that best describes Al Petrilli's annual "The White Party" that was held outdoors on the grounds of his beautiful home in Winthrop: Special.

Yes, special in the sense that more than 300 guests attended the impressive, Hamptons-style event and enjoyed a festive night of great food, friends, and music in what Al humbly calls, "my yard."

But even more special is the fact that Al Petrilli and his guests combined to raise \$150,000 for the Marie C. Petrilli Cancer Fund that helps cancer patients and their caretakers and support students aspiring to enter the health profession as nurses. It is the only fundraiser of year for the Cancer Fund.

The amount of money raised is astounding when you consider there are no major corporate sponsors of the event. "It is just the people that attend the party that night," said Petrilli. "In the 25 years of the

fund," we've raised over \$2 million, and we've given over \$1 million to cancer patients, along with "Courageous" awards to patients who keep fighting the disease for years."

#### A Tribute to **Marie Petrilli**

Al Petrilli and Marie Petrilli dated for five years and were married for 11 years.

"Marie was a remarkable lady that died at the age of 39 [after being diag-

nosed with cancer at 37)," said Petrilli. "As beautiful as she was on the outside. she was even more beautiful on the inside. When she died, my son, Albert, was nine years old, and my daughter, Marielle was six."

Al Petrilli and his brother, David Petrilli decided to launch the Cancer Fund soon after Marie's death.

"The big challenge was to say, 'Am I going to keep Marie's spirit alive for the kids and myself and the family, or am I going to do damage to the kids because I wanted to start the fund right away?""

The Petrilli brothers held their first fundraiser in November, 1999, at the Winthrop Yacht Club.

Through the years, the fundraisers have been held in different venues, but the events have now seemed to find a permanent home – at Al Petrilli's Nahant Avenue where this year's "White Party" was held on a perfect summer evening.

Petrilli said "the theme this year was the 25th year anniversary of Marie's passing, which was June 19,1999."

#### Helping the future of nursing

Al Petrilli said the Marie C. Petrilli Fund caps its grants at \$5,000 to individuals.

"The money goes toward improving cancer patient care, which includes cancer patients, scholarships to oncology nurses (67 individual nurses have received more





than \$250,000), and capital improvements at Mass General. Twenty-five years ago, we bought the first blanket warmer at Mass General (at a cost of \$8,000) because we thought it was so important for cancer patients in chemotherapy sessions to be warm and comfortable. If you walk through a hospital, you see blanket warmer everywhere."

A man who loves the town of Winthrop, Al Petrilli takes considerable pride in the fact that the Cancer Fund gives scholarships annually to Winthrop High School students.

"If we find that there's a group of seniors at the high school that are going into nursing, we will give each student a scholarship," said Petrilli. "That scholarship maybe helps pay for their books in their freshman year in college."

Petrilli said the goal of the Fund has always been to help researchers find a cure for cancer.

"We said it from the very beginning that we want to see a cure, so we've given up to 10 percent of our year's funding to cancer research," said Petrilli.

Reflecting on the success of the annual party, Petrilli said proudly, "Over the years, [the Marie C. Petrilli Fund] has done what we wanted it do - keep Marie's spirit alive. And my children now take a very important role in helping us to execute the process of raising funds and helping cancer patients."

And Marie C. ### First 36 apartments at Overlook Ridge hit the market

or more than 100 years, Rowe's Quarry was a rock-mining venture, but after much discussion and a significant amount of debate, it has finally become a place to call home.

The first 36 apartments went on the market last week at the mammoth Overlook Ridge residential project in the former quarry in North Revere. It was what Roseland spokeswoman Nancy Sterling called "mini-phase I" of the project. The entirety of Phase I includes two buildings with 310 luxury apartment units, a parking garage, an amenities building and a new park across Salem Street - abutting the Rumney Marsh. The entire Phase I should be

complete within one year.

The whole project, which is expected to span nearly a decade, includes a total of 2,400 apartment units and, tentatively, a commercial business district and maybe even a hotel.

Though there is still a lot of construction going on - and probably will be for some time the beginning of one of Revere's biggest construction projects ever was marked on Sunday, when a large ad appeared in the Sunday Boston Globe apartment listings. That was furthered by the unveiling of a four-story, purple rental advertising sign on the side of the Main Building - readily visible from Route 1.

Sterling said they have been receiving calls from prospective tenants for over a year. Of the

### **REVERE** Through the Years

#### 20 years ago October 20, 2004

The first 36 apartments at Overlook Ridge at the former Rowe's Quarry went on the market this week, the beginning of a mammoth apartment complex which ultimately will include 2400 apartments and a commercial district to be built over a 10-year period.

The Paul Buonfiglio and Sons Funeral Home acquired the Bruno Funeral Chapel this week.

Revere Board of Health officials were informed this week by state health officials that there presently is no available flu vaccine and if there is some to come, it will be in small supply and limited to those most at risk.

Charles Lightbody and Vincent DiCesare, developers of the former Surf Club site, have proposed a development of 50 loftstyle apartments, a change from their original proposal of a commercial development. The pair bought the land from the city for \$600,000 earlier this year.

The City Council this week approved a \$1 million bond for the construction of a new police-fire department facility on the Revere Beach Parkway.

#### 40 years ago October 17, 1984

One of the worst-kept secrets in years finally came out of the closet Tuesday night when the Special School Committee gave full-time jobs to the wives of City Councillor William Bell and Regional School Committeeman James Guido in the School Department's computer services program.

A comprehensive report commissioned by the

Special School Committee has made the following recommendations: the demolition of the McKinley School; the formation of a magnet academy at the high school for interested 7th and 8th graders; a 10-room addition to the Garfield School; a reduction in the number of directors in the school system; and less interference in the day-to-day operation of the School Dept. by members of the School Committee.

Mrs. Betty Parotta, Pres. of the McKinley School PTA, has been informed that the McKinley PTA has been chosen as the most outstanding group in the state and will be honored at the upcoming PTA state convention.

Revere Police Officer Lorenzo "Larry" Torregrossa, an unsuccessful candidate for mayor last fall, has been indicted on charges of motor vehicular homicide and leaving the scene of an accident after an alleged incident in September in which Torregrossa allegedly ran down a 31 year-old Saugus resident and dragged him 100 yards on North Shore Rd. Torregrossa, who owns several businesses in Lynn, initially called police to report his vehicle had been stolen. Mayor George Colella has placed Torregrossa on unpaid leave.

Lawrence Swartz is the new President of the Revere JCC.

#### 50 years ago October 16, 1974

Patricia A. Buono, an 18 year-old recent honors graduate of Revere High, has died in a fire that gutted her family's home at 56 Fenley St. Her

uncle, 41 year-old Joseph Fitzgerald, who lived in a basement apartment in the home, is listed in serious condition at Mass. General with burns over 85 percent of his body that he suffered when he went back into the raging inferno upon realizing that his niece had not escaped the house with the rest of the family.

An alarming amount of damage was caused by young vandals at Revere High over the holiday weekend. The vandals also wreaked havoc at other schools throughout the city.

Mayor William G. Reinstein, in explaining why the city's tax rate will be jumping \$19.40 to a new rate of \$188.20, cited costs associated with the new high school building, equipment for the police and fire departments, and implementation of a water distribution system.

Columbus Day was celebrated in great style in the city, beginning Friday with a gathering at St. Anthony's and then Saturday with a parade that featured some of the best marching bands in New England. The festivities continued at St. Anthony's with an appearance by Rex Trailer and his horse, Gold Rush, performing for the crowd.

#### 60 years ago October 15, 1964

The American and Italian flags waved sideby-side from City Hall Monday afternoon as Columbus Day was celebrated in the city with what was acknowledged as the largest and liveliest parade in the history of the city. More than 10,000 spectators were on hand to watch the parade despite cool temperatures and brisk winds. The first prize for floats went to that of the Sons of Italy, who also sponsored the parade, for their float depicting Columbus being met by the Indians upon his landing in the New World.

The number of registered voters in the city for the upcoming national election is at an all-time high of 22,314.

Joseph J. Tegan Jr., the son of a School Committee member, has been appointed by the committee to the post of director of junior high athletics even though he has been a teacher for only a year. Committeeman School William G. Reinstein unsuccessfully nominated Richard Penn and Gerald Battista for the job. The committee also engaged in a heated discussion about whether to continue the bowling program and if so, how to improve it.

Rabbi Sidney Thaler will be installed as the new spiritual leader of the Temple Tifereth Synagogue October 25.

Mr. Alfred B. Bingham Jr., who has been serving as the pastor of the Trinity Congregational Church for about a year, will be ordained as a new minister Sunday, the first ordination to be held in the Beachmont Church in more than 30 years.

Joseph Gazza, 13, officially became the youngest member ever of local Boy Scout Troop 5 to attain the rank of Eagle Scout in impressive ceremonies held at the Joseph Leon Mottola Post 4524 VFW following a Bene-

. diction at St. Anthony's Church.

Five Revere High students, Susan Reid, Ferma Perullo, Julie Chiaramonte, Ronald Eydenberg, and Walter Weinberg, recently attended a conference on the subject of the nation of Japan Today at the Cambridge School of Weston sponsored by the World Affairs Council of Boston. The Japanese General Consul for Boston was among the guest speakers. He noted that Japan is the only Westernized country in Asia today. Other speakers were from Harvard and Rutgers universities.

#### 70 years ago October 21, 1954

Drainage problems at Roughan's Point continue to prove baffling for city officials who fear that the city may have lost a proposed 40-home development and the loss of residents of that area because of the damage caused by recent hurricanes and nor'easters. A solution to the problem does not appear imminent after a meeting among the City Council, City Engineer, Planning Board, City Planner, Building Inspector, and the housing project developers, who already have built one model home with 39 more being planned.

The program is designed to ensure OST educators can build a lasting career in a field that plays a critical role in child development.

A Proven Model for Success: The new apprenticeship builds on FKO's Full-Time OST Educator Initiative, a two-year pilot

program that has already achieved a 76% retention rate for full-time group leaders-a 40% increase over part-time staff. With support from both public and private supporters, such as EEC's Commonwealth Cares for Children's C3 grant, EOLWD Expanded Apprenticeship funding, the Department of Elementary and Education's Secondary ASOST-Rebound and 21st Century Community Learning Centers grants, Amelia Peabody the Foundation, Liberty Mutual Foundation and United Way of Massachusetts Bay, FKO's initiative sets a precedent for sustainable workforce models in the OST field.



A Remarkable Man



Born in Revere, MA, on June 17, 1953, Rich packed a lot of different experiences into his 71 years of life.





Revere's Silvio Neto pressures Somerville quarterback Sam DeSouza while being blocked by Somerville's Mack Esmael and Jojo Flores.





Coach Lou Cicatelli and his staff made a major adjustment, going from a shotgun-style offense to Hou operating directly under center.

The result was a streamlined ground game, with Hou perfectly executing handoffs and pitchouts and scoring on touchdown runs of 2, 78, and 30 yards.

Woodard showed his speed and power on touchdown runs of 26 and 28 yards. Ramirez, a


