# Council closes out

The city council rounded out its last session of the year on Monday with several quality-of-life mo-

Ward 1 Councillor Joanne McKenna introduced a motion requesting the mayor ask MassDOT to repair the street lights on the stretch of Winthrop Parkway (Route 145) at Short Beach in the interest of public safety.

The poles were damaged due to motor vehicle accidents and the state has yet to make the repairs, according to McKenna.

"We have four lights on Winthrop Parkway around a bend that is very dark coming from Winthrop

## Disabilities Comm. moving forward on music programs with Music Center of Boston

Revere Commission on Disabilities (COD) held its regular monthly meeting last Tuesday evening, December 10, via Zoom. Chair Ralph DeCicco, Mario Grimanis, Annemarie Fiore, Ellie Vargas, and Jason Barone-Cichocki were on hand for the session.

The members held a discussion regarding a pro-

People are encouraged to park at the Immaculate Conception Parking lot and to stay off the side streets. This is a free event but guests are advised that there are capacity limits and that people will be turned away if the street has filled up.

#### TWO MEN ARRAIGNED FOR FLYING DRONES FROM RESTRICTED LONG ISLAND

Two men were charged in Dorchester BMC today with three counts each connected to flying drones in hazardous air space around Long Island and Boston Harbor on

Saturday, Suffolk County District Attorney Kevin Hayden announced.

Robert Duffy, 42, of Charlestown, and Jeremy Folcik, 32, of Bridgewater, were each charged with trespassing, breaking and entering, and violating a municipal ordinance or bylaw. Judge Erika Reis released the men on personal recognizance and ordered them to stay away from Long Island and to not operate drones. Both will return to court February 6 for pre-trial hearings.

Boston Police responded to the abandoned homeless and hospital campus on Long Island via patrol boat at about 10:30 p.m. Saturday to investigate reports of unmanned aircraft being flown in hazardous proximity to Logan Airport. As officers searched the site they saw a light on in a building and a person walk by a window. Officers climbed to the second floor of the building by fire escape stairs and conducted a room search. Officers encountered Duffy and Folcik in the building. Duffy told officers he had been flying a drone and that it was in his backpack. Duffy and Folcik told officers they had been transported to the island on a boat owned by a third man. They said they did not know the man's name. Boston Police asked a State Police patrol boat unit for assistance in locating the third man but he was not apprehended.

Using data from the drone's serial number officers identified six recorded flights on Saturday and seven recorded flights on December 7.

"No trespassing" signs are posted on structures throughout the shuttered Long Island campus.

"There are many areas in Massachusetts to safely operate drones. But flying them from an area closed to the public while creating a potential public safety hazard in the process is conduct that will land people in court to answer to criminal charges, which is exactly what happened here," Hayden said.

## Subcomm. tables housing plan discussion

The city council will continue the discussion of a proposed Housing Production Plan at a future committee of the whole subcommittee meeting.

The plan was discussed

during both a subcommittee meeting Monday night and during the public speaking portion of the regular council meeting later that evening. During the commit-

tee of the whole meeting,

councillors voted to table the consideration of the housing plan to its next meeting. Some residents raised concerns about how the plan would affect development in the city with some

possible zoning changes,

while others urged the

council to take action and adopt the plan, citing the need for affordable housing in the city and across the state. The housing production plan, which has been in the works for over a year, aims to create housing for

residents of all income

levels as well as sustain

the city's current housing

The city's department of planning and community development worked on the plan alongside outside consultant JM Goldson and a working group composed mainly of volunteers.

The ultimate goal of the housing production plan is to create a roadmap for building the right kind of housing in the right locations across all income spectrums in a way that can predictably help the city manage its growth as a community, planning and community development director Tom Skwierawski has stated.

Noah Harper, a housing-focused planner from JM Goldson, had stated that a housing production plan is a state-created program that, once it is approved by the state, can help mitigate 40B affordable housing projects in a community.

Approving the plan would not enact any zoning changes, but the plan does recommend zoning reform to support housing

production. Some of those zoning reforms could include reducing the minimum lot size, allowing for twoand three-family homes by right in residential districts, and minimizing or eliminating off-street parking requirements near public transit.

Gail Giuffrida Kingsley, a lifelong Revere resident, said she fears that she might have to leave Revere if the housing plan leads to overdevelopment. She said she was especially concerned about a zoning recommendation that could eliminate side setbacks in some zoning districts.

Giuffrida Kinglsey also noted that Revere has traditionally been a community where people move to from the city to live a more suburban life.

"I feel we should keep it that way," she said.

However, several people did speak in favor of the housing plan, noting the severe need for housing for residents of all income levels and back-

Lor Holmes, a housing advocate who was a member of the working group for the plan, said it should not be seen as a take-it-orleave-it document.

Holmes said it is understandable that the council doesn't want to move quickly on the plan considering the questions some residents have raised, but said she hopes the council does commit to addressing housing issues in Revere.

"There are a lot of strategies in this plan, and they won't all work for Revere right now, but we've got to do something," said Holmes.

Council President Anthony Cogliandro said the decision to table discussion on the plan shouldn't be taken by the public as meaning it will be ignored.

"We are not getting rid of this in any way, shape, or form," he said. "Please don't think we are going to be getting rid of the Housing Production Plan, we are going to be talking about it at the next committee of the whole subcommittee."

D'Ambrosio, a graduate of Yale University and a former Revere School Committeeman, welcomed the large gathering to the reception.



## Revere man pleads guilty to ammunition charges in connection with Everett shooting

A Revere man pleaded guilty last week in federal court in Boston to illegally possessing ammunition in connection with a January shooting in a residential

neighborhood of Everett. Kenneth Munoz, 27, pleaded guilty to one count of being a felon in possession of ammunition. U.S. Senior District Court Judge William G. Young scheduled sentencing for April 9, 2025.

On the afternoon of Jan. 2, 2022, three individuals fired over 20 shots in an Everett neighborhood causing ballistic damage

in the surrounding area, including bullet holes inside of bedrooms and living rooms in surrounding residences, according to the U.S. Attorney's office. The shooting was captured on video surveillance from nearby residences. Munoz was identified as one of the two shooters.

Munoz is prohibited from possessing firearms and ammunition due to prior convictions.

The charge of being a felon in possession of ammunition provides for a sentence of up to 10 years in prison, up to three years of supervised release and a fine of up to \$250,000.

Sentences are imposed by a federal district court judge based upon the U.S. Sentencing Guidelines and statutes which govern the determination of a sentence in a criminal case.

United States Attorney Joshua S. Levy, James M. Ferguson, Special Agent in Charge of the Bureau

of Alcohol, Tobacco, Firearms and Explosives, Boston Field Division, Everett Police Chief Paul Strong and Chelsea Police Chief Keith E. Houghton made the announcement. Assistant U.S. Attorney Sarah Hoefle of the Organized Crime & Gang Unit is prosecuting the case.

squad did a great job, traveled to nationals and practiced hard and they got a great second place finish," said Argenzio. "I would like to acknowledge them for all their efforts."





## THE BATTLE OF THE BULGE STARTED 80 YEARS AGO THIS WEEK

It was 80 years ago this week that the final big battle of WWII in Western Europe -- the Battle of the Bulge

In brief, the Battle of the Bulge marked a last-ditch counter-offensive by the German Army against the U.S. and its allies as the allies advanced through Belgium and toward Germany. The German attack, which caught the Americans by surprise, earned its name from the "bulge" that the sudden German thrust created in the middle of the American line in the Ardennes Forest of Belgium.

The battle was immortalized in the 1965 movie, The Battle of the Bulge, and then 40 years later in the great HBO series Band of Brothers, which followed the exploits of E Company of the fabled 101st Airborne Division, including its crucial role in the defense of the Belgian town of Bastogne where General Anthony McAuliffe uttered the famous, one-word declaration word, "Nuts!" in response to a demand for him to surrender from the German commander who had surrounded the Americans. The 101st Airborne hung on, against all odds and a militarily-superior enemy, stalling the German offensive until General George Patton arrived with reinforcements.

Soldiers fought in brutal winter conditions against a ruthless German enemy that literally was taking no prisoners -- the Nazis executed hundreds of captured American soldiers during the engagement. Altogether, the U.S. Army lost approximately 19,000 men and suffered 75,000 total casualties in what became the United States' deadliest single World War II battle, which extended from December 16, 1944, to January 16, 1945. When the battle was over, so too for all intents and purposes were the Germans, whose surrender occurred less than four months later.

The reason we wish to make note of this epic battle is because in some of our sister newspapers, we write a weekly "Through the Years" column. In our Revere newspaper, it was noted that seven Revere families were notified this week 80 years ago that their sons, husbands,

and fathers had been killed in action.

We today can only imagine the profound and deep sense of grief and sadness that enveloped entire communities all across the country as the telegrams from the War Department were delivered by the thousands to families informing them of the loss of their loved ones over those terrible four weeks.

In addition, it occurred to us that so few of the Greatest Generation, including our own uncles and fathers who served in that war, are still alive today. All of the members of Easy Company have passed away.

We do so in hopes of acknowledging the debt we owe to the brave soldiers who gave their lives in the forests and on the fields of Belgium 80 years ago, with the hope that we might fulfill the sentiments expressed by Abraham Lincoln in the Gettysburg Address: "...that from these honored dead we take increased devotion to that cause for which they gave the last full measure of devotion—that we here highly resolve that these dead shall not have died in vain."

## Some anniversaries remembered and some forgotten

Anniversaries are a time to look back, to celebrate milestones and achievements; it is also a time to remember the misfortunes and hardships that some of the members of our society experienced leading to the creation of our new nation and to reflect upon those events as we reconnect with our past.

During the upcoming two years a constellation of past historical events will be occurring which are significant to both our national and local histories, as we celebrate the 250th anniversary of the American Revolution and the signing of the Declaration of Independence.

As this year comes to a close a lesser known local historical event will be concluding; the 400th Anniversary of the, settlement of Winnisimmet, (now Chelsea, Revere and Winthrop), when an adventurous 22-year-old young man from Devonshire England, named Samuel Maverick, journeyed from Weymouth England arriving at Wessagusset , (now Weymouth), Massachusetts in 1623 to pursue his fortune in British North America. A short time after his arrival he decided to move on from Wessagusset traveling to the north side of the Mystic River, at the junction of Massachusetts Bay, arriving at an area of land in 1624, then populated by the Rumney Marsh Indians, part of the indigenous people of the Pawtucket nation, on land that they called Winnisimmet. Maverick took possession of the lands of Winnisimmet from the Rumney Marsh Indians by occupation, in keeping with the adverse land acquisition provisions of British law, thus establishing Winnisimmet as the fourth permanent British North American settlement in Massachusetts. Maverick would quickly develop the land that he occupied constructing a home, with a palisade defensive fortification enclosure, on the Winnisimmet hillside facing the Mystic River. Although in early conflict with the Rumney Marsh Indians Maverick subsequently established a harmonious fur trading relationship and friendship with them. During a smallpox epidemic outbreak Maverick ministered to the medical needs of the Rumney Marsh

their dead in one day. In June of 1630 Maverick would greet, the legendary John Winthrop, the Puritan leader of the Massachusetts Bay Company, at his Winnisimmet home, as Winthrop traveled from his Salem outpost to Bos-

Indians and buried 30 of

ton Harbor in search of a suitable location for the capital of his Massachusetts Bay Company settlement, his proverbial new Jerusalem, which Winthrop referred to as his, "city upon a hill", a model for the building of a new Puritan society in North America. Maverick would render essential services to Winthrop's Massachusetts Bay Company, as Winthrop labored to establish a home for his Puritan religious community as well as his, British North American economic colony. Winthrop would later establish Boston as the capital of the Massachusetts Bay Company in 1634 and he then quickly annexed all of Winnisimmet, including the lands of Rumney Marsh and Pullen Point as part of the new Puritan Town of Boston. Maverick would remain as a resident of Winnisimmet for a short time until he deeded his hillside estate and a portion of his other Winnisimmet land holdings to Richard Bellingham in 1635. By then Maverick had already moved on from Winnisimmet to his new home at Noddle's Island, (now East Boston),

in Massachusetts Bay. While it is fitting and appropriate to recognize Maverick as the first English settler of our area, 400 years ago in 1624, it is inappropriate to condone Maverick's less then honorable character, stature and reputation since Maverick shamefully became the first slave trader in Massachusetts, committing New England's original sin. It should be noted, that Maverick was a product of his seventeenth century English times that condoned slavery for both cultural and economic reasons. Moreover, slavery was a major component of British economic Imperialism that relied heavily upon slavery for the establishment of British North American agricultural plantations, to acquire resources and produce agricultural products for shipment back to England. The cultivation, of agricultural products, required substantial feudal forced labor by both indentured servants as well as Negro slaves to become a successful economic venture.

In 1645 John Winthrop, who had served as Governor of the Massachusetts Bay Colony on six different occasions, wrote about British North American economic expansion "I do not see stating: how we can thrive until we get...a flock of slaves sufficient to do all of our business...and it will be cheaper to maintain twenty Negro slaves cheaper than one English servant." A number of those very slaves now rest in our

sachusetts Constitution of 1780, and its subsequent judicial in1783, that ultimately brought an end to slavery in Massachusetts. March 27& 28,1775, members of our

town's militia joined together with 1000 militia men from all of the then New England colonies, and tenaciously confronted 400 British Royal Marines, with their fleet of three naval vessels, assault barges and field artillery, encountering British troops beginning at the inner islands of Boston Harbor and ending in the marshlands and mudflats of Chelsea Creek, near Slade's Mill, resulting in the capture and sinking of the British Royal Navy schooner "Diana". Battle of Chelsea Creek, although mostly forgotten to history, was notable since it was the first planned offensive battle of the Revolutionary War; the first instance of military cooperation by the New England colonies, battling the Redcoats; the first naval engagement of the Revolutionary War; the first capture of a British vessel of war; and the first time that artillery was used by the colonial militia against the British. While the colonial losses were minimal the Redcoats lost sixty-four of their elite troops.

On April 19,2025 our nation will commemorate the 250th anniversary of the, "Short heard round the world", on April 19th 1775, when we celebrate the confrontation of Massachusetts colonists and British Redcoats at Lexington and Concord,

marking an important battle of our war for Independence from Great Britain and another transition from a war of words to

one of bullets. Although little known, by many of our current Revere citizens, a number of the then residents of our early town played an important role in this confrontation for independence from Great Britain, when the pastor of The Church of Christ at Chelsea, (now Revere), Reverend Phillips Payson, lead a party of men from his church congregation halting the retreating British Redcoats, after the confrontation at Lexington and Concord, engaging the Redcoats at Menotomy, (now Arlington), in an intense rear action confrontation, when the men of the church congregation killed a number of the Redcoats and took several of the enemy as prisoners. By their courageous action the men from our town enshrined themselves in the history of our nation by their heroic participation in this important confrontation of the American Revolution for Independence from Great Britain. Also, for his heroic leadership of the men from his church congregation, Pastor Phillips Payson would become forever known as "Fighting Pastor Payson". Payson would go on to participate, with John Adams as a contributor, in the writing of the Massachusetts Constitution and as a founding member of the American Academy of Arts and Sciences, along with John Hancock, Robert Treat Paine and John

Twenty days later, on June 17,1775, the colonists once again battled the British Redcoats at the bloody battle of Bunker Hill. The battle, which ac-

## Over 100 RPS caregivers turn out for 'Know Your Rights' event

On Tuesday, Dec. 10, Jessica Chicco, Director of Training for the Massachusetts Immigrant & Refugee Advocacy Coalition (MIRA), provided vital information to Revere Public School (RPS) caregivers about their rights while living in the United States.

Chicco, the Director of Training for the Massachusetts Immigrant & Refugee Advocacy Coalition (MIRA), delivered essential insights to over 100 RPS caregivers during the district's 'Know Your Rights' Family Engagement Night. At the event, Chicco emphasized the rights that individuals have while living in the United States, empowering them with knowledge to navigate their immigration status effectively. The session aimed to equip

caregivers with the necessary information to support themselves and their families.

With the incoming presidential administration's immigration agenda raising concerns, the session aimed to equip families with the information needed to better support themselves and their loved ones.

Topics Chicco discussed included basic rights; rights if immigration comes to your home; family preparedness; getting legal help; rights

when driving; rights if immigration comes to your work; and rights in detention.

"MIRA is so happy to have been invited to participate in this important event organized by Revere Public Schools," said Chicco, who formerly served as Senior Immigration Attorney at DOVE (Domestic Violence Ended, Inc.) in Quincy. "Sharing information about our rights in families' preferred languages is key to empowering our parents, caregivers, and communities. We hope that RPS families and caregivers have gained more knowledge and resources from our "Know Your Rights" page, and they will continue to access and share these essential resources within their communities."

The political rhetoric surrounding immigration has caused significant anxiety and distress for many of our families, caregivers, and students. RPS serves a significant number of families from

tually occurred at Breed's Hill, only lasted two hours, however, the losses were significant resulting in 1,054 British casualties and 450 colonial losses, demonstrating the fighting ability of the colonial forces to effectively do battle against the British Redcoats.

Over one year later, on July 4,1776,the Second Continental Congress of the thirteen American Col-

onies, meeting at Philadelphia, sent a bold message to the King and Parliament of Great Britain by proclaiming the American Declaration of Independence, from Great Britain.

Recognition of our past, acknowledging historical events and experiences of a bygone era, including both positive and negative aspects, allows us to gain important insights and lessons learned as we strive to shape a better future. We can't change history but we certainly can learn from it. As William Shakespeare wrote in his play "The Tempest"

play, "The Tempest",
"The past is prologue."

information sessions could be conducted either in-person, via Zoom, or through a hybrid combination and could be held at whatever intervals are convenient (monthly, quarterly, etc.). The times and frequencies of the classes for children also could be held at the convenience of local residents.

DeCicco noted that input from Parks and Rec. would be necessary to determine the availability of space at the George Colella Community Center at the Garfield School. After the discussion, Fiore agreed to write-up a detailed plan that could be presented to the Parks and Rec. Dept.

"As a commission, we always are seeking new programs we can implement in Revere to benefit children and young adults with disabilities, and the more we can do, the better, because there is a need," said DeCicco.

DeCicco presented a summary of the December 4 meeting of the Commissions on Disabilities Alliance (CODA) that he attended. Among the items discussed at the meeting were:

-- The Disability Policy Consortium (DPC) will be hiring for a few positions, including a Community Organizer, an Executive Assistant, and a Deaf and Hard of Hearing Ombudsman. For more information and to apply, visit their website at https:// www.dpcma.org/;

-- DPC also mentioned that the next legislative session begins again in January and soon thereafter will start to conduct advocacy updates for the new session;

-- The Newburyport

COD representative spoke about a new program that community will be implementing called Project Lifesaver in which the Newburyport COD will be partnering with the Newburyport Police Department and Council on Aging. This technology has a success rate of being able to locate a lost individual within 30 minutes, which is much faster than other programs.

The initial cost to implement this program is approximately \$9800 for the first year. This includes wrist or ankle transponders for 14 individuals (additional users could be added for an additional cost), along with equipment for three police cars and other equipment needed to be installed throughout the community. The training necessary for the police officers is included. More information on this technology can be found at https:// projectlifesaver.org/; and

-- Representatives from various CODs discussed roadway construction-related issues that cause accessibility difficulties for pedestrians with disabilities. They noted that the problems principally arise when state agencies perform construction projects, but do not take appropriate measures to help persons with disabilities navigate the construction areas.

In a separate matter, the commission discussed sending a letter to Revere's representatives at the State House to urge them to ask that the Mass. Dept. of Conservation and Recreation (DCR), which has jurisdiction over Revere Beach, provide additional street lighting, including flashing pedestrian crossing signals, at the beach.

Last month, vice-chair Pauline Perno warned residents and her fellow commissioners that crossing the streets in the area of Revere Beach is "treacherous" because of the lack of lighting on Revere Beach Blvd. She suggested that the COD send a letter to the city's elected State House officials about the need for the DCR to install flashing pedestrian-crossing lights.

Perno agreed to draft a letter for approval by the full COD at this month's meeting. The members reviewed the letter submitted by Perno (who was unable to attend last week's meeting), but unanimously voted to table moving forward on it until Perno is in attendance to discuss it with the members.

DeCicco concluded the meeting by reading the COD's monthly reminder:

"The Commission on Disabilities office number is 781-286-8267. Residents can also call Revere 311 directly and speak to their staff Monday through Friday. They will answer most questions, but if they cannot or if you want to talk to our department directly, ask to be transferred to the Disability office. Please leave a detailed message, and someone will get back to you soon.

"As always, don't hesitate to contact us if you want something discussed or added to our monthly meeting agenda. You can also let us know if you want to speak about any issue or concern. The Commission is here to help and assist all the disabled residents and families of Revere."

The COD's next meeting (via Zoom) is scheduled for Tuesday, January 14, 2025, at 6:00 PM.

Brazil, Guatemala, Ecuador, El Salvador, Colombia, North Africa, and the Middle East—many of whom are undocumented and fear deportation once the new administration comes to term.

"Given MIRA's role in educating and supporting immigrant families about their rights, particularly in uncertain times, we felt it was a beneficial idea to invite representatives from the coalition to speak with our families and provide crucial information at December's Family Engagement Night," said Dr. Lourenço Garcia, RPS Assistant Superintendent of Equity and Inclusion.

During the meeting, Chicco highlighted that non-U.S. citizens may face increased vulnerability to deportation, particularly those who are unauthorized or undocumented, as well as individuals seeking asylum or holding refugee status. According to the U.S.

Constitution and related laws, all people living in this country have legal rights, regardless of their immigration status, said Chicco. "It is important to as-

sert these rights and pro-Chicco.

tect our basic rights," said During the meeting, Chicco provided some advice on what to do if U.S.

**Immigration and Customs** 

Enforcement (ICE) visits

your home.

"Do not immediately open the door," she advised. Legally, you are not required to open the door unless the officer presents you with a judge-signed warrant. Ask officers to identify themselves. Inquire about the presence of a judge-signed warrant. Slide a "Know Your Rights" card under the door. Additionally, you possess the right to maintain silence and seek legal representation. If you choose to invoke that, state to officers, "I request my right to silence and to an attorney."

Chicco also advised calling a US citizen friend or family member or an attorney.

Chicco urged families and caregivers to make a plan. This involves updating your school contacts, ensuring you have the correct contact information for a few trusted individuals who can pick up your child from school in the event of your inability to do so. Tell the school you want to "opt out" of any directory information the school puts out to protect your information.

You should also register your child's birth with your foreign consulate. Registering your child's birth with the consulate could make it easier for them to travel or relocate to your home country.

"Apply for passports for your child: most governments require that both parents give permission for their child to get a passport," said Chicco. "If you have sole legal custody or a specific court order, you do not need the other parent's permission."

She also suggested writing a travel letter.

"If your child needs to travel outside the U.S. they may need a notarized letter that gives them permission to travel with a trusted adult," she said. "You may want to contact an airline or your consulate to get exact instructions.'





#### 90 years ago **December 21, 1944**

Two more Revere soldiers were confirmed as killed in action this week, bringing the city's toll of war dead to nine in the past two weeks. They are First Lieut. Francis N. Petro, 24, of 912 Winthrop Ave., and Pvt. Joseph Gorfinkle, 19, of 54 Shirley Ave.

Lieut. Richard B. Jacobs reports that he was one of the last three men to leave the aircraft carrier U.S.S. Princeton just before it was sunk in the battle of Leyte Gulf off the Philippines in October. He is home on a 30 day leave and provided a thrilling first-person account of the courage and daring of the men on the carrier. Jacobs, wounded in the leg and back by shrapnel, was among the remaining crew of 60 men who stayed behind on the vessel after the crew had abandoned ship. About half of the crew perished when the ship's magazine exploded. The two destroyers escorting the Princeton initially fought off the enemy's air attacks, but two direct hits doomed the carrier. Jacobs stayed on the ship for seven hours after the last of 200 Japanese warplanes was downed, but it became impossible to save the ship and it finally was torpedoed and sent to the bottom by one of the escort destroyers.

## **Old North Church unveils** hidden 18th-century angels in ongoing restoration

An interior revolution is underway at Boston's Old North Church and Historic Site. On Sept 30, a 6-month paint conservation and restoration project began to uncover 18th-century painted angels hidden beneath layers of white overpaint on the balcony arches in the church's sanctuary. I invite you to join renowned paintings and murals conservator Gianfranco Pocobene for the multi-step process that has begun at Old North Church in Boston's North End and will continue through late March.

The angels at the center of this work were painted by John Gibbs, an accomplished decorative painter and congregation member, who completed Old North Church's first major interior decoration, including the painting of 16 angels, between 1727 and the 1730s. The angels are depicted as cherubs, with round childlike faces and wings.

While Old North Church once boasted a colorful interior filled with intricate and ornate designs, all of this artwork - including Gibbs's angels - was painted over with white paint in 1912. However, a paint study conducted in 2017 revealed that the lost cherubs still exist. Expert craftspeople painstakingly removed layers of white paint to partially uncover one of the angels painted in 1727. Old North's team nicknamed this angel "Howard" in honor of a beloved advocate and supporter of the church.

The 2024-2025 paint restoration project is restoring more of Gibbs's work: the rest of the angels and decorative festoons between them. In order to uncover the angels, lead conservator Gianfranco Pocobene and his team apply a solvent gel similar to a paint stripper that softens the layers

of white paint, manually

remove the overpaint with a plastic scraper, and then do additional cleaning with a cotton swab covered in solvents. An exciting discovery has been that Gibbs's angels do not have identical faces; each one was designed to be unique. Watch this video interview with Gianfranco

to learn more. "The timing of this project is particularly exciting. As we approach the 250th anniversary of Old North's signal lanterns and Paul Revere's midnight ride in April 2025, visitors to the church will get a glimpse of the sanctuary as Revere knew it," said Nikki Stewart, Executive Director of

Old North Illuminated. This project will be done in two phases:

• Phase 1 (through Dec.): Gianfranco and his team will work on scaffolding in the rear of the church while they conduct the work and test solvent mixtures on small areas of paint. The winning solution will be used on the surface to swell and dissolve an estimated three to four layers of paint, which will be delicately stripped away to reveal 8 of the hidden angels. The project will then pause as scaffolding will come down for holiday services in the church.

• Phase 2 (mid-Jan. through late March): Scaffolding will go back up in the front of the church to continue the stripping process. Eight more angels will be revealed. In early 2025, visitors will see half of the work complete and the other half in progress, making it an ideal time for media coverage. The grand reveal, when all 16 angels will be uncovered, will be in April. "The step-by-step uncovering of the angels

at Old North Church is revealing fascinating aspects of John Gibbs's painting technique," said Gianfranco. "Even more intriguing and exciting is the opportunity to con-

## Civil suit from a Revere case could head to state Supreme Court

A \$1.6 million civil suit stemming from the horrific 1992 murder of a 5-year-old girl in Revere could be headed to the state Supreme Judicial Court (SJC) and could end up having statewide implications on how far residential landlords must go to protect their tenants.

The state Appeals Court heard the case, Or vs. Edwards, in November and Judge Benjamin Kaplan ruled against the landlords, local insurance agents Lawrence and Florence Edwards. However, their attorney, Michael Sams of Boston, said they have appealed the case.

The case stems from the brutal rape and murder of Anmorian Or in May 1992 by Vao Sok, a handyman hired by the Edwards family to work at their 146 Shirley Ave. multi-family building. The Edwards family had entrusted Sok with keys to several vacant apartments in 1992 when the building was being abated of lead paint.

On May 15, 1992, Anmorian's mother had taken her three children to school and then retrieved

serve and restore some of the earliest paint decorations in America and make them accessible to the public and scholars alike."

Born in Italy and raised Canada, Gianfranco received his Master of Arts in Conservation from Queen's University, Kingston, Ontario in 1984. He first came to Boston in the 1980s to earn a Certificate of Advanced Training from the Center for Conservation and Technical Studies at Harvard Art Museums. He then spent the next 15 years working for the Straus Center for Conservation, Harvard Art Museums where he oversaw the restoration of mural cycles at the Boston Public Library by Puvis de Chavannes, Edwin Austin Abbey, and John

Singer Sargent. In 2004, he was appointed Chief Conservator at the Isabella Stewart Gardner Museum where he carried out treatments and technical studies on the paintings collection. Early this year he left the Gardner Museum to focus exclusively on his private practice, Gianfranco Pocobene Studio which was established in 1991. Some of the Studio's significant mural projects include the restoration of the John LaFarge murals at Trinity Church, Boston, the Women's Gallery mural at Vilna Shul, Beacon Hill, Puvis de Chavannes' Philosophy mural at the Boston Public Library, and Benjamin Constant's mural at the Ames-Webster Mansion, Boston.






