

# Traffic Comm. to consider making changes along bus routes permanent



April 17 in the City Councillor Joseph A. Del Grosso Council Chambers. On hand for the session were Chair and DPW Director Christopher Ciaramella and fellow members City Planner Frank Stringi, City Engineer Nick Rystrom, and Acting Fire Chief James Cullen.

The commission held one public hearing regarding a request to Amend Schedule VIII of Title 10 (Parking Restrictions Generally) by removing Wilson Street Easterly from "No Parking Anytime" and by adding Wilson Street Westerly as "No Parking Anytime."

A resident told the commissioners that the present situation prevents buses from making the turn off



Acting Fire Chief Cullen also said he is in favor of the changes.

After a brief discussion, the commissioners unanimously approved the measure.

The commissioners then took up a number of new items. The first was a request from the city for the metering of 17 public parking spaces designated for public use in the area at the new Gibson Point apartments.

After Stringi explained the purpose of placing meters in the area, the commission unanimously approved moving the matter to a pub-

lic hearing at its next meeting, at which time they will take a vote on the measure.

The next item was a request to Amend Schedule IX, Section 10.99.090 (Resident Parking Twenty-Four Hour Enforcement) to include Prince St. Ward 3 Councillor Anthony Cogliandro (who was not present for the meeting) had filed the request at the behest of the residents.

Zach Babo, the city's Parking Director, told the commission that a nearby construction project on Broadway had created the problem because the construction workers are parking on Prince St.

# **Council approves special permit for Broadway business**

The city council approved a special permit allowing for a contractor's yard at Master Spray Foam at 870 Broadway at its meeting on Monday night.

The approval to change from one nonconforming use (a commercial garage) to another (the contractor's yard) came with a long list of conditions to address concerns raised by residents at previous meetings.

for the storage of six vehicles, three box trucks and three vans, for the use of the business on the property.

At previous public hearings, neighbors raised concerns about the state of the existing building at 870 Broadway, as well as unregistered cars on the property and noise at the site early in the morning.

"We put many conditions in there," said Councillor-at-Large Anthony Zambuto, who chairs the The special permit allows zoning subcommittee. "We had many calls on this, and I think this addresses every item every resident had, and I think it puts enough safeguards in.'

The special conditions include making sure the exterior of the building is repaired, including the replacement of missing stucco and boarded up windows, as well as the fire department approval of fire suppression and ventilation systems in the building.

The building must also be brought into compliance with all city codes.

The owner must also cease operation of the commercial garage and used car sales on the property. In addition, all employees must park off street, and the hours of operation for the business will be from 6 a.m. to 7 p.m. from Monday through Saturday.

Finally, only materials related to the spray foam business will be allowed to be stored on the property.

The commission voted to refer to the city's Traffic Working Group item #4, which was as follows: "A request to place approprilights ahead of all speed bumps to provide sufficient "This would open up a warning to drivers and improve roadway safety. Furthermore, that the Traffic Commission and Department of Public Works conduct a review of all existing speed bump locations to ensure proper signage and report back with recommendations."

The commission also voted to postpone taking up item #5, which was a request to install two speed bumps along Mills Avenue and two on Rice Avenue.

The next item was a request to reduce the speed limit on Campbell Ave. between Centennial Ave. and the Revere Beach Parkway from 25 to 20 miles per hour. Ward 2 Councillor Ira Novoselsky spoke in favor of the request.

in the city that are commercial streets that have a speed limit of 20 miles per hour, but this is a residential street with 25 miles per hour," said Novoselsky.

The commissioners unanimously voted to move the matter to a public hearing at its next meeting.

The commission then heard a report presented by Olivia Mobayad, a :Project Manager with the MBTA's Better Bus Transformation Project, regarding the Bus Stop Pilot program that was launched this past December. Mobayad first reviewed the pilot program's main goals, which are as follows: -- Relocation of bus stops for Routes 116, 119, and 110 along Broadway and Park Avenue to improve transfers for riders; and -- Installation of new Transit Signal Technology to allow buses to safely serve the new bus stops without adverse impacts to intersection operations. Mobayad said that bus routes 116 (which absorbed former bus route 117) and 110 are now Frequent Bus Routes, which has increased service to every 15 minutes or better during service hours every day. In addition, she said that consolidating the bus stop at Park and Broadway for both of those routes has made transfers between the two routes easier and more accessible for riders. Mobayad also noted that the project has eliminated the use of the so-called "driveway" behind the fire station that previously had been used by buses to get from Broadway onto Park Ave. Mobayad said that there are 5,100 total daily bus riders (compared to 30,000 automobiles), who traverse Broadway and that there are 255 average weekday transfers and 580 daily boardings at the new bus stops. "Things are working well and we are benefiting a lot of riders every day," said Mobayad. Mobayad noted that large vehicles have difficulty making the right turns from Broadway onto Central Ave. and Broadway onto Park Ave. She said the T is proposing to move the stop bars in the roadways on Park and

Central 10 feet further back from the intersections. The commissioners suggested that the area right after the current stop bars could be "X'd" out wth "Don't Block the Box signage," rather than moving back the stop bars, to which Mobeid suggested a compromise of moving the stop bars back five feet, along with instaling the "X" striping.

Mobayad also said that the T is recommending placing new bus stops on Mountain Ave. that would avoid 170 pedestrian crossings on Central Ave. and 400 additake a formal vote on the T's permanent proposals, the commissioners unanimously did so.

The next matter was a request from Babo to add 44 parking meters in the Shirley Ave. business district (for a total of 110) which he said will benefit the new businesses, especially those in Sandler Sq., that have come to the area since 2019.

Babo said that the new parking meters will have sensors that will allow for 15 minutes of free parking for customers who are making quick pick-ups at the businesses. He also asked that the meter rates be increased from \$1.00 per hour to \$1.50 per hour after the 15-minutes of free parking. John Festa, the economic liaison for the city with the Dept. of Community Development, spoke in favor of the proposal, as did Ward 2 Councillor Novoselsky, who suggested that there be different configurations for the new meters that will take into consideration the needs of both businesses and residents. Richard Viscay, the city's CFO, Auditor, and Budget Director, also spoke in favor of the proposal. "Parking meters will help the businesses by creating turnover in parking in that district," Viscay said. The commissioners unanimously voted to move the matter to a public hearing next month. The meeting concluded with DeMauro updating the commission about two items that have come within the purview of the Traffic Working Group regarding measures that have been undertaken to reduce speeding on Walnut and Crescent Aves. She suggested that speed pillows be installed on Crescent Ave. and a pedestrian beacon be placed on Walnut Ave. Novoselsky however, noting that two pedestrians were struck by automobiles recently, strongly advocated for the installation of a speed bump on Walnut Ave. as being the "only way that we can reduce the speeding on that street." The matters will be placed on the agenda to be taken up at the commission's next meeting.

Mobayad said the T's present timeline calls for the six-month pilot program to end in June. She said that if the commission agrees to make the changes permanent, the construction work to be undertaken by the T for ADA-compliant sidewalk improvements along the bus routes will begin in the fall.

Mobayad said the proposed changes include the following:

-- Permanently remove the bus stop located at Walgreens (Broadway southbound) and relocate the stop to Mountain Ave. and Broadway (south side) to improve bus stop access for riders of the 116, 119, and 411;

-- Permanently remove the bus stop located at TD Bank (Broadway northbound) and relocate the stop to Mountain Ave. and Broadway (south side) to improve bus stop access for riders of the 116, 119, and 411;

-- Move the left-turn lane stop bar on Central Avenue at Broadway up to 15' back from the intersection to allow safe turning for large vehicles and improve intersection operations; and

-- Move the left-turn lane stop bar on Park Avenue at Broadway up to 15' back from the intersection to allow safe turning for large vehicles and improve intersection operations.

# Council to consider non-binding ballot question on term limits

This November, voters might get the chance to let their opinion be heard on term limits.

At Monday night's city council meeting, Councillor-at-Large Michelle Kelley introduced a motion requesting a non-binding ballot question in November asking voters if they would support term limits for elected city officials.

The proposal was moved to the May 12 meeting of the council's legislative affairs subcommittee.

Earlier this year, Council President Marc Silvestri introduced a motion asking the council to approve a home-rule petition for term limits. That motion was

also set to be discussed at residents to have a say in the May 12 subcommittee meeting, but Silvestri removed that motion and signed on to Kelley's motion for the non-binding ballot question.

Even if voters support term limits if the question comes to the ballot, the council would still have the ultimate say on sending a home-rule petition to the state legislature for approval.

"After the discussion we had on term limits at the last meeting, I decided to submit this motion," said Kelley. "I think it is apparent to everyone that residents really want to weigh in on this issue and have their voices heard. This simple ballot question would empower

shaping their government structure and would allow for direct democracy."

Kelley said a council vote on term limits without input from the public would allow for the appearance of a conflict of interest.

"If we vote on this issue, we are voting on our own job security, which creates an appearance of impropriety,"

Kelley noted that some councillors have stated that the current election process provides for a kind of term limits since voters can decide not to return an incumbent to office if they are not happy with them.

"This argument fails miserably, because when incumbents run unopposed repeatedly, it fails there and there is no democracy in that," she said. "In the last 10 municipal elections, incumbents ran unopposed 31 times. Incumbency and name recognition in Revere act as potential deterrents to newcomers who would otherwise enter a race."

Ward 4 Councillor Paul Argenzio has stated that he does not personally support term limits, but that he would support putting the question on the ballot.

Councillor-at-Large Robert Haas, III noted that he believes the council operates best when there is a mix of newcomers and veteran leadership, and that the term limits would limit that veteran leadership.

approval of the final agreement at its May 12 meeting.

Monday night, a number of councillors raised concerns about the potential tax break, the current status of the Suffolk Downs project, and how it will affect the city's funding of the new high school project.

"On Feb. 10, the Revere City Council approved a Housing Development Incentive Program (HDIP) District at Suffolk Downs," stated Skwierawski. "As discussed, this tool provides a housing developer with the opportunity to receive both state tax credits and to enter a local Tax Increment Exemption agreement with the City of Revere. This TIE agreement exempts the value of improvements on a housing development for a period between five and 20 years, exempting between 5 to 100% of the value created on a new development."

The draft agreement proposes an increment of 50 percent for a period of 15 years.

and is expected to take up clause where abatements on the property cannot be sought within the first 10 years of the agreement.

In addition, the city is working on the separate development agreement with HYM outside the scope of the TIE, Skwierawski added that includes the additional payments to the city tied to construction dates of other Suffolk Downs projects and other benefits.

Skwierawski said the TIE agreement is necessary for HYM to receive state tax credits on the Portico project, and must be submitted to the state by May 13 to be included in the next round of HDIP state tax credits.

"If they do not meet this round, it would likely delay this project by another construction cycle," he added.

Councillor-at-Large Michelle Kelley raised a number of questions about the TIE, and said specifically that she would like to see language about construction starting by the end of the year tightened up.

Now, Kelley said, the city council is being told that it has to pass the tax incentive plan in order to boost the development.

"I am not 100 percent comfortable with anything that has to do with this project now, which upsets and saddens me, because I want the project to be successful because we desperately need the revenue to fund the high school," she said. "Everything was going fine until this tax increment plan became available, and now all of the sudden it is available and they need this money to get this going again because we need money to fund the high school."

Mayor Patrick Keefe noted that the sluggish economy and construction market is an issue throughout the Northeast and the country.

"It is not what we ideally planned on in 2016, and I understand that there are pessimistic and optimistic views on any large-scale plan," said Keefe.

With the tax incentive

Both Ward 3 Councillor Anthony Cogliandro and Council President Marc Silvestri raised some concerns about the TIE, and noted they wanted to make sure that the negotiations ensure increased union jobs for Revere residents on the project.

Several councillors also noted that the city should take a look at costs associated with the \$500 million high school project. About half of the cost of the project is due to be reimbursed through the state's school building authority.

Nomination papers are now available at City Hall for all prospective candidates for the 2025 municipal election on Tuesday, Nov. 4.

With the mayor elected to a four-year term, the only positions on the ballot this year are ward and at-large city council seats and ward ant at-large school committee positions.

The general election is set for Tuesday, Nov. 4. The preliminary election, if there are enough certified candidates to warrant it, would take place on Tuesday, Sept. 16.

Early this year, the city council also approved early voting for the elections at city hall.

If there is a preliminary election, early voting will take place from Saturday, Sept. 6 to Friday, Sept. 12. Early voting for the gen-

eral election would take

place from Saturday, Oct. 25 through Friday, Oct. 31.

For those thinking about seeking elected office, nomination papers were made available from the election department at city hall on Monday.

All potential candidates need to gather 50 qualified signatures to be placed on the ballot. Candidates must file nomination papers with the election department by Tuesday, July 29 at 5 p.m.

The deadline to register to vote for the preliminary election is Saturday, Sept. 6 by 5 p.m. The deadline to register to vote for the general election is Saturday, Oct. 25 at 5 p.m.

In the event of a close election, the last day for a candidate to file for a recount for the preliminary election is Monday, Sept. 22. The last day to file for a recount for the general election is Friday, Nov. 14.

Councillor-at-Large Anthony Zambuto said that as a long-time backer of the Suffolk Downs project, he finds himself in a tough position relative to the tax break and the funding of the new high school.

"I am worried about the fiscal health of the city, and I'm sure you are, too," Zambuto told the mayor. "I see a problem down the road here and we are at a crossroads and I'm not sure how we deal with this."

Keefe noted that the TIE is a one-time deal for the Portico high-rise project and would not be part of

engineering for the project which could total up to \$20 million in savings. He added that the project's contractor has also brought recent school building projects in under budget without touching contingency funding.

The council approved Jaramillo's motion to ask the mayor to ask for additional money from HYM in return for the tax breaks, but some councillors said they were wary to show their hand by putting a dollar figure to the request.

"What this motion might do is send a message to the developer that we're not too happy about these terms and it might open the door for further negotiations," said Kelley.

Keefe said he has heard the concerns of the council and understands its wishes.

"We'll go back to the table and continue to negotiate for more in every facet, including the economic facet," said Keefe.



# THE TRAGIC WAR IN VIETNAM ENDED 50 YEARS AGO THIS WEEK

It was 50 years ago this week on April 30, 1975, that the U.S. involvement in the War in Vietnam officially came to an end when the last U.S. military helicopter flew ignominiously from the roof of the U.S. Embassy in Saigon (as the capital of South Vietnam was known at that time, but which is now Ho Chi Minh City, named after the No. Vietnamese leader who once worked as a pastry chef in Boston's Parker House from 1911-13).

For the generations of Americans over the past 50 years who know about the Vietnam War only from their U.S. history classes, the few pages in their textbooks devoted to the war cannot even remotely describe both the upheaval that the war caused in American society at that time and the lasting impacts upon our nation that reverberate today.

More than nine million brave young Americans served during the war, of whom more than 58,000 gave their lives, while another 300,000 were wounded. In addition, there were hundreds of thousands more who suffered the psychological effects from PTSD, as well as the latent toll from Agent Orange (the powerful chemical herbicide that took its name from the orange striping on the barrels in which it was stored) and other weapons used by the U.S. military that resulted in later-life cancers and birth defects that affected tens of thousands of our soldiers and Vietnamese civilians.

For those of us who came of age during that era from 1965-75, we recall watching the war brought into our living rooms every night on the national TV news shows with reports from correspondents who were embedded with our military as they went on their infamous search and destroy missions that transformed the beautiful and placid Vietnamese countryside into a living hell for the Vietnamese people.

We recall reading with stunned disbelief in Time Magazine (Time was delivered to our home every week) about the massacre by U.S. Army American soldiers, led by Lieutenant William Calley, at the Vietnamese village of My Lai, in which hundreds of civilians, almost all of them women, children, and elderly men, were raped and murdered.

We remember the "body count" of "enemy soldiers" that was issued daily by U.S. military officials, under the direction of General William Westmoreland, which was so huge that it seemed that it would be only a matter of time before the small country of No. Vietnam would run out of soldiers.

Only later did we learn that these so-called body counts included hundreds of thousands of So. Vietnamese civilians who were killed by our bombs and assaults on their villages.

Then in 1971 came the publication of the Pentagon Papers, which had been leaked by Daniel Ellsberg to the New York Times, which detailed the secret history of the war (compiled by the Pentagon itself). The Pentagon Papers spelled out how President Lyndon Johnson and previous administrations had systematically lied both to the American people and Congress about what was going on in Viet-The Pentagon Papers detailed the covert actions by the U.S. military that involved us ever-deeper into the process of escalation that culminated with the Tonkin Gulf Resolution passed by Congress in August, 1964, that basically gave Johnson carte blanche to send millions of soldiers to Vietnam without Congress ever having issued a Declaration of War. Senator Ernest Gruening of Alaska was one of only two senators to oppose the resolution with words that would become prophetic, saying he was voting against the resolution because "...we are sending our American boys into combat in a war in which we have no business, which is not our war, into which we have been misguidedly drawn, and which is steadily being escalated." Only years later was it revealed that the basis of the Tonkin Gulf Resolution -- the supposed attack on U.S. naval vessels by No. Vietnam in the Tonkin Gulf off the coast of No Vietnam -- was a complete fiction. Moreover, the overall justification for the war was the oft-stated Domino Theory, by which American policy-makers suggested that if one country in Southeast Asia were to fall to the Communists, the others would fall like dominoes and would become vassal states of China and the Soviet / union. But that analysis completely ignored the simple fact that the Vietnam War was a civil war in which the Vietnamese were seeking to throw off their colonial rulers -- the country had been invaded and governed first by the Chinese, then the Japanese, then the French, and then the Americans.

Over the years, FBI Boston has expanded its efforts, eventually sponsoring five JTTFs in its area of responsibility, including the nation's first airport-based JTTF at Logan Airport, a recognition of the region's significance in national security.

JTTFs unite investigators, analysts, linguists, and tactical experts from federal, state, and local agencies to share intelligence and respond to threats. Acting Special Agent in Charge James Crowley emphasized their crucial role in disrupting extremist plots. The FBI Boston Division has a history of significant involvement in counterterrorism, including the investigation of the 9/11 attacks, given that two of the hijacked flights originated from Logan Airport. Boston's JTTF also played a vital role in the investigation following the Boston Marathon bombing in 2013. To report suspicious activity, call 1-800-CALL-FBI (225-5324) or submit a tip online at tips.fbi.gov.

Robert McNamara, who served as Secretary of Defense under Presidents John F. Kennedy and Johnson from 1961-68, and who was one of the chief architects of the American strategy, admitted 40 years later that American involvement in the war in Vietnam was "wrong."

In the aftermath of the war, trust in our government reached an all-time low and has continued to plummet ever since, even among those of us who generally believe in the values of our democracy and the need for a strong national government.

The War in Vietnam was a tragedy for everyone who even remotely was touched by it. It was a war built on lies on top of lies -- and its legacy is a large part of the reason why Americans have such distrust of our government and institutions today. All walking tours are available for group tours year-round by appointment and are perfect for tourist groups, family outings,

# First Congregational Church of Revere Food Pantry hits the pavement for Project Bread's 57<sup>th</sup> Walk for Hunger

On May 4, First Congregational Church of Revere will step up for Project Bread's 57th Walk for Hunger. For the 7th consecutive year, the Revere-based nonprofit will raise money to support statewide food security through the Commonwealth Program. The Commonwealth gives organizations addressing food insecurity 60% of all funds they raise to support their own hunger relief programs, with the remaining 40% applied to Project Bread's statewide food security efforts.

The Walk for Hunger, Project Bread's flagship community fundraiser, brings together a diverse community dedicated to ensuring food security across the state. The celebration is set for Sunday, May 4 at 9 a.m. and will feature family-friendly activities, food and entertainment. This year's Walk will remain an accessible route on the fully paved sidewalks, allowing people with mobility devices, young children, and other needs to participate. ASL interpreters and multilingual staff will be present throughout the event.

"It is becoming more and more difficult for people to afford enough to eat," says Erin McAleer, President & CEO of Project Bread. "One in 5 families with kids are worried about where their next meal will come from. The Walk for Hunger is our opportunity to make an immediate difference in the lives of thousands of our neighbors. Organizations like First Congregational Church of Revere Food Pantry are what make The Walk for Hunger such a powerful event. Together, as a community, we're making sure people can access food with dignity and choice each day."

The First Congregational Church of Revere Food Pantry works to provide emergency food to food insecure families in their community, providing two bags of non-perishable and perishable food per month to each family. In the city of Revere, 40% of households reported that they were facing food insecurity to the Greater Boston Food Bank. In 2024, the First Congregational Church of Revere Food Pantry served more than 3,000 unique families and had nearly 14,500 visits. The organization currently serves up to 350 families each week during the two hours the pantry is open on Wednesdays. Funds raised from the 57th annual Walk for Hunger will go toward the pantry's purchasing of food from the Greater Boston Food Bank and other sources, specifically focusing on the culturally preferred food items for residents of the city of Revere. This year, the team has a goal to raise \$2,500 for the cause

Giardina, Operations Manager for the First Congregational Church of Revere Food Pantry. "In 1989, we applied for the first grant to request funding from the Walk for Hunger, receiving \$1,000. We continued to receive funds from the Walk for Hunger grant program until 2019. That same year, we participated in the pilot Commonwealth Program and have participated in this program ever since. This funding helps us to purchase much needed supplies for the many food insufficient families in our community. As federal programs are reduced or eliminated, the need is greater than ever."

Beginning in 1969 as the first pledge walk in the nation, money raised from The Walk for Hunger is critical to fund systemic change for hunger relief. Project Bread launched the joint-fundraising Commonwealth Program in 2019. In 2024, 39 nonprofits raised more than \$228,000 to support their own programs for statewide food security.



# License Comm. approves license for cornhole tourney; revokes Antonia's license

The Revere License Commission held its regular monthly meeting on Wednesday, April 16, in the City Council Chamber. Daniel Occena, who chaired the meeting in the absence of chair Robert Selevitch, and Liliana Minroy were on hand for the session.

The first item on the agenda was a request by Rice Passions World Corp. d/b/a Rice Passions, 163 Squire Road (Guillermo Rodriguez, manager), for the transfer of an All Alcohol Restaurant License from Rice Passions, Inc.

A consultant representing the applicant told the commissioners that the restaurant next door, Que Arepa!, is purchasing the present Rice Passions restaurant, which serves Thai food, and that all operations under the new owner will remain the same, including the operating hours of Sunday 12 p.m.-9:30 p.m. and Tuesday-Saturday 11:30 a.m.-9:30 p.m., seating for 50, and entertainment of widescreen cable TV and radio.

There were no opponents and the commission approved the transfer.

Next up was an applica-

tion from 388 Broadway, LLC, d/b/a Volare, 388 Broadway (Cecilia Maya, manager) for a 1-day change of opening hours to open at 5 a.m. for an Easter breakfast for a church group.

Ms. Maya explained that this was a one-time request to open early on Easter Sunday morning in order to host an Easter Brunch for a church group of about 40 adults and children with no alcohol to be served.

Ward 5 City Councillor Angela Guarino-Sawaya spoke in favor of the application. "I am very happy with the way this establishment has presented itself and am in favor of anything we can do to help them," Guarino-Sawaya said.

There were no opponents and the commission approved the request.

The third item was a request from Colwen Management, Inc., Staybridge Suites/Holiday Inn Express-Revere, 245 Revere Beach Parkway (Cynthia Baysic, manager) for a change of manager from Catherine Cucchiello.

Ms. Baysic appeared along with attorney Jon D. Aieta of the Boston law firm McDermott, Miller,

Ms. Pomponio and Erica Porzio, the Executive Director of the Chamber of Commerce, presented the application to the commission.

"This will be our second annual Cornhole Tournament with the support and partnership of the city's Parks and Rec. Dept," said Ms. Porzio, who informed the commission that Murray's Tavern will be managing the beer and wine garden and will be issuing bracelets and checking IDs.

"John Murray is very well-aware of the rules for these events," noted Occena. "You guys ran a good event last year and I'm confident you will do so again."

There were no opponents and the commission unanimously approved the application.

The commission con-

ducted two hearings. The first was a continuation of the hearing from March pertaining to MFRP Corp., d/b/a The Squire, 604 Squire Road (Peter DePesa, manager) "into the failure to provide adequate security, resulting in multiple violent attacks on patrons." The incidents in question

had occurred in January and involved stabbings in the Squire's parking lot which had required emergency intervention by Revere's first responders.

Mr. DePesa had told the commission in March that the Squire would be undertaking its own security measures, rather than using police details, and he explained to the commissioners what the new security measures would entail.

"We've updated our security systems through the recommendations of a security company we've hired," said DePesa. "We've added AI technology with thermal cameras in the parking lot which nightclubs are using across America that have reduced crime by 60 percent. The technology picks up people who are moving and makes them aware they are being video recorded.

"We've also added security personnel both inside and outside the building and added four more cameras by the front door to monitor the parking lot," DePesa added. "In addition, all of the staff has been retrained in crowd control."

However, Occena said the commission wanted more details about the security plan. "We were looking for a plan, such as the closing hours and the number of security personnel you've added," said Occena. "We want to see an actual plan. Everything you're doing is great, but I would ask that we continue this hearing to May in order for you to spell out exactly what your security plan will be."

"I understand what you're looking for and that will not be a problem," DePesa responded.

The commission then voted to continue the hearing until the May meeting, with Occena adding that DePesa also must present a payment plan for the large outstanding balance that the Squire owes to the city for past police details.

The next hearing pertained to Four Partners, Inc., d/b/a Antonia's at the Beach, 492 Revere Beach Boulevard, "into the unauthorized transfer of control of the license; no approved license manager; resident noise complaints; and unpaid license fees."

"You've been in front of this commission repeatedly since 2019," Occena told Fernando Loiaiza, the owner of Antonia's. "There have been a host of issues surrounding the restaurant and the commission has given you a significant amount of grace about these issues."

Loiaiza said he has hired a lawyer to try to resolve those issues, which also has involved the ABCC and the State Department of Revenue because of outstanding taxes, which has prevented Antonia's from receiving a Certificate of Good Standing.

However, Wayne Cintolo, the landlord of the building in which Antonia's is located, told the commissioners that Antonia's is being evicted by the end of the month and that the new tenant will be Floramo's, thereby essentially rendering the hearing as a moot issue.

Occena then recited the litany of the violations since 2019, noting that Antonia's still does not have an approved manager. "Given the chronic and noncompliant statutory violations, as well as the significant history of non-cooperation, the revocation of the license in its entirety is justified and necessary to maintain compliance with the state laws and regulations and to uphold the integrity and proper management of the licensed establishments in the City of Revere."

Occena then made a motion to revoke the license in its entirety to be effective immediately, with Monroy voting in favor.

The commission next noted that it had received a communication from the Alcoholic Beverages Control Commission (ABCC)

regarding changes to the forms of identification which licensees may reasonably rely on. They now include: 1) a valid driver's license issued by another state; and 2) a global entry card issued by United States Customs and Border Protection.

The commission concluded the meeting by renewing the following licenses for the coming year:





Kalliavas and Reed both had three hits to pace the 11-hit Revere attack. Zizi K. also stole three bases on the day.









City residents are mourning the passing of Mrs. Jennie Colella, 82, mother of Mayor George V. Colella and wife of the late, retired Fire Capt. Albert "Bucky" Colella, who was a firefighter for 40 years until his death in 1969. She was a native and lifelong resident of the city.

## 50 years ago April 30, 1975

City Councilor Edward O'Hara has demanded that the members of the Licensing Board and a representative from the ABCC meet with the council concerning charges made by O'Hara that the Licensing Board has failed to comply with state guidelines for the past three years.

Retired Army Major General Thomas A. Lane, a native of Revere who attended the Lincoln School and served as an altar boy at St. Anthony's Church, passed away this week at the age of 68 in Washington, D.C. Lane graduated third in his class at West Point in 1928 after receiving an engineering degree from MIT. He was named in 1958 to the three-member board of commissioners that operates Washington, D.C.

### 60 years ago May 6, 1965

Acting City Manager Joseph McChristal painted a dark picture of the city's finances, with some coaching from City Councilor Peter Jordan. McChristal said the council must accept legislation filed by State Senator Harry Della Russo that will allow the city to borrow \$427,148 to pay bills that were incurred in 1963. Councillors George V. Colella and Ray Carey both voted against the measure, saying that phony bills had been added to the total.

City Councillor George V. Colella labeled as "criminal" the delay by the School Dept. and its architect for not having filed plans with the State School Building Assistance Committee for the reconstruction of the Lincoln School. A mothers' group last week laid a wreath at the school in a silent protest to mark the two-year anniversary of the destruction of the school by a fire.

The War Dept. brought the sad news to Mrs. Marie Bovd of 84 Beachland Ave. that two of her sons were killed in action in Europe. M/Sgt. Phillip F. Boyd, 28, was killed in Belgium on April 12 and Sgt. William S. Boyd was killed in Germany on March 29. A third brother, George, who is Phillip's twin, is serving in Italy.

Two Revere soldiers who have been held captive by the Germans for some time have been liberated by Allied forces. Pvt. Harry L. Peckham, 29, of 41 Agawam St., who had been reported as missing in action in Italy as of February 27, 1944, was freed in the village of Thurheim, Germany, south of the Danube. Pfc. Roland Bergeron, husband of Mrs. Rita King of 48 Bradstreet Ave., who was reported missing in action December 16, also was liberated in Germany. Both men are reported to be in good condition.



# Ambrosino proposes an unprecedented \$105 million budget

Increasing by \$5 million over last year, this year's proposed city budget topped the \$100 million mark for the first time in the city's history, resting at \$105,210,192.

Mayor Tom Ambrosino released his budget proposal on Friday from

the office of City Auditor Laurie Giardella. City government increased by \$4.3 million and the group health insurance and rubbish schools - which are funded in partnership with the state - increased by \$1.2 million. All combined, the budget increased by \$5,648,203.

"It's probably a greater percentage increase from what it has been in the past, but I don't know how

you can argue against that when certain non-discretionary costs like are increasing so much," said Ambrosino. "This year was a good year for those; next year may not be. You're always holding your breath on those costs."

For those outside of government circles, namely the residential and

commercial taxpayers of the city, the question is just how much the proposed budget will cost - funding comes from their pockets in the form of taxes. More than likely, there will be another property tax increase next year, and water and sewer rates are slated for a 14 per-

A mysterious illness has gripped the dogs at the Wonderland Greyhound Track over the past week and thrust the raceway into the national spotlight for all the wrong reasons.






