# **City council** subcommittee begins FY2026 **budget hearings**

Mayor Patrick Keefe and city finance director Richard Viscay kicked off the Fiscal Year 2026 city council ways and means committee budget hearings last Thursday morning.

Viscay laid out the revenue and expenses for a proposed balanced budget of just over \$309 million, as well as touched on future financial obligations, such as the funding of the new high school project. The budget presentation included the school and municipal government budgets, debt service, and other expenses as well as revolving accounts for water, sewer, and solid waste disposal.

While Viscay and Keefe noted that the budget will be balanced, the administration will be proposing some increased fees, as well as increases to the water and sewer rates, to the city council in the near future.

During the budget presentation, Viscay also noted that the city's biggest longterm expense, the new high school, recently saw a \$10 million cut to its budget. The

# Six pickleball courts to replace tennis courts at **Gibson Park makeover**

The Revere Conservation Commission (ConsCom) held its regular monthly meeting last Tuesday evening, June 3, in the City Council Chambers. Chair Nicholas Rudolph and fellow members Brian Averback, Joseph LaValle, Thomas Carleton, and Wilson Correa were on hand for the session.

The first matter taken up was a request for the issuance of a Notice of Intent (NOI) for the demolition of existing structures and construction of a multi-level garage at the property identified as "Rear of Squire Rd.", which is located across from 320 Charger St.

The matter came before the ConsComm last month and a full hearing was held, but the commission was unable to issue an NOI because the Mass. DEP had not issued a File Number, which is a statutory requirement before a local conservation commission can issue an NOI.

However, the state has since issued the File Number. Rick Salvo with Engineering Alliance presented the application on behalf of Steve Caruso and R&S Realty Trust. He noted that the only comment made by the state was that the structure, half of which sits in the 100-year flood plain, should have flow-through openings. Salvo said that flow-through openings have been added to the engineering plans in excess of what is normally required.

The land consists of about 2-and-1/2 acres and contains two steel buildings and presently operates as a contractor's yard. The property abuts a number of wetlands resource areas, including Rumney Marsh. Portions of

The area at one time had been intended to be the site of the connector for the Northeast Expressway, a long-dead part of the state's highway system that was formulated in the 1960s but was killed in the 1970s by the administration of Gov. Francis Sargent and never came to fruition.


There were no opponents and the commissioners voted unanimously to issue the NOI.

Next up was a request for an NOI from the City of Revere for the city's overhaul of Gibson Park. The city had made a presentation of the project at last month's meeting, but the ConsComm could not issue the NOI because the Mass. Environmental Protection Agency (MEPA) had not issued a Final Environmental Impact Report (FEIR) Certificate. However, MEPA issued the FEIR Cert. on May 19, including a Determination of Public Benefit.

Claire Hoogeboom, a Wetlands Scientist with LEC Environmental Consultants, Inc., who presented the application last month, once again was on hand for this meeting.

Hoogeboom noted that she had sent an email addressing some of the questions raised by commissioners, including a response to LaValle's query about the number and type of plantings to be installed at the new park. Hoogeboom said 17 trees will be removed, (10 of which are native), but there will be 33 new trees planted for a net increase of 23 native trees.

She also stated that six pickleball courts will replace the initially-proposed two tennis courts. Hoogeboom had said at last month's meeting that the inclusion of pickleball courts (an issue that also had been raised by LaValle ) would

# S&P Global Ratings affirms City of Revere's AA Underlying **Rating and Stable Outlook**

Mayor Patrick M. Keefe Jr. and City of Revere Chief Financial Officer/City Auditor/Budget Director, Richard Viscay, announced that S&P Global Ratings, a municipal bond credit rating agency, has affirmed the City's underlying rating of 'AA'. The outlook is stable. S&P also assigned the SP-1+, the highest rating attainable, to the City's pending issuance of \$75,000,000 General Obligation Bond Anticipation Notes to be dated Wednesday, June 25.

Mayor Keefe commented, "I'm confident in our money-management practices, and I am appreciative of the work of our financial team. We spent a lot of time crafting a fiscally responsible budget that ensured our strength for years to come: I'm proud that we delivered."

"Maintaining a strong bond rating will allow the city to borrow money as efficiently as possible," commented Viscay. This "AA" bond rating represents the City's strong

capacity to meet its financial commitments, including the development of the new Revere High School, the new McMackin Field, and the McKinley School renovation project. The rating agency cited the City's above-average resident income, rapid tax base growth highlighted by development at the Suffolk Downs site, detailed long-term financial planning, and maintenance of healthy reserves as positive credit factors.

Note proceeds will be used to begin the financing of the City's local share of its new high school construction project.

The bids for the Notes will be accepted on Tuesday, June 10, 2025, at the offices of the City's Municipal Advisor, Hilltop Securities Inc., at 54 Canal Street in Boston, Massachusetts.

high school building committee recently approved a cut in the school building budget from \$493 million to \$483 million, with about half of the total cost of the project reimbursable through the Massachusetts School Building Authority (MSBA).

For the current budget, Viscay noted that one of the biggest drivers for the budget is a 17 percent increase in health insurance costs.

"Before you is а \$309,608,179 budget, revenues equal expenses, the budget is balanced," said Viscay. "The mayor and the departments, we had a pretty rough year meeting with departments and getting expenses in line with revenues. We believe it is a responsible budget with realistic revenue estimates based upon currently known information, and on behalf of the mayor, I would strongly recommend you pass the budget as submitted."

The largest chunk of the operating budget is the school budget, which is about \$131.5 million. The school transportation budget is \$9.7 million, a five percent increase over the current year.

"We do have a fund that we set up a couple years back with the council and the school committee that is for reimbursements of transportation costs via the state, and that's for special education students and homeless transportation," said Viscay. "That money was building up a surplus in the fund and for Fiscal Year 2026, we are using some of that balance to offset the cost of student transportation."

Viscay said there will be longer-term strategies discussed by the city and the schools about overall student transportation.

"Minimum net school spending does not include transportation, it is a cost absorbed by the city, and this particular year, with the rising costs, it was pretty much unsustainable at the figure that was being asked, so we had to dip into our special revenue accounts to offset the costs," said Viscay. "There are going to be some long-term strategies talked through with regards to bussing and how that works with regard to student lottery and high school transportation, etc."

The biggest department budget on the municipal side of the ledger is public safety, with that figure coming in at just under \$34 million. That budget includes the police, fire, parking, and inspectional services departments, as well as the 911 operations.

"Uniformed police officers will be budgeted at 112, uniformed firefighters budgeted at 119," said Viscay. "We did see a regional 911 budget decrease due to some increases in grant revenues that offset the expenses."

Viscay also highlighted the revenues that will pay for the budget, with the two biggest chunks coming from property taxes and state aid. The majority of the \$123.6 million in state aid, about \$107 million, helps fund the schools through Chapter 70.

As a result of new growth and the increase in the levy limit under Proposition  $2-\frac{1}{2}$ , Viscay said the estimated property tax revenues for FY26 will be about \$126.3 million. Local receipts through excise taxes and other city fees are expected to go up by 5 percent to \$23.5 million, Viscay said.

The water and sewer and other enterprise revenues are slated at \$36.3 million, with that budget being supported by the water and sewer rates. However, Viscay said the city will be asking for a 9.7 percent increase in water and sewer rates to help cover those costs.

"I just wanted to thank CFO Viscay for presenting this today, and as mentioned, we are very confident in what we have put in front of you," said Keefe. "I am excited to see our department heads perform; I know that this is a great opportunity for them to explain their roles and what it takes to run their departments throughout the entire year. As mentioned, we put out a very responsible budget; the real challenges are all fixed costs, things like insurance and we all know that those are things that are really out of our control.

"We did a very good job with our department heads to make sure that our controllables were very much

kept in control," the mayor continued. "You can see that in a number of those departments there were actually reductions in expenses, which is really abnormal over the last dozen years because we had to offset the uncontrollables. But outside of that, we are very confident in what we have put in front of you and we look forward to your conversation and communication."

The ways and means committee's review of individual department budgets was expected to continue this week, with the school department slated to appear before the committee Tuesday, before the full council takes up approval of the FY26 budget later this month.

Ward 4 Councillor Paul Argenzio thanked the school building committee, the mayor, and Viscay for the recent vote to cut the high school project budget by \$10 million.

"I agree with my colleague to the right's comment about the \$10 million cut, but without being derogatory, I would say that is a good first step, not nearly where we need to go," said Councillor-at-Large Anthony Zambuto. "I'm still, you know where I stand about this, and I wouldn't want to be in your position right now coming up and telling us how we are going to afford it, but that is a whole other story. So \$10 million is a good first step, but it's only a drop in the bucket."


O'Hara believes his leadership makes him the perfect fit for the position., "I'm running for Trustee because I believe it's time for a fresh

# **OUR HEALTHCARE SYSTEM** IS ON THE CRITICAL LIST

Anyone who has been to a hospital emergency room lately has seen firsthand the health care crisis that we are facing in this country.

ERs routinely are filled beyond capacity, with patients lying on their hospital beds in corridors while they wait for a room to open up -- sometimes for days.

And during the respiratory illness season, when seniors and young children flood the ERs, our overcrowded hospitals resemble something out of a developing country, rather than what is supposedly the most advanced healthcare system in the world.

The statistics tell a bleak tale: The U.S. has less than three hospital beds per 1,000 residents, while the European Union has more than five and Japan almost 13. On average, 75% of America's hospital beds are occupied on any given day, 11 points higher than in 2019.

In Boston's hospitals, the daily occupancy rate reportedly is 86%. According to some experts, the system becomes overloaded when the occupancy rate reaches 85%.

We grew up in a time (the 1960s-70s) when just about every city and town in Massachusetts had its own hospital, institutions that were the pride of their communities. But starting in the 1970s, thanks to a combination of declining reimbursement rates from state and federal governments and surging costs for modern-day equipment (such as MRI machines) and treatment, community hospitals one-by-one began to disappear, leaving us in our present predicament of too few hospitals serving too many people.

Another looming crisis in our healthcare system is a shortage of doctors. It is estimated that there are 1,010,892 active physicians in the U.S., of whom 851,282 are direct patient care physicians. (Physicians who do research or are administrators represent the difference between the two numbers.)

Anyone whose primary care doctor recently has retired knows how difficult it is today to find a new doctor. But this shortfall is only going to get worse over the next decade. By 2037, the United States is expected to face a shortage of 187,130 physicians, including 87,150 primary care physicians.

It is estimated that there already are 75 million Americans who live in areas where it is difficult to get access to primary care -- and the ratio of primary care providers is projected to decline to 76.8 per 100,000 people by 2037, from 81.6 per 100,000 in 2022.

To make matters worse, the present -- and future -- shortfalls in hospital beds and doctors do not take into account the effects of the policies in Washington that are threatening to cut back on Medicaid eligibility, to reduce Medicare reimbursements even further, to limit the loan programs available to medical school students, and to restrict (if not prevent) foreign-born doctors from coming into this country.

In short, all of the ingredients are in place to create the Perfect Storm for a healthcare crisis in our nation.

This story isn't just about a hawk—it's about listening to your instincts, acting with heart, and doing the right thing even when no one's watching. Joanne gave that hawk a chance. And in doing so, she reminded all of us what real compassion looks like.

# THERE MUST BE ZERO TOLERANCE FOR VIOLENT PROTESTS

We completely understand the anger and frustration on the part of many Americans with the manner in which members of immigrant communities are being arrested and deported not only without any semblance of due process of law, but also in a deliberately cruel and inhumane manner.

But the urge to respond with acts of lawlessness, including throwing rocks and dangerous objects at police officers and other law enforcement personnel, burning vehicles in the street, smashing windows of businesses, and defacing property, is not the answer.

The First Amendment of the Constitution guarantees the right "of the people peaceably to assemble" -- and we would emphasize the word "peaceably."

However, the protests that we have seen the past few days in Los Angeles have not been peaceful. They are creating a dangerous situation for everybody concerned -- and it is inevitable that if the protesters escalate their actions, the outcome will be a tragedy.

Those who are partaking in the protests should keep in mind the words of Winston Churchill during the height of WWII when England was facing a threat to its very existence:

"You do your worst and we will do our best."

# FINAL REMARKS TO CLASS OF 2025

# **Chris Bowen** Revere High School Principal

Graduates: As you enter your next chapter—one that invites you to serve, to grow, and to lead us all into the future - I ask you to reflect tonight on one simple idea that I hope you carry with you: The world doesn't need people who agree on everything. The world needs people who can lead across our differences—with humility, with courage, with compassion and with love.

Your time in Revere Schools has given you opportunities to practice this kind of leadership every day, in ways you might not realize. In our school, in this community, you've encountered people whose stories, whose languages, and whose beliefs are not your own. And instead of turning inward, most of you have chosen to build a habit of listening to each other, learning from each other, befriending each other and advocating for each other.

These simple, daily habits are necessary conditions for the real leadership skills that you'll carry with you into the future.

True leadership isn't about status, or spotlight or viral sound bites —it's about showing up. It's about finding opportunities for solidarity with people who are different. It's about lifting others as you rise. It's about doing the slow, and often unseen work of building trust, behind the scenes, across lines of

> And let's be honest: you are graduating into a complicated world. One where people argue more than they listen. Where headlines are filled with conflict—between nations, within neighborhoods, and, yes, even within our own school.

Here in Revere, you live amidst differences every day—where some here tonight are starting over in a new country, seeking safety and opportunity as folks have done in Revere for generations, while others are adjusting to a community that is changing faster than they expected it ever would.

In today's world, we all face immense pressure to paint as villains those on the other side of issues - issues that are wildly more complex and nuanced than the warriors of "cancel culture" would have us believe. Yet you all have shown us that it's possible to see through the "other" to see the dignity in the person on the other side - even when we disagree, even when their lived experience feels most unfamiliar to us or when they act in ways we cannot comprehend.

You've shown us that being strong doesn't mean being loud—it means being steady and grounded. Being right doesn't mean refusing to change—it means being open to transition. Leading across

difference doesn't mean simply making room for others to have a seat at the table. It means setting the table with the relationships you intentionally build to make everyone - especially those at the margins - feel they belong.

Leading across difference is not a solo act. It's the practice of walking with others to change the systems that too often exclude. Sometimes this walk is more like a march that the times require you direct from the front lines. But more often than not, this walk is a dance that you're choreographing - quietly, purposefully, steadily - from the side. It's up to you to decide when it's the right time to march and when it's the


Coots also acknowledged the contributions of assistant coaches Jason Torrey and Justin Pezzuto. "This wouldn't have been possible without them," Coots said.







# LARGE CROWD ATTENDS CAMPAIGN RECEPTION FOR REP. JESSICA GIANNINO







As if it weren't enough that he had beaten death after a horrendous car accident two years ago, now Angrisano - whose saxophone is still seemingly attached to his person - is playing music gigs on the eve of his 100th birthday.

Just last Feb. 4, Angrisano turned 100 and even played extensively for the large crowd at his birthday party held at the Newburyport Elks Club.

One would think that Revere's population is growing.

What with a seemingly everincreasing number of vehicles swarming the streets, along with several new homes and a growing school-age population, most would think that the number of people in our fair city is on the rise.

However, according to the U.S. Census Bureau, Revere's population is down by 2.4 percent since 2000. Last week, the Census Bureau released its population estimates for the calendar year 2004 and Revere's official population decreased from 47,315 in 2000, to the new number of 46,169 - a swing of 1,146 residents.

Admittedly, the population estimates aren't without a margin of error. While the 2000 Census was done with door-to-door visits and a

tion is in line with almost every community around Revere and almost all communities within Massachusetts. Lynn was the only city near Revere that increased in population, and its increase was only a few hundred people. The areas of the country showing the greatest population increases were Florida, the Southwest and California. Phoenix, Ariz. actually increased by 30,000 residents since 2000 and has become the sixth largest city in the nation, just behind Philadelphia.

Many locally believe Revere's decrease may not be entirely accurate - mostly due to increased immigration and a large amount of residents who aren't unaccounted.

Mayor Tom Ambrosino has recently predicted that by the next complete census, in 2010, Revere's population will be well over the 50,000 mark.

Only time will tell.




# Malden's Gina Hayes named Massachusetts Crossing Guard of the Year
