#### CLARK VOTES TO RAISE MINIMUM WAGE RATE

Vice Chair of the Democratic Caucus Katherine Clark joined the U.S. House of Representatives in passing H.R. 582, the Raise The Wage Act, which will increase the federal minimum wage to \$15 an hour by 2025. This is the longest stretch in U.S. history without an increase to the minimum wage and according to the Congressional Budget Office, is estimated to lift 1.3 million workers out of poverty, including 600,000 children.

"For the first time in more than a decade, we voted to raise the minimum wage to \$15 dollar an hour. No one working a full-time job in America time should be living in poverty, yet that is the reality for so many people in our country. I am proud to join my Democratic colleagues to take this strong step to deliver on our For The People agenda and give working men and women across the country a well-deserved raise."

The Raise The Wage Act will:

Increase wages for up to 33 million American workers, according to independent economic analysis from the Eco-

## 34 candidates submit nomination papers to appear on ballot

The deadline for submitting nomination papers for the Revere city election was Tuesday at 5 p.m. and 34 candidates will be on the ballot.

Two of those candidates, Mayor Brian Arrigo and Councillor-at-Large Dan Rizzo, will vie for the position of mayor in a rematch of their closely fought 2015 election.

A third potential candidate, Cheryl Whittredge had

pulled nomination papers, but Whittredge did not submit papers for certification as of the 5 p.m. deadline. As a result, there will be no preliminary election in the mayor's race and Arrigo and Rizzo will proceed to the general election to be held on Tuesday, Nov. 5, 2019.

The biggest election day contest will be in the councillor-at-large race where 13 candidates will be contending for the five at-large seats.

There will be an at-large preliminary election on Tuesday, Sept. 10.

Four at-large incumbents, Jessica Ann Giannino, Steven Morabito, George Rotondo, and Anthony Zambuto are seeking re-election to two-year terms.

Interestingly, well-known resident Richard Ireton made a decision last week to run for an at-large seat and he was successful in securing the necessary signatures to earn a

spot on the ballot.

School Committee member Gerry Visconti will be seeking an at-large seat while retired Fire Lt. John Correggio will be seeking a return to the City Council. Also running for an at-large seat are Robert Capoccia, Dimple Rana, Wayne D. Rose, Philip Joseph Russo, Kevin Sanchez, and Brian Vesce.

There will be one preliminary election in the ward races. Nicholas Moulaison Sr.,

Francis C. Sarro, and Ricky Serino are candidates for the Ward 6 seat currently held by Charles Patch, who decided to not seek re-election. The top two finishers in the Sept. 10 preliminary will advance to the Nov. 5 general election.

Two incumbent ward councillors will face competition in the general election. Ward 2 Councillor Ira Novoselsky and candidate Robert E. Bent

### Remembering community legend Mickey "Say No To Drugs" Casoli

The city of Revere is mourning the loss of one of its most legendary residents, Michael "Mickey" Casoli, who died on July 20, 2019 following a brief illness.

A retired Revere Police detective, Mickey was known for his involvement in many community activities and projects. But most notable in a lifetime of achievement that included his decorated service in the U.S. Army during World War II, Mickey was devoted to advancing his "Say No To Drugs" campaign, frequently speaking out to youths about the harmful effects of using illegal drugs.

That message ultimately became his middle name as the former Revere High School standout athlete was always introduced at local events as Mickey "Say No To Drugs" Casoli.

Taking pride in his lifelong dedication to physical fitness, Mickey possessed a firm handshake along with a

distinctive voice, engaging smile and warm personality, but even stronger that was his loyalty to friends and associates. If Mickey was in your corner, he was always in your corner.

Local officials remember Mickey Casoli

"We have lost one of the city's staunchest advocates and most colorful personalities," said Mayor Brian Arrigo. "I've heard a lot of people refer to Mickey Casoli as a 'legend' in this city, and that is quite accurate."

"Mickey devoted his life to law enforcement, promoted athletics, and tirelessly led the fight against the scourge of illegal drugs in our community and in our culture," noted Arrigo. "He touched thousands of lives through his relationship with the City of Revere, and we long remember his gravelly voice and his plea, 'Say No To Drugs.'" Mickey Casoli always fought for the good about the City of Revere, and

personified our resolute character. We have lost a friend, but we are a better community thanks to that friendship."

Councillor-at-Large Dan Rizzo never missed one of Mickey Casoli's "Say No To Drugs" addresses to the Revere High football team that were held at a Labor Day football practice each year.

"Mickey gave so much to our community," said Rizzo. "I will always remember his hard work and dedication to the children of our community for decades and trying to set them on the right road and lead them to a successful life. He was a guy who was committed to serving our community as a true professional and he served his country admirably. "Mickey's primary focus was on young people and doing whatever he could to help them lead healthy and successful lives," added Rizzo. "He's going to be missed and his absence will be felt as time goes along."

## Close to one million visitors are expected at Sand Sculpting Festival this weekend

The Sand Sculpting Festival on Revere Beach that just keeps growing every year is expected to attract almost one million visitors over the three day-long event under predicted perfect summer skies.

This year's Festival is set for July 26-28 and will be out of this world, as the 2019 Revere Beach Partnership's (RBP) 16th International Sand Sculpting Festival celebrates the 50th landing of Apollo 11 on the moon.

"The International Sand Sculpting Festival shines a bright light on our country's first public beach" said Mayor Brian Arrigo. "We can't wait to showcase all our city has to offer and welcome people from all over the world to this summer tradition."

America's First Beach is an appropriate landing pad for the moon's first step, everything to the moon and back will be carved out of finely tuned, crushed granite sand trucked in from Hudson, N.H. which was delivered to the beach last week.

A Florida company called Sanding Ovations is the sand sculpture organizer, with Meredith Corson-Doubleday and her husband Dan at the helm, with lots of other master sculptors from around the world pitching in. It was Dan Doubleday who developed the sand sculpting technique that is used today.

"A key component is the sand," he said adding, "regular beach sand wouldn't work because of the ocean's

movement over the grain. The grains can't hold together because they are little spheres. The crushed granite under a microscope are tiny little rods grabbing on to each other."

RBP is also introducing an amazing display of drones Friday night to dazzle the crowds. The Drone Light Show Company of California will put on a show at the main stage at dusk as part of a small pyrotechnics show. Zipping around will be 150 drones with laser lights timed

to music from the 1960s for 15 minutes.

"The show is based on the moon landing," said Adam Beniot, the RBP events coordinator.

"This year's theme is the 50th anniversary of the moon landing. I can't wait to see what our master sculptors come up with," said John Hamel, a director on the Revere Beach Partnership Board.

"There will also be a montage in the main sculpture showing John F. Kennedy,

Walter Cronkite and others who were there," Beniot said.

The actual date of the moon landing was July 20, 1969.

Get ready to also see the premier sand-sculpture featuring a family watching the moon landing on television, the Apollo rockets and the lunar lander, and special topping of the sculpture with the astronauts planting flags.

No doubt astronauts Neil Armstrong, "One small step for man one giant leap for mankind," Buzz Aldrin and Michael Collins will be featured throughout festival.

Winners of the master sculptures will be announced at 2:30 p.m. Saturday afternoon.

The amateur competition starts on Sunday there will be a live demonstration from a master sculptor. Other master sculptors will also offer tips as the amateur competition goes on. The top three amateur teams out of 30 take home part of a pool prize valued at up to \$2,000.

## Arrigo says City is ready for weekend's festival

Mayor Brian Arrigo today announced City preparations ahead of the 16th Annual International Sand Sculpting Festival, taking place at Revere Beach July 26-28. An additional city investment of \$150,000 in free cash has been dedicated to improve community programming, and city officials have been working closely with state and local partners on a coordinated traffic management and event plan.

"The International Sand Sculpting Festival is an opportunity to showcase our city

and all it has to offer to the world," said Mayor Arrigo. "We have been working collaboratively with our partners to ensure a comprehensive plan is in place for all to enjoy this annual tradition. As we proudly welcome the crowds to Revere Beach, our top priorities are making sure that visitors are being respectful of our residents, keeping main thoroughfares moving, and minimizing impacts on the community."

Mayor Arrigo and public safety officials are strongly urging the public to use pub-

lic transportation to travel to the festival. Revere Police will have officers assigned to traffic posts to facilitate traffic and keep key intersections, including Mahoney Circle, Revere Street and North Shore Road, open. There is very limited parking available for the event at the Wonderland parking lot. Drivers should seek alternate routes to 1A when traveling to other destinations.

Revere's Mobile City Hall will also make its debut at the Festival this weekend as an additional resource for residents.

and adjacent residential uses to enable the construction of a four story, 18 unit residential apartments and two commercial on Lots A and B at 177 Shirley Ave.

will be on the November ballot.

Ward 5 Councillor John Powers and candidate Eric Lampedecchio will meet in a rematch of their 2017 race for the seat.

Ward 1 Councillor Joanne McKenna, Ward 3 Councillor Arthur Guinasso, the current president of the City Council, and Ward 4 Councillor Patrick Keefe Jr. are unopposed in their bids for re-election as of Tuesday's deadline for nomination papers.

There are nine candidates for the six elected seats on the Revere School Committee. Five incumbents, Stacey Bronsdon-Rizzo, Michael Ferrante, Susan Gravellese, Frederick Sannella, and Carol Tye, will be seeking re-election. The other candidates are Anthony D'Ambrosio, John Kingston, Albert J. Terminiello Jr., and Michael Toto.

D'Ambrosio, 23, is the son of Attorney Gerry Ambrosio, who served six years on the Revere School Committee.

"I am incredibly excited to announce my candidacy for the School Committee," said Anthony D'Ambrosio, who attended Yale University and the University of Cambridge (England). "It has been a dream of mine to engage in public service in Revere for my entire life, and I'm glad that I finally have the opportunity. The School Committee presents the perfect platform to enact policy that will positively impact the youth of our city. # Revere High School to expand Bring Your Own Device pilot program

Last year Revere High School Principal Dr. Jonathan Perella was getting a lot of feedback from teachers and students that the Google Chrome Books they were assigned were hardly being used.

"Most of our juniors and seniors were not utilizing the ChromeBooks we were making available," said Perella. "They would take one or receive one, bring it home, keep it in their room for the school year and then return it at the end of the year. It was like we were pushing a device on them."

Each student at Revere High is guaranteed a Chrome-Book for things like researching assignments, completing work or papers on Google Docs or Google Classroom and taking standardized tests.

However Perella said most students were more comfortable using their own devices for this work.

So last year Perella and Revere High launched a pilot program dubbed Bring Your Own Device or BYOD among seniors.

The pilot program allowed seniors who wanted to use their own devices for everything except standardized testing where ChromeBooks were still required. Seniors who wanted to continue using ChromeBooks still had the option.

At last week's School Committee meeting Perella said the school will expand the program next school year to include juniors.

"We want to take the success of the BYOD pilot pro-

gram and extend it and bring that concept to the junior class," said Perella. "Juniors and seniors can still take out a chrome book from the Learning Common and we are in the process of creating a system to track what they use it for. But those who want to use their own device they will be able to do so."

Chrome Books however will still be issued to all juniors and seniors during standardized testing when they will be unable to use their own devices.

Perella said all freshman and sophomores will be assigned ChromeBooks and will not take part in the expanded pilot program as of yet.

"It's because in these grades they utilize ChromeBooks in all their classes," said Perella. "Much of the focus of their work is on Google, Google Docs and Google Classroom. All 9th and 10th grades will also be utilizing the Chrome-Books for projects, research and testing."

Perella also said distribution of the ChromeBooks for juniors and seniors who wish to receive one for the school year will be Tuesday, August 20 through Thursday, August 22 at the High School.

"The plan is as of now that prior to school start junior and seniors can come on those days to pick up their Chrome-Book," said Perella.

School committee member Carol Tye congratulated Perella for setting up this program because it gives students the freedom and flexibility to learn in a way they feel most comfortable while enhancing the high school experience.

## OVERUSE OF ANTIBIOTICS THREATENS ALL OF US

The discovery and widespread use of antibiotics in the middle of the last century ranks as one of the greatest achievements of modern science.

Until the 20th century, infections that we now consider straightforward to treat – such as pneumonia and diarrhea – that are caused by bacteria, were the number one cause of human death in the developed world.

However, during World War II, the widespread use of penicillin is credited not only with saving the lives of thousands of American soldiers, but also with paving the way for the development of many other forms of antibiotics that we take for granted today for the treatment of everything from ear infections in our children to more serious bacterial infections in those with compromised immune systems.

However, as with everything else in life, too much of a good thing can lead to bad consequences. Antibiotics not only are prescribed for illnesses for which they are often not needed in humans, but are in widespread use in the production of livestock. More than half of the antibiotics produced in the United States are used for agricultural purposes. If you are a consumer of beef, pork, chicken, farm-raised fish, and dairy products – which is to say, just about all of us -- then you have been ingesting antibiotics with every meal you have eaten for decades.

The result of this mass use of antibiotics has resulted in the evolution of antibiotic-resistant germs. Recent news articles have highlighted the inability of even the top-rated hospitals throughout the world to fight these super-bugs. Individuals who go into the hospital for routine procedures now are subject to contracting a super-bug that modern science is powerless to fight.

Epidemiologists tell us that the greatest health threat worldwide is a super-bug that is resistant to all of the antibiotic weapons currently existing in our treatment arsenal and that the only way to prevent such an occurrence is to stop the overuse of antibiotics.

However, with the drug and agriculture lobbies firmly in control of Congress, it is not likely that anything will be done to change our present practices, thereby placing all of us at risk for becoming the victims of a super-bug that we will be powerless to stop.

## Raising the minimum wage is a women's issue

We've been cheering on the U.S. women's soccer team — first as they won the World's Cup and now as they pursue pay equity. For too long, female professional athletes have earned just a small fraction of what male sports stars earn.

And to that we say: Pay them what they're owed.

The U.S. House of Representatives passed a bill to finally end the unfair and blatantly sexist gender pay gap for a vastly larger group of American women — those who work in low-wage jobs. Because they're more likely than men to be on the bottom rungs of the income ladder, women have even more to gain from a raise in the federal minimum wage.

So here's the shocker: Minimum wage is a women's issue and an economic justice issue.

According to the Economic Policy Institute, 58 percent of the nearly 40 million U.S. workers who would benefit from this wage hike are women. Nearly one in three out of all female wage-earners and 43 percent of single mothers would receive a raise. This increase would disproportionately

benefit black and Hispanic women.

For women and men across the country, this raise is long overdue. Congress hasn't passed a wage increase for more than a decade. The bill the House voted on, the Raise the Wage Act, would increase the hourly minimum gradually from \$7.25 to \$15 in 2024.

Passing this legislation would mean that millions of women will get a necessary raise. Many work hard every day performing services that are essential to our communities and our society, and yet they earn so little that they still worry about paying their bills. We're talking, for example, about the more than half a million childcare workers whose typical pay is just \$11.17 per hour. And we're talking about the nearly 800,000 home health aides whose median pay is \$11.63.

The overwhelming share of individuals doing the life-supporting, honorable, and extremely challenging work of caring for our children, people with disabilities, and seniors are women. These types of female-dominated, low-paid jobs are in the fields with the largest projected growth over the next decade. Meanwhile, Wall Street employees, who are predominantly male, made

an average of \$422,500 (over \$200 per hour) in 2017.

Cities like Seattle and states like Massachusetts have been a test case for the federal wage increase. The Seattle City Council voted in 2014 to gradually raise the city's minimum to \$15 by 2021. It currently stands at \$16 per hour for large employers and at least \$15 for companies with 500 or fewer employees. A recent study indicates that this can help hardworking Seattle moms put food on the table by raising their pay while not pushing up grocery prices. In the Commonwealth of Massachusetts, the legislature voted to increase the minimum, including the subminimum wage, beginning in 2018.

The federal Raise the Wage Act would also raise the subminimum wage for restaurant servers and other tipped workers, which has been stuck at just \$2.13 per hour for a quarter of a century. While employers are technically supposed to make up the difference if workers' tips don't bring them above the regular minimum wage, enforcement can be lax.

That's why poverty rates for tipped workers, two-thirds of whom are women, are more than twice as high as rates for workers overall, according to the National Women's Law Center.

It's also why the restaurant industry is the single largest source of sexual harassment claims in the United States. "Women forced to live on tips are compelled to tolerate inappropriate and degrading behavior from customers, coworkers, and managers in order to make a living," Saru Jayaram of Restaurant Opportunities Centers United explained in a 2015 New York Times op-ed.

Under the wage hike bill, the subminimum wage for tipped workers would be gradually increased until it's the same as the full minimum wage. Eight states have already eliminated the two-tier wage structure. Women in these One Fair Wage states are less likely to live in poverty than in other states.

All women — whether they are sports champions in the limelight or the caregivers, servers, and others at the low end of the income ladder — deserve fair pay. Today, we hope our colleagues in Congress will help give them that opportunity.

Ward 2 Ira Novoselsky said he "literally grew up with him on the Avenue (Shirley Avenue)."





## Harley Davidson seeks four one-day special licenses for store events

Black Marble Motorcycles doing business as Boston Harley Davidson on Squire Road is very familiar with holding special events for its customers. As part of planning for the events their representatives have been to many License Commission meetings – seeking malt licenses, common victuallers license and entertainment licenses.

On July 17 they were seeking four special one-day malt licenses, common victuallers license and entertainment licenses for events such as honoring military veterans, a craft beer night, a motorcycle Rodeo skills night and a traditional car and motorcycle show.

This time though, Commissioner Linda Guinasso questioned the number and type of events being offered. She also asked about a past incident with neighbor Easy Pie and a car show. Chairman Robert Selevitch shared a complaint that they received about someone stepping outside of the premise (with alcohol) and allegedly walking into Easy Pie next door with alcohol “obtained from your

event.”

Heather Viera, the event manager for Black Marble Motorcycles related that the problem of cars in the Easy Pie parking lot was at issue.

“There were two separate events. We have spoken to them for it,” Viera said. “Easy Pie had an impromptu car show and people brought their own beer. It was not associated with Boston Harley Davidson, but as they are our tenant and we cited them for the lack of following procedure.”

Guinasso brought up having a police detail and said that its time the group to consider it. She added that even the fire department should be there for some of the stunt shows.

“If we had police detail we would know who was walking around,” Guinasso said, adding when she was at Easy Pie for a function there was no alcohol. Guinasso said through her research she found it was not common to run this many events.

Where there used to be a roped off boundary is now “coned” off area, with sometimes use of metal gates.

“A couple of years ago you wouldn't have gotten out of

your premises and I'm a little concerned as to what changed and how we got to this point,” Guinasso said. “Are you using the same procedures or did something change.”

She later added she wasn't placing the blame on anyone.

Viera said there is another motorcycle shop in Billerica that hosts events monthly.

“You have a great business in the sale of motorcycles and I see now you're going to have cars there for a show,” Guinasso said. “I'm just concerned for so many licenses so many times.”

The Commissioners voted to approve all four licenses.

In other business:

There was a little confusion over a request for a malt and wine license, coming from Blanca's Bakery and Restaurant, 341 Broadway. Commissioner Linda Guinasso made a quip about a cannoli and a beer, and she couldn't see the two going together. But the confusion was soon undone. The shop (bakery) is open for breakfast, lunch and dinner and the malt license will be for 12 noon to 10 p.m.

## Yawkey League Rockies win three straight for a 18-1 record





## REVERE THROUGH THE YEARS

### 10 years ago July 22, 2009

A team of state archaeologists is undertaking a project to attempt to find the HMS Diana, the British warship that sank in Chelsea Creek in what is acknowledged as the first naval encounter of the Revolutionary War.

The battle for the City Clerk's post, which is open upon the retirement of long-time Clerk John Henry, is being waged among the various candidates who are vying for support of the members of the City Council, who will be choosing Henry's successor. Henry presently is serving as the interim City Clerk until a new clerk is named.

The annual Sand Castle contest and festival was held this past week. Although the event was a huge success, drawing hundreds of thousands of visitors to Revere Beach, it was a nightmare for local residents because of huge traffic problems.

### 30 years ago July 26, 1989

Joe Mulcahy and Dana Goodwin took first place for the second year in a row in the 11th annual Row, Row, Row to Revere race held Saturday to benefit spina bifida. Their time was 24:21, handily beating their own winning time last year of 27:38. Lisa Orlandella and Sharon Concilio took first place in the ladies division with a time of 29:19. More than 220 teams of canoes made the 2.5 run from Nahant to Revere Beach and raised over \$93,000 for spina bifida research.

The legislature has voted to override the veto of Gov. Michael Dukakis and restore \$100 million in the local aid

account of the state budget. Mayor George V. Colella said if the veto override stands, the city can make it through the current fiscal year.

Hundreds of local residents turned out to mourn the passing of local resident Daniel Kurtz, 24, who was killed while riding his motorcycle on the Revere Beach Parkway along the Revere-Chelsea border Wednesday night by a Texas tourist traveling the wrong way on the Parkway.

The state essentially has declared a moratorium on future development on Revere Beach, denying a permit for a 391-unit condo complex. State Environmental Affairs Sec. John DeVilliers said there has been enough development on Revere Beach for now. The denied condo project was to have been built on the site of the old Surf Nightclub at 20 Ocean Ave.

### 40 years ago July 25, 1979

A canoe race to benefit Children's Hospital and the Leukemia Foundation has been organized by a group of civic-minded citizens and will take place this Saturday. The Row, Row, Row to Revere event will start in Nahant and end at Revere Beach. A maximum of 50 canoes, all rented from a New Hampshire company, will compete.

The Atlantic Bank has announced it will not commit any more funds to the \$100 million Revere Beach project and has offered to withdraw as developer. The bank has been the developer and moving force on the project for most of this decade, but the national recession and general economic conditions caused the bank to pause this past spring. Mayor George V. Colella

has ordered the contractor on the Shirley Ave. renewal project to cease all work and come up with a new design in the wake of protests by Shirley Ave. businesses.

Towle Manufacturing Company has agreed to pay the city \$500,000 for the former Freedom Realty land on American Legion Highway. Towle, an international company renowned for its sterling silver flatware, will build a new plant that will employ 500 to 800 persons.

The Revere East Little League team handily won two games in tourney play by scores of 20-5 over the Chelsea Americans and 18-0 over the Winthrop Nationals. In a 15-0 rout of East Boston Central, John Caton had a double, two homers, and seven RBI. Caton also had a grand slam against Chelsea. David Vigliotti, John DeRoche, and Rick Delaney, who pitched a three hitter against Eastie, also have swung big bats for Revere.

Fernando Braz of Peabody defeated Ed Richard of Chelsea to win the 4.25 mile Revere Jaycees Road Race Sunday morning in a new record time of 20:58. Richard finished in 21:29.

## NEWS FROM AROUND THE REGION

### CPC TO BE VERY ACTIVE

CHELSEA - Chelsea residents can expect to see a flurry of activity from the Community Preservation Committee (CPC) over the coming year.

Earlier this year, the City Council approved Community Preservation Act (CPA) funding for a round of pilot projects recommended by the CPC.

The projects recommended by the CPC included money for the rehabilitation of the city's Civil War monument, improvements to the Garden Cemetery, a Marlborough Street Community Garden proposed by The Neighborhood Developers (TND), renovation of the Governor Bellingham-Cary House, renovations to the Congregation Agudath Shalom Museum (Walnut Street Synagogue) and for the city to hire an Affordable Housing Trust Fund housing specialist on a one-year contract basis.

Chelsea voters approved the adoption of the CPA in November 2016. It will provide hundreds of thousands of dollars each year to be used for the creation and acquisition of affordable housing, historic preservation, open space and recreation. The CPA trust fund currently has a balance of just over \$2.2 million before any money was spent on the recent round of pilot projects.

The projects that could be funded during the initial pilot round were capped at \$50,000 each. The total of the seven proposals that came before the CPC is just under \$270,000, according to CPC Chair Jose Iraheta.

Although Iraheta said he can't speak for the other members of the CPC, he said he was excited by the Council's approval of the pilot program.

"The committee has been entrusted by our fellow Chelsea residents to help preserve our open spaces, historic sites, and housing affordability," Iraheta said. "The projects that were funded through this pilot honor our fellow community members' wishes. I cannot wait for our next funding round and see what kind of solutions our community comes up with."

One of the immediate goals for the CPC is to make sure everyone in Chelsea knows what the CPA is, what the community values are, and how the CPC funds have been used, according to the CPC Chairman.

"The CPC will focus on standardizing the community engagement efforts, capture our community's voice in the community preservation plan and create a straightforward application process so people can know what to expect," Iraheta said. "We want to create a system that is responsible for our community's goals and priorities. If organizations and individuals know what to expect, we hope to see more robust and strong community projects that reflect our community's values."

To accomplish this, he said the CPC will be engaged in deep reflective conversation around the pilot process, including inviting CPC members from other communities to learn from their experiences, building on proven practices.

"My expectations are for the next grant applications to receive more solutions that meet the values, goals, and priorities laid out in the Community Preservation Plan," Iraheta said.

A CPC meeting was scheduled to be held on Thursday night.

During the summer, the CPC will work to finalize engagement and application timelines for CPA projects. The next round of funding will not be limited to the \$50,000 cap of the pilot round, Iraheta said, but a final decision has yet to be made on if there will

be a larger cap on the requested amount.

Organizations or individuals can get more information on how to apply and on the Community Preservation Plan through the City of Chelsea's Community Preservation Committee dedicated portal at [www.chelseama.gov/community-preservation-committee](http://www.chelseama.gov/community-preservation-committee).

Iraheta said he would like to continue to see proposed projects that meet the core values of the Community Preservation Plan.

"The CPA funds are a tool that strengthens our communities through funding for open space protection, historic preservation, affordable housing, and outdoor recreation preserve," he said. "The CPC does not implement projects; community organizations and individuals do. If your proposal adheres to the values in the Community Preservation Plan, we will consider your application for funding."

### RESIDENTS CLEAN UP PARK

CHELSEA - The temperature was 83 degrees and heading north of 90 when a group of residents showed up for a cleanup of the park adjacent to Creekside Commons in Chelsea.

But the hot sun proved no match for members of the Chelsea Enhancement Team (CET) who worked diligently to spruce up the park and walking path that begins behind Beth Israel Deaconess Healthcare and continues to the Locke Street Apartments.

Sharon Fosbury, senior engagement manager at The Neighborhood Developers, and Michael Sandoval, a founding member of CET and recycling and solid waste coordinator for the City of Chelsea, have headed the regularly scheduled events that have come to be known as "Chelsea Shines - The Neighborhood Cleanup."

"We do these events in various parts of the city," explained Fosbury. "At our last meeting, the group decided that they wanted to go to Creekside Commons for July, so we're here cleaning, weeding, picking up trash, trying to keep our parks clean."

Sandoval said the city and CET are committed to providing safe passage for the Chelsea residents who use the local parks and recreational areas.

"We're very committed to stepping up our cleanings and educating the public and creating an awareness for the importance of reducing litter in our parks," said Sandoval.

Each week city workers maintain a bag dispenser and dog waste station at the site, one of 33 such stations throughout the city, according to Sandoval.

Sandoval credits City Manager Tom Ambrosino for his support of the CET and the consistent cleanup efforts throughout the city.

"This is a work in progress and we have an amazing leader in our City Manager, Tom Ambrosino," said Sandoval. "He's been our backbone and given us all the support we need as far as doing the outreach and talking to residents about the importance of keeping our city clean."

Fosbury said the CET also regularly maintains the area at the corner of Marlborough and Willow streets.

"We've adopted this little area right where the Silver Line goes by," related Fosbury. "We've planted a bunch of sunflowers. Every year we do plantings and weeds."

Fosbury, who's become one of the faces of the highly successful TND agency that totally transformed Gerrish Avenue into an incredible residential community among other projects, invites local residents to join the Chelsea Enhancement Team at its meetings which are held on

the third Wednesday of each month.

### STRING OF BREAK-INS IN ORIENT HEIGHTS

EAST BOSTON - A thief is on the loose and responsible for several break-ins at popular restaurants in Orient Heights Square.

The thief first struck on July 1 at night long after Orient Heights Square restaurants and bars are closed. The suspect broke into Renegades on Bennington Street and later hit Luna Restaurant on Saratoga Street across from Noyes Field.

The suspect returned on July 5 and hit Renegades for a second time.

"Our detectives are working on this case and have good video of the suspect and identified him as a person of interest," said District A-7 Community Officer Dan Simons.

Simons said that the suspect is described as a white male driving a dark-colored pick-up truck.

"That's all we have for now," he said.

Renegades co-owner Gred Weinstock said the thief must have worked pretty quick to crack the safe and make off with some money.

"By the time our staff and kitchen crew clean up and are out of here it's close to 3 a.m.," he said. "Then someone is usually back at the restaurant by 8 a.m."

Simons said community members wishing to assist this investigation anonymously can do so by calling the CrimeStoppers Tip Line at 1 (800) 494-TIPS or by texting the word 'TIP' to CRIME (27463). The Boston Police Department will stringently guard and protect the identities of all those who wish to help this investigation in an anonymous manner.

space where our youth feel safe and can be themselves is our main priority. Our kids are Salesians kids, there aren't any more 'my kids, their kids,' they are our 'city's kids.'"

Traint and Gaeta said the teen nights are free and open to teens ages 13 to 18. The program is sponsored in part by the Boston Police's Youth Activities League. The teen nights will be held rain or shine. If it rains, activities will be brought into the gym.

### LYNN COUNCIL LEARNS ABOUT GOING GREEN

LYNN - The Lynn City Council heard from Neal Duffy, northeast regional coordinator of the Commonwealth's Green Communities Division, at Tuesday night's meeting. It is the third time he has visited with city officials to help make Lynn become a Green Community.

Local green communities include Revere, Saugus, Swampscott and Salem. Lynn could be slated to be eligible for up to \$500,000 in grants if it is designated.

So far the city has switched over to LED streetlights and Duffy believes there will be some electric cars for municipal use in the future.

"I'm supportive of Lynn becoming a Green Community," said Mayor Tom McGee. "Builders are working in the community and they're already using the stretch energy code. It's the direction the whole state is going."

Duffy said another avenue to take is to use a "stretch energy code," which is part of the building code intended to encourage energy savings. The stretch energy code pertains to new residential construction. This could help move the city toward earning the designation as a Green Community. This designation would open the city to be eligible for certain grants for energy efficient projects.

### CBD MAP HEADED TO COUNCIL

WINTHROP - The Planning Board has decided on a much-awaited boundary of the Center Business District (CBD) and will present the new map to the Town Council for approval or not.

It will also be up to the Town Council to decide

whether or not the old middle school site will be included in the district. It will also be suggested to the council that the senior housing on Putnam Street and 105-107 Fremont St. are not actually in the district.

Last week the Planning Board met to discuss the proposed CBD map drawn by Michael Wang, of Form & Place, Newton.

Before getting too deeply into discussions, Planning Board Chairman David Stasio, who is an attorney by profession, recused himself from any motion, vote or recommendation about the map because he may have clients who are affected by new maps.

"Tonight's vote is just a recommendation from this board to the town council," Stasio said. "Town Council will then decide to accept, reject, nullify or our recommendation."

"Thank you for respecting our homes for where they are," said Jean Coughlin, of 23 Cottage Park Road. She added that she feels like this whole process, which has included numerous meetings, has felt like the cart being put before the horse. She questioned how the developer Envelo, who proposes a four-story, 30-unit apartment building and mixed use at 10-25 Somerset St., was able to design the property without a map.

"A key piece of information," she said. "This map is the horse."

Planning Board member Christopher Boyce reminded people that the map is only a recommendation to the town council. He said the middle school site was part of the master plan.

Currently the old school has no proper zoning attached to it and that has been a problem of getting a developer interested, Boyce said.

"This is an opportunity to see that the council could actually act on this," Boyce said.

Planning Board member Gina DiMento said that she has heard ideas meant to improve Winthrop instead of having more and more empty buildings, "that no one pays any attention to and then they fall apart and make our town look bad." She also said that she wanted to look at the map in two pieces, phase one for the CBD and phase two for all of the brainstorming that has been done for the area.

"I'm not in favor of sending this map with the middle school property in it. It's a whole other can of worms," said Planning Board member Vincent Zappulla. "As far as I'm concerned the town dropped the ball on that from the beginning."

Zappulla fears sending the recommendation to the Town Council will get hung up in the council and end up in a stalemate or sending the map back to the Planning Board.

The Planning Board agreed on a base map that the middle school site, 105-107 Freeman St. and senior housing on Putnam Street shown in hashmarks as possible exclusions from the CBD base map.

### FERRY STILL REMAINS OUT OF SERVICE

WINTHROP - The Winthrop Ferry service remains suspended until mechanical repairs can be made to one of its engines.

The town is still awaiting delivery all of the necessary parts for the repair. Tanji Cufini, who manages the ferry, said the engine, covered by warranty, has been ordered from Cummins NE.

"We are currently working on alternative service while the equipment is down," said Town Council President Ron Vecchia. "We are having ongoing discussions with local ferry operators in the Greater Boston area to possibly take over the service that has been very popular with many local residents."

And what is in the ferry's future?

"It has always been my desire not to have the Town overseeing the operation and the costs associated with it, but rather have a local operator contracted to run it for the town. It has proven to be an alternative to sitting in rush hour traffic that has become impossible of late."

Ferry service is anticipated to be suspended through the end of next week. All prepaid tickets have been credited.

"We thank you for your continued patience, cooperation and continued support of the Valkyrie. We sincerely regret any inconvenience that this interruption in service has caused and we are working hard for a solution for our riders," said Town Manager Austin Faison.

Mike Prizio and his wife Phyllis of Revere went on vacation for two weeks to Aruba on July 11. After a few days in Aruba Mike started feeling ill and got a fever. On Friday July 19, Phyllis and Mike went to a walk in clinic where they gave him antibiotics because they said he had inflamed colon.

The very next morning he became very ill and went to the emergency room in Aruba at the Dr. Horacio Oduber Hospital. The doctors did much testing to find out his appendix burst and he is septic. At this point he was transported into ICU. His blood pressure

was low and his temperature was high. They told the family they couldn't perform surgery because he was really sick and in critical condition. They said that they will attempt to put a drain plug in to get all the toxin (pus) out.

At this point, he became even worse and they had to take him to operating room to get (toxins out). Then suddenly they told the family that Mike needed to be intubated and on a ventilator.

After, hours of this, a breathing tube and ventilator were taken off. However, Mike is still in ICU and in crit-

ical condition.

The one thing that is hurting the family right now is the hospital only takes cash and credit cards and no insurance.

In only 24 hours, the bill is up to \$20,000.

The family is trying to get him Medflighted home as soon as possible. As most of you know Mike and Phyllis were in a major accident in November and were in hospital for about a month.

# Roca draws praise as national model at panel discussion

## CPD Capt. Batchelor speaks out on need identifying high-risk individuals at a younger age

Community leaders praised Roca as a national model for its positive impact in helping to decrease incidents of urban violence during a panel discussion held June 27 at Northeast Crossing in Boston.

Carl Miranda, director of Roca Boston moderated the discussion that featured panelists, Thomas Abt, author of "Bleeding Out: The Devastating Consequences of Urban Violence – and a Bold New Plan for Peace in the Streets"; Ed Dolan, commissioner of Massachusetts Probation Services; Tracy Litthcut, co-director of the Boston Mayor's Office of Public Safety; and Anthony Braga, director and Distinguished Professor, School of Criminology and Criminal Justice at Northeastern University.

Molly Baldwin, CEO of Roca, was in attendance at the panel discussion. It was Baldwin who founded the Chelsea-based agency whose mission has been "to disrupt the

cycle of incarceration of poverty by helping young people transform their lives."

Abt, a senior research fellow at the Harvard Kennedy School of Government, has some interesting observations

in his book, which not only contains a rigorous analysis of urban violence and its consequences, but also a concrete and helpful framework for the moving the needle on violence.

For example, Abt writes that "In Boston, 70 percent of all shootings over a three-year period were concentrated in areas covering approximately five percent of the city. In most cities, four percent of city blocks account for approximately 50 percent of crime."

Chelsea Police Capt. David Batchelor, whose work with city partners in Chelsea Hub has helped local families facing difficult challenges, thanked the panelists for their research and the information presented at the forum.

"Any information that we can get to make our city safer and helped people is definitely beneficial to us," said Batchelor.

Batchelor then spoke about identifying at-risk individuals at a younger age.

"It certainly makes sense in identifying individuals that are at high risk and getting those people the services and remove them from that high risk," said Batchelor. "My only thought is that sometimes we wait too long. I think there are identifying risk factors prior to a person getting involved in a shooting or being a victim – and I think we know that."

"I wish we could start [identifying high-risk situations] a little younger – we're starting at 17, 18, 19-year-olds into their 20s – I think you can identify those behaviors almost in middle school,"

concluded Batchelor. "Sometimes, we're waiting for something bad to happen, we're waiting for that person to be a victim or a perpetrator before everything is mobilized and I know it's a challenge because they're at a young age, but I think we're doing a disservice not trying to figure out a way to get that help to them at an earlier age."

Batchelor said he appreciates conversation about urban violence, "but being a police officer for a long time, but I wonder how things are getting

done – how are we going to do this? We have to share information and there are privacy concerns and laws so we're afraid to talk to each other and we're all working in our own little worlds. It's a challenge. Where's the line where we can share or not? I think we need to be able to figure that out to help our communities and keep people safe and get them on the right track."


