More than six thousand Revere Public School students headed back to school this week to start an exciting 2019/2020 school year.

With the new school year underway, school leaders are hoping to implement several initiatives that will make the educational experience better and more fulfilling for both students and families this year.

## Restiano named head basketball coach at Chelsea High School

One of Revere High's greatest basketball players is now a head coach.

Gena Restiano, a 1,000-point scorer, three-time Northeastern Conference All-Star and league MVP during her four varsity seasons in Revere, has been named the girls basketball head coach at Chelsea High School. She will also take over the CHS softball program next spring.

Restiano, daughter of Lawrence and Debra Restiano, was promoted from her junior varsity basketball coach position to head coach. At 24, she becomes one of the youngest head coaches in the area.

"I'm 24 so it feels a little surprising that they gave me the job, but I'm happy they did because I worked hard to get it," said Restiano, who has been involved in a player-training program at the CHS gymnasium this summer. "I know a lot of the players because I was a teacher at Chelsea High, too."

Restiano said she has a few players returning from last year's Red Devils contingent that just missed qualifying for the State Tournament. One of the returnees is a 6-foot-3-inch center.

"I'm going to bring in [former RHS and Suffolk teammate] Caitlyn Carmello to work with our centers and forwards," said

Singer received a standing ovation as he made his way to the podium.

McKenna said she was speaking from her heart when she told the audience, "Joe Singer is an American."

At Revere High, Restiano was a consistent, double-figure scorer, playing two seasons each for head coaches Diana Finn and Katelyn Leonard. During her sophomore season, Restiano was the electrifying point guard for a 20-0 Revere High team that defeated Lynn English in the State Tournament before being ousted by Lincoln-Sudbury.

Despite her career being hampered by knee injuries, Restiano would eventually eclipse the 1,000-point milestone in her final game against Westford Academy in the State Tournament. The 1,000<sup>th</sup> point was a free throw, she recalled.

She played one season of basketball at Babson College before transferring to Suffolk University. She sustained two more ACL injuries at Suffolk, but true to her determination and competitive nature, she worked hard in rehabilitation, returned to the court, and completed her collegiate basketball career.

"I had a better high school career than I did a college career, but I was able to finish, which was nice," said Restiano. "It was great to be reunited with Caitlin at Suffolk and play basketball for Coach [Ed] Leyden."

Following her graduation from Suffolk in 2017

with a degree in Marketing and a concentration in data analytics, Restiano worked for the Bank of New York Mellon and Nike before deciding to enter the field of education and become a teacher.

The jump to basketball coaching was a natural for Restiano, who was always fundamentally sound and a highly respected teammate and mentor to other players. She is one of the few high school basketball players to have mastered the behind-the-back dribble at full speed. She also thrived in three-point land, setting the RHS record at the time with seven in one game from beyond the arc.

can hero, he really is. He doesn't want the praise. He doesn't want the credit and it took me one year to get him up to get this certificate. McKenna described the Sept. 1, 2018 incident in which Singer's rapid re-

sponse, after being alerted of the emergency by his children and niece, helped save the child's life.

"Mia stepped on a little boy that was submerged on the bottom of the lake," related McKenna. "So right

away the kids ran to alert Joe. Joe ran in to the water and he saw the boy and he pulled him out of the water. He did CPR right away and he was calling for help. Crazy enough there was a cardiologist on that beach

that day. Joe called the EMTs and assisted with the defibrillator and they got a pulse. At the hospital with God's help and everybody praying, the kid made a remarkable recovery and he's running around now and he's 100 percent fine."

McKenna said she believes in fate "and these four people [Joe Singer, Mia Singer, Domenic Singer, and Jayna Singer] were at a place in time where they were supposed to be."

McKenna concluded her remarks by noting that Joseph Singer was her student when she was a teacher at Revere High School.

"He has proven to be one of the finest people I know," said McKenna.

Council President Arthur Guinasso, who led the presentation ceremony, graciously called for a brief recess so that Singer's family could participate in photos with the Council. Mayor Brian Arrigo also personally congratulated Singer and the children for their life-saving efforts.

through her years at Revere High, and she was extremely excited to hear about the trip.

"I couldn't believe it! At first when Ms. Lapolla mentioned it, I didn't think it would actually happen," she commented on her first reaction to her teacher sharing the information about the trip to her class.

As DiCicco is part of the Honors Society, she was qualified to go, saying "... besides, it's not everyday you get a chance like this,

I thought why not take it?" Kathy Umanzor, a senior going on the trip, has taken the language for all three years that she has been at the High School, and is taking AP Italian this year.

"My interest in Italian was sparked because I wanted to try to pursue a third language," Umanzor explained as she is fluent in both Spanish and English. "Taking Italian seemed like the best fit. Spanish and Italian are extremely similar, which makes it easier

for me to understand and grasp things quickly."

Umanzor was "immediately interested in going," when finding out about the trip because she "... thought it would be a good opportunity to not only travel, but also to learn ..."

She is excited to be exposed to a different culture and "... put what I learn in the classroom into a real world situation."

Emmanuel Alvarado, another junior who completed the first two years of

the language, is also going on the trip this February. Similar to Umanzor, he is bilingual and decided to take Italian to learn a third language.

Alvarado said this was his best chance to travel internationally, and expects Italy to be full of exciting experiences.

The students going to Italy have done fundraisers in and out of school. Some have also constructed their own fundraisers including Go-Fund-Me pages and selling snacks at school to other students.

As a group, those attending have done school-wide fundraisers such as selling mango biche during lunches and slush after school. The students have held two car washes as well. They plan to have a pasta dinner night for families as well as a bingo night. A donation page for all students may also be set up in the future.

DiCicco noted how all donations, no matter how small, are greatly appreciated given that "... the trip per person is thousands of dollars, and any form of contribution will help lower the expenses and help leave a positive mark on

our lives." "I'm incredibly excited to be able to visit such a beautiful country, I love to travel and am excited to have another stamp in my passport from somewhere so special," DiCicco said expressing her excitement towards this opportunity.

## Understanding traffic, and addressing it

Last week we ran through some of the City's accomplishments of the past summer -- and there were quite a few. But it's also true that once the school buses start to roll and summer vacations come to an end, a lot more drivers occupy the roads. That, of course, means we're likely to find ourselves sitting with all those other drivers in traffic during our weekday commutes.

If you live and drive in Massachusetts, you are well-acquainted with traffic. Especially if you live in Metropolitan Boston. A few weeks ago the Baker Administration released the results of a comprehensive traffic study that concluded that the state's traffic issues have reached a "tipping point." Many of us in Revere may have shrugged, "no kidding."

We've been hard at work to study our local congestion points, devise remedial plans, and promote those plans to the state level agencies that oversee so many miles of roadway that connect Revere to our neighboring communities.

It's important to understand where all the traffic comes from. When it comes to traffic, it's the one time that geography isn't Revere's friend. Revere absorbs a greater brunt of regional traffic all year round thanks to where we are.

While we hail Revere Beach as our City's prized gem, its regional popularity draws thousands of visitors into our City every nice day during summer -- a season when traffic subsides in most communities.

Another consideration is our proximity to Logan Airport and downtown Boston, magnified by our unique place in the regional trans-

portation structure. Route 1, Route 60, and Route 1A carry thousands of Boston-bound drivers from our northern neighbors into Revere every day. As modern technology such as Waze, Google Maps, and GPS become commonplace, drivers are routinely guided off of those clogged arteries and rerouted onto our local streets.

It's not just motorists who drive through Revere, it's also those who drive here to use the public transportation based in our city to get to their destination. An MBTA study released late last year counted some 63,000 riders per day using the Blue Line, up 14 per cent from just five years ago. Ridership at the Wonderland station grew more than at other stations. This suggests that more North Shore T riders are driving into Revere and parking at the T garage and surface parking lots.

This influx of traffic chokes American Legion Highway, North Shore Road, and Revere Beach Boulevard every weekday morning. Our own traffic study determined that more than 90 per cent of morning traffic on North Shore Road and Revere Beach Boulevard crossed the border into our city from the north -- and onto our roads.

Keep in mind, most of the major roads that bring vehicles into our city are under the control of the Massachusetts Department of Transportation (DOT) and Department of Conservation and Recreation (DCR). We are working closely with both departments as we advocate plans originating in Revere's Community Development department. As these plans proceed through administrative review on the state level, we will continue to advocate on behalf of Re-

vere to make sure we get priority.

Help is on the way:

- The City is finalizing a plan to upgrade all signalized intersections along Broadway with fully-synchronized Adaptive Signal Control Technology that will efficiently regulate traffic flow and adapt for emergency requirements. These improvements will represent a quantum leap from the outdated system now in place.

- After decades of consideration, DOT has abandoned plans to widen Route 1 between Copeland Circle and Route 60 in Saugus. There is good news, however: a recent grant from the Massachusetts Gaming Commission will fund roadway improvements and repairs that will repave, restripe, and redesign segments of the roadway that will effectively increase traffic capacity without the prolonged course of new road construction -- and at far less cost.

- As a result of the traffic study that we commissioned, we have made significant recommendations to DCR for the redesign of the intersection of Ocean Avenue, Revere Beach Boulevard, and Revere Street. The redesigned pattern, if approved and implemented, will decrease the bottleneck at Ocean Avenue and Revere Street, improve pedestrian safety, and facilitate steady traffic flow in the area.

- Also as a result of our traffic study, we have made additional recommendations to DCR for alterations that will improve traffic flow and pedestrian safety at Eliot Circle.

- The City is working closely with our state delegation to strongly advocate the construction of a commuter rail stop at Wonderland. We are optimistic

that future development at Wonderland and at the nearby Necco site on American Legion Highway will advance the argument for this proposal.

- Looking further down the road, the traffic mitigation measures planned by HYM Investments in conjunction with their development of Suffolk Downs devotes \$40 million to traffic facilitation measures that include modernized signalization along Revere Beach Parkway and traffic flow alterations at the Route 16-Winthrop Avenue intersection; a new travel lane on McLellan Highway (Route 1A) between Railroad Avenue and Border Street, along with a new traffic flow pattern at the McLellan Highway -- Border Street intersection; and the construction of a new exit off Route 1 Southbound onto Route 16 eastbound.

- The Baker Administration has signaled its support for major new tools to combat roadway congestion, including an \$18 billion plan to repair and expand the public transit system.

Make no mistake: traffic is not a local problem. It is a regional problem that we are taking seriously along with our state partners.

Revere is in better position than most in dealing with traffic. We are far ahead of other communities, as we already have plans in action to address traffic concerns.

Our plans are based on an educated understanding of what causes traffic, careful consideration of traffic management, and advocacy for adequate alternatives. At City Hall, we are working toward relief.

## REVERE THROUGH THE YEARS

### 10 years ago Aug. 26, 2009

Revere native Barbara Kelly has been named the new Principal of the Paul Revere School. Students from the Paul Revere will attend school at the Beachmont School this school year while the new Paul Revere School is under construction.

City Health Agent Nick Catinazzo said the schools will be prepared in the event of another outbreak of the swine flu, which struck the city last year.

Revere native and long-time resident Carmela Ranno turned 100 this past Sunday. A birthday party was attended by her three children, 17 grandchildren, and 25 great-grandchildren. She and her eight siblings were raised by their parents, Andrew and Lea DeMore, immigrants from Italy, at their home on 41 Fernwood St.

Long-time residents are mourning the passing this week of former State Rep. and former Revere School Supt. William J. Hill.

### 30 years ago Aug. 30, 1989

More than 100 residents of all creeds and nationalities crowded into the Metro North Jewish Community Center last week for a Ward Two Neighborhood Unity Meeting. However, rather than bring neighbors together, the meeting served as more of a soapbox for gripes by residents. The Shirley St. area in recent years has changed from a beachfront business community populated primarily by Jewish families, to a low-rent, run-down area that has become besieged by crime and arson.

School bells will ring for local students this Wednesday, Sept. 6. However, School Department budgetary constraints have forced cutbacks in bus service, which means that many children will be walking to school.

State budget cuts may mean the closing of five Registry offices, including the one in Malden that is used by Revere residents.

Construction has begun on the new Garfield Magnet School, but area residents are upset with the dirt and dust being caused by trucks.

Long-term mortgage interest rates are expected to drop slightly through the fall and will bottom out at nine percent, according to a recent economic survey.

### 40 years ago Aug. 29, 1979

Revere school bells will ring next Wednesday, with students in Beachmont set to begin classes at the sparkling new Beachmont School. However, students who formerly attended the Henry Waitt, Wolcott, and Mabie schools will be going to different schools this year since the School Committee voted last spring to close those schools.

A startling development has occurred in the Revere High School kickback case with the declaration this week by a key prosecution witness in which he has recanted his testimony.

The Parks and Rec. Department held its fifth annual Olympics Day at Harry Della Russo Stadium to climax the 1979 summer playground season.

Edward Arnold will be installed as the fifth President of the Chelsea Revere

Jewish Community Center. The installation dinner and dance will be held at Nick's Restaurant in Boston.

### 50 years ago Aug. 28, 1969

Mayor George V. Colella and Board of Assessors Chairman Ronald P. Corbett have announced a tax rate for 1969 of \$124.40, an increase of \$7.80. Colella said that the rate of increase was less than most other area communities and attributed the hike to a less favorable exchange of funds with the state, increased school costs, and payraises for city employees.

The Revere Youth Commission held its annual Play Day exercises for all 17 of the city's parks and playgrounds. A parade down Broadway to Paul Revere Stadium, featuring floats from each of the parks, was the highlight of the day's festivities. The No. Revere playground had the winning float, Aquarius. Chosen as Miss Revere Youth Commission were Denise Falzone, first place; Patty Brannen, second; and Kim Alba and Tracey DeFrancesco, tied for third.

City Councillor Donald J. Zollo, frustrated with the refusal of certain department heads to provide information to the council, has proposed withholding the salaries of any department heads who fail to comply with the council's orders.

A throng of 2,500 teenagers filled Paul Revere Stadium for a rock concert. The concert, dubbed A Night for Sight, featured up-and-coming MGM recording stars Orpheus. The concert was the brainchild of eight RHS juniors who used the concert as a fundraiser for the Mass. Eye and Ear Infirmary.

### 60 years ago Aug. 27, 1959

The City Council, School Committee, and School Building Committee once again failed to reach a consensus on the issue of construction of a new Revere High School, with the Council insisting on a school that would cost \$1 million less than the proposed \$4.9 million estimated cost.

Revere Journal advertising manager Benjamin Schwab has been named to a four year term on the New England Interstate Water Pollution Control Board by Gov. Foster Furcolo.

Colorful costumes, decorated floats, bicycles, and doll carriages, and contests marked the season-ending day for the Revere Youth Commission's 1959 summer program. Top finishers in the Mr. Atlas contest were Alan Segal, first place; Robert Capoccia, second place; and Mark Falzone, third place. Miss Lisa Naseck was chosen as Miss Revere Youth Commission.

The 60 members of the Immaculate Conception Drum and Bugle Corps unveiled the CYO Music Circuit championship banner that was awarded to them after the competition held in Holbrook on Sunday.

### 70 years ago Sept. 1, 1949

Mayor Peter Jordan and the Board of Assessors announced a tax rate of \$53.40 this week, an increase of \$1.60 over last year. An additional \$80,000 from the state in the "local credits" column of the state's exchange of funds with the city kept the tax rate from

increasing by another \$. Payraises to city employees added about \$1 onto the tax rate.

The number of candidates for the City Council under the new Plan E form of government has reached 58 for the seven council seats.

The Revere Journal announces a money-saving feature for its readers with the Product of the Week plan, in which a strip of

coupons, worth 10 cents each toward the purchase of a nationally-advertised product, will be printed in the Journal every week.

Rev. Leo McGann has assumed his duties at Our Lady of Lourdes Church, succeeding Rev. Andrew J. Corbett.

The Navy Cross, the U.S. Navy's highest honor, has been awarded posthumously to Douglas J. MacDonald, formerly of Calumet

St., for heroism aboard the USS Ticonderoga on Jan. 21, 1945. MacDonald was credited for saving a number of his fellow sailors after a Japanese suicide dive bomber exploded into the ship.

A spectacular blaze in the farm section of the city Saturday night at Suffolk Farms resulted in the burning of 35,000 packing boxes.

Five persons were in-

jured Saturday night when the brakes failed on the Derby Racer roller coaster at Revere Beach. A three car train hurtled off the tracks and into an underground tunnel. None were injured seriously.

Construction on the new Mystic River Bridge has resulted in detours for Revere commuters en route from Revere through Chelsea to Charlestown.

## RHS SPORTS Roundup

### HOPES ARE HIGH FOR RHS FOOTBALL TEAM

The Revere High football team has been preparing arduously for the 2019 campaign over the past two weeks in anticipation of their season-opener.

"We've been having a great pre-season," said veteran RHS head coach Lou Cicatelli. "The team has been working hard and has a great attitude."

The Patriots showed flashes of potential brilliance to come in their annual pre-season scrimmage with Hamilton-Wenham Saturday morning on the turf at Harry Della Russo Stadium.

The RHS first team stayed on the field for 20 downs, controlling the play on both sides of the ball. Senior Joe Llannos, who transferred from Attleboro High last year, but who suffered a broken leg mid-way through the season, rushed for close to 100 yards on just five carries and scored a touchdown.

"Joe is back and he's going to be a real force for us," said Cicatelli.

Junior quarterback Calvin Boudrow, who also missed a big chunk of 2018 with a shoulder injury, was impressive throwing the ball. One of Calvin's favorite targets was junior wide receiver Dillan Day.

"Dillan has great hands and is a tremendous athlete," Cicatelli said of Day, who also is known for his exploits on the basketball court for the Patriots. "He's a tough kid who really goes for the ball."

Junior Mark Galvez also turned in an impressive performance as a running back/slot back, and grabbed a 40-yard pass against the Generals.

On the defensive side of the ball, linebacker Billy Ginepra was a powerful presence for Revere, roaming all over the field in pursuit of General ballcarriers.

Revere also will feature a big weapon this season with the foot of junior Rayan Rizazi, who has been named a pre-season All-Scholastic as a place-kicker.

"Rayan proved the difference for us last year in some close games," noted Cicatelli. "He has been kicking field goals consistently from 40-50 yards out during the pre-season."

The 2019 Patriots will be led by a quintet of senior captains: two-way lineman

Jaryd Benson; senior defensive end/tight end Mazer Ali, who is returning from a broken leg suffered mid-2018; running back/safety Zach Furlong, who played a key role in Revere's fine 2018 season; defensive back/X-back Jonathan Murphy, who took over the quarterbacking chores last season when Boudrow was injured; and speedy running back/linebacker Lucas Barbosa, who is returning from a hamstring injury.

Cicatelli's squad enjoyed unprecedented success last year, continuing an upward trend for the RHS program that has been building for the previous four seasons.

After an 0-2 start, the Patriots finished at 7-4, including the program's first-ever triumph in the post-season, a victory over North Reading in the sectional quarter-finals.

Patriot fans also no doubt will recall their team's 18-6 triumph over archrival Winthrop on Thanksgiving Day at a frigid HDR, a triumph that marked the third straight win, and four of the past five, on Turkey Day for Cicatelli's crew, a feat accomplished only twice before by Revere in the schools' long series.

Revere never has defeated Winthrop four years in a row -- but that goal still is three months away and there is a lot of football to play between now and then.

Unlike all of the other RHS athletic teams, which have reunited with their former long-time rivals, Everett, Somerville, Malden, and Medford, to create a newly-reorganized Greater Boston League, the football program will remain in the Northeastern Conference for the next two seasons before rejoining with the GBL for the 2021 schedule.

Revere will play in the middle-tier division of the NEC comprised of Salem, Lynn Classical, Gloucester, Peabody, and Marblehead.

The Patriots have a rigorous week of work and scrimmages ahead. They were set to travel to Danvers yesterday afternoon (Tuesday) and will host Northeast Regional Friday morning at HDR. They will travel to Malden Saturday for a 1/2 game.

The Patriots then will have two weeks off to prepare for their season-opener under the lights on Friday evening, Sept. 13, when they will host defending





2019/2020 school year. "We developed district-wide improvement plan in 2015 and now this school year we will enter the fifth year of that plan," said Kelly. "When we first started (in 2015) we had focus groups with students, parents and teachers to try and identify what the district goals should be over the next five years. We came up with the three strategic objectives of building community, teaching all students and assessing student learning. We then broke down those three categories into strategic initiatives that we have been working on the last four years."

Kelly said the first big objective for this year is building community. "We want to work with the larger Revere community on projects and city initiatives that impact students and their families," said Kelly.

One such initiative is the ongoing planning for a new Revere High School (RHS). "This year we want to engage parents, communi-

ty members and students in the planning for the new Revere High School," said Kelly. "A goal for this year is to have at least one parent and five community members named to the Revere High School Building Committee. We also want a 50 member Revere High School Visioning Team that represents all of Revere School's diversity."

Last school year Revere Public Schools cleared a major hurdle during a Massachusetts School Building Authority (MSBA) board meeting. At that meeting the MSBA board voted to invite Revere and ten other school districts that filed Statements of Interest (SOI) to take part in the eligibility process that could ultimately lead to for grant money to build new high school here.

Then in the spring, Revere High School Principal Dr. John Perella and the RHS Design Team, which consists of Perella, students, parents and architects from the Massachusetts School Building Authority

ty (MSBA) held a design event to start envisioning what a new Revere High School might look like.

For the past three years Revere has been trying to get a plan off the ground to consolidate some old school buildings and build a new high school that will serve the city's students and families for generations to

come. Aside from focusing on the potential for a new high school Kelly said Revere Schools want to increase equity and access by creating more opportunities for parents to engage with the school department and school officials.

"We also want to increase the number of relationships between the schools and local businesses, increase PTO (Parent Teacher Organization) participation by 25 percent, increase participation at school based activities and events by 10 percent as well as increase the number of Revere High and Seacoast students placed in internships by 20 percent."

Also by the end of this year Kelly hopes that Revere School students will be able to report to the School Committee on how they had a voice in selecting school projects and avenues of learning based on their interests and passions as well as grading that is more fair and based on knowledge of subjects and not on work habits of how that knowledge was acquired.

NEW SUPERINTENDENT IS READY

CHELSEA -The corner office in City Hall – and the head of the Chelsea Public Schools – will have a new look and some new ideas now that incoming Supt. Almi Abeyta has taken her place as the leader of the schools, ready to welcome faculty and students on Aug. 27 for their – and her – first day of school.

After a public process last spring, Abeyta was chosen by the School Committee after a close vote, but in deciding fashion, and she reported to work on Aug. 12. This week, with former Supt. Mary Bourque still on the job to help with the transition, Abeyta has been meeting with staff and learning all about Chelsea after having left her position this summer at Somerville High School.

“I’ve just been listening a lot so far – getting to know people,” she said. “It’s one thing to read about a district – a plan – but it’s a whole other thing to see it in action. What I was reading about online and hearing about in the interview process – now I’m seeing it play out and it’s refreshing to see there is alignment between the two. In education, there is theory in action and theory in use. I’m seeing both working together in Chelsea Public Schools.”

That was a refreshing take from the new leader of the schools as she accompanied Bourque around the district – meeting with teachers on Monday for professional development sessions at the Early Learning Center.

Abeyta comes to the district with a great deal of experience in and around Chelsea, living in Revere and having taught in leadership positions at East Boston and Somerville.

“This process was for me a long time coming,” she said in a recent interview. “I just couldn’t pass up Chelsea. I drove through Chelsea every day to Somerville from Revere. I really wanted to serve a community like Chelsea. When I saw it was open, I said I have to do this. I felt it was a perfect step for me professionally and personally... Having been in East Boston, Chelsea felt like home to me. It is me. It feels right and where I am supposed to be.”

Abeyta grew up mostly in New Mexico in a military family, having spent time in various places around the world before settling there. After attending public schools all her life, she eventually made her way to the East Coast and went to graduate school at Harvard University. During that process, she had interned at the Donald McKay Elementary in Eastie. Intending to move on after that, she was heavily recruited by the Boston Public Schools (BPS) to take the principal job at the McKay – and she served there for four years before taking a role in the central administration of the BPS.

“I took the job because I fell in love with the people of East Boston, and I just really liked that neighborhood,” she said. “I was happy in Boston and everything I wanted to do professionally I was doing. Then I got a call out of the blue.”

That call came from Sante Fe, N.M., where her hometown was recruiting her to come back and be a key deputy superintendent during a transition time in the system.

That was a job she couldn’t pass up, she said, having wanted to be home for such a long time. However, Boston was calling her, and she soon accepted a job as deputy superintendent at the Somerville

Public Schools – which is where she has been.

Abeyta has been a rising star in the education world for several years, but said she has not taken the step for superintendent before due to her family obligations. This year, her daughter graduated from school in New Mexico and is headed to Boston to go to college. Abeyta said she had never wanted to take on the demanding role of superintendent until her daughter was in college.

“To be superintendent, I feel like you have to be completely committed,” she said. “I always said I’d be ready for that step in my career when my daughter went to college and I was more of an empty-nester.”

Coming into the district – and able to keep a pretty good conversation in Spanish – Abeyta said she feels like she can take the system to the next level.

“I see a district where there are already systems and structures in place,” she said. “People are working hard on instruction. There is so much energy. That’s exciting and attracted me when I applied. It was a great place where I didn’t have to go in and rebuild. That’s a gift...There are a lot of good things happening already. My role is to build on those great things and take them to the next level. That next step will depend on what I hear and see in the data. I will take that next step with the community.”

School starts in Chelsea on Weds., Aug. 27, for students across the school system.

BALLOT FOR NOVEMBER ELECTION SET

CHELSEA - The City Election ballot for November has been set for City Council and School Committee, and it features several intriguing races – and one blockbuster Preliminary Election on Sept. 24 in District 2.

The City Clerk’s Office has concluded the certification process this month, and one of the most interesting outcomes is a Preliminary Election for District 2.

Three good candidates have filed signatures for the Powderhorn Hill district, and the campaigns will begin to take shape immediately.

Incumbent Councilor Luis Tejada has filed his signatures, and he will once again face challenger Olivia Ann Walsh – an attorney who lives at the Soldiers’ Home and ran against Tejada two years ago.

The interesting new candidate is Melinda Vega Maldonado, who is the daughter of Chelsea Collaborative Director Gladys Vega and the wife of a Chelsea Police officer.

Those three in the race are all very well-known in the City and will hustle for votes around the district. The outcome will leave only the top two vote getters to square off in November.

The at-large Council race will also be interesting, but will not come up for a vote until November. Council President Damali Vidot and incumbent councilors Roy Avellaneda and Leo Robinson will be on the ballot.

Challenging them will be License Commission Chair Mark Rossi – who ran for a district seat last time out – and Chris Winam, a newcomer on the scene with deep Chelsea roots.

District 1 Council features a vacant seat with the bowing out of Councilor Bob Bishop. Running for the empty seat are Planning Board member Todd Taylor, and Economic De-

velopment Board member Rick Pantano. Both are very well-known in the city and are very active in City affairs. It will be a close race to the end.

In District 4, it seemed like Councilor Joe Perlatonda wasn’t going to have an opponent, but late in the process Naomi Zabot successfully turned in her Nomination Papers – and so Mill Hill will have a race on its hands too.

Councilor Judith Garcia in District 5 has had several contests over her tenure, and this time won’t be different, as she will face Jason Benetti from the waterfront area.

Councilors Enio Lopez (District 3), Giovanni Recupero (District 6), Yamir Rodriguez (District 7) and Calvin Brown (District 8) will have no opponent on the ballot.

•SCHOOL COMMITTEE

There is no Preliminary Election in the School Committee, but there will be one to watch when it comes to the at-large race, where there is no incumbent due to School Committeeman Frank DePatto choosing not to run again.

That leaves Shawn O’Regan, a former School Committeeman, who is making another run and said he is ready to challenge the system after having watched it work previously.

The other candidate for the at-large seat is Roberto Jimenez Rivera, who grew up in Puerto Rico and came to the mainland to attend the University of Michigan. He and his wife, Sarah, recently moved to Chelsea, and he works as an admission’s officer at a local university.

A race in District 1 will also be interesting as long-time School Committeewoman Rosemarie Carlisle will face James O’Regan. Both have deep roots in Chelsea and the votes will be close.

The only other race is in District 7 where incumbent Kelly Garcia will face former School Committeeman Charles Klauer.

Incumbents Jeannette Velez (District 2), Marisol Santiago (District 3), Lucia Henriquez (District 4), Henry Wilson (District 5), Ana Hernandez (District 6), and Yessenia Alfaro-Alvarez (District 8) will have no opponents on the ballot.

VILLAGE FEST ON SEPT. 14

EVERETT - The 5th annual Village Fest will feature headliners ‘The Wailers’ and ‘Fastball’ this coming Sept. 14 in the Village, from 3-9 p.m.

“At BNY Mellon we continually optimize our real estate footprint to ensure we are operating efficiently while continuing to deliver for our clients,” said Madelyn McHugh, a spokesperson for the company.

The owner of the building is Gilbane of Providence, and they said they are happy to still have BNY Mellon in the Everett building, and are looking to find another great tenant for 140,000 square-feet of office space on the top floor.

They are using Cushman and Wakefield to help market the newly vacant space. “It’s my understanding BNY Mellon will be shrinking their footprint in that building, but they plan on staying in place in the building,” said Wes Cotter, a spokesman for Gilbane. “We’re thrilled to hear they will remain a tenant. It’s a great building and we look forward to finding a second great tenant for the other part of the building.”

MADARO HONORED BY PIERS PARK SAILING PROGRAM

EAST BOSTON - State Rep. Adrian Madaro, who as a youth learned how to sail in Boston Harbor through the Piers Park Sailing Center’s (PPSC) summer program, was honored

by the PPSC board, staff and youth on Monday afternoon for his support and advocacy for the program.

Madaro filed legislation in the state budget that was signed by Gov. Charlie Baker earlier this month to expand the PPSC summer program so the sailing center can serve an additional 100 youths in 2020.

“It’s hard to believe that years ago, Rep. Adrian Madaro was a youth sailor in the program,” said PPSC Board Vice Chair Mary Cole. “We are here today to thank him for helping the sailing center every step of the way. When we had some financial issues a few years back he guided us, he put us in touch with people who could help and keep the program alive. Now we are alive and thriving and much of that is thanks to Rep. Madaro.”

PPSC board member Steve Kirk followed Cole and thanked Madaro for his years of support.

“We had a great Eastie Pride Day with over 300 people out on our boats,” said Kirk. “This is in part due Madaro’s support for the program. This Sailing Center is something that helps make the community vibrant and I want to thank Rep. Madaro for his support.”

PPSC Executive Director Alex DeFronzo credited Madaro for helping to keep the Sailing Center afloat during a recent dire fiscal crisis.

“Like Mary (Cole) said three years ago, the summer program finished up like it will at the end of this week,” said DeFronzo. “The sailing center then closed for six months. There was no staff, no instructors and it was a really hard time for the sailing center. I grew up in the sailing center and learned how to sail here as a little kid. I heard about the trouble the center was having and I wanted to help and keep this important program that meant so much to me and many others alive.

We needed a lot of help to be able to make that happen. There was really one person that was there through the whole thing to help us, and that was Rep. Adrian Madaro. When we needed his help to get Massport to help the program again he had our backs. When we needed him to make sure Massport would continue their support he had our backs. And now through the state budget he has made sure that next year 100 extra kids will get to come to the program and not have to pay anything to do Harbor Explorers and Science of Sailing. This is why we are presenting him today with the PPSC’s Harbor Hero award.”

After accepting the award Madaro addressed the crowd of PPSC staff and youth sailors.

“This is a particularly special honor because just a few short years ago I was at PPSC enjoying my summer as an East Boston resident attending this summer program,” said Madaro. “It is so special and such an honor for me that I’m in a position to work with the PPSC board and staff to make sure this organization stays afloat, continues to be strong and continues to give youth in East Boston the same opportunities I had. We have to make sure we keep this thing going and I’ll do my work at the State House but I need all of you to spread the word about this awesome program.”

WOMAN FOUND TO BE INCOMPETENT

EAST BOSTON - The East Boston woman who was arrested for stabbing a Boston EMT and possibly trashing Sacred Heart Church last month was found to be incompetent to stand trial.

Suffolk County District Attorney Rachel Rollins’ office made the announcement last Friday that Julie Tejada, 31, East Boston will instead be held without bail and admitted into a mental health treatment facility.

According to the D.A.’s office, Tejada’s lawyer and the commonwealth both agreed with doctors that drafted the accused’s competency report.

Tejada will be treated at the Worcester Recovery Center and Hospital.

Tejada, 31, of Eastie appeared in Boston Municipal Court on single counts of assault with intent to murder and assault on a public employee and two counts of assault and battery with a dangerous chemical.

Assistant District Attorney Jessica Erickson told the court that the victim, an on-duty EMT, was rendering assistance to the defendant when the defendant allegedly stabbed the victim multiple times. Prosecutors said that the defendant then used pepper spray on the stabbing victim and a second EMT who was driving the emergency vehicle that came to her aid.

The stabbing victim was rushed to Massachusetts General Hospital, where she underwent emergency surgery. The second victim was also treated and ultimately released.

Boston Police located the defendant inside the ambulance in the area of 24 New Chardon St.

The Monday before the stabbing, the Boston Police Civil Rights Unit launched a probe after a woman smashed a window and defaced the doors at Sacred Heart Church.

After Tejada’s arrest, Boston Police sources said she was considered a sus-

pect in the Sacred Heart vandalism.

Boston EMS released a statement Friday afternoon saying the EMTs involved in the attack are still recovering at home and have not yet returned to work.

“As a result of today’s hearing, we hope Ms. Tejada will receive the treatment that she needs. It is assuring to know that for the time being Ms. Tejada will not pose a public safety risk,” the statement read.

Tejada is due back in court on March 4, 2020.

Her younger brother, Travonne Berry-Rogers, was a standout athlete at Lynn English where he helped lead the Bulldogs boys basketball team to the Division 1 state finals in 2006. He went on to play basketball at Merrimack College and is an assistant girls basketball coach at Lynn English.

“I remember when I was at Classical and Travonne was at English, our parents [Douglas Rogers and the late Lillian Berry-Rogers] had to go back and forth to our games,” recalled Berry. “Now my dad is going to be doing it with us both coaching in Lynn.”

## STUDYING BIKE LANES IN WINTHROP

WINTHROP - The Town Council approved a feasibility study last week for painting a bike lane on Veterans Road.

Supporters say that installing a bike lane along Veterans Road connects a huge portion of the town, and also connects Lewis Lake, the center of the town and the beach. There is a huge safety increase when you use bike lanes, supporters contend.

“This is about making Winthrop a great place to get around,” said Julia Wallerice, chair of the Transportation Advisory Committee. “It’s not about turning Winthrop into Somerville or Cambridge. It’s about pulling together past studies and moving forward.”

Chris Aiello, urged support of the study and said it’s a safety issue and quality of life.

As for covering the cost of striping the bike lane, Wallerice said there are grants and kickstarters that can be used. “There are people in the community that really want to so this go forward. To make Winthrop a better version of what it already is.”

# Encore set to give away sports car

New Red Card promotions allow free parking during the week

Encore Boston Harbor is looking to put a little pizzazz in the Labor Day weekend with a full day of giveaways and fun on Sunday, Sept. 1, a day that will culminate with a drawing to give away a McLaren sports car.

Encore President Bob DeSalvio said the giveaway will mark the first big day at the resort casino built on a major drawing. The winner will get a 2019 McLaren 570Z Spider (valued at \$200,000), or the option of \$100,000 cash.

“The car is a big one for us,” he said. “The final drawing will be around 7 p.m., but we’ll have preliminary drawings all afternoon. We start accepting entries at noon that day and there are drawings all the way from 2 p.m. to 6:30

p.m. We want to get a lot of people involved.”

The promotion will feature 10 people drawn from the entries every 30 minutes. Nine of the 10 names will get \$500 in credits, and the 10th name will get a slot in the final drawing for the car.

“At the end, we take all the finalists and draw the winner,” said DeSalvio. “They can take the car or the cash. The others that don’t win will get \$2,500 in credits.”

There will also be a second-chance drawing at 8 p.m.

“It’s a full day of promotions around that drawing that is really the culmination of our entire August promotional campaign,” he said.

•In addition, another major promotion now available for Red Card holders is in the realm of parking.

DeSalvio said they have started a promotion for free, midweek parking at

the resort. Between 5 a.m. Monday and 5 p.m. Friday, Red Card holders will get free parking. On weekends, parking for Red Card holders is just one credit from their card.

“The idea behind this is that during the week, we have opportunity in the garage,” he said. “We get a lot of customers that ask for this because they go to regional resorts with free parking. We decided we can do it midweek, and then charge \$1 on weekends. That’s a way to reward those playing in the casino. They can use the comp dollar on weekends and on weekdays they can park for free.”

•DeSalvio said they are also offering deeply discounted hotel rooms (up to 35 percent off) this month in a partnership with Expedia and Priceline.

He said that while they are building up their clientele, they wanted to take the opportunity to reward those with a Red Card.

“The idea is that as we continue to build up the hotel to full occupancy, we want folks to experience it,”

# MGC announces appointment of independent monitor for Wynn Resorts

The Massachusetts Gaming Commission (MGC) announced the appointment of Washington D.C.-based law firm Miller & Chevalier Chartered to serve as the Independent Monitor for Wynn MA, LLC, et al. During a public meeting at MGC’s Boston office, the five gaming commissioners voted unanimously to ratify the selection of the firm and authorize the execution of the contract.

In April 2019, the Commission issued a Decision and Order regarding Wynn’s suitability. As one of several conditions, the decision required the implementation of an independent monitor at the Company’s expense and with the Company’s full cooperation. In May 2019, the MGC issued a competitive Request for Response seeking to retain an independent monitor of Wynn MA, LLC, the holder of the Region A Category 1 gaming license, to mitigate the risk of recurrence of violations identified in the MGC’s written decision.

After a comprehensive procurement process, MGC’s internal procurement review team selected Miller & Chevalier to review and evaluate policies and organizational changes made by the Company. The review will focus primarily on the Massachusetts licensee and accomplish the following objectives:

•Ensure compliance with the priorities outlined in MGC’s written decision.

•Review the Company’s design, implementation, enforcement, and effectiveness of human resources policies and procedures, with particular attention to communications and trainings on those policies and procedures.

•Review the use of retractions, mandatory arbitrary provisions, gag orders, confidentiality clauses, and non-disparagement provisions.

•Evaluate and test the Company’s internal reporting and communication channels and ensure that the response and investigation of such reports are independent and impartial.

•Assess the selection and use of the Company’s outside counsel and ensure the maintenance of and adherence to de-conflicting policies and procedures.

Alejandra Montenegro Almonte, Miller & Chevalier team lead, said, “Our firm will approach these objectives through the lens of our decades of experience building compliance programs across industries and through our extensive monitoring expertise. The process will be grounded on three inter-related principles — independence, efficiency, and transparency.”

MGC Chair Cathy Judd-Stein stated, “The overall wellbeing, safety, and welfare of employees are a key metric of the gaming industry’s success here in the Commonwealth. A second but equally important metric is the importance of compliance and communi-

cation with the regulator. We believe that the team at Miller & Chevalier will ensure that the Company’s multitude of policy and organizational changes meet best practices.”

In May 2019, the MGC issued a notice of intent to post a Request for Response for the services of an independent monitor. The internal procurement review team met to discuss the parameters of the RFR and collaboratively drafted the request for responses to reflect the decision of the Commission. The team conducted a robust competitive bidding process that resulted in many high-quality responses. The team reviewed the responses and scored submissions based on relevant experience, diversity, cost, and quality and thoroughness.

Miller & Chevalier has estimated its fees for the first six months of monitoring will range from \$575,000 to \$775,000, based on an estimate of approximately 850 to 1,150 hours. This is only an estimate and will be subject to adjustment based on initial findings during monitoring activities. All monitoring fees will be paid for by the licensee.

Miller & Chevalier’s contract will be for a term of five years; however, it would be subject to early termination at the request of the gaming licensee, and at the Commission’s sole discretion after the initial three years.






