GOLDBERG ANNOUNCES RELEASE OF **UNCLAIMED PROPERTY** LISTINGS

Massachusetts State Treasurer Deborah Goldberg announced the latest grouping of names that have been added to the state's list of unclaimed property owners. Over 49,000 new properties worth millions of dollars are owed to individuals and businesses throughout the Commonwealth.

"We currently hold over \$3.4 billion in unclaimed property at Treasury and it could be yours," said State Treasurer Deborah B. Goldberg. "One in ten Massachusetts residents are owed money. Call our office today to begin the claims process."

Unclaimed property includes forgotten savings and checking accounts, un-cashed checks, insurance policy proceeds, stocks, dividends, and the contents of unattended safe deposit boxes. Most accounts are considered abandoned and are turned over to the state after three years of inactivity. Last year, Treasury processed over 120,000 claims and returned over \$139 million in property to its rightful owners.

This newly released list includes only individuals and businesses with unclaimed property over \$100. Treasurer Goldberg urged all citizens to check the comprehensive list for all amounts at www.findmassmoney.com or call our live call center at 888-344-MASS (6277).

Edwards is running for the First Suffolk and Middlesex District seat held by Sen. Joseph Boncore of Winthrop, who has stepped down from the position to become the chief executive officer at Mass BioTech.

Democratic State Committeeman Juan Pablo Jaramillo introduced Edwards prior to the announcement of her candidacy in front of an enthusiastic group of support-

Community vaccination clinic to open in RHS

Since vaccines became available in the spring, Revere Public Schools has taken a proactive approach through public education campaigns, webinars and

other avenues to really pump up student vaccination rates ahead of the 2021/2020 school year.

As a result, Revere vacation rates are surpassing the state's average for students and residents 12-19

year old. In Revere, one of the cities hammered early on in the pandemic, 75 percent of 12- to-15-yearolds had received at least one shot by Sept. 2, along

Arrigo pushes back on BPHC proposal

Mayor Brian Arrigo has reacted "with immense frustration" to continuing rumors that the Boston Public Health Commission (BPHC) is considering a regional plan to allegedly convert the Quality Inn Hotel at 100 Morris St., Revere, into a homeless transitional cen-

Arrigo has written a sternly worded letter to Dr. Bisola Ojikutu, executive director of the Boston Public Health, expressing his displeasure about the potential impacts on the city by this initiative. Arrigo has also sent copies of the letter to Gov. Charlie

Baker, State Sec. Marylou Sudders, and Boston Mayor Kim Janey.

Following is the text of Mayor's Arrigo letter to the Boston Public Health Commission:

"It is with immense frustration that I write to you today regarding continued rumors of plans your agency has for the City of Revere. Specifically, I am disappointed in the Boston Public Health Commission's operations, communications, and accountability measures-or lack thereof-as they concern its "regional" plan to address the disaster on

The full list of the new individuals and businesses added to the unclaimed property list was published in the Boston Globe on September 12th and will be published in the Herald on September 19th. In addition, the list of names will be published in regional and local papers.

The Treasury releases an updated list of unclaimed property assets every six months as the new accounts are turned over to the Commonwealth. There is no time limit for a person to claim this property and, in many cases, claimants will receive interest.

MARKEY CALLS FOR FACEBOOK TO ABANDON PLANS FOR INSTAGRAM FOR KIDS

Following reports Facebook has conducted and reviewed research showing a connection between Instagram and mental health problems among young users, Senator Edward J. Markey (D-Mass.) Representatives Kathy Castor (FL-14) and Lori Trahan (MA-03) wrote to Facebook CEO Mark Zuckerberg today, demanding answers and calling for the company to abandon its plans to develop an Instagram for Kids platform. The recently revealed internal Facebook research includes data on the connections between Instagram use and body image problems, suicidal thoughts, and other mental health challenges among teens on the platform.

"Children and teens are uniquely vulnerable populations online, and these findings paint a clear and devastating picture of Instagram as an app that poses significant threats to young people's wellbeing. As the internet-and social media specifically—becomes increasingly engrained in children and teens' lives, we are deeply concerned that your company continues to fail in its obligation to protect young users and has yet to commit to halt its plans to launch new platforms targeting children and teens," said the lawmakers in

In April, Senators Markey and Richard Blumenthal (D-Conn.) and Representatives Castor and Trahan wrote to Zuckerberg regarding Facebook's announcement that the company is "exploring" plans to develop a version of Instagram for children and expressed concerns about Facebook's past failures to protect children on Facebook's Messenger Kids app. In May, after the company failed to make meaningful commitments to protect kids online, the lawmakers released a statement calling on Facebook to abandon its plans for the children's platform. Previously, Senator Markey has repeatedly pressed Facebook on its failures to protect children and teens, including during Mark Zuckerberg's 2018 appearance before the Senate Commerce, Science, and Transporta-

Featuring the U.S. Postal Service's first new Happy Birthday design in more than a decade, this stamp offers a chance to give envelopes and cards an additional touch of good cheer. It goes on sale today at Post Office locations nationwide and at the online Postal Store.



The celebration of birthdays in the United States has its origins in a wide array of cultural traditions. Some ancient civilizations observed the birthdays of prominent figures or celebrated rites of passage, and well-wishes and gifts have long been associated with bringing about good fortune. Folklorists and historians claim to see the origins of birthday parties in older practices that resemble our customs, such as candles on a cake, which existed in some form in both ancient Greece and early modern Germany. When we gather to sing, brighten our spirits with candles, and make a wish, these deeply rooted rituals connect us to loved ones and invite everyone to share in the birthday fun.

The U.S. Postal Service issued its first Happy Birthday stamp in 1987, when a stamp showing a candle on a slice of cake was part of a Special Occasions booklet that reflected a variety of greetings and well-wishes. In 1988, a second Special

cluded a Happy Birthday stamp that depicted a colorful row of candles. Birthdays reappeared as a subject on U.S. postage in 2002 with the issuance of a stamp featuring the words "Happy Birthday" amid a smattering of festive confetti.

In the years since, the Postal Service has issued several stamps on the theme of celebration. This new Happy Birthday stamp provides another way for the mailing public to convey good wishes on the recipient's special day.

The word "HAPPY" appears most prominently in capital letters, with each of the five letters inspired by a different party decoration: a red and green piñata, an orange and yellow striped birthday hat, a red piece of frosted cake, a green birthday candle, and an orange balloon sculpture. The word "BIRTH-DAY" appears below it in blue, with "Forever" and "USA" centered in smaller red lettering at the bottom. Surrounding all the design elements is a flurry of multicolored ribbons and confetti.

This stamp was designed by Lisa Catalone Castro and Rodolfo Castro, with artwork by Rodolfo Castro. Ethel Kessler served as art director.

The Happy Birthday stamp is being issued as a Forever stamp, which is always equal in value to the current First-Class Mail 1-ounce price.

Plainridge Park Casino, MGM Springfield and Encore Boston Harbor The Massachusetts Gaming Commission reported today that the month of August 2021 at Plainridge Park Casino (PPC), MGM Springfield and Encore Boston Harbor generated approximately \$92 million in Gross Gaming Revenue (GGR). PPC, a category 2 slots facility, is taxed on 49% of GGR. Of that total taxed amount, 82% is paid to Local Aid and 18% is allotted to the Race Horse Development Fund. MGM Springfield and Encore Boston Harbor, category 1 resort-casinos, are taxed on 25% of GGR; those monies are allocated to several specific state funds as determined by the gaming statute. To date, the Commonwealth has collected approximately \$869 million in total taxes and

assessments from PPC, MGM and Encore since the respective openings of each gaming

Administration awards over \$10 million for park and open space projects

Staff Report

Building on efforts to enhance and protect natural resources, the Baker-Polito Administration awarded \$10,090,749 in grant funding for park improvements, open space acquisitions, and land conservation projects in 37 Massachusetts communities and six conservation districts, including Harmon, Gibson and Costa Parks in Revere. The grants, funded by the Executive Office of

Energy and Environmental Affairs' (EEA) capital budget and administered through several programs, including the Parkland Acquisitions and Renovations for Communities (PARC), Local Acquisitions for Natural Diversity (LAND), Conservation Partnership, and Conservation District Innovation Grant Programs, will help municipalities and land trusts in their efforts to protect land for future generations for outdoor recreation purposes. Re-

vere will receive \$320,237 for accessibility and inclusion park renovations at Harmon, Gibson and Costa Parks. The announcement was made by Governor Charlie Baker and Lieutenant Governor Karyn Polito at the City of Lowell's South Common as part of the Administration's celebration of Climate Week in Massachusetts.

"Massachusetts great open spaces and natural resources that not only provide recreation

and access to the great outdoors, but make the Commonwealth more resilient to the impacts of climate change," said Governor Charlie Baker. "Our Administration has made land conservation and local park improvements a key priority since coming into office in 2015, and our proposal to direct \$100 million of federal relief funding into parks and open spaces will allow us to invest even more resources into these important projects, especially in Gateway Cities and underserved communities that need better access to green spaces."

"Since the start of the COVID-19 pandemic, access to the state's green spaces and parks has never been more important to residents in every community across the Commonwealth," said Lieutenant Governor Karyn Polito. "The PARC, LAND and Conservation Partnership programs all play a critical role in ensuring the public has many opportunities to explore and enjoy natural recourses that are available close to home, and partners in municipalities

across the Commonwealth to support these park improvement projects."

Administration The awarded \$8 million through the PARC Grant Program to support 24 projects that will support the development of parks and outdoor recreational assets. The program was established in 1977 to assist cities and towns in acquiring and developing land for parks and outdoor recreation purposes. Any community with an upto-date Open Space and Recreation Plan is eligible to apply for the program. Since 2015, the Administration has awarded \$47 million to 153 projects to acquire land for and build new parks, and renovate existing ones..

Additionally, the Administration awarded \$1.2 million to four projects through the LAND Grant Program. The program was established in 1961 to assist municipal conservation commissions in acquiring land for natural resource protection and passive outdoor recreation purposes. Since 2015, the Administration has awardhave permanently protect-

ed more than 4,576 acres. Through these programs, the Baker-Polito Administration is partnering with local communities and land trusts to protect critical open spaces and support the acquisition and restoration of local parks that provide important access to the outdoors, especially in our urban communities and Gateway Cities," said Energy and Environmental Affairs Secretary Kathleen Theoharides. "The enthusiasm and joy residents across our Commonwealth have for these special places and the strong desire to get outside throughout the pandemic demonstrate the need for even greater investments in resilient lands, natural resources, and outdoor recreation through Governor Baker's



There is something about being in the outdoors, under a canopy of brightly-colored trees with the sound of a running stream, that soothes us both physically and spiritually in a way that is altogether lacking amidst the constant noise and congestion of our lives in

So we urge all of our readers to make the time for themselves and their families to travel west or north over these next few weeks and go for a hike in the mountains.

A hike, particularly during this time of COVID-19, will be a reminder that the best things in life are free.

A SAD -- BUT PREDICTABLE -- OUTCOME

Amidst all of the big news stories during these past two weeks, perhaps the one that has grabbed the most attention from Americans of all ages involved the mysterious disappearance of 22 year-old Gabrielle Petito, the young woman who had been on a cross-country trek in a van with her 23 year-old fiance, Brian Laundrie.

When Laundrie returned home in early September without Petito, and with no explanation as to where she might be, it was obvious that Ms. Petito -- whose body was found this past Sunday in a camping area in Wyoming -- had become yet another tragic victim of domestic violence in this country.

Despite all of the strides we have made to combat domestic violence since the 1980s, the fact remains that a woman in this country is in more danger from an intimate partner than from any other source. Intimate partner violence accounts for 15% of all violent crime in the United States.

The cold, hard statistics paint a grim picture:

- -- 1 in 4 women have been victims of severe physical violence by an intimate partner in their lifetime. -- 1 in 7 women have been stalked by an intimate
- partner during their lifetime. -- The presence of a gun in a domestic violence situa-
- tion increases the risk of homicide by 500%.
- -- Women between the ages of 18-24 are most commonly abused by an intimate partner.

That last statistic fits the profile of the relationship between Ms. Petito and Mr. Laundrie.

As this is being written, the authorities are searching for Mr. Laundrie, who disappeared early last week, according to his family.

The tragic death of Gabrielle Petito is yet another sad reminder of the pervasiveness of domestic violence in this country, a problem for which there appears to be no end in sight in our society.

Melnea Cass Boulevard by allegedly converting the Quality Inn Hotel at 100 Morris Street, Revere, to a homeless transitional center. I am deeply concerned about the chaotic nature dis-information and have lost all confidence in the Boston Public Health Commission to thoughtfully execute on an issue of such regional public importance. People experiencing homelessness deserve the resources and intervention efforts necessary for them to lead stable, fulfilling lives. Unfortunately, the actions taken by the BPHC thus far place the City of Revere's commitment to these neighbors in jeopardy while at the same time frustrating efforts for the regional collaboration necessary to combat this regional crisis.

Given the immense challenges of supporting a population marginalized by high rates of substance use disorder, mental health challenges, and trauma, every public health measure concerning the unhoused ought to establish clear lines of communication readiness protocols with all involved stakeholders. The BPHC has failed to establish these relationships at the onset of their initiative. The City

of Revere was first made aware of the BPHC's plans for the Quality Inn through a voicemail left to our Substance Use Disorder and Homelessness Initiatives SUDI Office on August 30 by a recovery coach with Eliot Community Human Services. With no prior notice whatsoever, we were taken aback by the message's announcement that the Quality Inn allegedly would begin operating imminently as a homeless transitional center with over 150 beds. At this point, I do not even know how many beds BPHC is contemplating. Over the last three weeks we have been told different numbers by different members of this collaboration. I have heard 156, 30, 60 and 160 but I still have not received anything in writing. Simply put, the level of disorganization from BPHC regard-

ing this effort is appalling. With concern over the preparedness of our first responders and our Health and Human Services Division as well as the regulatory procedures completely ignored by BPHC, we made repeated attempts to connect with BPHC, the City of Boston's Office of Recovery Services, and Eliot. At this point it is clear that our hopes of an organized plan of action would reveal itself have been dashed by the BPHC's inability to produce contingency and operational documentation that ought to come standard with such a sensitive initiative. It is also clear that little to no planning was undertaken in advance of the relocation of unhoused individuals from Melnea Cass Boule-

The BPHC has continued to insist that the Quality Inn initiative is just one instance of a larger regional approach to the crisis on Melnea Cass Boulevard, yet they have not been able to provide my administration with other municipalities joining this effort. This information gap is particularly frustrating as I would find extremely valuable an initiative that bound several municipalities together in solidarity to root out homelessness in the Commonwealth. I only hope that this effort is not just focused on our Gateway Cities but rather a true collaborative approach across our region and the failure to provide this information is not due to surreptitious operations ongoing in other cities and towns.

Beyond the logistical and communication challenges, the BPHC has set the stage for fierce reaction against the interventions our homeless neighbors need, ultimately undermining the public health improvements we all agree are necessary. Political opportunists with no desire to ameliorate the overlapping crises that create homelessness will seize any challenge that arises from the poor, unprofessional management of this initiative. Consider the impact of an emergency at this site without the full preparedness of Revere's first responders. Not only would the lives of our most vulnerable neighbors be at stake, but also the viability of the much larger reform movement. The victims of BPHC's mismanagement and collateral consequences would number not in the hundreds, but in

the tens of thousands. The stakes are too high for BPHC to squander the opportunity for a truly regional solution to the housing and homelessness crises. My profound disappointment come from genuine concern over our unhoused neighbors, and we will continue to support them through both established partnerships and innovative practices. Unfortunately, the BPHC has yet to demonstrate the capacity to meet the moment and have instead endangered the progress we all hope to

Zambuto. "I'm collaborating on this plan with neighbors. We are exploring all options."

Zambuto has witnessed the coyotes' presence firsthand. "The coyotes think they own the street," he said. "They come parading down the street five or six in a pack. It's crazy and it has to stop. We can't allow a baby or another animal to get seriously hurt. We don't want to be like other communities that have had situations like that." Mayor Brian Arrigo has

been closely monitoring the situation on High Street. He has been in touch with officials from the state wildlife office. "When my office was ini-

tially alerted of the coyotes in the High Street neighborhood, we reached out to the State to come up with a solution," said Arrigo. "Unfortunately, because coyotes are considered a protected species, we have to be creative in our approach. Over

the last year, the Revere

DPW has made efforts to

clean up coyote breeding areas to potentially steer them away from the neighborhoods of Revere. Clearly, the city is in a tough spot navigating protected species protocols and ensuring our residents feel safe. I applaud Council President Zambuto for bringing this to the attention of the Revere City Council and for the residents who are creatively collaborating on a solution to the problem at hand." Dave Wattles, a biologist

and an expert on wildlife management at the State Wildlife Office, said he has conferred with High Street neighbors about the coyote situation.

Wattles provided neighbors with the proper steps to take to limit coyote activity in the area. Some of those steps include blowing an airhorn, banging pots and pans, spraying a hose, and

too comfortable with their surroundings right now and they're not afraid of the surroundings and they're not afraid of people either, on the street," said anoth-er neighbor. "That comfort zone is what's going to cause them to be aggressive for little kids." There is a City Council

meeting Monday night, so High Street's continuing coyote problem could be up for discussion, with a resolution in sight.







I'm very excited that you have all joined us today," said Jaramillo. "We know that Lydia has been a tireless advocate for working families in our community and around the Commonwealth - from her work doing the domestic workers' bill of rights, and insuring that we have good, strong-paying jobs throughout the district.

"Just a stone's throw away from here, she fought to ensure that we have more affordable housing in what will be a 20-year development in the area," continued Jaramillo. "Aside from her being my friend, I know that she is the best candidate to fill what will be my former boss' position. I had the pleasure of working in Senator Boncore's office for three years, and I know exactly what type of senator our district needs, and I know Lydia will meet that expectation and exceed it by a lot."

Edwards, who represents East Boston, Charlestown, and the North End on the Boston City Council, began her remarks by stating, "I'm running to be your next state senator. My name is Lydia Edwards, and I live in East Boston. I'm a career advocate. I'm a person who has come from all over the world - my mother was in the military and raised me all over the world to really appreciate what community can be.

"And while you may not be born in a community, you can create community, you can lead in that community, and you can always serve in that community – and that's why I m running – to serve each and every one of you in whatever language, to make sure you are seen, that you are heard, that you are valued," said Edwards.

She told the attendees that she is a legal services attorney who has been practicing

Edwards said that af-

ter her mother left the Air Force, "she worked two jobs because the minimum wage was \$5.15 an hour. I know a lot of you know parents who are working two jobs right now to pay the rent. I will not forget where I come from, and I will not forget that my mother still taught me, it's about service to others, even when she worked two jobs, and had a parttime job on Saturday. I had a job and my sister had a job, and we would pull our money together to pay the bills.

"A lot of families are doing that right now," she said. 'A lot of families are doing that in East Boston and they're doing it throughout the district. I'm running for them. I'm running for the kids who are on free lunch. I'm running for the seniors oftentimes who are on limited income and can barely afford to keep their homes.

"There are a lot of people who are struggling right now," said Edwards. "And I've been honored to serve them as a legal services attorney, and I certainly could do so as your next state senator. We have a grassroots campaign and it is strong and growing every day."

Edwards said her sup-

porters consist of people from varied jobs and backgrounds. "You can't look and see what a typical Lydia Edwards voter is, and that's intentional. I meet people, all people where they are, and it's important to hear and listen. We speak a lot as politicians but we don't re-

ally hear the pain, the strug-

gle, and understand the policies to really help people."

For me and my family, these opportunities have life-changing included education, good jobs, and a welcoming place to call

I have deep roots in our community. My paternal grandparents immigrated to East Boston in 1972 and later started a successful landscaping business, Revere Gardens Company, which serviced the local area. My maternal grandparents immigrated to the US in 1968 and have lived in Winthrop. My mother, aunt and uncle are all proud Winthrop High School graduates. My father, also an immigrant to the US, attended both East Boston and Revere public schools. Today, he operates a community law office in Revere. I have spent years in the District, living primarily in Revere but frequently visiting family in Winthrop, East Boston, and the North End. I stand on the shoulders of my grandparents and parents, who came to this country from Southern Italy with literally the clothes on their backs and have given me the privilege to run for Senate today.

As an adult, after graduating from Yale University and the University of Cambridge in England, I returned to Revere and began working as a financial analyst in the technology industry. My job gave me a front row view of the ways in which technology is radically transforming our economy. With a job at the intersection of finance and technology, I wanted to ensure that future generations of students are likewise prepared for the

21st century economy. That is why I ran for the Revere School Committee and why I am now running for Senate. I hope to give back to my community and bring a new, outsider's perspective to the State House.

The Covid-19 pandemic disrupted our community in virtually every way imaginable. It laid bare all our society's vulnerabilities and inequities, as well as the ways in which our leaders are failing in their obligations to Massachusetts residents. Like so many others, I watched loved ones be hospitalized with Covid-19. One of the most painful periods of my life was watching my father struggle to breathe while hospitalized despite supplemental oxygen and incredible medical care. Even with the progress Massachusetts has made in containing the virus, the fear and pain of losing loved ones or seeing them suffer has still not dissipated for my family and countless other families in our community.

As a member of the Revere School Committee, I took calls over the last eighteen months from dozens of Revere parents who had to make the extraordinarily difficult decision to quit their jobs to provide care and educational support to their suddenly homebound children. This decision meant sacrificing half or even the entirety of their household incomes.

I similarly heard students describe falling months behind in their schoolwork because they did not have access to consistent, reliable In-

ternet, despite living just a few miles away from some of the top research universities in the world This inequity, among others, inspired me to lead the creation of an Equity Advisory Board in Revere that will work to eliminate educational disparities.

Additionally, I pushed increased mental health services for children in Revere Public Schools. Through my research and conversations with city leaders across the District, I know that similar numbers of students in Winthrop, Boston, and Cambridge public schools have also struggled with mental health issues over the past year.

These situations are unacceptable. We need to immediately allocate federal relief funds to help children TODAY, not in two or three years when the damage cannot be repaired. While the old ways of Beacon Hill are still prevalent, we need new, modern ways of examining our problems and

planning for the future.

We are at a pivotal moment where we can not only recover to a pre-pandemic normal, but also rebuild in a way that prepares our residentsand especially our children-for the challenges and promises of the 21st century. I am running for State Senate because I want to help ensure that the District that has given so much to me and my family can continue to do so for generations of families to come.

Join me. I again ask for your vote."



The expanded gam-

ing bill that might have the end result of a casino opening at Suffolk Downs was passed by the House last week and is now in the Senate where its particulars are being examined before an expected vote at the end of the month. The Senate is believed ready to pass the bill, which would then be sent to the governor for his signature. According to the bill's language, a casino at Suffolk Downs would designate Revere and East Boston as host cities and would make available 6.5% of casino revenues to be divided equally by the two cities from year to year. It has the potential of bringing many millions of dollars into the Revere city treasury at a time when the city is hard pressed to meet the growing cost of its huge fixed expenses.

State Representative Kathi Anne Reinstein has endorsed candidate for mayor Dan Rizzo. Reinstein's endorsement came during Rizzo's annual luau affair held at Casa Lucia before a large crowd two weeks ago. Rizzo told the Journal that Reinstein's endorsement meant a lot to him and to many others. Reinstein said she would be working for and with Rizzo to get out the vote in November. "It is important to the future of this city for Dan Rizzo to be elected the next mayor of Revere," she said.

A debate will be held at the Whelan School Auditorium between mayoral candidates Dan Rizzo and George Rotondo, according to statements issued last week from officials for both their campaigns. The Revere Journal-sponsored debate will take place on the evening of October 18 inside the auditorium of the Whelan School. The agreement to debate follows months of wrangling between the two mayoral hopefuls. As it is presently-planned and agreed-upon, seating will be available for 100 Rizzo supporters, 100 hundred Rotondo supporters, and for an additional 100 voters who presumably have not yet decided for whom they will be casting a vote.

with 80 percent of 16- to the public aged 12 and 19-year-olds.

Now, the Revere Department of Public Health (RPH) has teamed up with Cambridge Health Alliance (CHA) as part of a comprehensive strategy to vaccinate local communities.

CHA, in partnership with RPH, is launching a series of community COVID-19 vaccination clinics in Revere.

yesterday, Starting September 21, CHA will hold a regular community vaccination clinic at Revere High School at 101 School St. The clinic will run every Tuesday until October 19 from 3-6:30 p.m. and will be open to older. The Pfizer vaccine will be available, and will be free of charge.

"We realize that vaccination is the best way to prevent serious illness from COVID and we are thrilled that Lauren Buck and the Revere Department of Public Health have been able to partner with CHA to bring these opportunities directly to our students," said RPS Superintendent Dianne Kelly. "It takes the barrier of access out of the equation for many."

Ahead of the new school year and after vaccines became available RPS hosted a series of webinars to encourage more high schoolers to get vaccinated.

"Vaccines do work," said RPH's Dr. Nathalee Kong at one of those webinars. "We have data here to show that onecde the vaccine rollout started in nursing homes infections significantly dropped. So the vaccines are effective at protecting the most vulnerable members of our community from getting hospitalized from getting severe symptoms of COVID and from dying with COVID. So this is what we're aiming for so that we can keep our kids in school and get them back to prom, back to

sports, just back to all the things that we used to do and enjoy."

Dr. Kelly said all members of the Revere community have been encouraged by RPS to talk to a trusted medical professional--primary care provider or trusted nurse--when making a decision about receiving the vaccine.

50 years ago Sept. 23, 1971

The body of an East Boston man, John Joseph Silva, 35, was found lying on Revere St., with two bullet wounds to the head this past week. Silva had been released on parole from state prison only 15 hours earlier when his

body was found. Silva pleaded guilty in 1962 to the armed robbery and pistol-whipping of Surf Club owner Joseph DiCarlo, a member of a prominent family involved in Revere politics. Silva had received a16-20 year sentence for his crimes.

Mitchell Ginsburg, 51, a foreman for New England Telephone, is being credited with saving the life of 16 year-old Robert DeRosa, who was struck by an automobile as he rode his bicycle on Broadway. Ginsburg, of 206 Park Ave., was alerted to the accident by the screams of his wife as they were enjoying dinner in a restaurant on their 27th anniversary. He found DeRosa with a severe gash in his neck through which blood was pouring out. Ginsburg applied pressure to the wound, which eventually required 100 stitches. Ginsburg said the restaurant picked up the tab for his dinner.

Councilors Fran Doris and Victor Fanikos, the first and second-place finishers in Tuesday's primary election, clashed over urban renewal at this week's City Council meeting, with Doris asserting that the urban renewal project on Ocean Ave., which eventually became an MDC parking lot, was the first, and worst, urban renewal project in the state. 



Chelsea High-Revere High was always a great football rivalry in the old Greater Boston League – and in Pop Warner as well. In fact, head coach Lou Cicatelli experienced it as a former football player for the Revere High Patri-





# Residents among fourteen Brazilian nationals charged with identity theft

Fourteen Brazilian nationals including three men from Revere were charged in a second superseding indictment by a federal grand jury in Boston in connection with a nationwide conspiracy to open fraudulent driver accounts with multiple rideshare and delivery service companies. In May 2021, 19 de-

fendants were indicted on one count of conspiracy to commit wire fraud by using stolen identities and falsified documents to create fraudulent driver accounts for rent or sale to individuals who might not otherwise qualify to drive for the rideshare or delivery services. The defendants allegedly exploited referral bonus programs

offered by the rideshare and delivery companies and used "bots" and GPS "spoofing" technology to increase the income earned from the companies. As a result of the scheme, Internal Revenue Service Forms 1099 were generated in victims' names for income that conspirators earned from the rideshare and delivery companies. The second superseding

indictment also charges 14 of the defendants with aggravated identity theft related to their use of victims' means of identification in connection with the conspiracy. According to the charging documents, the defendants allegedly used victims' identifying information to apply for driver accounts with the rideshare and delivery companies, enabling defendants to pass those companies' required background checks and create driver accounts in victims names. At times, defendants also edited victims driver's license images to display photos of the drivers renting or buying the fraudulent accounts in order to circumvent facial recognition technology that the rideshare and delivery companies used as a security measure. The defendants allegedly obtained victims' names, dates of birth, driver's license information, and or Social Security numbers from co-conspirators and

other sources, including

driver's license images

directly from victims, by

victims' photographing licenses while completing an alcohol delivery through one of the services or while exchanging information with victims following vehicle accidents, some of which defendants or co-conspirators intentionally caused in order to obtain victims' license information. The grand jury previ-

ously returned a superseding indictment charging two of the 19 defendants in the case with aggravated identity theft in June 2021. Sixteen of the defendants have been arrested in connection with the conspiracy and three remain at large. The Patriots also saw two starting linemen forced out with injuries. The Pats struck for the first score in

the opening quarter when Lauria capped a 60 yard drive and went over from the four yard line. Jeff Simbert kicked the PAT to make it 7-0.



# Rockland Trust, Metro Credit Union partner in unique, community-minded agreement to preserve jobs

Independent Bank Corp., parent of Rockland Trust Company, and Metro Credit Union today announced an agreement whereby Metro Credit Union will acquire four of the East Boston Savings Bank branch locations that Rockland Trust previously announced would be closing following the Bank's impending acquisition of East Boston Savings Bank. The mutually beneficial transaction will enable further retention of jobs for former East Boston Savings Bank employees and will enable Metro as Massachusetts' largest state-charted credit union.

With this transaction, Metro will acquire four physical branch locations and the employees working within them, enabling Metro to open two new locations at 960 Morrissey Boulevard in Dorchester and 1985 Centre Street in West Roxbury and relocate two existing branch locations in Burlington and Melrose to 50 Summit Drive and 108 Main Street, respectively.

The four locations are scheduled to open as Metro branches in early 2022. The closing of the four branches by Rockland Trust and the opening of the four new branches by Metro is subject to receipt of customary regulatory approvals. The sale transaction between Rockland Trust and Metro is structured as an assignment of the applicable leases and is limited to the physical branch facilities, as Rockland Trust intends to maintain the existing customer relationships. As part of the agree-

ment, Rockland Trust and Metro Credit Union agreed that employees working within those branches at the time of the East Boston Savings Bank acquisi-

tion will be extended job offers with Metro, subject to a background check. Additionally, branch employees at these locations will receive a generous severance package from Rockland Trust during the bridging period.

"We approached this branch sale with the priority of securing as many jobs as possible, while minimizing the disruption to the neighborhoods around these branches." said Robert Cozzone, Chief Operating Officer and Executive Vice President of Consumer and Business Banking at

Rockland Trust. "We

share and appreciate Metro's high level of commitment to customers and employees, and we're grateful this agreement will benefit the communities we serve."

In addition to these four locations, Metro plans to open two additional new offices in the fall of 2021 a new location on Main Street in Reading, and a second Peabody location on Andover Street. In total, Metro plans to open six new locations over the next six months, bringing its branch network to 18 locations.

# Baker-Polito administration announces \$15 million in support for the Food Security Infrastructure Grant Program

Building on investments to address food insecurity among Massachusetts residents, the Baker-Polito Administration last week announced it has made available \$15 million in funding through a second round of its Food Security Infrastructure Grant Program. The funding will enable the Administration to continue to implement the recommendations of the Food Security Task Force, which was convened last year by the Massachusetts COVID-19 Command Center in response to increased demands for food

assistance. "Addressing food security issues remains a high priority of our Administration to help ensure all residents have fresh, healthy produce readily available to them," said Governor Charlie Baker. "By working with dedicated partners, we will continue to strengthen the food distribution supply chain and address more needs throughout the Commonwealth."

"This round of grants

from the Food Security Grant program will further expand on our efforts to provide greater access to locally harvested and produced food products," said Lieutenant Governor Karyn Polito. "With higher numbers of people experiencing food insecurity, we continue to take significant strides in ensuring fresh, locally sourced food remains widely available to the residents of Massachusetts."

The Administration opened the funding opportunity on Wednesday, September 15, 2021 and is currently accepting applications for funding. In this round, the program is focused on addressing access to fresh food by improving and strengthening the resiliency of the Commonwealth's food system and expanding the distribution of locally grown and sourced products to vulnerable communities. The Request for Responses for project proposals is available here, and is open until October 31, 2021.

Administration The launched the Food Security Infrastructure Grant Program last years part of a \$56 million investment to combat food insecurity for Massachusetts families and individuals. In addition to expanding access to healthy local food, the program seeks to ensure farmers, fishermen and other local food producers are better connected to a strong, resilient food system to help mitigate future food supply disruption. Last year's program dedicated over \$35.5 million to hundreds of projects to address food insecurity across the Com-

"The Baker-Polito Administration has been addressing increased food insecurity for families as a result of the public health emergency, building on and strengthening the infrastructure in place, and leveraging existing nutrition resources like SNAP and WIC," said Secretary of Health and Human Services Marylou Sudders. "The \$15 million in additional funds will further strengthen the food system in Massachusetts, increasing access to local, healthy food, particularly among communities hardest-hit by the COVID-19 pandemic."

Eligible grantees include entities that are part of the Massachusetts local food system, including production, processing and distribution, the emergency food distribution network, community and food organizations, school meal programming, urban farms and community gardens, non-profits, and other organizations involved in ensuring that everyone in the Commonwealth has access to fresh, healthy foods. Applications for the second round of the Food Security Infrastructure Grant Program are due Sunday, October 31, 2021.

The first round of the Food Insecurity Infrastructure Grant Program was announced in May 2020 as part of a \$56 million investment by the Baker-Polito Administration to combat urgent food insecurity for some Massachusetts families and individuals as a result of COVID-19. The Administration also announced a \$5 million increase for the Healthy Incentives Program to meet increased demand for local produce and to increase access points that process SNAF and HIP benefits, \$12 million for the provision of 25,000 family food boxes per week through a regional food supply system, and \$3 million in funding as an immediate relief valve to food banks.

# State health officials announce seventh human case of WNV

The Massachusetts Department of Public Health (DPH) announced an additional case of West Nile virus (WNV) in the state this year. WNV infection was identified in a woman in her 30s who was exposed to WNV in Bristol County. This is the seventh human case of WNV

this year. Previously, since September 1, DPH has announced six human cases and one animal case of WNV in Massachusetts. Twenty-seven communities in Essex, Middlesex, Brookline and Suffolk counties are at high risk and forty-nine communities are at moderate risk. Based on mosquito findings and the new human case, eleven additional communities are being raised to moderate risk. Those communities are: Fall River and Seekonk in Bristol County; North Andover in Essex County; Bridgewater, East Bridgewater, Halifax, and Plympton in Plymouth County; and Blackstone, Hopedale, Milford, and Millville in Worcester County. As overnight temperatures get cooler, mosquito activity right around

more intense. "This is our first West Nile virus case this year in someone under the age of 50," said Acting Public Health Commissioner Margret Cooke. "This is a reminder that although people over the age of 50 are at greater risk from

dusk and dawn may be


West Nile virus, all ages can be affected. Risk from West Nile virus will continue until the first hard frost and people should remember to take steps to prevent mosquito bites anytime they are outdoors."

In 2020, there were five human cases of WNV infection identified in Massachusetts.

WNV is usually transmitted to humans through the bite of an infected mosquito. While WNV can infect people of all ages, people over the age of 50 are at higher risk for severe disease. Most people infected with WNV will have no symptoms. When present, WNV symptoms tend to include fever and flu-like illness. In rare cases, more severe illness can occur.

People have an important role to play in protecting themselves and their loved ones from illnesses caused by mosquitoes.

**Avoid Mosquito Bites** Apply Insect Repellent when Outdoors. Use a repellent with DEET (N, N-diethyl-m-toluamide), permethrin, picaridin (KBR 3023), oil of lemon eucalyptus [p-menthane 3, 8-diol (PMD)], or IR3535 according to the product label. DEET products should not be used on infants under two months of age and should be used in concentrations of 30% or less on older children. Oil of lemon eucalyptus should not be used on children under three years of


