REVERE HIGH FOOTBALL OPENS PLAYOFFS FRIDAY

The Revere High School football team will play Plymouth South in the opening round of the Division 3 playoffs Friday (7 p.m.) in Plymouth. Revere (4-4) is the No. 14 seed in the 16-team field. Plymouth South (8-0) is the No. 3 seed. The two teams previously met in the second game of the season, with Plymouth South prevailing by a 35-20 score. Revere clinched its playoff berth with a 23-0 victory over Malden last week. Giovanni Woodard rushed for touchdowns measuring 9 yards and 20 yards. Quarterback Carlos Rizo threw a 10-yard touchdown pass to Sami Elasri. Placekicker and punter Felipe Maia booted a 30-yard field goal and three PATs, and pinned Malden deep in its own territory on punts. Jason Shosho, who will likely be a unanimous selection to the GBL All-Star team, had 11 tackles in the shutout of the Tornados. Maykin Funez Gonzalez intercepted two passes. Chris Cassidy also excelled on defense with six tackles. Despite losing key starters to injuries during the season, Revere rallied to

Board of Health reviews new biosafety regulations

The Revere Board of Health held its regular monthly meeting last Thursday, October 27, in the City Council Chambers. The chairperson, Dr. Drew Bunker, and fellow members Dr. Craig Costanza and Nezha Louadi were on hand for the meeting, as well as Lauren Buck, the Director of Public Health; Michael Wells, the Health Agent/Director of Inspectional Services; and Paula Sepulveda, the board's Administrative Assistant. The board took the first step toward promulgating

updated biosafety regulations, a move necessitated by the anticipated life sciences buildings that will be located in the Suffolk Downs develop.m.ent, with an initial review of draft regulations that had been put together by Buck and Claire Inzerillo, a Policy Writer & Analyst with the City Solicitor's office. Ms. Inzerillo, who made an excellent and thorough presentation of the proposed regulations over the course of the next 30 minutes, told the board that the draft regulations were based on similar regulations in Peabody, Beverly,

Boston, and Cambridge, which have hosted life sciences industry facilities for a number of years. Some of the other aspects of the new regulations highlighted by Inzerillo were: -- Revere will continue to prohibit animal testing and allow only Level 1 and 2 biosafety facilities, which are the least-dangerous (as opposed to Level 3 and 4 facilities); -- The new regulations specifically will exempt clinical and professional healthcare ser-

ZBA approves variances for scaled-back, 25-unit Salem St. apartment building

The Revere Zoning Board of Appeals (ZBA) gave its approval to developer Mario Zepaj for four variances for the construction of a 25-unit apartment building at 344 Salem St. at its regular monthly meeting last Wednesday evening. The often-contentious, 45-minute hearing saw neighborhood residents often interrupt the proceedings, drawing repeated admonitions from ZBA chairperson Michael Tucker and pointed responses from Atty. Gerry D'Ambrosio, who represented the applicant. Thursday's hearing was the third to be held on the application in the past three months. After the initial hearing in August,

the ZBA voted to continue the proceedings to allow for the developer and the neighbors to get together to work out their differences. The parties met in early September and then when the matter came up at the ZBA's meeting on September 21 meeting, attorney Nancy O'Neill of the D'Ambrosio law firm told the ZBA that based upon the input from the residents, Zepaj would be drawing up new plans to be presented at the October meeting. Zepaj's initial plans for the half-moon-shaped lot, which presently is the site of a long-vacant auto garage at the corner of Salem and Clifton Sts. and abuts the Northern Community Strand Trail in the rear, called for 25 apart-

ments consisting of five two-bedroom units and 20 one-bedroom units. D'Ambrosio told the board that the new plan eliminated the two-bedroom units and instead would consist of 24 one-bedroom units and one studio unit, which resulted in an overall reduction in the size of the structure. He also noted that there would be parking for 50 spaces -- two per unit, which goes beyond what is required per the zoning ordinances -- that would be in an underground garage with a mechanical parking system. With the scaled-back project, D'Ambrosio came before the board seeking only four variances, compared to the seven vari-

Revere voters will go to the polls on Tuesday, Nov. 8

Revere voters will head to the polls Tuesday for the general election to select the next governor of the Commonwealth of Massachusetts. Maura Healey and Kim Driscoll (Democratic Party), Geoff Diehl and Leah Allen (Republican Party) and Kevin Reed and Peter Everett (Libertarian Party) are seeking the gubernatorial and lieutenant gubernatorial positions respectively in the election to a four-year term. Gov. Charlie Baker and Lt. Gov. Karyn Polito, who served two terms in office, are not seeking re-election. Revere Election Commissioner Paul Fahey said that the polls will be open from 7 a.m. to 8 p.m. Tuesday. "I'm predicting a moderate turnout," said Fahey. "There are no contested local races at the state legislative or county level. We have 3,000 residents who have voted by mail-in ballot or participated in early voting, which is 10 percent of all registered voters." In addition to the races for the state constitutional offices, the four ballot questions are driving voter turnout in Revere, notably Questions 1 and 4. State Reps. Jessica Giannino and Jeff Turco and State Sen. Lydia Edwards are unopposed in their elections. Suffolk County Sheriff Steven Tompkins and District Attorney Kevin Hayden are also unopposed in Tuesday's election. U.S. Rep. Katherine Clark, a resident of Revere, is being challenged by Republican candidate Caroline Colarusso for the Fifth District seat in the House of Representatives.

vice facilities, pharmacies, and high school labs;

-- Inzerillo explained that the definition of regulated biological agents is derived from the federal regulations and noted that there is a significant overlap of most local and state regulations with the federal regulations;

-- Regarding the issue of institutional governance, each company will be responsible for establishing a committee that oversees compliance with local, state, and federal regulations, and the committee must include a representative from the local Health Department and a local community resident who is an expert on biosafety. Inzerillo emphasized that the life sciences industry has previous experience with the requirements of regulations such as these because they are federally-mandated; and

-- The Board of Health will have to determine the fees for permit applications and annual renewals, as well as fines for violations.

Wells added that there should be mandatory inspections by the city twice per year.

Finally, Inzerillo noted that HYM, the developer of Suffolk Downs, has agreed both to the prohibition on animal testing and the restriction on tenants in its life sciences buildings to those who will operate only Level 1 and 2 biosafety laboratories.

The board's next step in the process will be to hold a public hearing on the proposed regulations at its next meeting

Prior to the discussion on the new biosafety regulations, Buck presented her monthly communicable disease report. She told the board that there were

six confirmed cases of influenza in October, with the patients ranging in age from three to 80, which she said is typical.

"However," said Buck, "we expect these numbers to rise in the coming months. It is important that everyone gets a flu shot."

She also said there were two confirmed cases of Legionnaires Disease in the city and that Ebola has arisen again in Africa. Though there have been no confirmed Ebola cases in the U.S., federal authorities are taking precautions for U.S.-bound travelers from Uganda.

As for COVID, Buck said that both the daily average and the positivity rate have shown slight decreases in October compared to September.

Inspectional Services Dept. (ISD) Director Wells presented the ISD's statistics for the month which included: the issuance of 96 certificates of fitness for occupancy, 19 re-inspections for certificates of fitness; 23 interior complaints that were submitted; seven interior or complaint re-inspections; two pool inspections; two lodging house inspections; 48 food inspections, including the Revere school cafeterias; two food complaint inspections; and five pre-opening inspections for new establishments.

The ISD issued 472 citations for violations of the city's trash ordinance, three citations for improper signage on public property, 13 citations for improper storage of garbage and trash, 13 citations for junk car keeps/improper storage of automobiles, one for a rodent complaint, and 13 citations for violating the city's over-growth regulations.

MBTA expands Pay-Per-Use Limited Fare Program to local employers

The MBTA announced partnerships with Kendall Square Association (KSA) members Google and Sanofi, the City of Boston, and retailers in Assembly Row to provide employees of those organizations with local bus and subway passes through the Pay-Per-Use limited fare program. During this program, a select number of employees from Google, Sanofi, the City of Boston, and retailers at Assembly Row will have unlimited access to subway and local bus services with their trips fully funded by their employers or for Assembly Row retail employees funded by Assembly Connect for the duration of the Pay-Per-Use limited fare program initiative.

Since 2016, the MBTA has partnered with MIT to operationalize a post-paid institutional fare program that charges the institution based on usage of their employees' transit passes. The MBTA is excited to extend the fare program to Google, Sanofi, the City

of Boston, and retailers at Assembly Row this fall. The Pay-Per-Use limited fare program initiative is expected to run for 24 months, whereupon the MBTA will evaluate expanding it further as we transition to the new fare collection system.

"We've been so excited to partner with the MBTA and expand on the proven success of the Access MIT model to provide this service to two more of our KSA members—Sanofi and Google," said Beth O'Neill Maloney, Executive Director of the Kendall Square Association. "Our members are innovating around their commuter culture, parking assets, and carbon footprint as a part of their commitment to sustainability."

"Mayor Wu is deeply committed to advancing reliable, affordable, and sustainable transportation across the City of Boston," said City of Boston Chief People Officer Alex Lawrence. "This work includes making multimodal options accessible to our workforce.

Through this pilot program, we will gain valuable insight about MBTA usage that will help us make transit related decisions in the future. We are so excited to partner with the MBTA in early 2023."

"By subsidizing transit passes for retail employees we're helping retailers attract and retain essential workers for whom the costs of parking and transportation are often prohibitive," said David Webster, Federal Realty Investment Trust, President Assembly Connect.

"The benefits and policies that employers offer their employees play a key role in what mobility choices their employees make," said MBTA General Manager Steve Pofatak. "We are thrilled to partner with the City of Boston, Google, Sanofi, and Assembly Connect to support their employees' use of transit. By studying this limited expansion of the program that Massachusetts Institute of Technology (MIT) helped

pioneer, we aim to guide further development of flexible fare programs for employers as we transition to the new fare collection system."

Many employers in the greater Boston area provide their employees with transit benefits through the MBTA's Perq for Work program, offering pre-taxed (sometimes fully or partially) funded transit passes to employees. This Limited Pay-Per-Use fare program works with employers and TMAs such as Assembly Connect that want to fully subsidize their employees' transit trips to incentivize employee use of transit when commuting to work. Participating employees at Google, Sanofi, the City of Boston, and retailers at Assembly Row will have unlimited access to MBTA Subway and Local Bus services with their trips fully funded by their employers or by Assembly Connect for the duration of the Pay-Per-Use limited fare program initiative.

WILDEST HALLOWE'EN IN YEARS RESULTS IN MUCH DISCOMFORT FOR POLICE

Nine False Alarms Sounded—20 Windows Broken—Tree Pulled to Highway—No Injuries Reported

In one of the most hectic Halloween nights of many years, local police, firemen, and ordinary citizens were kept on their toes as fine Indian Summer weather made Tuesday an ideal night for children and their pranks.

Starting shortly after 7:30, the fire alarms started to come in. The first one was sounded at 7:43, a bell alarm from box 52. This was a false. At 7:50 another also was sounded from box 125, and fifteen minutes later a third was sounded from box 115. The firemen were back to their posts but a few minutes when box 25 sounded and the apparatus went clanging through the streets once more.

At 8:40 box 8 rang in and this proved another false, but two legitimate alarms came soon after, one from box 124 at 9:32 and the other from box 13, three minutes later. These were minor fires, one a dump and the other a deserted shack.

The fire department was given a rest until shortly before 11 p. m. when the false alarm faddists started in again. At 10:15 a false was sounded from box 315, at 11:35 another false from box 125, and the final of the evening at 11:40 from the self-same box 125.

From shortly after nightfall to 10 o'clock the streets of the city were a steady stream of ghosts, pumpkin heads, girls dressed as boys and vice versa. It was a night for hilarity and it seemed that everyone took advantage of it.

BREAKWATER OFF ROUGHAN'S POINT SOUGHT BY GROUP

Mayor Casassa Leads Local Delegation for Public Works Aid

Representatives of Revere, Lynn, Lowell and Haverhill have urged projects upon the Emergency Public Works commission that call for State expenditures, with federal aid, amounting to more than \$1,000,000.

A delegation from this city in favor of the construction by the state, with the aid of federal funds, of a breakwater off Roughan's point in the Beachmont section of the city was led by Mayor Andrew A. Casassa. He argued that construction of the breakwater, estimated to cost between \$150,000 and \$195,000 is necessary to protect about 320 acres of residential property from the high tides and ravages of the sea during storms.

A group of legislators from Lynn, led by Mayor J. Fred Manning, asked for \$700,000 for the extension of Market street, Lynn, across Lynn harbor to connect with Nahant.

\$206,000 ROAD WIDENING IS OK'D BY GOVERNOR ELY

The reconstruction and widening of a section of State highway in Revere, from John's avenue northerly about 11,000 feet, was one of three projects approved by Governor Joseph B. Ely this week. The project was submitted by the Massachusetts Emergency Public Works commission under the NRA program, and would cost \$206,000.

MANY INVOLVED FROM REVERE IN BERKWITZ CASE

Constable Duval, Kettleman in Group Questioned in "Jury Fixing"

After days of "jury fixing" testimony in which many local citizens figured, the disbarment proceedings against Attorney Abram J. Berkwitz in the Supreme judicial court, were taken under advisement by Judge Fred T. Field yesterday.

The case has stirred a great deal of excitement in State legal circles and from the start of the hearing to its close the testimony was punctuated with names of Revere residents, one of whom was Meyer W. Kettleman, disbarred attorney.

Friday was the most hectic day as far as local interested parties were concerned. Frederick A. Crafts, prosecuting attorney, had a helpful witness in William Jensen, 42 Orchard street, this city, who testified that he was promised \$100 to join four other jurors in a "fixed" case, and was given \$72. At the first session of the hearing it was brought out that three other jurors received \$30 each in this case—a suit brought by Martin Handlin against George I. Feldman, in which Berkwitz was counsel for the plaintiff.

Raymond T. Duval, 21 Essex street, this city, another witness called by the prosecution refused to testify. He was reprimanded by Judge Field for his flippant attitude on the witness stand as he muttered his refusals. During the questions that were put to him the name of Kettleman was brought out. One of the questions which Duval refused to answer was "Did you testify that Kettleman paid you in two cases?"

It was brought out that the cases referred to were the suits brought by Alice Demears against Clara

POINT OF PINES BRIDGE BIDS ARE FINALLY OPENED

The Grandall Engineering company of Cambridge made the lowest of seven bids which were opened yesterday by officials of the State Department of Public Works for building the structure for a steel bridge over the Saugus river, near Point of Pines.

The company bid \$510,418.79. The local project will be the first large construction endeavor undertaken by the State Department of Public Works under the Federal emergency public works program.

Acceptance of the bid mark the culmination of years of legislative effort to have such a structure built, the present bridge at the Point of Pines proving totally inadequate for the traffic which it is forced to handle during the summer season.

With the completion of the East Boston vehicular tube the flow of North Shore traffic is expected to be doubled and a larger bridge is acknowledged an absolute necessity. Plans have been drawn and everything is ready and awaiting the work of the contractors if their bid is given official sanction.

Council Discusses County Ditch, Insurance Increase

A request that Mayor Andrew A. Casassa conduct an investigation into health conditions surrounding the county ditch in this city was voted by the Revere city council at a quiet conclave in city hall Monday night.

Councilmen George Foley and William H. Gallagher instigated the probe, citing the urgency of the investigation and urging that some relief measures be taken at once even to the extent of soliciting financing through the National Recovery administration to correct conditions allegedly growing out of the inadequacy of the ditch.

As the result of recent civic activities in regard to a reported higher insurance rate for certain sections of the city, a petition was presented to the council, signed by S. E. Horner, 11 Ellerton street, this city, who stated he was speaking for the citizens of the Oak Island district.

The petition asked that the council take up the matter of increased insurance rates in Oak Island and other parts of Revere. The rates, the communication said, had increased since July 10th, 1933, from 200 percent to 500 percent.

State officials are now endeavoring to pass on the matter of a readjustment as the result of a public hearing recorded in the matter, the communication stated, and it stresses the fact that a good opportunity is provided for the council as a body to forward a protest to the State Insurance Commission.

As a result of this petition, Councilmen Foley, Reinstein and Lund presented a resolution along the lines requested and this was ordered accepted and adopted. On a motion presented by Councilman Foley and Gallagher, it was ordered that the Commissioner of State

CHISHOLM ASKS FOR AID IN NRA BUYING PROGRAM

Reports Indicate Business Is on Steady Upgrade to Recovery

Convincing proof that the country is slowly but steadily being lifted out of the business slump, is reaching NRA headquarters in Revere according to a statement today by Mr. C. F. Chisholm, chairman.

"We are in daily receipt of bulletins, messages and reports from NRA headquarters in Washington which show how the country everywhere is swinging into step with the great recovery march," said Mr. Chisholm. "As a rule statistics are rather dry reading, but in the figures that reflect this upturn we behold the unfolding of a great human drama. In time of war we are stirred to our depths by reports of victories at the front. The present reports of people going back to work, of more money being placed in labor's pay envelopes, of increasing prices for farm products as compared with a year ago and of a general reawakening, are also extremely significant. Behind these figures we see happiness in millions of homes where there was only despair a few months ago.

"From every part of the country reports are coming in which show the gradual dwindling away of unemployment. One of the most heartening statements that have been made was that by President Roosevelt in his recent radio address to the country revealing that in recent months four million persons have found employment."

Mr. Chisholm emphasized that the current efforts being made to stimulate

CHISHOLM ASKS FOR AID IN NRA BUYING PROGRAM

The encouraging possibility that \$125,000 may be made available to the city of Revere under the Tax Title act was the result of a series of conferences between city and state officials at the State House throughout the week. Although plans had nearly reached a settlement yesterday afternoon, some technicalities still exist, it is said, and these must be straightened out before progress can be made.

According to some who are close to the financial pulse at the State House, the city's financial condition is looked upon in a favorable light, and but for some requirements which will ultimately be inserted prior to granting the loan, the grant would go through with but little difficulty.

A conference was held Monday with the State Emergency Finance board, attending which were Senator Frank D. Crowley, Representatives Augustine Airola and Thomas F. Carroll, City Treasurer James M. O'Brien and Chairman John Liset of the Board of Assessors, as well as representatives of Boston banking officials.

Since the Monday meeting, city officials have been in and out of the State House conferring informally on the matter and no real formal conference has been held.

The money forthcoming from the tax title loan would make it possible to pay city employees' salaries in time for Thanksgiving. To this use the money will be put, if granted, unless stringent regulations are placed on the expenditure of the funds by the grantors, which is unlikely as far as wage payments are concerned.

FOUR ELIGIBLE TO SUPERVISE WELFARE WORK

State Civil Service Commission Announces List Who Passed Tests

The list of those eligible to become supervisors of unemployment in the Revere Public Welfare department was made public this week by the Massachusetts Civil Service commission.

Of the eight applicants to take the examination on July 19, but four of them have been declared eligible.

The four men are: Timothy F. McCarthy, veteran, 71 Hichborn street; William W. Stowell, veteran, 7 Bell Island avenue; George G. Berlow, 133 Kimball avenue; and Henry T. Noel, 57 Howard street.

NEW PROJECTS WILL LIGHTEN WELFARE LOAD

Nearly two hundred veterans, the majority of whom are on the rolls of the local Department of Soldiers' Relief, will be afforded employment when the two local public works projects get under way, according to a statement released by Commissioner Ralph W. Robertson this week.

The placing of these men on the employment list will cut the costs of the Relief department almost in half, Commissioner Robertson stated. According to regulations laid down by National Recovery officials, all machinery will be barred in the construction of both the East Boston-Revere road, and the Point of Pines bridge, unless absolutely necessary.

AN IMPORTANT ELECTION WITH BIG BALLOT QUESTIONS

This Tuesday, November 8, is state election day in Massachusetts.

With two-term incumbent Governor Charlie Baker having chosen not to seek re-election, voters will be choosing a new governor for the first time in eight years.

The contest between Democrat Maura Healey and Republican Geoff Diehl represents the starkest contrast between two candidates for the governorship in our state in almost 100 years.

Healey and Diehl espouse polar-opposite views on almost every topic, most notably regarding former President Donald Trump (Diehl is an unabashed supporter, Healey is not).

It is not an overstatement to say that the future direction of our state is dependent on Tuesday's outcome, and for that reason alone, everyone should get out to vote.

There also are four ballot questions for voters to consider. The two that have garnered the most attention are Question 1 and Question 4.

Question 1 would impose an additional four percent state tax on the income of residents that exceeds \$1 million. Net income up to \$1 million would still be taxed at the five percent rate, with only the amount exceeding \$1 million taxed at the higher rate.

It should be noted that the state legislature cannot enact a graduated income tax. The Mass. Constitution does not allow the legislature to do so, and thus voters essentially will be determining whether to amend our state constitution to permit a higher tax rate on high-income individuals.

The question is being supported by the citizens group Mass. Fair Share and is being opposed primarily by a number of ultra-wealthy individuals who have contributed millions of dollars to the Vote No campaign.

Question 4 on the state ballot essentially does this: It allows any resident of Massachusetts, regardless of immigration status, to obtain a Mass. driver's license, provided they meet all of the usual requirements of obtaining a license. In addition, the new law specifically states that such persons will not be eligible to become registered voters and will not be able to obtain a REAL ID driver's license

The Mass. legislature already has approved a law to do this. That law is set to go into effect on July 1, 2023. However, those who oppose the law gathered enough signatures to place the question on the ballot. A "Yes" vote on Question 4 will allow the law to go into effect on July 1, 2023.

We would note that a wide array of various groups, including police chiefs, district attorneys, and other law enforcement agencies, strongly support a "Yes" vote on Question 4. In addition, similar laws have been enacted in many other states.

As a final reminder to our readers, early voting is now underway in every city and town hall across the state. However, early voting ends this Friday -- there is no early voting this weekend -- so if you do not vote before Friday at your local city or town hall, you will have to go to the polls on Tuesday.

With so much at stake, we urge all of our readers to get out and vote.

YES ON 4: Practical Public Safety and Economic Policy

Mobility is essential to working families in the City of Revere. It is critical that our residents can get to and from work, doctors' appointments, school or to buy groceries safely. There has been a lot of misinformation shared about The Work & Family Mobility Act, but the bottom line is this – tested and insured drivers make the roads safer for law enforcement and the driving public. That is why we hope you will join us in voting YES on Question 4. Question 4 is a ballot question concerning driver's licenses in Massachusetts. A yes vote assures keeping the law we (the legislature) just passed. A no vote would repeal the law. The law allows for residents of Massachusetts to apply for and earn a driver's license, regardless of their immigration status. To obtain a license, you must pass the state standardized road test and be insured.

Assuring that all drivers are tested, licensed, and insured creates safer roads for all of us. That's why the majority of sheriffs, police chiefs, and district attorneys from across the Commonwealth support Question 4. Allowing people to earn a license, regardless of their immigration status, does not provide for protection against deportation; it also does not allow for drivers

to get on planes, access government benefits, or vote. It only allows a person to operate a motor vehicle. In addition, it would generate \$5 million in fees and \$6 million in taxes for our state.

Under the law, to apply for a standard driver's license, applicants will need to provide at least two documents to prove their identity and date of birth. All documents written in a foreign language must be accompanied by a certified translation to English:

- Document #1: valid unexpired foreign passport or valid unexpired consular ID

- Document #2: valid US driver's license, birth certificate, valid foreign national ID card, valid foreign driver's license, or a marriage certificate or divorce decree

Residents who cannot prove lawful presence in the United States would remain ineligible for a "REAL ID" which requires documentation of U.S. citizenship or lawful status as a matter of federal law. To protect applicants' privacy, the legislation also prohibits the RMV from disclosing any information about applicants for and holders of a standard driver's license except as authorized by regulations promulgated by the Attorney General.

Driving Families Forward is the coalition that has worked tirelessly to push the drivers'-licenses-for-all initiative forward. In addition, Massa-

chusetts district attorneys and police chiefs support the modification because of the public safety factors that it harbors. Leaders in law enforcement understand that insured drivers make the roads safer for all to travel. They also realize that the licenses will reduce the number of hours it takes a law enforcement officer to verify a person's identity during traffic stops.

Other states that issue these types of licenses have seen a significant reduction in hit-and-run accidents. The District of Columbia and 16 other states have taken the steps toward safer roads for their citizens by passing laws that allow people without status to obtain state driver's licenses.

Studies show that the number of uninsured drivers drops dramatically when all drivers are given the opportunity to acquire licenses. Drivers generally feel more comfortable knowing they are less likely to foot the bill for damage stemming from an accident caused by someone else. With less barriers to licenses, the probability of a hit-and-run is reduced when more people are covered and accounted for. Licensing all qualified state residents with a Massachusetts driver's license or ID, is a common sense proposal that allows the 78% of workers in the Commonwealth, who rely on vehicles to get to their jobs, to travel the roads as

licensed, registered, and insured drivers. That is why this is supported by a number of labor unions. Immigrants without status are essential workers and card-carrying, dues-paying union members. They are our neighbors, friends, and family and an integral part of our economy and community. The removal of the barrier to licensing ensures consistency of drivers' safety qualifications and knowledge of the rules of the road.

Additionally, Massachusetts gains an economic benefit from issuing more licenses. More revenue is generated through registration fees, title certification, and inspection costs. Not to mention, the issuing of licenses brings economic stimulation for small businesses not easily accessible by public transit. Having permission to drive should not be conflated with immigration authority, citizenship status, collection agencies, or the numerous arguments used to distract voters from having safer roads and a uniform understanding of the rules of the road.

When November 8th arrives and you're confronted with the choice of yes or no on Question 4, we ask you to please consider how voting YES on 4 will make our roads safer, make identification processes easier for police officers, and will provide economic stimulus to the Commonwealth.

John Fetterman, President Roosevelt and Disability in Public office

One of the greatest Presidents of all time was Franklin D. Roosevelt. He served from 1933 to 1945. He led this country and saw us through some of our toughest years. Many say he stands as the greatest President of all time. Ironically, he had a difficult time standing.

Photographs of Roosevelt in a wheelchair are rare but you can find one on the Internet.

Franklin D. Roosevelt, was our 32nd President but he began experiencing symptoms of a paralytic illness in 1921 when he was 39 years old. His main symptoms were fever; symmetric, ascending paralysis; facial paralysis; bowel and bladder dysfunction; numbness

and hyperesthesia; and a descending pattern of recovery. He was diagnosed with poliomyelitis and underwent years of therapy, including hydrotherapy at Warm Springs, Georgia. Roosevelt remained paralyzed from the waist down and relied on a wheelchair and leg braces for mobility, which he took efforts to conceal in public. In 1938, he founded the National Foundation for Infantile Paralysis, leading to the development of polio vaccines. Although historical accounts continue to refer to Roosevelt's case as polio, the diagnosis has been questioned in the context of current medical science, with a competing diagnosis of Guillain-Barré syndrome proposed by some authors.

We could talk and write about Franklin D. Roosevelt all day. However here are a few of his noted accomplishments from his 12 years of service – longer than anyone. Creation of the emergency banking act to counteract the Great Depression. Establishment of FDIC. Unemployment rate reduction. Setup many institutions to support the New Deal. Created institutions as part of the New Deal. Created the U.S. Social Security System. Established the minimum wage and 40-hour work week. He took action to prohibit discrimination in employment, led America to victory in World War II, and, took part in the creation of the United Nations. He also aided water pollution control and more. (Wikipedia)

However, would Roosevelt even have a chance today? Can you imagine him trying to conceal his wheelchair or his leg braces? Not in this age. Would The Press and the opposition tear him to shreds as being physically incapable of holding down the job?

Disabled Americans and people worldwide can point to Roosevelt as someone who dealt with tremendous physical obstacles to accomplish much for our country and the world.

Americans with disabilities should not be excluded from running for public office. We vote for who we want to vote for but in a free country all citizens should be able to try.

CityLab High School, Jaslin Ziamora Sanchez Mendez, received the honor.

Superintendent of Schools, Dr. Dianne Kelly, outlined the award: "Each year we have a real honor to recognize some of our students who perform far and above their peers in our schools. We're able to give them an award from the Massachusetts Association of School Superintendents, which is a pretty prestigious honor." She continued by explaining that, out of the over 100,000 students in the Commonwealth, "only about 600 [students]" receive this specific award. She continued by noting, "We're just so proud of the work that these students have done."

Dr. Kelly continued by explaining the character and achievements of the award-winning students. She began by highlighting Kathy Trinh, whom she described as a "remarkable

young woman" who "has achieved great things at Revere High School." She explained that, this summer, Kathy was "selected to the prestigious Northeastern Young Scholars' program," where she had "opportunity to conduct, analyze, and present research to Northeastern faculty." Kathy also works as a counselor for Revere Parks and Recreation, while also being a part of numerous clubs and organizations at Revere High School, including swim team, tennis team, math team, Feminist Empowerment Movement, and student government. Beyond this, Dr. Kelly explained, Kathy is a STEM and Writing Center Fellow, who will "have completed 8 Advanced placement courses while earning the distinction of AP Scholar with honors" by the time she graduates. Currently, Kathy holds the highest GPA in the senior class of 2023.

Kathy addressed the council and explained her future plans to attend a four year college, quipping "maybe even more." Dr. Kelly read a statement from the CityLab staff, which detailed how Jaslin has thrived at CityLab: "From the moment she walked through the door, we knew that she would flourish in her new learning environment." Jaslin is described as "outgoing" and "articulate," and, in her application to CityLab, "she stated that she wanted to write more and express herself better." Just a few short

months after transferring to CityLab, Jaslin now is "dually enrolled" at Benjamin Franklin (BFIT) in English college level coursework, where she is described as "a shining star." Dr. Kelly continued, "Jaslin is able to effectively communicate and participate in discussions with her CityLab peers, as well as her other BFIT classmates. It appears Jaslin has found her place."

Jaslin also addressed the School Committee, noting, "Before I came to [CityLab], I didn't want to go to college. Now that I started going to [BFIT], I have decided I do want to go to college and pursue an architecture career."

Dr. Kelly finished by presenting the third and final award to Christy Ly. Dr. Kelly described her as "an incredible student" and a "profound artist," who has "many talents, including drawing and

sketching." She continued by noting that "Christy has been involved in numerous activities at the school and local community." Dr. Kelly explained, "In July of 2022, [Christy] attended the National Student Leadership Conference at Johns Hopkins University, exploring mechanical, electrical, and other forms of engineering." Beyond this, Christy recently completed the Northeast Metro Tech Vocational Program's Acquiring Advanced Skills in Photoshop Illustrator, as well as "other Adobe suite programs." Christy is an AP Scholar, who has previously received the City of Revere Certificate of Appreciation for "coordinating charitable drives during the Covid-19 pandemic." Christy works at the Revere Youth in Action program, where she is working on "creating a high school level ethnic studies curriculum."

She is also a leader in the Feminist Empowerment Movement, and "e-board graphic designer" for the Asian American Student Association. Dr. Kelly expressed how Christy has range, participating in programs such as the MGH Youth Scholars Program, while also painting murals at Revere High School. Dr. Kelly noted that Christy's murals have "beautified the hallways."

Christy addressed the committee: "I plan to go to college for four years, and I'm interested in studying engineering or public health. I definitely want to continue being involved in the community and finding ways to help other people." She closed by offering a thank you to her mother and her family for "all their support, and Revere teachers, "who helped [her] ever since [she] was little."

Tragically, Fetterman's health apparently prevents him from articulating

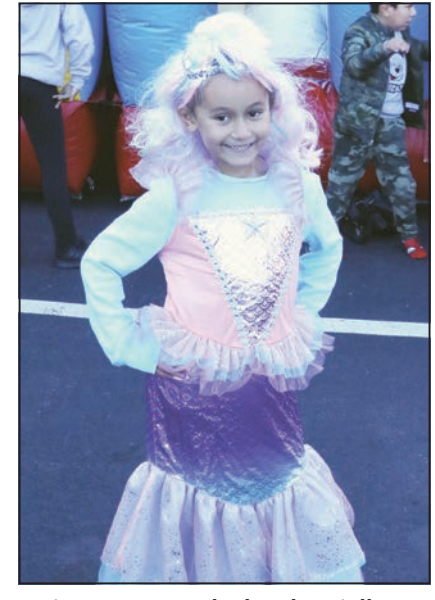

New waste disposal ban regulations now in effect

The Baker-Polito Administration on November 1 announced that new waste ban regulations that promote recycling and reuse, reduce trash disposal, and foster recycling business growth take effect starting today, November 1, 2022. The new regulations will ban the disposal of mattresses and textiles in the trash, as well as decrease food waste from businesses and institutions. Massachusetts currently has a food waste ban on businesses disposing one ton or more per week, and these regulations lower that threshold to a half-ton per week.

The Massachusetts Department of Environmental Protection (MassDEP) established a ban on disposal of food waste from businesses and institutions disposing of one ton or more per week in 2014, which increased food waste diversion from

100,000 tons per year to more than 300,000 tons per year, while also creating hundreds of new jobs and increasing the gross state product by \$77 million. Despite this progress, food waste still represents more than one-fifth of the trash we dispose of. Lowering the threshold from one ton to a half-ton per week aims to continue Massachusetts' progress in this area. An estimated 4,000 businesses will be subject to the new threshold. Fortunately, Massachusetts businesses are well on their way to compliance as more than 3,500 businesses already participated in a food waste collection program in 2021.

"In order to meet the important goals outlined in the 2030 Solid Waste Master Plan, the Baker-Polito Administration has focused on reducing waste disposal, while also increasing recycling, di-

version, reuse, and composting measures," said Energy and Environmental Affairs Secretary Beth Card. "These regulations and the supporting strategies that are being implemented today will continue our nation-leading efforts and jump-start waste diversion work that is occurring across the Commonwealth."

MassDEP has supported the food waste ban by providing grants to businesses establishing or expanding capacity to manage food waste, including anaerobic digestion and composting operations. MassDEP also recently announced a new grant offering to invest in expanding the infrastructure for collecting food waste, mattresses, and textiles. Additionally, MassDEP supports business waste reduction, recycling, and composting initiatives through the Recycling-

Works in Massachusetts program. This program, which is fully funded by MassDEP, is run under contract by the Center for Eco Technology. Through RecyclingWorks, Massachusetts businesses receive free assistance to manage any waste they generate, including the new banned materials.

Textiles represent another important opportunity for Massachusetts to reduce the waste stream and capture valuable resources. Each year, the Commonwealth throws out more than 200,000 tons of textiles in the trash. This includes old clothing, as well as other things like towels, linens, and even bags, belts, and shoes. Fortunately, Massachusetts has an extensive collection infrastructure of both non-profit and for-profit textile recovery organizations that can find a new use for these mate-

rials, either through selling or donating for reuse, or recycling into products such as carpet padding, insulation, or wiping rags.

"Recovering textiles is an excellent opportunity for our cities and towns to reduce trash disposal from their residents at the same time as they get paid for the valuable textiles that they recover," said MassDEP Commissioner Martin Suuberg. "We are pleased to partner with this burgeoning industry to remove these valuable materials from the waste stream and put them back to work."

Mattresses are a difficult material to manage at solid waste facilities and take up a large amount of space in landfills. More than 75 percent of mattresses can be effectively separated and recycled, including metal, wood, fabric, and padding. Massachusetts has established

a statewide mattress recycling contract that includes five recycling companies that can serve Massachusetts municipalities that establish mattress recycling programs to serve their residents. MassDEP has provided grants to several of those companies, as well as other Massachusetts-based mattress recyclers, to increase the capacity to manage mattresses, as well as to create new job opportunities. Massachusetts generates approximately 600,000 unwanted mattresses per year, about 200,000 of them from residents, with the rest coming from businesses and institutions. MassDEP has provided grants to help establish mattress recycling programs in 137 municipalities.

ances that were requested under the original plan.

Those four variance requests were as follows:

1. Noncompliance with Section 17.24.010 with respect to minimum side yard set back requirement of 15 feet within the NB District;

2. Noncompliance with Section 17.24.010 with respect to the maximum height requirement of 35 feet within the NB District;

3. Noncompliance with Section 17.24.010 with respect to maximum of 2 1/2 stories allowed within the NB District;

4. Noncompliance with Section 17.28.035 (A) with respect to mechanical parking systems not allowed within the NB District.

The requests that were eliminated from the original application pertained to minimum front yard setback, minimum rear yard setback, the permissible maximum building coverage requirement, and minimum parking requirement of two spaces/unit for apartment use.

D'Ambrosio noted that the unusual, half-moon lot configuration necessitated the request for the side-yard setback. He also stated that Zepaj will be required to clean up any environmental problems with the property that may arise as a result of its past use and that he will repair a collapsed culvert that will resolve drainage and flooding issues in the area.

Additionally, addressing an issue that had been raised by the project's opponents, D'Ambrosio stated that he had spoken to Nick Rystrom, the City Engineer, who said that the current infrastructure for water and sewer in that part of the city could support the new development.

Finally, D'Ambrosio said the area is zoned as a Neighborhood Business (NB) district, which allows for the construction of apartment buildings as a matter of right and that other permissible uses, such as a medical building or a convenience store, would create more congestion in the neighborhood than an apartment building.

"This is a smaller building, with smaller units, and with more parking," D'Ambrosio said in conclusion.

A number of individuals spoke in the favor of the application.

Danna Nazzaro spoke on behalf of her mother-in-law, who lives at 248 Salem St. She said that her mother-in-law has seen other projects by Mr. Zepaj in the city and believes that the building will be an improvement in the neighborhood.

Robert Mahoney, a Revere resident who has worked with Mr. Zepaj on some of his other projects, told the board, "This project will be an asset to the neighborhood."

Lou Markakis, a local real estate agent who represented Patricia Nazzaro, who was the seller of the property, told the board that Ms. Nazzaro had rejected other potential buyers, including businesses that would have had trucks on the premises and a convenience store, because, "She wanted to sell it to somebody who would clean up the site."

Another proponent, Lily Chow of 156 Breeden's Lane said, "I believe that the developer has addressed the concerns of traffic and congestion and will bring a lot of value to the neighborhood."

David Chmel, who lives at 124 Breeden's Lane, said he favored the project because it will bring taxes to the city.

The opponents then had their turn to speak. The opposition was led by Ward Six Councilor Richard Serino who presented his opposition in a letter to the board. Serino cited a number of concerns, including low water pressure in the area, and stated that the "size and scale of this project is too large for the parcel."

John Oakes 22 Clifton St. said to the board, "This is a neighborhood of one-family homes and this lot is not big enough for this building."

John Riccio of 24 Franklin St. opined that mechanical parking is not usable in a practical sense. However, Tucker noted that mechanical, stacked parking is occurring in many projects in Greater Boston, including in Revere.

Resident James Vasquez, an abutter, said the problem is not so much an apartment building, but that the developer is seeking variances. "Why should the city subsidize what he does?" said Vasquez. "Would you want this as close to your property as he wants to do here? He can build it within the zoning laws.

Let him build what he can build. This is one of the nicest neighborhoods in the city."

Another resident, Mourad Chibane, who owns a condo at 292 Salem St., said there is not enough parking in the area.

"Why can't they comply by following the rules?" he asked. "It's very simple."

At the conclusion of the public comment portion of the hearing, chairman Tucker was the lone member of the board to express an opinion.

"The developer has bent over backwards to make this work and the zoning relief is far less than what has been asked in other places in the city," said Tucker, who listed the various concerns that had been raised by the residents and addressed by the developer. Tucker also noted that if there are environmental concerns, those will fall within the purview of the Conservation Commission.

Upon a roll call vote, Tucker and fellow members Aklog Limeneh, John Lopes, Hazem Hamdan, and Arthur Pelton voted unanimously to approve the variances. (Alternate member James O'Brien was on hand for the meeting, but did not cast a vote.)

The board took up three other applications prior to the 344 Salem St. hearing, approving two of them, but denying one.

Sergio A. Sorto, 28 Proctor Avenue, came before the board seeking the following variances from the ZBA to enable him to construct a 252 sq.ft. addition and reconstruct and extend the existing deck at the rear of his existing single-family dwelling:

1. Noncompliance with Section 17.24.010 with respect to minimum side yard setback requirement

of 10 feet within the RB District;

2. Noncompliance with Section 17.24.010 (a) with respect to minimum side yard setback requirement of 10 feet for all decks.

Michael Szymanski, the architect on the project, appeared before the board and explained the scope of the proposed work.

There were neither opponents nor opponents to the application.

This matter initially came before the board in September at which time members expressed some concern about the turning radius on the property itself. However, Tucker reported that the Office of Planning and Development said there was no issue in this regard.

The board then voted 5-0 to approve the variances

Nixon Jimenez came before the board requesting a special permit for the purpose of converting his pre-existing, non-conforming, single-family structure at 114 Augustus St. into a two-family home.

Atty. Larry Simeone represented the applicant, whose mother currently lives in the single-family home. Simeone said that the applicant proposed adding a new third floor onto the existing structure to create a three-bedroom unit for his daughter.

Simeone noted that the increase in height will not be in violation of the ordinance. He also said that not only will the new, altered structure "not be substantially more detrimental" to the existing neighborhood (which is the standard by which the board must be guided per the zoning ordinances), but that it "actually will constitute an added investment to the neighborhood."

There were no opponents and the board voted 5-0 to approve the appli-

cation.

The lone application to be rejected was another matter that had been continued from the previous month by the board members, who said they had wanted to take a closer look at the property in question.

Herby Jean-Baptiste, 321 Proctor Ave., came before the board seeking a variance of RRO Section 17.24.070 -- no parking in the rear yard -- to enable him to establish a driveway entrance on Burbank Street in order to provide two additional off-street parking spaces in the rear of his house. Mr. Jean-Baptiste already has a driveway, with parking for two cars, off Proctor Ave.

Mr. Jean-Baptiste said that in addition to the additional parking spaces that he needs for his family, the new driveway would provide access to the rear of his property in the event of an emergency. He noted that there is no dedicated parking on the street in the front of his house, which is by resident permit only, thus making it difficult for family members or other visitors to park, especially during times of snow removal and street sweeping.

Ubi Barbosa, a neighbor who lives across the street on Proctor Ave. and who has rear-yard parking on his property, spoke in favor of the application.

"I know how difficult it can be to park on the street," said Barbosa. "His proposed driveway is more than 100 feet from the corner of Proctor Ave. and will not be a hazard to anyone," he said.

However, Ward 4 City Councillor Michael Keefe

spoke against the application, stating that there was widespread opposition to the creation of the driveway by the residents of Burbank St.

"This will be a detriment to the residents who live behind him," said Keefe. "Burbank St. can be hard to navigate during a snowstorm and the residents know that there will be difficulties when he is exiting that driveway during a storm. All of the abutters across the way on Burbank St. have called me in opposition."

Keefe also informed the board that there are preliminary plans by the city for a proposed children's park directly across from the proposed driveway that will be negatively affected by the driveway.


Michael Ferrante of 59 Burbank St., told the board of the possible safety issues created by motorists making a turn off Proctor onto Burbank, especially in the winter, because of the steepness of Burbank St.

"We don't really need any more traffic on Burbank St. Getting out of his driveway will be a tight turn and will make for more congestion," Ferrante added.

Prior to the vote, board member Lopes suggested to Baptiste that he should consider extending his existing driveway off Proctor St. to the rear of his property, rather than creating a new driveway off Burbank. Councillor Keefe indicated that he would have no objection to that proposal.

The board voted 5-0 against granting the variance.

REVERE Through the Years

10 years ago October 31, 2012

While conditions were much worse south of the Boston area, Revere took some punches as Hurricane Sandy rolled in with tropical storm force winds on Monday afternoon, creating some mean looking seas and a situation that was no joking matter. The storm on Monday was certainly something, and while Revere got off without any major damage, the potential for some perilous situations was present all day long. "That was quite a storm," said Beachmont Assistant Harbormaster Arthur MacDonald. "I haven't seen anything like that since at least 2000. The sea had a lot of force and a lot of power in it." The force of the waves was awesome, hitting the seawall or the sand with such strength that it shook the ground underneath. However, when it came to flooding and damage, the City seemingly might have gotten away with one. Fire Chief Gene Doherty said damage was minimal despite the strong wind and the tremendous storm surge. In the afternoon and evening hours on Monday, power outages all over the city plagued several neighborhoods.

Judging by the large turnout of developers, business owners, and state and city officials at

the Summit and the exciting commercial development opportunities that were presented during the speaking program and in two well-orchestrated videos highlighting the city, Rizzo and Director of Economic Development John Festa and his team accomplished their goals and more.

20 years ago November 6, 2002

Massachusetts voters chose Republican Mitt Romney for governor in Tuesday's state election. "Mitt Romney will be the greatest governor our state has ever known," said local Romney supporter and City Councillor Richie Zambuto. Revere supported Democrats for the State Senate seats here, Robert Travaglini and Jarrett Barrios and the State Representative seats, Robert DeLeo and Kathi-Anne Reinstein. Local voters also joined with voters across the state in abolishing bi-lingual education in public schools.

November 8, 1962**

Revere gave Democratic gubernatorial candidate Endicott "Chub" Peabody a victory of 10,201-7715 votes over Republican incumbent John A. Volpe in Tuesday's state election, helping Peabody win a narrow victory state-wide. In the race for U.S. Senate, Revere heavily favored Edward M. Kennedy, brother of the President, over Republican George Cabot Lodge by a vote of 12,689-4866. Incumbent Democrat Harry Della Russo handily defeated GOP challenger Frank Butman for State Senate. Incumbent Democrats Ray Carey and Joseph DelGrosso easily retained their State Representative seats from a challenge by Republican Vincent P. Ar-

genzio. Revere voters also joined with voters across the state in rejecting a graduated income tax and disapproved of a \$1500 pay hike for state legislators.

A three-alarm fire at Suffolk Downs resulted in the deaths of seven harness race horses yesterday morning. A few days earlier, a four-alarm blaze destroyed the Wonderland Factory Sales store at 1290 No. Shore Rd.

Revere joined the nation with a record turnout

of voters in Tuesday's presidential election. Although the country supported Republican Dwight D. Eisenhower for President over Democrat Adlai Stevenson, Revere favored Stevenson by a vote of 11,463-7573. Revere also backed the losing candidate for Governor, incumbent Democrat Paul Dever, giving him 13,098 votes to 5550 for Republican Christian Herter. However, Revere favored Congressman John F. Kennedy with 12,180 votes in his win for U.S. Senate over Republican incumbent Henry Cabot Lodge, who received 6675 votes.

In the race for State Senate, Revere narrowly backed local Republican Paul Buonfiglio over incumbent Democrat Andrew P. Quigley by a close vote of 9348-9070, but Quigley handily carried the rest of the district. In the contest for the two Revere State Representative seats, incumbents Harold Canavan and William H.J. Rowan fended off challenges from Mrs. Grace Rizzo, Roland Merullo, and Joseph DelGrosso.

As usual, the regular referendum questions to allow package stores and bars to operate in the city passed by wide margins.

The family of Pvt. Cyril G. Mahar, 19, son of Mr. and Mrs. Daniel Mahar of 97 Crystal Ave., has been informed that Pvt. Mahar has been wounded in action in Korea by artillery fire. 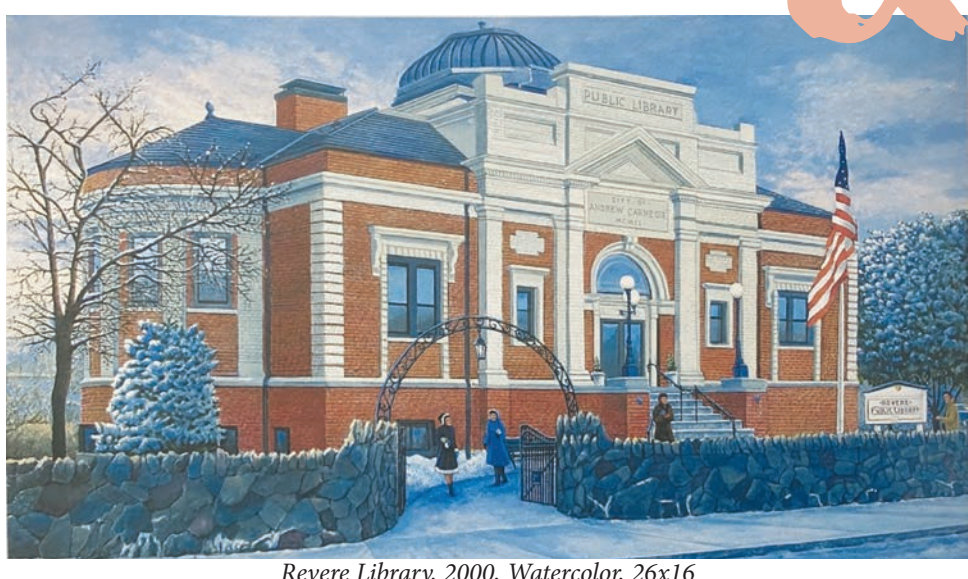
Norman Joseph Gautreau & The Art That Immortalized Revere

 As we celebrate the Norman Joseph Gautreau was born on January 13th, 1917, in Lynn, Massachusetts. Ever since he was a child, Norman enjoyed going to the movies and sketching his favorite scenes. This was only the beginning of what would be an accomplished life. After marrying his wife,

Rose, and welcoming two children to their family, he traveled to Italy to fight during World War II. He returned shortly after, adding a third edition to the household. In 1949, the Gautreaus moved to Fenno Street in Revere and their fourth child was born. Today, their family lives on through in-laws, nine grandchildren, and nine great-grandchildren.

Norman diversified his art by depicting various memorable life experiences. He has painted many places across several countries, but also local landmarks and occasions. These include the Saugus Iron Works, the Boston Marathon, the Chelsea Fire of 1973, and even Ted Williams at Fenway Park. His art has been featured in prominent places: Cardinal Cushing's portrait in The Vatican, "the Cyclone Roller Coaster of Revere Beach" on the cover of Boston Globe Magazine, and "Boston Bruins vs. Montreal Canadiens" as centerfold in the Boston Herald.

Through his depictions of Revere Beach's fascinating and nostalgic sights, as well as local landmarks like Revere Public Library, Gautreau has immortalized the City of Revere. His art

currently resides in Boston's Statehouse, noteworthy colleges like MIT and Harvard, and numerous libraries in Massachusetts. He received Citizen of the Year in 1997 from the City of Revere, cementing his importance to our city.

The Revere Society for Cultural and Historic Preservation wants to honor Gautreau's contributions to our community through our Annual Holiday Gath-

ering. On December 3rd, the Museum will open for light refreshments and offer commemorative souvenirs showcasing Gautreau's art. 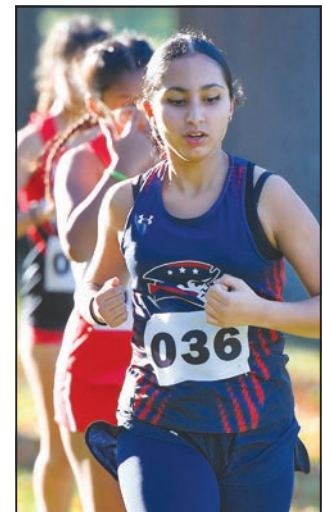

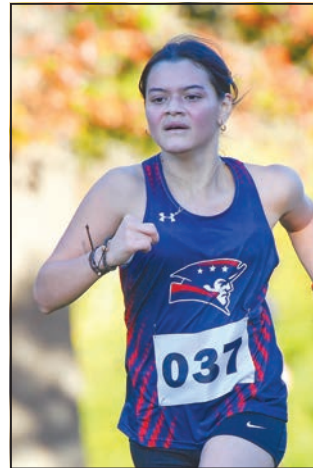

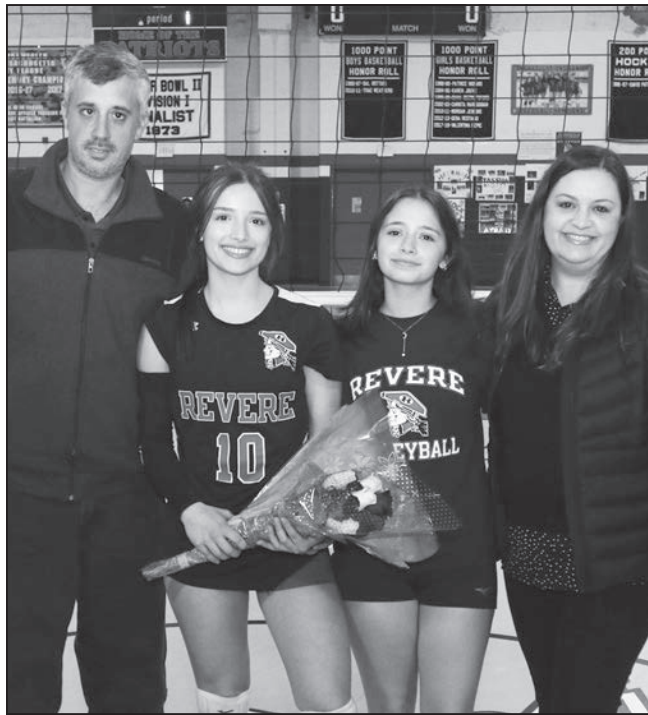

Administration celebrates completion of another part of Northern Strand trail

The Baker-Polito Administration celebrated the completion of more than 10 miles of the Northern Strand Trail, which is a shared used path that traverses parts of the Cities of Everett, Lynn, Malden, and Revere, and the Town of Saugus along the rail bed of the former Saugus Branch Railroad. The \$15.5 million project by the Executive Office of Energy and Environmental Affairs (EEA) was completed utilizing funding from the Gateway City Parks Program.

“Projects like the Northern Strand Trail serve as critical assets that link communities and residents across the Commonwealth together,” said Governor Charlie Baker. “Through the MassTrails team, our Administration has been proud to collaborate across state government and with municipal partners and trail advocacy groups to advance these projects that bring numerous environmental, recreational and transportation benefits to communities in Massachusetts.”

“We were pleased to fund the Northern Strand Trail, and to partner with Everett, Lynn, Malden, Revere, and Saugus to advance this critical project,” said Lieutenant Governor Karyn Polito. “The Northern Strand Trail will provide benefits not only to the residents and businesses along the trail, but also to visitors and those living in the surrounding region.”

The trail corridor connects neighborhoods, links residents to business districts, provides access to regional assets such as DCR’s Lynn Shore and Nahant Beach Reserva-

tions, serves as a critical component of the East Coast Greenway, and improves the quality of life for the region’s residents. The trail also has transportation and greenhouse gas emissions benefits. Provision of a practical, safe route of relatively short distance between major cities helps to encourage walking and biking as an alternative to driving, thus reducing emissions and helping the Commonwealth comply with the Global Warming Solutions Act.

“Safe and fun access to the outdoors is a priority of the Baker-Polito Administration, and I am pleased that this project provides residents with great opportunity to get some exercise and enjoy the Commonwealth’s natural resources,” said Energy and Environmental Affairs Secretary Beth Card. “Significantly, rail trails like the Northern Strand Trail also provide commuters with the option to leave their cars behind, which reduce the release of harmful carbon emissions and assists in the Commonwealth’s efforts to achieve Net Zero in 2050.”

The construction of the Northern Strand was supported by the work of the Interagency MassTrails Team, which is composed of staff from EEA, MassDOT, and the Department of Conservation and Recreation (DCR). The purpose of the team is to help develop a unified vision for a trails network and translate that into strategic investments, policy innovations to facilitate development of trails, and partnerships with municipalities and other

organizations. The Northern Strand trail project is a direct result of the group’s “one team, one plan, one vision” approach to advance multi-use trails across the Commonwealth.

“Shared use paths give people a safe, comfortable, and convenient option to walk and bike for everyday trips without relying on a car to get to destinations. The benefits are countless when it comes to active travel for wellbeing, public health, reducing pollution, and supporting local businesses,” said Transportation Secretary and CEO Jamey Tesler. “Whether people are commuting to work, going shopping, or just out for fun, more than 100,000 people of four gateway cities now are within ½ mile of the

Northern Strand.”

Following work conducted by many partners, including the long-time advocacy of Bike to the Sea organization, trail segments were in various stages when EEA took on the project. EEA’s partners on the project included the five communities, with Revere acting as the contracting entity during the construction phase. The project enhanced an already paved trail in some communities, such as upgrading road crossings to make them better and safer locations. In other communities where the rails were still in place the project involved all aspects of trail design, permitting, and construction. Additionally, the trail was designed by the team of Brown, Richardson, and Rowe, landscape architects, and Stantec Consulting engineers, who also administered project construction, and built by the R. Zoppo Corporation.

“After nearly 30 years of tireless advocacy, Bike to the Sea is thrilled to celebrate the official ribbon cutting for the Northern Strand Trail,” said Jonah Chiarenza, Executive Director of Bike to the Sea. “We thank the Commonwealth of Massachusetts for this historic investment in recreation and active transportation.”

Design work for the balance of the Northern

Strand Extension in Lynn, which will travel along South Common Street, Market Street, and the Carroll Parkway before reaching Nahant Beach, is at the 75% stage. Funding for construction is programmed on MassDOT’s Transportation Improvement Program for FY24, which means that work should begin in the fall of 2023 and end in the summer of 2025.

On the southern end of the Northern Strand the City of Everett has been building the segment from West Street to the Mystic River. In addition, DCR is completing the design and permitting of the Mystic River Bicycle and Pedestrian Bridge. Construction funding has been set aside for bridge work to begin in the summer of 2023, with construction expected to take about two years. The completed project will result in a transportation and recreation corridor of about 11.5 miles from the Somerville side of the Mystic River at Assembly Square to the beach at the Nahant causeway.

“I would like to thank Governor Baker, Lieutenant Governor Polito, and Secretary Card from the Executive Office of Energy and Environmental Affairs for their support of this important regional initiative,” said Saugus Town Manager Scott C. Crabtree. “I would also

like to commend the Cities of Revere, Malden, Lynn and Everett, as well as Bike to the Sea, for their partnership and dedication in turning this multi-community effort into a reality. In addition, I would like to thank all of the town’s volunteers and officials who contributed their ideas and suggestions, which strengthened the community vision for this important recreational staple.”

“We’re thrilled to see the expansion of the Northern Strand and to have Lynn added to the shared use path,” said Lynn Mayor Jared Nicholson. “This initiative will contribute to our goals of increasing connectivity and accessibility to transportation and open, green space throughout the City and beyond.”

“The completion of the Northern Strand Trail is a transformative multimodal transportation investment for the communities north of Boston that have been historically underserved by our transportation network,” said Everett Mayor Carlo DeMaria. “I applaud this achievement by the Baker administration, welcoming the Cities of Revere, Saugus and Lynn into the trail network, and look forward to the full completion of the path when the Mystic

NEWS FROM AROUND THE REGION

COUNCIL CONSIDERING PARK IMPROVEMENTS

CHELSEA - More park improvements are on the way for the city of Chelsea.

At its next meeting, the City Council is expected to take up funding for a major renovation project at Bosson Playground at 50 Bellingham Street. In addition, the council is also expected to accept grants to help with the development of a public park at 88 Clinton Street.

“Recently, the Executive Office of Energy and Environmental Affairs (EEA), notified the city that the Department of Housing and Community Development has secured a PARC grant for Bosson Playground, pending execution of the state grant contract and fulfillment of all pre-award program requirements,” said City Manager Thomas Ambrosino. “For this grant, the proposed renovations of Bosson Playground include replacement of the playground’s rubber surfacing, introduction of new playground equipment, installation of a new water feature and splash pad, installation of a multi-sport goal, installation of new site furniture and passive recreation areas, and lighting and reconstruction of all site utilities.”

Once completed, the playground will better serve the community’s youth and improve the quality of life in the city. The city will complete the design of the renovations by the end of June next year, a process that will involve input from many stakeholders in the neighborhood and the city, according to Ambrosino. The goal is to complete work on the playground by the end of June, 2024.

The state PARC grant will reimburse up to \$400,000 of the cost of the project, however, Ambrosino said the current estimate for the renovations stands at \$1,800,000. To help cover the additional costs, Ambrosino is requesting the City Council appropriate \$1,450,000

from the city’s stabilization funds.

The EEA also recently informed the city that it had recently secured a Land and Water Conservation Fund (LWCF) grant of just under \$350,000 for the creation of a new riverfront park at 88 Clinton Street.

“Proposed elements include seating areas, walking paths, a rain garden and other plantings, a water feature for children, a shade structure, and potentially a boat launch if this is found to be feasible, as well as lighting and utility construction,” said Ambrosino. “Once completed, the park will offer a space for residents of all ages and abilities to encounter Chelsea’s natural resources along Mill Creek, create better recreation and transportation connections between Mill Creek Riverwalk and the Mill Hill neighborhood, and offer opportunities for flood resilience and a respite from rising temperatures.”

The city is expected to complete its design and construction of the park by the end of 2024, according to the city manager. As with the Bosson Playground project, there will continue to be community input about the final shape of the park.

Ambrosino said he expects the total cost of the project to come in at \$875,000, which he is asking the City Council to appropriate from the city’s general stabilization fund. Once the project is completed, the LWCF grant will reimburse the city for nearly \$350,000 of the cost.

EARLY VOTING UNDERWAY

EVERETT - Everett Election Department Director Danielle Pietrantonio said that early voting has begun in the city and will continue through Thursday, Nov. 3.

Registered voters can cast their ballots at City Hall in the Keverian Room located on the third floor.

Pietrantonio said interest has been picking up in the election that features races for the state’s

constitutional offices, including the governor and lieutenant governor’s race with Maura Healey and Kim Driscoll on the Democratic side and Geoff Diehl and Leah Allen on the Republican side.

In an election that is drawing significant local interest, State Rep. Joseph McGonagle is being challenged by Councilor-at-Large Mike Marchese for the seat. Two candidates, Chelsea City Councillors Judith Garcia and Todd Taylor, are running for the state representative seat in the new district that includes all of Chelsea and a few neighborhoods in Everett. Ballot questions 1 and 4 are also generating interest among the Everett electorate that has 22,000 registered voters.

Pietrantonio reports that the Election Department received 3,000 requests for mail-in ballots. More than 1,000 ballots have been returned to the office.

Election drive at EHS a success

City Clerk and Election Commission Chair Sergio Cornelio and Jeanne Marie Gibbons from the Elections Office conducted a voter registration drive at Everett High School Tuesday, with several students registering for the Nov. 8 election and future elections.

Everett High students will also be assisting inside the polling locations

on Election Day.

“The students been a great addition to our election day team,” said Pietrantonio. “Their government teacher [Carolyn MacWilliam] is amazing. She reviews the ballot questions with her students. And we’ve been able to recruit Everett students to work at the polls.”

WALDEMAR PROJECT IS CONTROVERSIAL

EAST BOSTON - The Orient Heights Neighborhood Council (OHNC) kicked off its first Design Review Committee (DRC) meeting of the season on Tuesday, Oct. 18. There was a review of three potential projects in the area – none more controversial than the project at 20 Waldemar Avenue that was presented at the end of the meeting.

The proposed development would erect a six-unit building in an area currently zoned for one-family units. This development is not necessarily new, as some changes were made to the plans since it was presented at an abutter meeting back in July.

These changes include dropping the unit size from nine to six by scaling down the front of the building and moving the remaining portion of the building forward. Initially, there were concerns about the shadows a building like this would cast on abutting buildings, but the new size of the building seeks to quell those concerns. Privacy screens on the rear balconies of the building were also added to ease concerns about the ability to look into abutting build-

ings.

Overall, the reaction to the updated project was mixed, as some Waldemar residents still had apprehensions. One of those residents who voiced their concerns was Daniel Todesca, who lives at 24 Waldemar Avenue directly next to the proposed development.

Todesca outlined issues he has with the project regarding potential variances in terms of size and neighborhood congestion, among other things. He also raised concerns about the drainage issues a building like this could cause.

Todesca went into depth about the congestion issues citing that even with the proposed six off-street parking spots in the plans, there is potential for more than six cars in the building, which would make parking in the area worse.

“My main concern is that you are trying to build a condo building in a lot that is only zoned for a single-family dwelling, and I am the single-family dwelling next door, so I have concerns with my residence; what is going to happen to that,” said Todesca.

“If there was a vote today on the building, I would probably say no,” he added.

Another Orient Heights resident Gail Miller echoed Todesca’s sentiment, citing the height of the proposed development towering over abutters and congestion in terms of the number of units.

“This is a one-family zone – it is quite obnoxious to propose six units on the same site. Obviously, they are trying to chip away at the zoning in our neighborhood,” said Miller.

“It is not in keeping with the character of our current neighborhood ... I am opposed to it myself as a resident in the neighborhood,” she added.

While some opposed the potential project, others, like John Wyatt, who lives across the street, seemed to like the updated rendering.

“This looks really nice, and I think it fits in. The house that is there now has been neglected for years and is unsightly. At least this adds a little bit to the neighborhood – I like it,” said Wyatt.

“I am definitely fond of this project if we can get rid of that unsightly thing that is there now,” he said.

Toward the conclusion of the meeting Gary Carter the proponent of the proposal, addressed comments regarding the project and said he hopes to talk to more residents about the project in the future.

Carter and residents will have the opportunity to discuss the development further soon as the OHNC has requested that representatives for the project return to another DRC meeting slated for sometime in November.

River bridge opens in the coming years.”

The following image shows the route of the Northern Strand. The completed 10-mile (+/-) section of shared used path is shown as a solid blue line. On the northern end the dotted section in Lynn is in design, to be built starting in FY24. Also, the Community Path of Lynn, a spur trail, was built as part of a separate effort. On the southern end, the City of Everett is completing a connection to the Mystic River, and the Mystic River Bicycle and Pedestrian Bridge is under design (also to be built starting in FY24).

WINTHROP LEADS THE WAY WITH CLEAR PROGRAM

WINTHROP - Nearly a decade ago, Winthrop’s

public health and public safety programs began working together to provide better mental health and substance abuse resources for the town’s residents.

The program, now known as CLEAR (Community and Law Enforcement Assistance Recovery) program, has become a model for communities throughout the state and the country.

At last week’s community fall forum, Meredith Hurley, the town’s Public Health Nurse, updated the community on the history

and goals of the program.

“Back in 2014, I personally had never heard the phrase ‘police reform’ at that point, but that is really when public health aligned with public safety,” said Hurley. “As a result of the opioid epidemic, we were seeing a lot of loss in the community and we were concerned about that.”

Hurley began conversations with the police and fire chiefs at the time to try to determine different strategies to deal with the epidemic.

“We started with looking at the high rates of fatal and nonfatal opioid overdoses,

and public health and public safety came together and formed our collaboration,” said Hurley.

At that early stage, she said the collaboration allowed for a police officer to knock on doors along with a peer recovery coach at homes following overdoses.

“The peer recovery coach is somebody with lived experience who works (with someone with substance abuse issues) to take them down the path of recovery,” said Hurley. “It can look many different ways, it can be harm reduction, it can be giving Narcan so they or a family member can have it in the house for safety.”

As the partnership progressed, the public health department received a grant to hire a part-time social worker who worked with public safety on a jail diversion program.

“What we really want to do is keep people out of the emergency system,” said Hurley. “We don’t want to see people in jail and we don’t want to see people in emergency rooms. That’s what it really boils down to.”

Recent good news for the CLEAR program has included a licensed clinician trained in deescalation working with the police department, and nearly all police officers having been trained in the crisis intervention team model. Hurley said the goal is to also train the town’s firefighters on the model.

Hurley said the program has also been able to pivot from the earlier opioid-intensive model to address

other mental health and substance issues in the town.

“In Winthrop, alcohol was a bigger issue and continues to be a bigger issue, a bigger substance that we are concerned about, so it felt funny for (us) to tell somebody we would love to work with you, but you are not a heroin user so we cannot because of our funding,” said Hurley.

The CLEAR program was able to address its funding in order to serve a wider variety of issues in the town, she said.

The program continued to grow and grow, and when the Covid-19 pandemic hit in 2020, Hurley said the town had many resources in place to help deal with the pandemic itself, as well as the many mental health challenges associated with it.

“The CLEAR team has been pivoting and pivoting and pivoting with the needs of the community, and that is really where the success has been with this program,” Hurley said.

The latest highlights of the program include a police lieutenant assigned to the health department and increased resources to deal with domestic violence.

“CLEAR is on the cutting edge because we have been doing things that are now emerging as best practices,” said Hurley. With that increased visibility has come more opportunities for grant funding to expand the program even more, including a partnership with the Boston University School of Public Health.

AN OUTSTANDING CAREER COMES TO A CLOSE

Richard Pedi retires as regional manager of Boston Carpenters Union

In Chelsea, Rich Pedi will forever be known as the phenomenal second baseman on the 1971 Chelsea Little League National League All-Star that came within a game of a state championship on the road to Williamsport.

Pedi went on to achieve athletic excellence at Pope John XXIII High School and at Chelsea High School.

In his professional career in the skilled trade of carpentry, Pedi also brought much credit to the family name. At the age of 63, Pedi retired on Sept. 30 as the North Atlantic States regional manager of the Boston Carpenters Local Unions 327 and 328. Pedi compiled 22 years of commendable service as a staff member, business agent, business manager, and regional manager in the Carpenters Union. He has been a member of the Carpenters Union for 38 years. In his important post as regional manager, Pedi led a union of 5,500 members.

I was very fortunate and honored to serve in union leadership positions," said Pedi, who joined the carpenters' apprenticeship program in 1985 and as a journeyman, worked as a foreman and steward. "I think my work as steward prepared me for this position [regional manager], because my job was to represent members on the job, kind of a mini-version of a business agent," related Pedi.

A tremendous athlete in his hometown

Rich Pedi is the son of former Chelsea Police Officer and U.S. Army veteran, the late Anthony Pedi and the late Jennie (Presti) Pedi. He has five brothers, Don, Andy, Ed, Bob, and Bill, and two sisters, Joan and Paula.

Rich grew up on Normandy Road before his family purchased a home on Warren Avenue. He attended Our Lady of Grace School, Pope John XXIII High School for three years, and Chelsea High School, where he graduated in 1976.

Pedi distinguished himself athletically in Chelsea youth sports and in high school. In 1971, Pedi teamed up with other Little League stars such as Paul Wheeler, Earl Vigoda, Hughie MacDonald, Peter Hanlon, Carlos

Moreno, Miguel Ricart, Tommy Moscatelli, Sean Graham, Brian Archdeacon, Billy Perry, Bobby Chew, Robert Caputo, and Cary Shuman to lead the Chelsea Nationals to the city's best-ever finish in the Little League All-Star Tournament.

"I was also on the very first Pop Warner 'A' team in Chelsea," said Pedi. "Joe Leonard was my line coach."

Pedi became a three-sport (football, basketball, and baseball) athlete at Pope John and Chelsea High (football, track, and Baseball) as well. As a football player at Chelsea High, he was a defensive back and backup quarterback to David Molloy. He was also a brilliant pitcher and shortstop for the Pirates in the Chelsea Pony League, where he was coached by the legendary James "Bear" Burke.

Mayor Brian Arrigo said, "I wish Rich Pedi the sincerest congratulations on his retirement," said Mayor Brian Arrigo. "Rich has always been a trusted partner and friend. His impact will undoubtedly remain in the City of Revere for years to come and I wish him luck as he begins this new chapter of his life."

His early career

Rich Pedi held other jobs before entering the field of carpentry. He worked for an air freight company and a small airlines company (Bar Harbor).

"Those positions were kind of interesting," said Pedi. "I was the ramp foreman and it taught me to be a leader."

Pedi said he was always mechanically inclined, but he never took a trade in school.

"I first worked at Bradlees in Chelsea. My mother was one of Bradlees' original employees when it opened," said Pedi. "I also worked in the publicity department at Wonderland Greyhound Park."

Taking pride in his record as a union official

Pedi said as regional manager of the union he would attend many local planning and zoning meetings and connect with developers.

"I tried to work directly with developers to hire union contractors which would allow my members to work and earn a decent wage with benefits," said Pedi. "One of my main goals was that I tried to put in provisions that would put local people to work, people that actually live in the community where the jobs are. I still have my roots in Chelsea and that's always been important to me, helping local people."

Pedi is very proud of his record as a union official.

"I always say I was very blessed to be in this position because I could help people that needed the help," said Pedi. "I was part of several contract negotiations. You have to be able to hold your ground. A lot of people say that one of my best qualities is that I know empathy and my ability to listen to the other person's side. I don't have to agree with it, but I'll listen to it, and then make a decision based on all the information."

Pedi said he was also proud of his record in helping women secure employment in the construction trades. "As an example, I would say that 95 percent of the women that worked on building the Wynn Boston Harbor Resort and Casino in Everett are now working and

making a good living. I'm proud of that," he said.

Pedi attended numerous events in Chelsea and surrounding communities and built relationships with Chelsea City Managers Jay Ash and Tom Ambrosino, State Reps. Dan Ryan, Jessica Giannino, Joe McGonagle, and Adrian Madaro. Sen. Sal DiDomenico, Revere Mayor Brian Arrigo, Everett Mayor Carlo DeMaria, and former Boston Mayor and current Secretary of Labor, Marty Walsh.

A proud father

Rich and his wife, Lauren, have been married for 22 years. They have three sons, Chris, a U.S. Army veteran, who was a stand-out long distance runner at Columbia University and now competes in marathons, Dominic, who is a starting defensive tackle for the University of New England football team, and Alex, who is a proud member of the Carpenters Union.

Praise from leaders and legislators

Rich Pedi has been receiving a steady stream of congratulatory wishes from union colleagues and friends. City managers and legislators are praising his many years of dedication and service and for the professionalism he demonstrated during negotiations and conferences.

Former City Manager Jay Ash, who led the city's total transformation of the Everett Avenue district, said, "Rich has been a loyal defender of working people and huge champion of the communities they live in. His efforts have always been waged by others, and his impact has been to make life better for those relying on him."

State Rep. Dan Ryan also lauded Pedi's leadership as a union official.

"Rich has been a staunch advocate for the men and women in the building trades his whole career," said Ryan. "More importantly, he remained a loyal son of Chelsea. I congratulate Rich on a great career, and I offer my best wishes for the future."

Said Rep. Jessica Giannino, "I'm so grateful for Rich's years of advocacy and friendship on behalf of the Boston Carpenters Union. I will greatly miss his presence and wish him all the best in this next chapter."
