RHS senior Matthew Terrell selected to Gov. Healey's Youth Council

Matthew Terrell is the chairperson of the Revere High School Student Senate, a two-year captain of the varsity swim team, and a member of Mayor Patrick Keefe's Youth Advisory Board.

Those positions are a strong indicator of Terrell's excellent leadership skills. Monday night, Terrell showed his oratorical splendor while representing his six-person group at the Broadway Master Plan meeting at the Hill School. At 18, Matthew was the youngest speaker at the

meeting, showing poise and confidence as he summarized the group's ideas for the future development of Broadway in Revere.

The son of William Terrell and Nicole Deveau, Matthew will be taking his talents (as NBA great LeBron James once said about moving on to the Miami Heat) to the State House in Boston where he has been selected as a member of Governor Maura Healey's Youth Advisory Council.

Last October, Matthew applied for the prestigious position on the Youth Council, a process that included writing an es-

say about how he could best contribute to Gov. Healey's Council. The application also required a list of his extracurricular accomplishments and recommendation letters.

"I received the notification letter in mid-March, and I was sworn in [at a ceremony in Boston] on March 25," Matthew said proudly. "I'm currently interviewing for the opportunity to be chair or vice-chair of the Council. I look forward to being one of the youth voices making recommendations

Consultants provide update on Martin Street tide gate project

City officials and consultants provided an update on the Rumney Marsh Martin Street Tide Gates improvement project at a public input session last Thursday.

The project seeks to reduce flooding in the Martin Street and Rumney Marsh area.

The current two-year phase of the project is being funded by a state Municipal Vulnerability Preparedness (MVP) grant.

"In this phase of the project, we are looking specifically at the Martin Street tide gate and we're looking to design and permit an upgraded tide gate that is going to function property and provide some additional resiliency," said Chris Pyman, a project engineer with Weston and

Sampson.

The first year of this phase of the project will include the preliminary design and field investigations, while the second year the engineers are going to advance the design of the project and work to the project permitted through the necessary local and state regulatory agencies.

"These improvements will help to improve flooding upstream, as well as help improve conditions in Rumney Marsh as well the Central County Ditch marsh, which is the upstream salt marsh on the catchment side of the tide gate," said Pyman.

Overlook Ridge looks toward completion of development

The developers of the Overlook Ridge development in Malden and Revere are seeking a zoning change to their district that will allow the development of the last two parcels on the Revere side of the project.

Last year, developer Veris Residential was before the council seeking a change in the Overlook Ridge zoning district that would eliminate the need to build a hotel on one of the two remaining parcels on the site. Veris also sought parking relief for the remaining residential site on the property.

After going through a public hearing process last

year, Veris was back before the city council last week. The developer is still seeking the elimination of the hotel requirement for the parcel near Salem Street, but is no longer seeking the parking relief for the planned 310 residential units on the other side of the development.

"Right now, the way this ordinance is written, we have a condition that we must build a hotel and we can have an accessory use of retail," said Marshall Tycher of Veris Residential at last week's council meeting. "This amendment we are seeking tonight is to remove the hotel as a condition.

Board of Health hears of the coming installation of Naloxone boxes

The Revere Board of Health held its regular monthly meeting this past Thursday (March 28) in the City Council Chambers at Revere City Hall. On hand for the meeting were chair Dr. Drew Bunker and a new member of the board, Kathy Savage. Also in attendance were Lauren Buck, the Director of Public Health, and Paula Sepulveda, the Board of Health Clerk.

Special guests were CarrieAnn Salemme, the

city's Substance Use Disorder and Homeless Initiative (SUDHI) Program Manager; Nicole Palermo, a Mental Health Clinician/Social Worker; and Cheryl Sbarra, the Executive Director and Senior Staff Attorney for the Massachusetts Association of Health Boards (MAHB).

Buck presented the city's Communicable Disease monthly report. "Our flu number was quite high," said Buck. "We had 168 cases with the ages ranging from two months to 97 years old," said

Buck, who noted that there were only 50 confirmed COVID cases in residents ranging in age from one month to 96 years old.

Buck also noted that there was one case of brucellosis in the city, a rare bacterial disease which is contracted by consuming unpasteurized dairy products. "This is not typically seen in Revere, but it is worth mentioning so that residents are aware of the risk of consuming these products," Buck said.

Buck added that measles cases have been on

the rise across the country. "Students should be current with their MMR vaccines," said Buck, who also urged unvaccinated travelers to foreign countries, where measles cases also are on the rise, to obtain vaccinations before departing the U.S.

Buck also made mention of a new state initiative to implement "a health equity plan to address racism as a serious public health threat."

Finally, Buck pointed

ZBA issues variances for Campbell Ave. duplexes

The Revere Zoning Board of Appeals (ZBA) held its regular monthly meeting last Wednesday, March 27, in the City Councillor Joseph A. DelGrosso City Council Chamber. On hand for the brief (eight minutes) session were chair Michael Tucker and fellow members Aklog Lime-neh, James O'Brien, John Lopes, and Arthur Pelton.

The agenda consisted of only one item, an application from MJM Real Estate Holdings, LLC, 193 Crescent Avenue, requesting the following variances from the ZBA to enable MJM to construct three duplex dwellings on Lots 115, 116, and 117 on Campbell Ave.:

1. Revere Revised Ordinances (RRO) Section 17.16.040 with respect to minimum area requirement of 6,000 s.f. and frontage requirement of 60 feet for duplex dwellings within the Residential B (RB) District;

2. RRO Section 17.24.010 with respect to minimum front yard setback requirement of 20 feet within the RB District;

3. RRO Section 17.24.010 with respect to minimum side yard setback requirement of 10 feet (each side) within the RB District;

4. RRO Section 17.24.010 with respect to maximum building coverage requirement of 30% within the RB District;

5. RRO Section 17.24.010 with respect to maximum requirement of 2 1/2 stories within the RB District; and

6. RRO Section 17.24.070 (A) (4) with respect to minimum requirement of 40% landscaping within the front yard within the RB District.

Rick Salvo from the firm of Engineering Alliance, LLC, in Saugus, presented the application. He explained that these are three vacant lots consisting of 5191 sq. ft each with 50 feet of frontage.

"These lot shapes are unique and the topography features a 20-foot drop from the front to the rear," said Salvo. "There will be a tremendous amount of fill needed because of the soil conditions. The buildings have been designed to fit into the topography."

Ward 2 City Councillor Ira Novoselsky spoke in favor of the proposal.

"I've lived in this area for more than 70 years and there used to be homes on these lots, but the lots have been vacant for more than 50 years. We had a neighborhood meeting and sent out emails to the homeowners and individual tenants. We only had six people show up and there was nobody against it.

"I am in favor of it and have worked with the developer on the design," Novoselsky continued. "The direct abutters behind the lots on No. Shore Rd. were delighted because the design of the lots will prevent runoff from coming onto their land."

A representative from Atlas Auto Body, which is located on No. Shore Rd., said the water issue always has been a problem. "We're very happy to see this land is being developed," he said. "The water has been an issue for many years and we're excited that this issue now will be addressed."

There were no opponents and the members unanimously approved the application. The ZBA's next meeting is set for April 24 if there are any applications filed in time for that date.

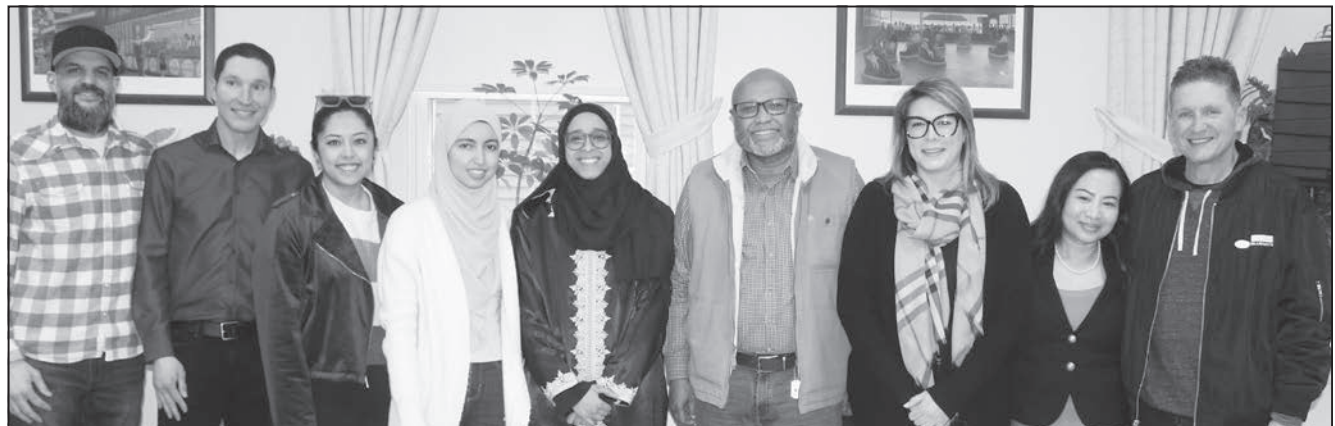

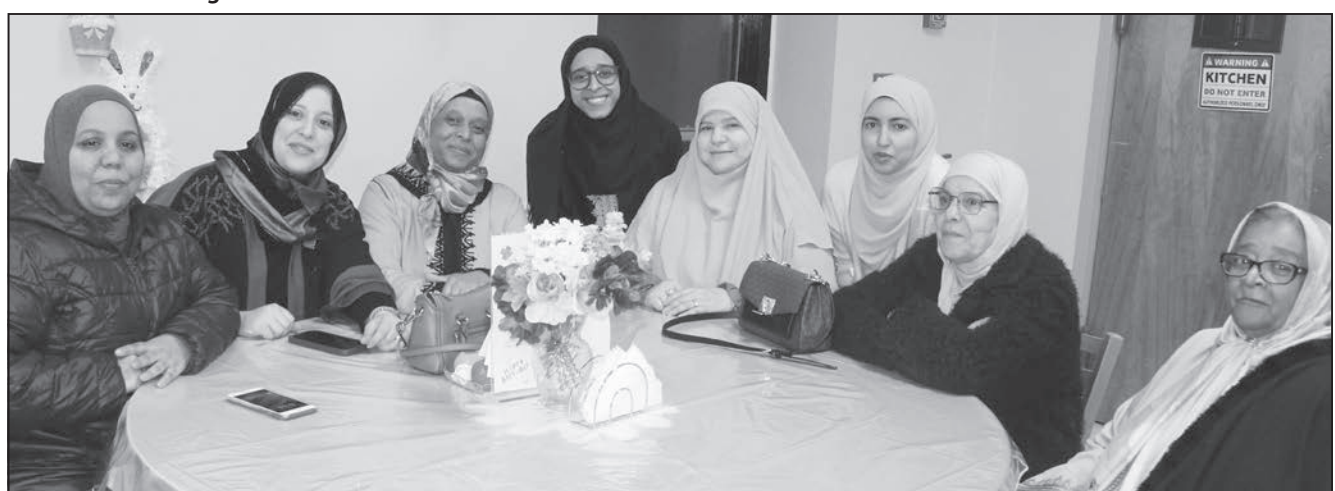

out that norovirus cases have been on the rise nationwide, particularly in the northeastern U.S. She said that the illness is transmitted by means of contaminated food and that proper hand washing by those who prepare food is essential to preventing its spread.

Sbarra made a presentation regarding the high degree of legal authority that local boards of health have in Massachusetts. She walked the members through the Massachusetts statute (M.G.L. c. 111, s. 31) and Supreme Judicial Court case law that empower local boards of health to invoke the municipality's broad police power to protect the health, safety, and welfare of its residents, even at the expense of individual freedom and business interests.

Most recently, the SJC upheld a recent by-law enacted by the Town of Brookline that forbids the sale of tobacco products to any person born after January 1, 2000. Sbarra also made note of an SJC de-

cision upholding the Town of Yarmouth's ban on the sale of a flavored tobacco product, even though the product did not explicitly advertise itself as containing flavored tobacco.

She also cited an SJC decision that upheld the Town of Athol's Board of Health regulation that forbids smoking in private clubs. Sbarra then showed a number of slides regarding some of the many areas of public health that fall within a board of health's jurisdiction and the means, including fines and actions in district court, by which boards can enforce their regulations.

The Opioid Abatement Working Group then made a presentation to the board. Buck first spoke on the subject of the funding for the programs for the city's efforts to combat opioid addiction, which is a serious problem in the city. Buck displayed a graph that showed the increase in opioid overdose deaths in Revere in recent years: 21 in 2020, 25 in 2021, 30 in 2022, and an estimated 123 total over-

doses, of which 17 were fatal, in 2023. She said the source of funding for local programs for treatment, support, and prevention comes from the national settlement with the pharmaceutical and retail companies who produced and sold opioid drugs.

"Our goal is to spend this money effectively and to make sure that we have a long-term spending plan, not year-after-year in short-term ways," said Buck. "We also want to focus on innovative plans."

Palermo spoke about the composition from across the community of the Opioid Abatement Working Group and the work the group is doing on this complex issue.

Salemme informed the board of the soon-to-appear outdoor and indoor Nalox-boxes, which are used to store Naloxone (also referred to as Narcan), that will be installed at various locations throughout the city. Naloxone, which now is an over-the-counter drug, is a medication that can reverse the effects of an

opioid drug overdose. She also noted that it is a very safe medication, similar to a nasal spray such as Flonase. Salemme pointed out that neighboring communities have installed these boxes with little or no vandalism.

Buck said the boxes will be placed at locations where the data has shown where the most overdoses occur in the city. Salemme said the boxes will be installed in May in conjunction with the city's DPW. She also said that instructions for how to administer Narcan to an overdose victim will be on the storage boxes themselves.

In its final business of the evening, the board approved the issuance of three licenses pursuant to the city's Urban Farming Regulations: Chick-keeping to Iphigenie Victorin; Bee Keeping to Damian DeMarco; and Bee Keeping to Aldo G. De Oliveira. Buck noted that all three applicants had passed the required inspections from the Health Dept.

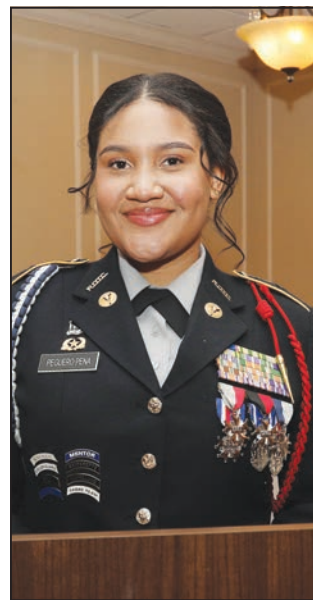

Sumner Street fire displaces 13 residents

A fire that originated in the kitchen of a condo unit at 34 Sumner Street on Sunday displaced 13 residents.

No injuries were reported as a result of the fire, which is still under investigation.

Calls for the report of a building fire at the three-story condo building on Sumner Street came in shortly before 10 p.m. on Sunday, according to Fire Chief Christopher Bright.

Group 4 was the working group on duty for the department, and the Officer in Charge was Deputy

Chief Michael DiCarlo.

Upon arrival smoke was showing from unit #2 of the six-unit, three-story condo building. Residents had self-evacuated from the building upon arrival. Firefighters initiated an aggressive interior attack stretching several handlines and ventilated the building, according to Bright. Hoarding conditions were found in the fire unit making it an extremely difficult and dangerous situation, according to the chief.

Firefighters were able to knock down the fire in the unit stopping the spread of throughout the struc-

ture. Power was shut to the building and National Grid was called to the scene to cut power at the pole.

Thirteen residents were displaced and the Red Cross was called to respond and assist the displaced.

The Health Inspector was called to the scene due to the unsanitary hoarding conditions found on scene. The fire originated in the kitchen of unit 2, according to Bright.

The Fire investigator was called to the scene, but the cause has yet to be determined.

Construction improvements to the tide gate could get underway as soon as Fiscal Year 2025, and should bring improvements to people in the neighborhood experiencing flooding, he said.

During the presentation, Pyman and other consultants also touched upon the environmental issues the marsh area and the city as a whole face, as well as how properly working tide gates can help with some of those issues.

Residents who attended the meeting also provided input on their use of and concerns about Rumney Marsh.

The majority of respondents to a slide questionnaire stated they were concerned about environmental issues in the marsh

area. When asked about how they use the area, several residents stated they enjoy walking and birdwatching.

“Revere is a coastal city, so it needs tide gates to effectively manage stormwater and protect the community from flooding,” said Pyman. “Without tide gates, tidal flow would inundate the stormwater system and during storm events and high tide, the storm water would have nowhere to go and the system would be inundated with salt water.”

Last year, the city undertook the first phase of the Martin Street Tide Gate project with improvements to the Diamond Creek catchments, said Pyman.

“We looked at the whole

Diamond Creek catchment area, which is the basin upstream of the Martin Street tide gate,” said Pyman. “It is approximately 574 acres, of which 329 acres is impervious surface areas – places where when it rains, the water does not have any ground to go into, so it is going to run off until it finds grass or dirt.”

Pyman noted that there is a great need for the improvements, since the current tide gate at Martin Street does not function as it was designed to function.

The current tide gate operates on a buoy system that has been stuck at times in both the open and closed positions, Pyman said.

OSHA levies \$6,500 in fines against Roseland

Violations and fines that the Occupational Safety and Health Administration (OSHA) leveled against Roseland Contractors on April 2 may be just the beginning of Roseland's problems, said two city councillors.

OSHA cited Roseland for five individual violations, with fines of \$6,500, which were uncovered during a visit to the Rowe's Quarry project on Feb. 24 that Councillor George Rotondo had urged.

The first item cited by OSHA dealt with workers being over 11 feet from the ground without the protection of a guardrail or safety harness, for which OSHA proposed a penalty of \$1,000. The second item had to do with open holes or slots over four inches wide on the walking surface, posing a tripping hazard. The proposed penalty for that was \$1,750.

The third violation was for not protecting workers from objects falling through holes from above, which brought no fine. The fourth item cited them for not protecting workers from a four-story fall down an unfinished stairwell. That proposed fine was \$1,250.

The final item dealt with an improperly build guardrail system to protect workers from falling down an elevator shaft. That carried a fine of \$2,500.

All five items were supposed to be corrected by Thursday, April 8.

"This is just the beginning," said Rotondo. "There are more things coming."

Teen idle

City is finding creative ways to keep kids busy after school

"Cool" is a difficult word to define, especially by teen-age standards.

Parents and directors of after-school programs have been trying to define "cool" for years in Revere, but with little success as a growing number of teens complained of nothing to do and nowhere to go.

More and more kids are congregating on Broadway, and the police increasingly have had negative encounters with young juveniles. The growing drug and alcohol temptations just never seem to subside.

Many have felt these problems could be stemmed if only there was something "cool" for kids to do - but that hasn't existed for some time.

Change seems to be on the horizon, though, and a wave of opportunities seems to be hitting the city all at once, leaving long-time youth activists like Kitty Bowman almost giddy.

"There's just some real good energy going around everywhere right now," said the Revere-CARES chief. "It feels as if finally things are beginning to come together in a way that will really change things."

WATCH THE ECLIPSE SAFELY

With our area in the path of the solar eclipse this coming Monday (and with clear skies forecast), we urge any of our readers who are intent on watching the event to be sure to wear proper eyewear and to ensure that their children do as well.

A person can cause permanent damage to their eyes -- and even go blind (a condition known as solar retinopathy) -- if they do not use proper eye protection, such as eclipse glasses or a special solar filter. Regular sunglasses don't offer any protection and viewing the eclipse through your I-phone camera offers no protection for you and will damage your phone. (Photography experts say just pointing your smartphone camera at the eclipse could cause catastrophic damage to the phone if you don't have proper equipment.)

Individuals also have to be certain that the eyewear they are using is certified. There are reports that knock-offs that are being sold on-line are not legitimate.

One eye doctor, who was quoted in the New York Times, offered this advice: Don't look at the eclipse at all, even with proper eyewear.

But for those who are intent on watching this event, please do so safely.

RUSSIA IS OUR REAL ENEMY

Sunday's special report on the CBS news show 60 Minutes revealed that Russia has been the culprit in the hundreds of cases of debilitating neurological injuries that have struck American intelligence and law enforcement operatives around the world in the past few years.

The phenomenon has been dubbed "Havana Syndrome" because the problems first became apparent among a cluster of employees at the U.S. Embassy in Havana, Cuba. However, as the 60 Minutes report showed, these attacks on U.S. personnel (and their families), all of whom have worked with the CIA, the FBI, the military, the State Department, and the White House -- almost all of whom were working on areas of national security related to Russia -- have been occurring all over the world and even in our own country.

The "weapon" being used by the Russians is thought to be directed energy or microwaves fired from hidden devices that inflict serious and permanent injury on those who are targeted.

The 60 Minutes report makes it clear that Vladimir Putin is a monster who is using any means necessary to undermine our national interests. Our political leaders, especially the Republicans in Congress, must recognize the threat he poses and do whatever it takes to thwart him.

BIRD FLU IS NOT JUST FOR THE BIRDS

The second confirmed case of the bird flu infecting a human in this country (a Texas dairy farm worker who worked among infected cows) raises a red flag about the possibility of another pandemic ripping across the world.

The current bird flu outbreak not only has killed millions of wild and domesticated birds world-wide, but it also has killed many mammals across the globe, including the well-publicized devastation of an elephant seal population in Argentina.

Although the bird flu is not as fatal in cows as seals, it has sickened cows in states across the country, an indication that cows are infecting each other as they move around farms from state-to-state. The virus has been detected in the unpasteurized milk of these cows. More ominously, the detection of the virus in the dairy worker suggests that the bird flu can jump from one mammal species to others -- including ourselves.

The bird flu -- also known as H5N1 -- wreaked havoc in many parts of the world, especially in Asia, in 2006. The U.S. largely was spared the ill-effects of the outbreak thanks to efforts by our national health authorities who worked in these foreign countries to contain its spread.

However, this new variant of H5N1 is being brought to this country by wild bird populations, which obviously is something we cannot control. If cows have been infected, it stands to reason that other animals, including our house pets, could become infected and spread the virus.

COVID-19 killed more than one million Americans. But as bad as the pandemic had been at its height, it was only killing about one percent of those who were infected, with substantially higher death rates among the elderly and those with prior-existing health conditions, including obesity.

However, the bird flu in humans is far deadlier, with death rates having been estimated at 50% during the 2006 pandemic in some countries. Even if the chances of a bird flu pandemic among humans are slim, the high mortality rate should be enough to raise the alarm bells among our public health officials.

10 years ago April 1, 2014

Revere Police this past week arrested 26 persons accused of dealing drugs, mostly heroin, including one man who is still being sought and is believed to knowingly have sold a lethal bag of fentanyl-laced heroin to a user who overdosed and died in February. Dubbed Operation High Tide and directed by Detective Rob Impemba and Lt. John Goodwin, with extensive help from undercover State Troopers and Trooper Tom Cannon, the three-month operation was deemed a success after 90 percent of the targets were arrested and charged.

Revere's RoseLee Vincent cruised to victory Tuesday night, topping Republican Todd Taylor of Chelsea by 880 votes and winning overall, 1,466 to 586 (not including results from two Saugus precincts), in the special election for State Representative.

The Jewelry Box on Broadway Revere has helped generations of people celebrate their anniversaries, and now the store is celebrating a little milestone of its own. Tom Yourawski and co-owner Justin Puopolo are celebrating the store's 38th anniversary this month.

The Planet Fitness at Northgate in Revere will serve as the New England outpost for a casting call to NBC's The Biggest Loser reality television show, the second year in a row that the casting call will be held at the Revere gym, said owner Tim Morrisette.

The Phantom Gourmet television show will be featuring one of Revere's well-known food establishments, New Deal Fruit, 920 Broadway, on an upcoming episode. The Phantom will highlight the Italian grocery's outstanding sandwiches, delicious fruit, and family atmosphere at the popular store.

20 years ago April 7, 2004

A deluge of six inches of rain caused minor flooding in homes and basements around the city Thursday, but caused major damage at the city's 100 year old police station, where a leaky roof caused extensive water damage to exhibits in the evidence room.

Local cable TV ratepayers are outraged at the latest increases in cable TV rates in an industry in which competition has been diminishing across the country for the past decade.

Revere motorists are being warned that towing on the city's streets will be starting April 19 when street-cleaning parking bans at certain hours on certain days go into effect through November 30.

Police are looking for suspects in the murder of a 29 year old East Boston man whose body was found in the parking lot of the Lion's Den nightclub on Revere Beach early Saturday morning. Police had responded to reports of a melee and shooting

at closing time and found the man's body. Two other men who also were at the club that night later were found by police at the East Boston Neighborhood Health Center, one with stab wounds and the other with a gunshot wound.

40 years ago April 4, 1984

Police are investigating the poisoning of seven youths in the city who drank soft drinks laced with rat poison. The youths, ages 13-15, were at the apartment of a man who allegedly allows the boys to use his apartment whenever they want. Some of the boys said they ingested the rat poison because they thought it would make them get high.

Colonial Cablevision officials have informed the City Council that they do not anticipate being able to offer viewers the NESN network for Bruins and Red Sox games in the near future because of technical problems with receiving NESN at the local facilities.

Although Thursday's snowstorm of March 29 was compared to the Blizzard of '78 for its fury, it fortunately did not cause anywhere near as much damage. Although the Pines and Beachmont areas were flooded, causing residents to flee, there were no deaths or injuries. However, the heavy, wet snow, combined with the hurricane-force winds, toppled many trees and power lines. The evening high tide, three feet above normal, caused significant flooding, covering the MBTA tracks near the Garfield School.

50 years ago April 3, 1974

The Cyclone roller coaster on Revere Beach, the most historic and prominent landmark on Revere Beach for the past 49 years, met its demise this week as bulldozers demolished the structure that had brought heart-thumping thrills to millions over the years. The ride, which had not been in use for the past five years, had 3600 feet of track and would hit speeds of 45-50 miles per hour, including a drop of 100 feet.

Although Mayor William G. Reinstein has denied the request by Colonial Cablevision to increase its rates from \$5.00 to \$6.50 for its monthly basic service, in addition to other price increases, George Sisson, the company's president, said Colonial will file for increases on a monthly basis until they are approved.

Mayor William G. Reinstein has approved funding for sewage improvements to Revere Beach Blvd. to alleviate problems in some homes where human waste is coming into their basements.

Max, a one year old German Shepherd, has joined the Revere Police Dept. as a member of its new K-9 Corps. Patrolman Dan Sweeney will be its handler.

A class of 205 boys and girls received the Sacra-

ment of Confirmation at Immaculate Conception School from Bishop Eustace Smith.

60 years ago April 2, 1964

The City Council gave final approval to a record-high budget of \$8,074,727, an increase of \$311,893 over last year, representing a \$4.00 increase on the present tax rate of \$99.60.

The Revere Police have arrested and obtained a conviction for a 19 year-old local youth who had illegally obtained prescription pills through phony scripts and who was selling the pills to other youths. When mixed with alcoholic beverages, the pills, known as goof-balls, give the person who imbibes the mixture a feeling of being on cloud-nine. The police action comes following a meeting with Dr. James Bono at the Immaculate Conception Church on the illegal use of these drugs by the youths, which in turn prompted parents who had noticed strange behavior among their teenagers to inquire into the situation.

Revere Police Sgt. Joseph Lennon reports that police are investigating five telephone calls of bomb scares that the Revere schools have received over the past week. Revere school officials, who ordered the schools evacuated after the bomb scares were received, held their students at school for longer days to make up for the time lost to the bomb scares.

Nine townhouses proposed for Sons of Italy site

City Councillors praised a plan to build nine townhouses at the site of the current Sons of Italy club at 8 Revere St. at last week's meeting.

The project is scheduled to go before the council's zoning subcommittee on April 8 before coming back to the full council for approval.

"The proposal is to raze the building and construct new townhouses ... four

on the easterly side of the property and five on the westerly side of the property, with a single curb cut," said project engineer Rick Salvo.

The townhouse project will increase the amount of greenspace on the property from 775 square feet to over 7,000 square feet, said Salvo. Each of the units will have two bedrooms, two bathrooms, and will be parking compliant with two spaces each. Salvo said the proj-

ect does need some zoning relief for the front yard setback.

"We think this will create a great transition from the commercial area to the multi-family area to the single-family area," said Salvo. "The Sons of Italy, while it served the city so well for so long, it has kind of met the end of its useful life. This can provide a much-needed housing option."

While the units will be market rate, they will be

condominiums offered for ownership rather than rental units and will help increase home ownership in the city, said Salvo.

The proposed townhouses are in Council President Anthony Cogliandro's ward, and he praised the developers for the project.

"We are not going to get another project like this," said Cogliandro. "Instead of getting 30 units, we are getting nine two-bedroom, two-bathroom, two-park-

ing spot townhouses. This is exactly what we need in this community."

Cogliandro said he spoke to a number of residents in the area who were thrilled that the developers were proposing townhouses rather than a larger multi-unit apartment complex for the site.

Several other councillors also spoke in support of the proposal, while Councillor-at-Large Juan Pablo Jaramillo said he would like to see the de-

veloper consider an additional bedroom in some of the units to make them more attractive to families.

Councillor-at-Large Michelle Kelley said she would like to see more projects in the city like the one on the Sons of Italy property, noting that it was aesthetically pleasing, had the required parking, and increased green space.

"This is something I've thought about from the time I was working at the Senior Center," said Haas, "and the Somerville program is something that could be a model for Revere."

Perno added that many communities on the No. Shore have formed partnerships with their youth centers to provide year-round assistance to seniors and disabled persons.

"I totally agree with the four-season program," said Haas, with DeCicco adding that the social interaction between older and younger residents of a community is a valuable component of these programs.

DeCicco reported on the monthly Zoom meeting of CODA (the Commissions on Disabilities Alliance) that was held on March 6. The highlights of the meeting were as follows:

--Members from various commissions discussed the Mass. Office on Disabilities (MOD) grant program and explored the reasons why a city or town is awarded or denied a grant. DeCicco explained that there are two kinds of grants, planning

and project grants, with the latter requiring a shovel-ready project. He said that in the past, the grants had to be applied for in the fall and were not awarded until January. However, he noted that the grant funds had to be spent by the end of that fiscal year -- June 30 -- which meant that the time constraints were significant.

However, DeCicco said that the application deadline has been moved up to April, with the awards expected to be made in the early fall, which should provide for a more reasonable time frame for receiving and spending the funds within the fiscal year;

-- COD members had questions regarding whether cities and towns can offer transportation services for people with disabilities to the polls on election days. DeCicco said that cities and towns do not offer rides to the polls, but candidates often

do. Julie Brown, the new President of the Revere SEPAC (the Special Education Parents Advisory Council), provided some updates that DeCicco read aloud:

-- At the last SEPAC meeting, discussions were had on the start of its document archive that lists resources available in our community for SEPAC members and other households dealing with disabilities. It can be found here and was distributed at the meeting: <https://tinyurl.com/sepac-family-resource>

-- SEPAC is working on scheduling April-June trainings and will be including a "Know Your Rights training, the new IEP Process, and Conservatorships."

DeCicco next reported that the Revere COD has applied for a grant from Save The Harbor/Save The Bay to conduct an All-Abilities Day at Revere Beach this summer.

"If we are awarded the grant, we would be planning an event called,

'All-Abilities Day at the Beach,'" said DeCicco. "This would take place one day in the summer at Revere Beach. This event would be similar to the one that Triangle Inc. has held for the past several years at Constitution Beach in East Boston."

DeCicco mentioned that Triangle, Inc. would be willing to provide consulting services to Revere if the grant is awarded. He also said that the city's Parks and Rec. Dept. would partner with the COD and added that DCR would be asked to provide beach-accessible equipment for the event.

"This would be a huge, huge event to bring to the city," said Perno.

Perno brought up the issue of dog owners in the city making sure that their dogs are leashed so as not to create a potential problem for persons with disabilities, especially for those who have service dogs, who have been trained not to respond if they are attacked by another dog.

The meeting concluded

with Perno reading the commission's monthly announcement:

"The Commission on Disabilities office number is 781-286-8267. Residents can also call Revere 311 directly and speak to their staff Monday through Friday. They will answer most questions, but if they are unable to or if you want to speak to our department directly or schedule an appointment, please ask to be transferred to the Disability office. If we are unavailable, please leave a detailed message and someone will get back to you as soon as possible.

"As always, please tell us if you want something discussed or added to our monthly meeting agenda. You can let us know if you would like to speak on any issue or concern. The Commission is here to help and assist all the disabled residents and families of Revere."

The next meeting of the commission (via Zoom) will be held Tuesday, April 9, at 6:00 PM.

for Clerk of the Supreme Judicial Court in Suffolk County. Cartwright is looking to build on her thirty-plus years of legal representation and management in the Clerk position, which oversees critical functions within the court system including managing the court's single justice caseload concerning bail reviews, appeals form state registration boards and agencies, and appeals from lower courts. Additionally, the Clerk handles all matters concerning the admission of attorneys to the Massachusetts bar, and attorney discipline.

"Fundamentally this job is about navigating justice and access to our state's highest court," said Allison Cartwright. "Ensuring the working class and poor people have access to justice and be able to navigate the court system has been my life's work. I have represented everyone from children to adults, immigrants, citizens, people in recovery - essentially everyone who has ever needed a second chance. Key to that second chance is a system that is fair, open, and equitable."

Cartwright currently serves in the Committee for Public Counsel Services's Public Defenders Division, where she oversees seventy-five public defenders, social workers, and investigators for Suffolk and Norfolk counties. She works daily to ensure that staff have the tools necessary to provide top notch defense, necessary services, and are able to protect fundamental constitutional and human rights.

In recognition of her zealous advocacy, commitment to justice, and

formidable career, Attorney Cartwright has been appointed to a number of advisory boards, including Boston's Police Reform Task Force, the Massachusetts Advisory Board on Probation, and the Governor's Restorative Justice Advisory Committee. Through her service on these boards, she has shaped criminal justice policies at the city and state level.

Cartwright today also announced that Maggie Van Scoy will spearhead her campaign as campaign manager. Van Scoy brings public service experience, having most recently served as Mayor Michelle Wu's Office of Neighborhood Services liaison to Back Bay, Beacon Hill, Fenway-Kenmore, and Mission Hill, where she served as the administration's primary point of contact for area residents and helped facilitate the delivery of core city services across the those neighborhoods.

"I am thrilled to join the Cartwright campaign and have the opportunity to elect someone with such an impressive background in law and public service to this critical position in our judicial system," said Van Scoy. "To know Allison is to be in awe of her dedication to justice, fairness, and society's most vulnerable."

We'd like to build retail here."

Tycher said Overlook Ridge, which will have over 4,000 residents once the final residential units go up, has no neighborhood services. He said the 10,000 square feet of retail space could be used for a neighborhood market, small restaurant, and other local services.

"This is our opportunity to build retail," said Tycher. "We don't think a hotel is viable."

On the larger residential parcel, Tycher said Veris is no longer seeking parking relief and will have the two parking spaces per unit required under the district zoning.

That property is zoned for 370 units, but Veris is proposing only 310 units, with 15 percent being offered at affordable housing rates.

Tycher also addressed several other concerns that were raised last year, including a shuttle service for the entire Overlook Ridge development that was stopped during the Covid pandemic. He said the service is fully operational again.

Planning and Community Development Director Tom Skwierawski said the city supports the zoning ordinance change.

"I understand the importance of bringing in hotel tax revenue to the city, and I will strongly advocate for those areas in which it seems appropriate," he said. "But this isn't one of those areas. There is a real need for neighborhood amenities such as restaurant and retail; we need to see more of that in North Revere, and we've heard that from residents."

Skwierawski also praised the inclusion of the affordable housing component of the project.

"This is the most aggressive support for affordability that we have seen from a private sector partner that is not having the project subsidized through state or federal dollars," he said.

Councillor-at-Large Anthony Zambuto said he was initially hesitant about eliminating the hotel requirement, but noted that since the original zoning was approved, the city has seen a number of hotels built in other areas.

The council's zoning subcommittee will take up the proposed ordinance change at its April 8 meeting before it comes back to the full council for a final vote.

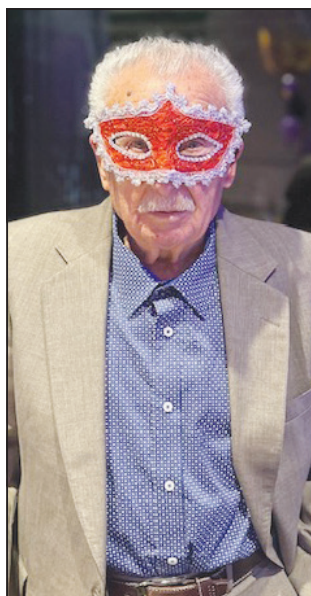

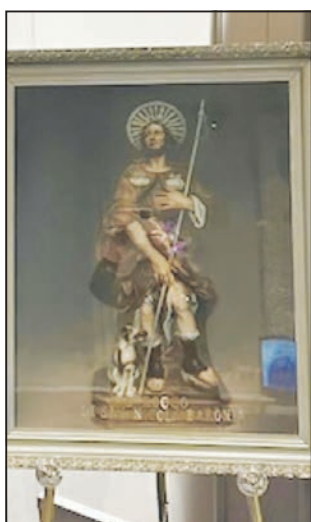

Council looks for return of Christmas Parade

After a hiatus of several years, a Christmas parade could be returning to Revere this holiday season.

At last week's city council meeting, Ward 5 Councillor Angela Guarino-Sawaya and Ward 6 Councilor Chris Giannino introduced a motion requesting the mayor reinstitute the Christmas Parade throughout the city.

Guarino-Sawaya said she has spoken to Mayor Patrick Keefe, and that the mayor and several local businesses have already expressed support for the

parade.

"I'm excited to bring this to the city and all the kids and residents," said Guarino-Sawaya.

Ward 5 Councillor Joanne McKenna suggested that the parade be connected to the Priscilla Nickerson Memorial Santa Walk in the city. Guarino-Sawaya replied that the mayor had made the same suggestion.

In other business, Guarino-Sawaya requested increased police patrols on Thorndike and Hastings streets. She said that drivers use those streets as a shortcut and speed through the residential

neighborhood.

McKenna presented a motion requesting that communications companies remove their lines completely when cutting lines rather than wrapping the excess lines around the telephone poles. She said the practice of poor and inferior workmanship has created eyesores throughout the city.

"It's wire after wire, pole after pole," said McKenna. "What happens is the ward councillor or the councillor-at-large sees a pole and they have to call Comcast and Comcast comes out. But they won't remove the wire,

and they leave it there and then it could be there for years."

Councillor-at-Large Robert Haas, III said he agreed with McKenna's motion and that he has seen numerous wires dangling from poles.

"There are instances of this all over the city where these wires dangle and some of them fall to the ground, some of them are wrapped around other wires, other poles," he said. "At some point this becomes a safety issue, you don't know what the wires are."

I would be majoring in PPES (Philosophy, Political Science, Economics, and Sociology.)"



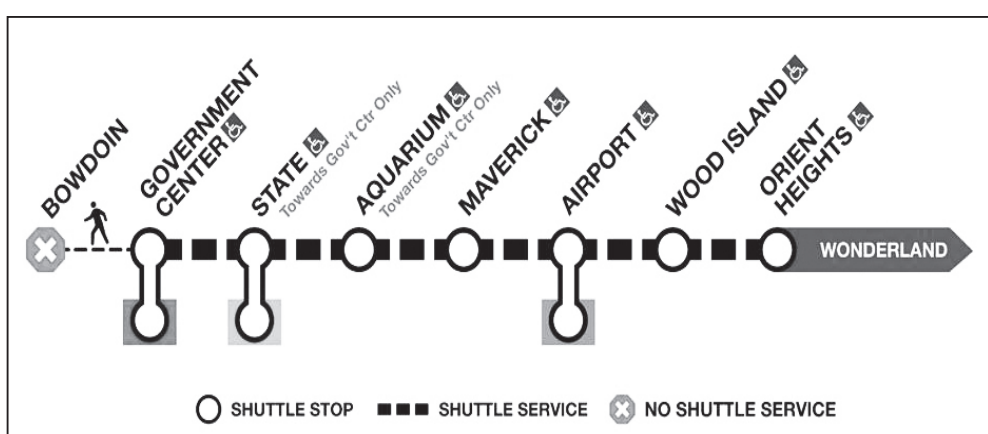

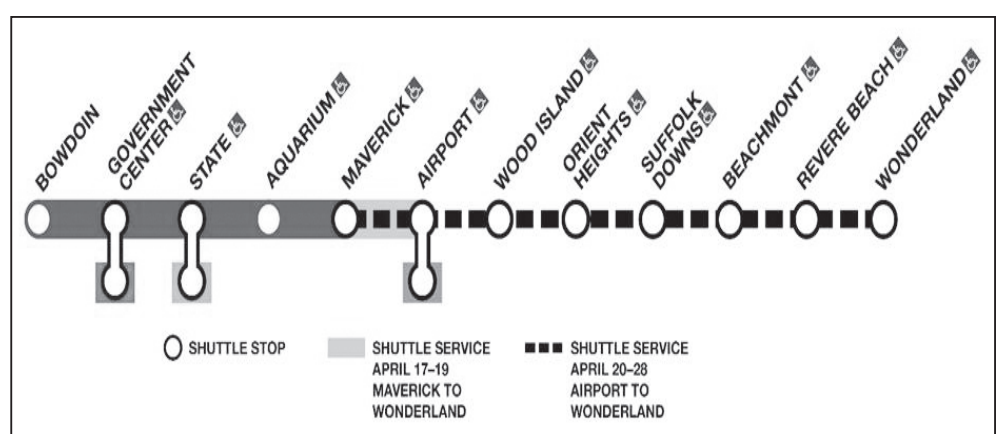

Shuttle Buses to replace Blue Line for critical track work latter half of April

Evening Blue Line service also suspended between Bowdoin and Orient Heights each day from April 9-11

Following up on the previous announcement on March 15, the MBTA is today reminding riders that Blue Line service will be suspended between Maverick and Wonderland for three days from April 17-19 and between Airport and Wonderland for nine days from April 20-28. Evening Blue Line service will also be suspended between Bowdoin and Orient Heights each day from April 9-11.

As previously announced, this service change is in place to allow crews to perform critical work to upgrade infrastructure as part of the Track Improvement Program, which will improve reliability and provide a safer ride. Work crews will also maximize this service change by upgrading the overhead catenary

wire system between Orient Heights and Wood Island stations.

As previously announced, Blue Line service will be suspended between Bowdoin and Orient Heights stations beginning at approximately 8 PM through the end of service each day from April 9-11. Free and accessible shuttle buses will make stops between Government Center and Orient Heights. Riders should note that shuttle buses will not stop at Bowdoin station. Riders can instead utilize shuttle buses at Government Center, which is about a quarter mile away (or about a four-minute walk). State and Aquarium stations will only be serviced by inbound shuttles to Government Center. Accessible vans will also be available to riders.

As previously announced, Blue Line ser-

vice will be suspended between Maverick and Wonderland for three days from April 17-19 and between Airport and Wonderland for nine days from April 20-28. Free and accessible shuttle buses will make stops at all stations. Accessible vans will also be available to riders.

Broadway Master Plan meeting generates interesting ideas

City officials, residents, and business owners attended a Broadway Master Plan Public Meeting Monday night at the Hill Elementary School cafeteria.

Mayor Patrick Keefe, Chief of Planning and Community Development Tom Skwierawski, Transportation Coordinator Julie DeMauro, and Business Liaison John Festa were all present for the formal presentation and discussion that focused on the future development of Broadway, the main business district in the city and

home address to City Hall and other iconic buildings such as the Central Fire Station.

Many were surprised and impressed by the large turnout of close to 50 people for the meeting, signifying that there is tremendous interest and excitement about the concept of a new look for the entire length of Broadway.

One interesting geographic and marketing proposal would be possibly placing Broadway under three separate names, North Broadway, Central Broadway, and South Broadway, for identification purposes.

David Gamble, founding principal of Gamble Associates, the City's planning and design consulting firm for the Broadway Master Plan process, led the formal presentation.

"This effort is really looking at the Broadway corridor at-large, from end to end, over a mile long," said Gamble, a graduate of Kent State University and the Harvard University Graduate School of Design. "Revere is lucky to have such a long, largely commercial but mixed-used corridor."

Following Gamble's presentation, the attendees separated into seven groups at individual tables, with one member of each group presenting its vision and ideas for Broadway.

The ideas for the new Broadway were plentiful, exciting, and innovative, with everyone agreeing that the city's main street should be more "aesthetically pleasing" with an increased number of trees and greenery along the route.

Other new concepts for Broadway and adjacent access areas included: making the street more pedestrian-friendly, well-lit walkways on streets of off Broadway, dedicated trolley transportation, the opening of a FedEx or Amazon drop-off or pick-up store for packages, no parking at all on Broadway on either side, the extension of sidewalks (for outdoor dining, for example), the construction of an off-Broadway parking garage, new signage for businesses, the opening of a brewery and new restaurants, a venue

statue of the great Patriot, Paul Revere (known for his famous ride in April, 1775, during which he warned colonial militia that British forces were approaching) for display in a highly visible location on Broadway.

All participants agreed that the flow of traffic must improve on Broadway.

Gamble was very pleased by the turnout ("Especially so following a holiday," he said) and the ideas presented for a new Broadway.

"We heard a lot of things that we've been brainstorming about and a lot of things that we hadn't heard before," said Gamble. "There's a lot of positive energy here that will move the Master Plan forward."

Gamble was asked about the potentially controversial decision of eliminating all parking spaces on Broadway. "Oh, one day, a man can dream, can't he? We've certainly got to do it the right way, and that's why we have a parking study that we're doing as part of this plan."

Gamble said that the parking study (being done by Stantec) will be completed by the fall of 2024.

"All of this will coalesce into a plan that hopefully, as best we can, connect the different developments and have a logical order of development and policy that works hand-in-hand in a holistic way," said Gamble.

Dylan and Tyler Stuart, Michael and Seth Amato, and Matthew Tata not only are following in the footsteps of their grandfather, but boasting with pride doing so.

Dylan and Tyler Stuart are the sons of Pat's daughter, Maria, and retired firefighter Michael Stuart.

"Dylan has been a firefighter since 2021. 'I've wanted to be a firefighter for as long as I can remember. I spent a lot of time in the firehouse with my father growing up and was enamored by the sights and sounds. As I grew older I still held that dream as I knew I wanted a career field where I could help people. My Papa, Dad, and older brother have always been my three biggest role models so to continue in their footsteps is a dream come true. Our grandfather loved his family more than anything. To see his grandchildren follow in his footsteps, in a career field that makes a difference every day, would've made him extremely proud.'"

Tyler has been a firefighter for 11 years serving as a private/firefighter and a driver/pump operator on Engine 1.

Seth has been with the department for eight months and is the son of Pat's daughter, Lisa. He is considered the "rookie" of the grandsons.

"I wanted to be a firefighter because I love helping others. I always knew my grandfather and Uncle were firefighters, and I took great pride in that. Although I think the biggest influence for me was when I was young and my older brother Michael who was a major father figure to me became a firefighter and continued that family legacy for the next generation of us. I could not be more proud to say that I am part of a legacy of firefighters. As the youngest firefighter not only in my family, but in the entire department, I do feel extra motivation to do my family's name justice and continue on the standard that has been set

by those before me. I think our Grandfather would be astonished and proud. He made such an incredible impact on all of us and he would love to see the fruit of his labor."

Michael has been a firefighter for 14 years and works in group I and is the tillerman on Ladder 1.

Caggiano reports that Revere bond payment will decrease by \$5 million

Revere School Committee member Anthony Caggiano said he is pleased to announce that the City of Revere's bond payment for the construction of the new Northeast Regional Vocational Technical High School in Wakfield will decrease by \$5.1 million over the life of the multi-year bond.

Caggiano said the decreased payment was a result of additional funding from the MSBA for the new school and cost-control measures by the Northeast Regional School building committee, on which he holds a seat.

"Since we are the largest contributor to the new school, we received the largest refund," said Caggiano, who serves on both the Northeast Regional School Committee and the Revere School Commit-

tee.

In March, Caggiano attended the groundbreaking ceremony for the new vocational high school which will built on the current school site. The construction of the new school is expected to be completed in 2026.

Revere is one of 12 cities and towns that sends students to the vocational school. Revere has the largest enrollment in the district, with approximately 320 students in Grades 9-12.

"Currently we have more than 300 applications for 70 seats in the freshman class," said Caggiano. "That's one big reason why a new [Northeast Regional] high school is so necessary. When the new school opens in two years, we will have a larger number of students from Revere being able to attend the school."

Caggiano was instrumental in Northeast Regional bringing a class in plumbing to Revere High School.

"Plumbing is a first-time program at Revere High, and it's been very successful," said Caggiano. "I'm hoping that we can add a second vocational program for the 2024-25 school year."

This has been an exciting stretch for Caggiano. Having been elected as a member of the Revere School Committee in November, he was recently appointed as the first treasurer of the Revere School Committee following a majority vote by his colleagues.

"The members felt it would be beneficial for the Committee to have a treasurer, and I'm honored to serve in that capacity," said Caggiano.

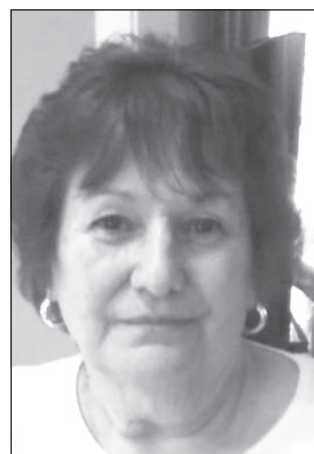

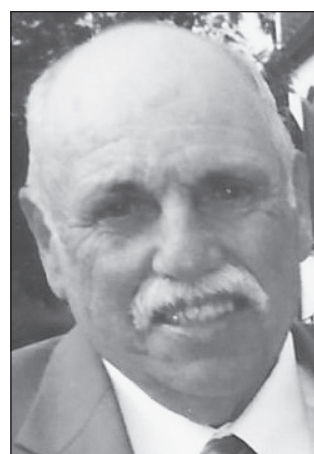
Joseph A. Pesce, Jr.

East Boston Neighborhood Health Center (EBNHC) recognized World Down Syndrome Day by unveiling a gallery wall of local pediatric patients living with Down Syndrome in the lobby of EBNHC's Maverick Square location. Nearly 20 families were in attendance to see their child's photo portrait on display.

World Down Syndrome Day is a global awareness day which has been officially observed by the United Nations since 2012. Down Syndrome (or Trisomy 21) is a condition in which a person has an extra chromosome, causing varying degrees of intellectual and physical disability and associated medical issues. Around 1 in every 800 babies will be born with Down Syndrome.

Remarks were delivered by CATCH Program Director and Pediatric Nurse Practitioner, Meghan Hamilton, NP. The Children's Access to Coordinated Healthcare (CATCH) program provides care coordination for the EBNHC's most complex pediatric patients while fostering community and connection with and between patients outside of the exam room by planning several accessible, adaptive recreational activities throughout the year.

East Boston Neighborhood Health Center, soon to be NeighborHealth as of June 1, 2024, is one of the nation's largest Federally Qualified Health Centers

(FQHCs) and the largest community-based primary care health system in Massachusetts, serving over 120,000 people and recognized by the Health Resources and Services Administration (HRSA) as a National Quality Leader. For more than 50 years, EBNHC has offered access to comprehensive primary care, specialty care and emergency care for patients in the Commonwealth. The Revere Human Rights Commission held its most recent monthly meeting on Thursday, March 7, in the City Council Chambers and via Zoom. Chairperson Shay Hossaini presided over the meeting that was attended by fellow members Dr. Lourenco Garcia, Molly McGee, Kourou Pich, Fire Chief Chris Bright, and two new members, Herby Jean-Baptiste and Somaya Larousse.

Also on hand for the session was former City Councillor Steve Morabito, who is the city's new Director of Diversity, Equity, and Inclusion (DEI).

Garcia presented a re-

cap of the HRC's activities in the month of February. "It was a successful month," said Garcia, who noted the celebration of Black History Month that took place at Revere High at the end of February. "It was a wonderful event."

The commissioners then selected their chair and vice-chair for the coming year, with Hossaini re-elected as chair and Jean-Baptiste as vice-chair.

The commission next took up the introduction for the new members of its subcommittees (also known as the HRC's Working Groups): Cultural Events and Celebrations

(Hossaini and Bright); Education, Research, and Evaluation (Garcia and McGee); and Community Outreach and Organization (Pich and McGee). Hossaini urged the new members to consider whether they would be interested in joining a working group.

In the open forum portion of the meeting, Morabito urged the commissioners to plan their events for the coming year well in advance. He also discussed compliance issues for the subcommittees relating to the State Open Meeting Law.

Garcia suggested that the commission hold a

retreat to plan its calendar for the year ahead. In response to a query from a fellow commissioner about the Open Meeting Law, Garcia said that by calling it a "workshop," as the schools do for the School Committee members, the commission can "circumvent" the requirements of the Open Meeting Law.

The commissioners concluded the meeting with a discussion about what would constitute meaningful education programs and workshops for the board members themselves, city employees, and the general Revere community.

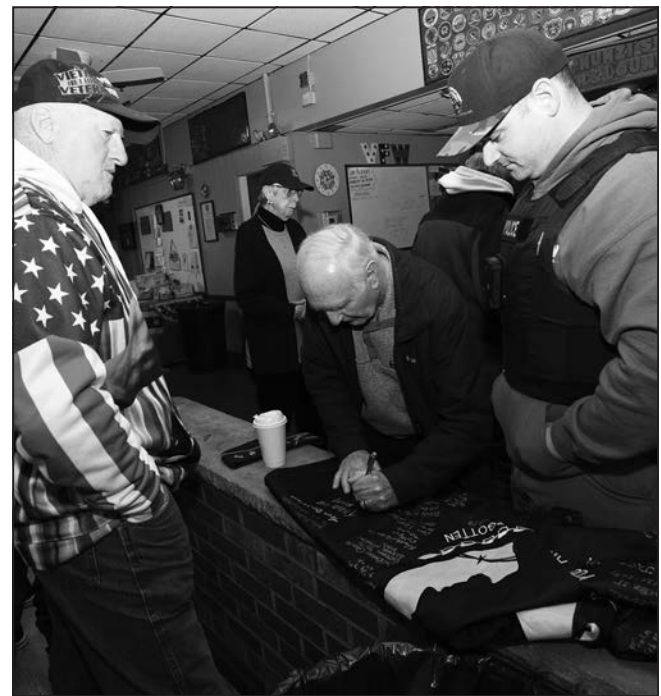

ees.org/) and search for “dogs allowed.” Our results included 77 properties where you could bring your dog. Each place’s “rules and regulations” tell you if dogs are allowed on or off leashes.

We plan to visit the Trustees deCordova Sculpture Park with friends this year. While the museum’s interior is

closed for renovations, the grounds welcome visitors with dogs. You may have to make a timed reservation; you can do that on the park’s website.

Wagons and Strollers Expand Possibilities

If your dog is older, unable to walk as far as you want, or has a medical issue that could curtail your

plans, consider a pet stroller or wagon.

Wagons are suitable for larger dogs. Today, you can choose collapsible ones that are easy to store. You can also use these for shopping, picnics, concerts, or other times when you need to tote stuff.

There are dozens of pet strollers available for smaller dogs. As we

planned our seasonal adventures, we realized that sometimes we left Poppy behind because part of the route would cause her anxiety and make her unhappy.

We discovered a great compromise with a stroller that, like a wagon, doubles as a shopping cart. Strollee is a company that sells a transformer frame with

available accessories that we can use for a dog and storage, for two dogs, or for shopping alone.

Over the years, we’ve come to appreciate the advantages of having a canine ambassador at the end of a leash. You meet many more people and become more engaged in the local community. Students and visitors to Bos-

ton often visit with Poppy. We’ve enjoyed interesting conversations with people we might never have met without our little ambassador.

Section 3. Section 12.04.080(A)(3) of the Revised Ordinances of the City of Revere is hereby amended by removing the words “five thousand” and inserting in place thereof the words “ten-thousand.”
Section 4. Section 12.04.080(A)(5) of the Revised Ordinances of the City of Revere is hereby amended by deleting this subsection in its entirety and inserting in place thereof the following the new subsection:
5. The superintendent of public works shall not issue any street or sidewalk opening permits to any permittee or excavator within five years of the final approval of any newly paved street or sidewalk by the superintendent of public works and the city planner unless in the case of an emergency, including but not limited to a gas leak, water break, water leak, sewer break, or sewer blockage. New installations for gas, water lines, sewer lines or connections shall not be permitted during the aforementioned moratorium.

Section 5. Section 12.04.080(C)(9)(c) of the Revised Ordinances of the City of Revere is hereby amended by removing the word “crackfilling” and inserting in place thereof the words “crack filling.”
Section 6. Section 12.04.080(C)(10) of the Revised Ordinances of the City of Revere is hereby amended by removing the word “three” from the first sentence and inserting in place thereof the word “four.”
Section 7. Section 12.04.080(D) of the Revised Ordinances of the City of Revere is hereby amended by re-lettering this subsection to “E. Billing and Collections.”
Section 8. Section 12.04.080 of the Revised Ordinances of the City

of Revere is hereby amended by inserting the following new subsection “D. Winter Excavations”;
D.Winter Excavations 1. Excavations into paved areas between November 15th through April 15th are authorized by the City of Revere in accordance with the department of public works’ “Rules and Specifications for Winter Excavation Activity within the City of Revere.” These rules and specifications shall be available to the public on the City of Revere’s website and at the Department of Public Works’ offices.
2. Approvals for permit requests for work occurring after November 15th shall be conditional upon adherence to the “Rules and Specifications for Winter Excavation Activity Within the City of Revere.” A street or sidewalk opening permit shall be issued upon receipt of a signed acknowledgement of the aforementioned rules and specifications by the permittee. Failure to adhere to the rules and specifications may result in the cancellation and refusal of existing and future permits. In addition to the requirements of 12.04.080(A), an additional Winter Excavation Fee of five-hundred dollars (\$500.00) is required upon approval of the permit. This fee is to offset the cost to the City of excavation issues pertaining to work being completed in winter months.
3. Water main shutdowns during winter months will be allowed solely at the discretion of the Revere Water Department.
4. This subsection shall take effect November 14, 2024.
Section 9. Section 12.04.080(E) of the Revised Ordinances of the City of Revere is hereby amended by re-lettering this subsection to “F. 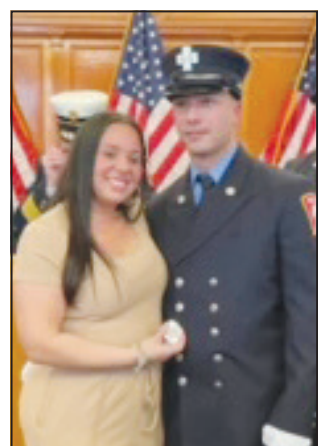

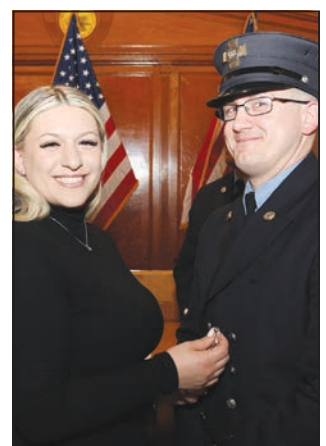

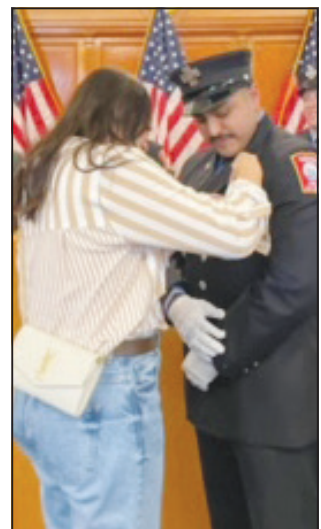

In the Catholic religion, the rising of Jesus from the dead, marks one of its holiest of holidays, and attending services on Revere Beach on the holiest

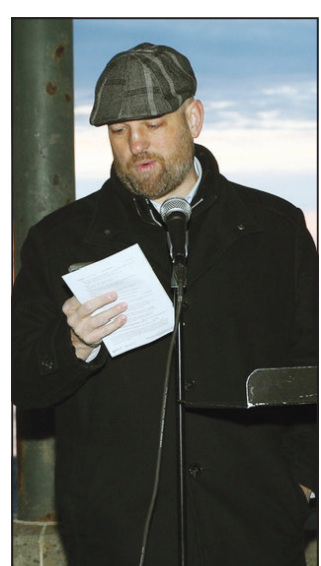

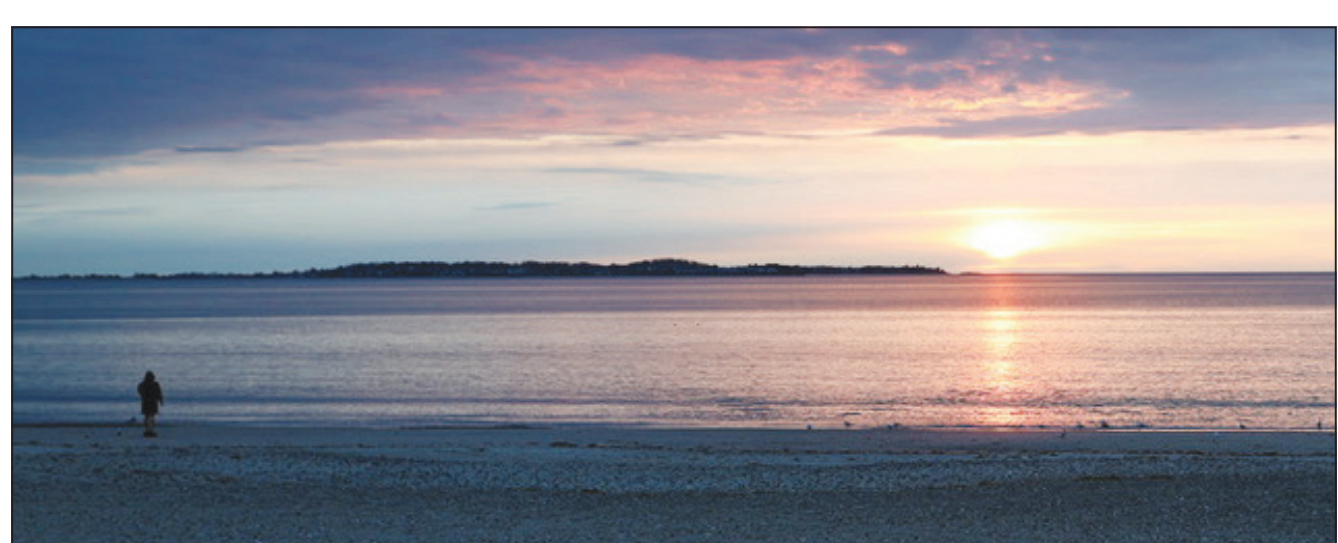

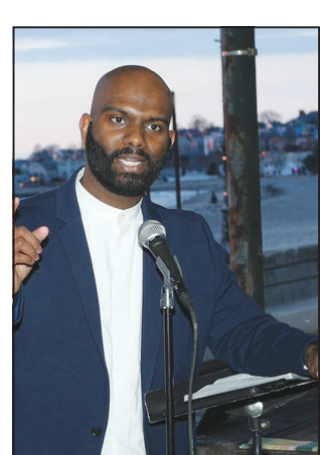
